## NW IL Art & Jazz Fest is jazzy, juicy and just plain jaw-dropping

The 2018 NW IL Art & Jazz will be the event of the year! The annual event features two days of regional fine art, live jazz music and scrumptious local food, craft beer & wine, along with the unveiling of a fourth wall mural in downtown Stockton, IL.

Set in the semi-wooded Stockton Lion's Memorial Park, this Galena Country spectacle was named Best Festival by Illinois Country Living readers in 2017.

Along with a juried art show, music kicks off Saturday, July 21, at 11 a.m. with Highland Community Colleges Big Band followed with saxophone virtuoso Amanee Avery and Too Deep. Closing out the first day will be festival favorite The Groove Hotel, featuring several RAMI award-winning musicians.

On Sun, July 22, music begins at 11 a.m. with the music of The Black Tie Trio, from DeKalb, followed by Round Midnight Quartet of Dubuque, IA.

The art show, opens 10 a.m.- 6 p.m. Sat. and 10 a.m.- 4 p.m. Sun., showcases a wide range of talented regional artists with everything from jewelry to glass and fiber to lawn sculpture. The Galena Brewing Company, Pecatonica Beer Tap House, Massbach Ridge Winery, Fergedaboutit Winery are offering samples, cups and bottles of locally-crafted libations. Food, samplers & meals, will be provided by regional chefs.

Not to be missed is the unveiling of the fourth wall mural on a downtown Stockton building. Muralist Chris Shannon has created visually explosive murals during the festival for the past three years. This year, the subject matter and location is a secret until the event weekend. Visitors are invited to watch Shannon at work and encouraged to take selfies in front of each of the four gigantic murals.

After a day at the Fest, trek down the road a bit to Woodbine Bend Golf

Course & Restaurant, the event's title entertainment sponsor, for a round on the immaculate links-style course and outstanding cuisine.

## Attorney General Madigan sues professional fundraisers

Attorney General Lisa Madigan filed lawsuits against professional fundraisers based in the Chicago suburbs seeking to ban them from operating in Illinois for numerous violations of the state's Solicitation for Charity Act.

In two separate lawsuits filed in Cook County Circuit Court, Madigan sued Community Guide Magazines Inc. (CGM) and Supplemental Security Foundations Inc. (SSF) for various fundraising violations, including making misleading representations to people during fundraising solicitations for charities.

"These fundraisers are engaged in illegal fundraising," Madigan said. "They kept the majority of money they collected instead of giving it to

the charity they claim to be raising it for. People who want to donate to a charity should contact the charity directly if they want to ensure their entire contribution benefits the charity."

Madigan's lawsuit against the Cicero-based CGM also names its operator Ron McMenemy, as well as professional solicitors Stephen Ashely, Ronald Chilman, Jarrod Horton, James Jindela, Peter Pearson, and Curtis McDowell. Madigan alleges that CGM and McMenemy hired professional solicitors with felony convictions to fundraise in Illinois, which is illegal under the Illinois Solicitation for Charity Act. CGM's professional solicitors were fundraising on behalf of two charities, Vietnow National Headquarters

and American Veterans Foundation (AVF). The professional solicitors submitted false documents to Madigan's office claiming they had no criminal records that would violate the Act. The Act prevents anyone convicted of a crime involving theft, fraud, or financial wrongdoing, or any felony from soliciting Illinois residents as a fundraiser for a charity.

In her lawsuit against SSF, Madigan also sued owner Ronald Broadstone, Gary Neuburger, a professional solicitor, and the charity AVF, for engaging in illegal fundraising activities. Madigan alleges that SSF, based in Oak Forest, made misleading representations to potential donors and did not disclose that they were paid professionals, in violation of Illinois

law. For example, Madigan alleges SSF's solicitation mailings listed a local Illinois phone number and address for AVF that really belonged to employees at SSF in order to falsely represent that AVF had a local presence in Illinois.

In addition, Madigan's lawsuit alleges that Neuburger and Broadstone falsely claimed on 2017 and 2018 forms that Neuburger had never been convicted of a felony or any crimes involving theft, fraud, or financial wrongdoing. Neuburger, in fact, is a felon with prior convictions for various crimes involving misuse of money, dishonesty and burglary. Madigan also alleges AVF allowed SSF to solicit contributions in a way that did not disclose that callers were

paid professionals and to distribute materials that misrepresented who was actually soliciting prospective Illinois donors, in violation of the Solicitation Act.

Madigan is seeking to ban both CGM and SSF from soliciting in Illinois. Additionally, Madigan is seeking an accounting of all funds raised and the forfeiture of any compensation paid to these fundraisers. She is also seeking to cancel AVF's registration in Illinois and institute a five-year ban on AVF from soliciting in Illinois.

Bureau Chief Therese Harris, Deputy Bureau Chief Barry Goldberg and Assistant Attorney General Pooja Shah are handling the cases for Madigan's Charitable Trust Bureau.

## Partnerships with Japanese companies lead to Illinois jobs

Gov. Bruce Rauner today told the newly appointed Japan Ambassador to the U.S. that Illinois is eager to expand its job-creating partnership with Japan and those businesses operating in Illinois. The Governor and Ambassador Shinsuke J. Sugiyama met in Schaumburg, where the ambassador is visiting as part of a Grassroots Caravan to tour company facilities, see the latest in manufacturing innovations, and learn more about the Illinois workforce.

"Our relationship with Japan is so important to the Illinois economy," Rauner said. "More than 630 Japanese companies operate within our borders today and they provide em-

ployment for 46,690 Illinois workers. For us, today's meeting reinforces the benefits our state derives from foreign direct investment. For Ambassador Sugiyama, we hope it helps confirm our commitment to helping Japanese companies grow here in Illinois."

Rauner and Sugiyama toured Amada America Inc.'s 133,000-square-foot facility to see the company's industry leading work in manufacturing automation and robotics. Along with a delegation of state and local officials, Rauner welcomed Sugiyama on his first official visit to the state of Illinois.

"Seeing is believing," Sugiyama

said. "Participating in the Grassroots Caravan, I understand that it is something more than just deepening our economic relationship, but also brings people closer together."

Japanese companies have been instrumental in creating jobs and driving economic development throughout the state. Employment at Japanese companies is up 6.1 percent in the last year. Rauner's first business development mission was to Japan in 2017.

The Ambassador's Grassroots Caravan visit was organized by the Illinois Department of Commerce, Intersect Illinois, Consulate General

of Japan in Chicago, Schaumburg Business Alliances, Japan External Trade Organization, Japan Chamber of Commerce, and the Illinois Manufacturers Association.

"The Illinois Manufacturers' Association is proud to be part of the delegation hosting new Japanese Ambassador Shinsuke Sugiyama and Consul General Naoki Ito in Schaumburg," said Mark Denzler, vice president and COO of the manufacturers' association. "We had a great visit at Amada America Inc."

"I'm honored that both the ambassador and the governor are here," Consul General Ito added. "The im-

portance of Japan's business relationship with Schaumburg and Illinois is on full display today. The greater Schaumburg area really stands out in our economic partnership."

"The Japanese Chamber of Commerce and Industry of Chicago, with more than 500 corporate and individual members, continuously strives for a further collaboration with the State of Illinois to better serve the people and play a key role in strengthening the relationship between the United States and Japan," said Tetsuro Mitani, executive director of the Japanese Chamber of Commerce of Chicago.

## Traumatizing immigration practices

As we began the summer, we saw horrific images of children who arrived in the U.S. illegally separated from their parents and detained in chain-link cages. Many of these children and their parents are fleeing gang violence in Central America. As our elected officials debate how to resolve the immigration issue, we should be firm in our belief that the forcible removal of a child from his or her parents is not in the child's best interest. In many cases, these children will suffer long-term trauma from the actions we have taken against them. As noted by the Harris Professional Development

Network, the "longer these children are kept away from their families or in detention, the more severe the harm to their development..." Detaining children in cages only adds to that trauma and is certainly not representative of a compassionate nation.

Since those pictures first appeared, President Donald Trump has signed an executive order reversing the separation policy. At the end of June, a federal judge in California ordered the government to reunify all parents with their children who are under the age of five by June 10, and reunify all parents with their minor children age five and older within 30 days (by July 26). Based on press accounts, 38 of 102

children under the age of five were reunited as of yesterday. The majority of the remaining children had yet to be reunited with their parents because of ongoing vetting, parents in criminal custody, safety reasons, or parents already deported. Last week, the Trump Administration estimated there were under 3,000 immigrant children separated from their parents and in federal custody. Voices for Illinois Children will continue to advocate for these children to be reunited with their asylum-seeking parents as quickly as possible and that their rights to due process are recognized and respected. Every day the government delays, it inflicts more trauma on the separated children.

## Master Gardener Helpline helps home gardeners

The University of Illinois Extension-Stephenson County Master Gardeners offers a helpline every growing season. The helpline is designed to help the home gardener with their horticulture questions. Master Gardeners volunteer their time on the helpline which is open weekdays from 9 a.m. to 11 a.m., May through September. Each year the Master Gardeners field a variety of questions from across the county. During the 2017 growing season, the Master Gardeners answered 175 horticulture related questions providing research-based answers.

Master Gardeners are volunteers that go through horticulture training led by University of Illinois Extension Educators. During the training they learn about all aspect of horticulture but they also receive training about the resources that the University of Illinois Extension has available for them to use. A Master Gardener has the ability to find research based information from the University to provide to homeowners when they call with a question.

"Each year the calls to the helpline are documented so that we know the types of questions are coming in and where in the county the questions are coming from" stated U of I Extension Program Coordinator Nikki Keltner "it helps us to identify trends and key issues for that particular growing season." From the 175 questions fielded in 2017 the majority of the questions were about trees and shrubs. Vegetable related phone calls were a close second. Master Gardeners also answer questions about bugs and other pests and are happy to identify that pest if the homeowner brings a sample to the office.

At the University of Illinois Extension-Stephenson County we are proud to work with 61 Master Gardener Volunteers. In 2017 the Master Gardeners contributed nearly 2,500 volunteer hours to the community. In addition to the helpline they also offer educational programs to the community, beautiful display gardens at many public locations, and much more.

# Highland Agriculture and University of Illinois Extension to host soybean research demonstration

Highland Community College Agriculture in partnership with University of Illinois Extension will be hosting a Soybean Research Demonstration on August 29, 2018 at Highland Agriculture's research plot located at 3472 W. Loras Drive in Freeport, IL. The free demonstration will begin at 9 a.m. and conclude 11 a.m. The public is invited to attend to learn about the research taking place at Highland as well as hear from University of Illinois Extension specialists from throughout the state about soybean insect, weed, disease, and production issues. Breakfast will be provided for those who pre-register. The research plot is in its first year of production at Highland Community

College through generous sponsorships from Hinrichs' Family Farms, Stephenson Service Company, Ogle County Farm Bureau, Stephenson County Farm Bureau, and Forreston State Bank. The 10 acre plot serves as a land lab where students gain hands on experience with crop production and research design. This year's research consists of testing the effects that various soybean population rates and seed treatments have on both yield and return on investment. The college intends to share the progress of this research at the August 29th demonstration and plans to report the final data to the public at the conclusion of the growing season.

University of Illinois Extension spe-

cialists Phillip Alberti, Russ Higgins, and Nathan Kleczewski will share their knowledge as part of the demonstration. Phillip Alberti, Commercial Ag Educator, will discuss current north-west Illinois crop concerns. Russ Higgins, Commercial Ag Educator, will

identify weed issues and control methods in soybeans. Nathan Kleczewski, Research Assistant Professor, University of Illinois, will be speaking about soybean insects and diseases.

The demonstration is free, however participants are asked to register by

## Certified Food Protection Manager Course offered in Freeport

The University of Illinois Extension will offer the Illinois Certified Food Protection Manager Course, formally known as the Food Service Sanitation Manager Course (FSSMC). This two-part course will meet the eight-hour coursework and examination required by the State of Illinois for both the initial CFPM, and the recertification.

Effective Jan. 1, 2018, the Illinois Food Service Sanitation Manager Certification (FSSMC) was eliminated. However, the Illinois Department of Public Health's Food Service Sanitation Code still requires food establishments to be under the operational supervision

of a certified food service sanitation manager during hours of operation.

Now food establishments must have an American National Standards Institute (ANSI) accredited Certified Food Protection Manager (CFPM) certification. This requirement helps to ensure the safety of consumers when eating away from home. Those receiving this certification have specialized training, by an ANSI approved instructor, regarding the safe handling, preparation and storage of food to help prevent foodborne related illnesses. The certificate is valid for five years from the exam date and then is repeated once a certificate expires. One of the positive aspects of this change comes in the form of students no longer having to apply for the additional Illinois FSSMC certificate, which will save them money.

During the two-day Certified Food Protection Manager Course, participants will gain knowledge about food safety and contamination, employee health and hygiene, safe food handling practices, cleaning and sanitizing, and HACCP.

The Certified Food Protection Manager Course will take place on Aug. 14, 9 a.m. - 3 p.m. and Aug. 17, 9 a.m. - 2:30 p.m., at the Stephenson County Farm Bureau, 210 W Spring Street, Freeport. Participants should bring a valid photo ID and arrive 15 minutes early to register, as class will begin promptly at 9:00 am. Participants must attend the full training to be eligible to take the exam.

There is a \$100 fee for the Certified Food Protection Manager Course. This fee is for the purchase of the book, educational materials, examination, and lunch. # NIFA to sponsor chain saw safety courses

The Northwest Illinois Forestry Association (NIFA) will sponsor two Chain Saw Safety and Woods Worker (SAWW) courses near Elizabeth this month, a Level 1 Session on Wednesday, July 25, and a Level 2 Session Thursday, July 26. The Level 1 Session is to be held at the Tom and Jessica Arnold Farm. It is open to participants of any level of experience. The Level 2 Session will be held at the Jim and Monika Breed Farm and is open only to those who have completed Level 1 any time previously. Level 2 will feature advanced tree felling techniques and more hands-on time in the timber. Both courses will be led by University of Illinois De-

partment of Natural Resources & Environmental Sciences forestry specialist Jay Hayek. This training is designed to teach novice and seasoned saw operators safe operation of gas-powered chain saws. All participants will be instructed in cutting and felling methods using the open-face directional notch and the bore-cutting technique. The course consists of both inside classroom instruction and outside hands-on training and saw operation.

## Topics to be covered

- safety and personal protective equipment (PPE)
- saw operation, starting, safety features, and body mechanics
- cutter tooth parts, basic saw

maintenance, and chain filing

- saw reactive forces (push, pull, kickback, and attack)
- the five-step felling plan
- the safe cutting of spring poles and limbing and bucking techniques.

Cost and Registration  
Each one-day course costs \$70 for the general public. NIFA members, their spouses, and children will receive a \$10 discount for each course with another \$10 discount for each course for anyone registering before 10 pm, Wednesday, July 18. Registration may be made by mailing request & payment to Tom Arnold, 997 N. Salem Rd., Elizabeth IL 61028, calling 815-858-2407, or emailing arnoldfarm@juno.com. To ensure

everyone receives hands-on, personal instruction, class size is limited to the first eight applicants, so register early! Registration will close at 10 p.m., Saturday, July 21.

Day of class sign-in will begin at 8 a.m. with the indoor session starting at 8:30. Course will end at 4:30 p.m. Bring your own lunch, chain saw, leather work boots, and gloves. If you have them, bring a safety helmet with face shield and hearing protection and chainsaw chaps. These items are a must-have to participate. If you do not have them, indicate so with registration, and they will be provided or shared.

July 25 - Arnold Farm is located at 997 N. Salem Rd., Elizabeth IL. From Hwy US 20 in Woodbine (half way between Stockton and Elizabeth), take Scout Camp Rd north near the east edge of town. Go approx. 5 miles and turn left onto Schapville Rd. In about 100 yards, take the first left onto Salem Rd. The farm is 2 miles down on the left side. Buildings are bordered by an evergreen windbreak.

July 26 - The Breed Farm is located at 3446 W. Long Hollow Rd. Elizabeth IL. From Elizabeth, head west on Hwy US 20 approx. 7.5 miles to the Galena Territory main entrance. Turn right (north) into the entrance, then an immediate right onto Long Hollow Rd. Travel approx. 2 miles to the farm lane on the north side (left). Buildings are not visible from Long Hollow Rd.

Jay Hayek has received over 144 hours of advanced professional chainsaw training through the following nationally recognized programs: Safety and Wood Workers (SAWW) Training, Game of Logging™, and NWCG's S-212 Wildland Fire Chainsaws. Jay is also the lead chainsaw instructor for NRES 285 - Chainsaw Safety & Directional Felling, a 2-hr undergraduate field course offered at the University of Illinois. Jay received his B.S. in forestry from the University of Illinois and his M.S. in forest resources (silviculture) from the University of Idaho.

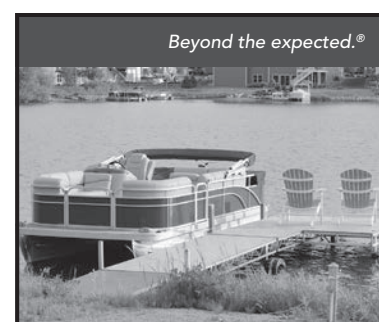

**WHEREAS**, Section 130/9 of said Act requires that the Lena Fire Protection District (the "District") each fiscal year establish the general prevailing rate of hourly wages to paid laborers, mechanics, and other workmen in the areas encompassed by the District employed by contractors or sub contractors in performing construction and maintenance of public works contracted for the District.

**NOW THEREFORE BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE LENA FIRE PROTECTION DISTRICT:**

**SECTION 1:** Contractors or sub-contractors doing construction and maintenance of public

works for the District shall pay the general prevailing rate of hourly wages to all laborers, mechanics, and other workmen employed by them as from time to time determined by the Department of Labor of the State of Illinois to be applicable to similar contract in Stephenson County, Illinois.

**SECTION 2:** This Resolution shall be published in a local newspaper of general circulation, to be publicly posted and kept available for public inspection at the District Office, is to be promptly filed in the office of the Secretary of State at Springfield, Illinois, all as by law prescribed where after the same shall be done in force and effect as by law provided.

**SECTION 3:** The general prevailing rate of hourly wages for all labors, mechanics, and other workmen hereby adopted shall be in effect for the Lena Fire Protection District beginning May 1, 2018 and ending April 30, 2019.
