Village of Lena pursues greening as an alternative to blight

Rather than deal with the stresses of urban blight resulting from empty lots and abandoned houses, the Village of Lena is undertaking a project designed to reduce tension through greening; a process that can be as simple as cleaning empty spaces, planting trees and shrubs and adding limestone signage. The first project is already underway and within months, Lena will open its newest comfort destination, Volunteer Park.

"After that house got tore down near the little triangle at Schuyler and Logan I was talking to the mayor and he said they wanted to do something with the empty lot," said Lena resident Ben Mayer. "At first we discussed putting a welcome sign with a panther on it at the edge of town like Pearl City has with their wolf sign, but after talking, some people thought we should do two on each end of town; one coming into town on the highway and one going out of town towards the ethanol plant."

As the talks continued, they decided that was too expensive.

"So, we decided it would be better to do one sign on that empty lot where they just tore a house down," said Mayer. "When you go into Freeport you see that sign that says, 'Welcome to Freeport' and then they have the debate sign both on large limestone stones. We thought we would go along those lines and have one stone that said welcome to Lena and another that identifies the park as Volunteer Park."

He said the Village of Lena, the three banks in town, and The Lena Lions are funding the project at this

point and they are expecting to take delivery of the stones by the end of August, meaning it is time to gather the volunteers and get started digging a base and pouring the concrete footings that will support the limestone signs.

"You've got to unload these stones one and a time and one weighs about three ton and the other weighs about four, so we won't be doing that with a wheelbarrow," Mayer said. "We have several volunteers lined up to help with the unloading and positioning of the stones and we should be ready when the stones arrive."

The lot is too small to locate a residence on it and attractive signs welcoming visitors to town should go a long ways toward cleaning up the intersection.

"It's a good thing for the village to expand its parks and recreation areas," said Mayer. "The Lions bought land where the park is and I think that helps a lot. We have the swimming pool, the ballpark and now with this Volunteer Park, it all fits together."

He said there really is not a problem with abandoned houses in the village, but they want to stay out front of that possibility.

"The village intends to continue applying for funding, so they can tear down some of these empty houses," Mayer said.

A vacant lot is a contagious place. Signs of disorder including overgrown weeds and bare spaces have a way of spreading, but Lena's Lions, its three banks, and the village are on the right path to beautification and that path can be even more contagious than blight.

Pearl City Mason Lodge closes after 124 years

many meetings and lots of thought we found a home for our existing members in Evergreen Lodge #170 in Freeport, IL.

I was a fortunate person to join the Mason at 21 years of age on Jan. 7, 1947, making me a 70 year member at this time. I had the opportunity of sitting in chairs and learning ritual. Being master a couple of times and raising your own brother was a real treat. When he was asked for something of a Metallic kind he said he was glad I was there because he was broken. In my life, I have belonged to many organizations. But only if they did not interfere with the Lodge meetings, making 25 in a row without missing one. We visited many

lodges helping them with degree work. One evening, we were having too much fun and he was jealous of all the members we had to put in the work. He spoiled his presence at our meetings and also others.

I will always be a Mason and enjoy the work they do and the kind of people they are. Traveling is always fun when you are recognized as a Mason and know you are in good company.

Losing our Lodge in Pearl City breaks my heart, but we are still Masons. And I hope we will support a Lodge where ever that may be. Years ago, the salary for secretary was \$1.00 per meeting. I never took the pay for a meeting, being a Mason was enough.

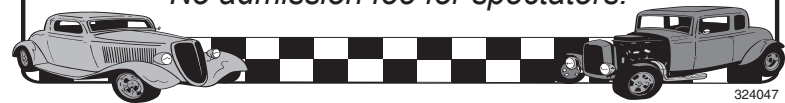

New law will improve medical care for sexual assault survivors in Illinois

Attorney General Lisa Madigan announced that a new law will require better care for survivors of sexual assault in Illinois. The new law, initiated by Madigan, makes Illinois a national leader in providing specialized care to conduct examinations and treat emotional trauma in the aftermath of sexual assault crimes.

House Bill 5245, sponsored by Rep. Michael Unes and Sen. Julie Morrison, was signed into law earlier today. The new law will expand the Sexual Assault Survivors Emergency Treatment Act to ensure that Illinois hospitals provide specialized sexual assault care in emergency rooms, which will include Sexual Assault Nurse Examiners (SANEs). SANEs are trained to collect physical evidence following a sexual assault, respond to the medical and psychological needs of a survivor and testify in court. Despite years of SANE training provided by Madigan's office to nurses in Illinois, few hospitals currently provide specialized care for sexual assault victims.

"Illinois hospitals must now provide sexual assault survivors with

specialized compassionate medical care," Madigan said. "This new law will ensure survivors receive the care they deserve to treat the physical and emotional trauma they have endured after a sexual assault."

"This law will ensure that the trauma of a sexual assault is not compounded when survivors, particularly children, undergo the lengthy examinations that are necessary to collect evidence," Unes said. "I appreciate the work of the Attorney General and advocacy groups to make sure that under this law, all survivors receive prompt treatment and child survivors have the ability to be treated at pediatric health care facilities."

"The thousands of women, children and men who are sexually assaulted deserve nothing less than prompt treatment by medical professionals who have been trained to address trauma while simultaneously conducting thorough medical forensic examinations," Morrison said. "I was proud to work with the Attorney General to support survivors, and I will continue to push to improve care and services for the survivors of these unimaginable crimes."

The law is part of Madigan's continuing effort to improve the response and care of sexual assault victims and increase successful prosecutions to ensure public safety. Under the new law, hospitals must ensure that a sexual assault survivor receives specialized care by a qualified medical provider within 90 minutes of arriving at a hospital by Jan. 1, 2022. The law also requires ongoing education to ensure that emergency room medical personnel such as attending physicians, physician assistants and nurses are trained to treat survivors

of sexual assaults appropriately.

In addition, the law seeks to lessen the trauma on child survivors of sexual abuse by giving them the option to undergo the necessary and critical medical forensic examination in a more familiar setting. Under the law, sexual abuse survivors under the age of 13 can receive acute medical forensic services at an approved pediatric health care facility beginning Jan. 1, 2019. The approved pediatric health care facility must ensure that the medical services are provided by a SANE or specially trained physician.

Since 2003, Madigan's office has provided classroom training to more than 1,600 nurses across the state, yet only 315 of those nurses have completed the clinical training required to become a practicing SANE in large part due to a lack of support from the hospitals where they work. At present, only 188 SANEs are practicing in emergency departments in Illinois hospitals and no hospital has a 24/7 SANE program.

The law is supported by a bipartisan group of legislators as well as the Illinois Coalition Against Sexual Assault, Illinois Sheriffs' Association, Illinois Association of Chiefs of Police, Illinois State's Attorneys Association, Children's Advocacy Centers of Illinois, OSF Healthcare, Chicago Alliance Against Sexual Exploitation, Rape Victim Advocates, Illinois NOW (National Organization of Women), International Association of Forensic Nurses - Illinois Chapter, and the Illinois Emergency Nurses Association.

Attorney General Madigan is a national leader in protecting survivors of sexual violence and strengthening their rights. Madigan drafted and successfully worked to pass legislation that improves the response of law enforcement to sexual assault survivors through evidence-based, trauma-informed, and victim-centered policies, procedures and training and obtained federal funding to provide the training required under the law. She also worked to pass the Preventing Sex-

ual Violence on Campus Act to set standards for all Illinois colleges and universities to prevent and respond to sexual violence, as well as a law to eliminate Illinois' criminal statutes of limitation for all felon criminal sexual assault and sexual abuse crimes against children. In addition, Madigan successfully advocated for enhanced crime victims' rights under the state's Constitution to ensure victims have a voice in the criminal justice system. Madigan also initiated a law that made Illinois the first state in the country to mandate the testing of sexual assault evidence kits.

Attorney General Madigan's Crime Victim Services Division manages programs that provide assistance to crime victims and service providers. Two regional superintendents to shape critical statewide education funding discussion

Two regional education leaders will play a role in shaping the critical discussion on ensuring the state's new historic education funding reform model is also helping provide aid for at-risk youth in schools around the state.

Regional Superintendent Julie Wollerman of Regional Office of Education #3, covering Bond, Christian, Effingham, Fayette and Montgomery counties in central and southern Illinois, and Gregg Murphy, Regional Superintendent for ROE

#32 covering Iroquois and Kankakee counties in northern Illinois, have been appointed to represent the Illinois Association of Regional Superintendents of Schools (IARSS) on the new state Evidence-Based Funding Professional Review Panel. The panel was created as part of the state's historic education reform law approved last year to steer millions of new state dollars into schools and programs that are in most need of extra aid, and it features lawmakers, educators and education advocates.

The law calls for the 27-member panel to review the entire evidence-based funding model and report its findings and recommendations back to the Governor, Legislature and State Board of Education. More information on the funding review panel is available here: <https://www.isbe.net/prp>. The group's next meeting is set for Sept. 18.

Wollerman and Murphy are both part of the subcommittee on the Regional Safe Schools Program (RSSP), which provides critical alternative education through ROEs for disruptive students who have been suspended or expelled from their schools. This subcommittee will review how to include RSSP and other alternative education programs into the new funding model.

"I am very excited to represent my colleagues and their programs that serve at-risk youth across the state," Wollerman said. "It's imperative that we find a way to properly fund such programs in an equitable and adequate manner."

"While our schools welcome the much-needed funding provided by the new formula, we cannot leave behind the at-risk students whose lives are changed from going through our alternative school programs," Murphy said. "I am eager to work with Julie and ensure IARSS has a strong voice for providing the resources our programs need to help these students."

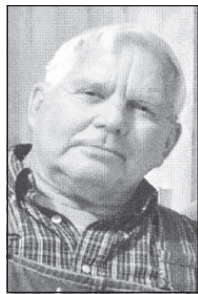

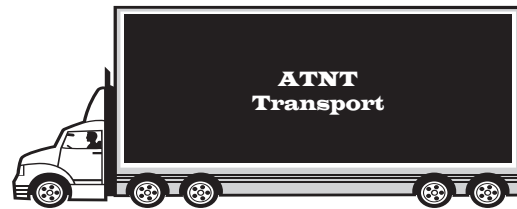

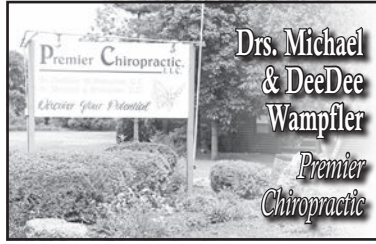


Elizabeth traffic crash with injuries

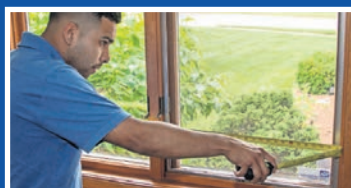

The not so skinny cook

Can you all believe that summer will soon be over? It is not very believable to someone who has spent most of the summer indoors. School will soon be in session. Tomatoes are coming in, and sweet corn is over. This week's recipes will still be featuring some of the great things from the garden.

The first recipe is for an interesting bean dip appetizer. In watching a million food shows this summer, beans are a trend that is both healthy and hearty. I have several vegetarian friends who love to use beans in many things and appetizers are a favorite way (and a cheap one too) of starting off a party or meal. This one is full of garlic, and cumin, so if like both of those, you are in for a treat.

Garlic Bean Dip

1 can (15 oz.) cannellini beans, rinsed and drained
1 T. cider vinegar
2 garlic cloves, minced
½ t salt
½ t. ground cumin
½ C. mayonnaise

2 T. chopped fresh parsley
Pita chips or fresh veggies

Place the beans, vinegar, garlic, salt and cumin in a food processor and process until almost smooth. Add mayo and parsley; pulse just until combined. Refrigerate and serve with chips or veggies.

This next salad is really great because of the blackberry dressing. The "croutons" are sort of nifty because they are cheese balls. You could substitute croutons from a package, but the cheese ones are a lot tastier and a tad bit elegant. You could substitute any green leafy lettuce for the spring mix. Use the dressing on other salads too.

Summer Salad with Blackberry Dressing

1 pkg. (4 oz.) feta cheese
4 oz. cream cheese, softened
¼ C. flour
¾ t. pepper, divided
1 large egg, lightly beaten
1 T. water
1 C. panko bread crumbs
8 T. olive oil, divided
¾ C. packed fresh basil leaves, divided
¼ C. white wine vinegar
¼ C. Blackberry Sauce
1 clove garlic
1 t. Dijon mustard
1 t. salt
6 C. salad greens, spring mix
½ of English cucumber, thinly sliced
4 small tomatoes, quartered
1 C. fresh blackberries
¼ C. thinly sliced red onion
In a small bowl, stir together feta and cream cheese until smooth. Di-

vide into 8 portions, and shape each into a ball. In a shallow dish, whisk together flour and ¼ t. pepper. In another shallow dish, whisk together the egg and 1 tablespoon of water. Place bread crumbs in a third shallow dish. Dredge cheese rounds in flour mixture, shaking off excess. Dip in egg, letting excess drip off. Dredge in bread crumbs, pressing gently to adhere. Place cheese in a single layer on a foil-lined baking sheet. Cover and refrigerate for at least 30 minutes or up to 4 hours.

In a large nonstick skillet, heat 2 tablespoons of oil over medium heat. Cook half of cheese until lightly browned, 2-3 minutes per side. Let drain on paper towels. Repeat with 2 T. oil and remaining cheese.

In a blender, process ½ cup basil, vinegar, Blackberry Sauce, garlic, mustard, salt and remaining 4 T. oil and ½ t. pepper until smooth.

Divide the salad greens, cucumber, tomatoes, blackberries, onion and remaining basil and cheese among serving plates. Serve immediately with processed dressing.

Blackberry Sauce

2 c. fresh blackberries
2 C. sugar
¼ . Water

In a small saucepan, cook all ingredients over medium heat, stirring constantly, until sugar's dissolved and berries are soft and falling apart, about 15 minutes. Let cool for 15 minutes. Transfer mixture to a blender and process until smooth. Strain through a fine-mesh sieve, discarding the solids. Cover and refrigerate for up to a week.

My Stockton friend Connie gave me this good salad recipe. It is a family favorite that she recently served at her family reunion. One of my other friends talked about how few Jell-O salads are served any more. I don't know about you, but I still like a refreshing jiggly salad. Be sure to use regular Coke and not Diet and to buy the canned cherry

pie filling with the extra cherries.

Connie's Salad

1 can (12 oz.) Coca Cola
1 large box (6 oz.) red Jell-O
1 can (20 oz.) cherry pie filling
1 can (20 oz.) crushed pineapple, undrained

In a saucepan, bring Coke to a boil. Stir in Jell-O until dissolved. Add the pie filling and pineapple and stir until it starts to set. Refrigerate until firmly set.

If you are looking for a one pot main dish that will be ready when you get home from work, this next chicken and vegetable dish is for you. I know we will have some hot days that will need a meal that won't heat up the kitchen. You can also save it for winter when you want to come home to an already prepared meal.

Cheesy Chicken and Vegetables

1½ C sliced carrots
1 C. chopped sweet onion
½ C. chicken broth
2 lbs. boneless skinless chicken breasts, cut into 1-inch pieces
2 sprigs fresh thyme
1 t. garlic salt
½ t. pepper
2 C. broccoli florets
1 pkg. (8 oz.) cream cheese, cubed and softened
2 C shredded cheddar cheese, divided
1 C. cherry tomatoes, halved

In a 4-quart slow cooker which has been sprayed with cooking spray, stir together the carrots, onion and broth. Add the chicken and thyme, and sprinkle with garlic, salt and pepper. Cover and cook on low until the chicken is tender, 44-5 hours.

Stir in broccoli and increase the heat to high. Cover and cook for 15 minutes. Stir in cream cheese and cook uncovered, stirring occasionally, until cream cheese is melted and smooth and sauce is thickened, about 10 minutes.

Discard thyme sprigs and stir in ½ cup cheddar and the cherry tomatoes until they are heated through. Sprinkle with remaining cheddar; let stand for 5 minutes before serving.

This dessert is an easy one to make because you use prepared items. You could use a shortbread crust instead of the graham cracker.

Blueberry Cream Pie

Graham cracker pie crust

1 pkg. (8 oz.) cream cheese, softened
1/3 C. powdered sugar
1 t. vanilla
4 C. frozen whipped topping, softened
6 T. blueberry preserves, divided
Blueberries for garnish

In a large bowl, beat cream cheese with a mixer at high speed until smooth. Beat in powdered sugar until smooth; beat in vanilla. Fold in whipped topping.

Spread half of cream cheese mixture into crust; dollop with half of preserves by tablespoonfuls; swirl together with a knife. Repeat layers and swirl. Loosely cover and refrigerate for at least 8 hours before serving; Garnish pies with fresh blueberries.

I did get out to a wonderful production of Fiddler on the Roof at Timber Lake on Sunday. I have been trying to do one or two challenging things a week in order to get back to my usual self. That outing was wonderful and brought back some great memories from when we presented it on the Le-Win stage. Once again I will attempt to go to Music in the Park on Sunday evening. The water samples for all tests will be immediately shipped to the laboratory.

Prices will vary, depending on the type of test ordered. Any test or combination of tests may be ordered. As in past years a Farm Bureau Discount will be given to any Farm Bureau member from Stephenson County. Member card will need to be presented when purchasing kits.

A confidential report of the results will be mailed directly to the home or farm owner within six weeks.

PurTest® Bacteria self testing kit is available from the District for \$20. This is not part of the regular testing kits.
