Stockton tops Lady Cats in conference battle

The River Ridge/Scales Mound girls basketball hosted the Stockton Blackhawks last Thursday for a battle in the Northwest Upstate Illini - West Conference. The game was set to be a heated matchup as the Wildcats and Blackhawks were tied for the second place spot amongst the top of the conference. Whoever would pull out the victory would not only get the win, but would take full ownership of the second place position. Eastland currently holds the top spot in the conference.

Stockton got on the board first with a three-pointer but the Wildcats quickly responded with a two of their own as the offense swung Claire Wienen open for a midrange jumper.

The Blackhawks then went on a 6-0 run, capped off by a set of free throws from Tiana Timpe, giving Stockton an early 9-2 lead in the contest.

The Wildcats would end the run with a free throw from Tabria Thomas, followed up by a three-pointer from Maddi Frey as they made the score 9-6. Stockton would quickly answer with a three of their own from Timpe, pushing their lead back up to six.

Stockton would go on a nine point run to end the first quarter. Timpe grabbed an offensive rebound and hit the put back layup just before the buzzer, giving the Blackhawks an 18-6 lead heading into the second quarter.

Kara Conklin would get the first Wildcats basket of the second quarter, ending the Stockton run, by hitting a three-pointer to make the score 20-9 Stockton.

Stockton opened things up midway through the second quarter as Timpe hit another three-pointer to put the Blackhawks up 27-11. The lead would remain at 16 until just before the half when Frey hit her second three-pointer right before the buzzer. The teams would go into the break with Stockton leading 33-20.

Reese Miller would hit the first Wildcats basket of the second half with a layup underneath the basket. Just when RRSB found themselves down 17, Miller scored once again, hitting a pair of free throws to make the score 39-24.

The Wildcats would cut the Stockton lead to 11 when Thomas fought her way to the hoop for a short range jumper, bringing the score to 39-28. Conklin would follow up with another three of her

own, cutting the Blackhawks lead to 10, down 41-31.

It was a game of runs for Stockton as the Blackhawks went on another 8-0 run near the end of the third. Miller would end the run with a basket underneath as the Wildcats went into the fourth trailing 49-33.

Things were a bit back and forth to start the final quarter, but Miller scored from underneath once again to cut the Blackhawks lead to 52-41. Thomas would then cut the lead to just 10 with a free throw, as the Wildcats looked to make their move on a comeback.

The Lady Cats were strong from the free throw line as Morgan Shetler hit both of her shots late in the fourth to bring the Blackhawks lead to just eight.

Stockton would hold off the Wildcats comeback efforts, however, as they took home a 59-48 victory over River Ridge Scales Mound.

The loss put the Wildcats record at 16-7 (6-3) while the Blackhawks moved up to 20-3 (6-1).

Miller led the way with 13 points, while Frey finished with 11, and Conklin had eight for the Wildcats.

Timpe led the way for the Blackhawks with yet another impressive offensive game, scoring 25.

River Ridge boys dominant over West Carroll

Last Wednesday the Wildcats hosted West Carroll for an inner conference matchup. The Wildcats, who sit near the top of the Northwest Upstate Illini - West conference, looked to make a statement as The West Carroll Thunder held the last place spot with a 0-3 conference record. The River Ridge boys came in hot as they were riding a five-game win streak into Wednesday's game.

The first quarter featured a tight matchup as the Wildcats spread the ball around on offense to start. Every River Ridge starter scored in the first as they worked out to a 16-13 lead heading into the second quarter.

It was in the second quarter that the Wildcats really started clicking on offense. Jacob Speer and Ben Crist found their rhythm as Speer dropped 12 while Crist totaled 8 points in the quarter alone. The duo helped lead the way to a 26 point second quarter as the Wildcats went into halftime with a 15 point lead up 42-27.

Speer and Crist continued to have the hot hand in the third quarter as the Wildcats exploded once again offensively. Crist led the way with nine third quarter points while Speer went three of four from the free throw line. Andrew Merkle provided four third quarter points of his own as the team combined for 23.

The Wildcat defense was equally impressive, holding the Thunder to just 13 points, which led to a 65-40 lead for River Ridge heading into the fourth.

Bennett Reese, who went scoreless throughout the game, led the way for the Wildcats in the fourth. Reese scored half of the teams fourth quarter points with eight, as



The University of Illinois Extension Office in Elizabeth announces the availability of several scholarships: Ralph & Katherine Norris Scholarship, Floyd & Alice Bale Scholarship, Dairy Herd Improvement Scholarship, Home & Community Education Scholarship and the Dalgarn Family Scholarship

Ralph & Katherine Norris donated funds to provide scholarships for Jo Daviess County residents studying agriculture or related fields. Scholarships will be awarded to people pursuing a two or four year degree program as full-time students. Current high school students, college students, and others continuing their education can apply. Applicants must be accepted at a chosen school, college, or university. Past applicants must submit a new application each





FROM LENA'S KITCHEN



The not so skinny cook

As I am sitting here writing this column, the weather people are all over the place with whether (notice the two uses of the word) or not we will be having snow or when we might have it. The only thing they are really sure about is bitter cold on Sunday and Monday. This week we continue to offer a soup to warm you up, a citrus salad to ward off colds, two Chinese dishes, and two yummy desserts.

I have developed a sinus infection. I didn't have a cold or flu all last year. It could have been because I was on so many antibiotics for my wound infections that colds didn't have a chance. I am pushing the Vitamin C, so this salad has two citrus elements as well as some other fruits. I heard that pomegranate seeds ward off illness also. Enjoy this refreshing salad.

Ambrosia Salad

2 navel oranges
1 grapefruit
3 T. honey
½ pineapple, peeled, cored and sliced
2/3 lb. strawberries, quartered
2 T. pomegranate seeds
1/3 C. toasted sweetened flaked coconut

Using a sharp knife or vegetable peeler, remove rind and pith from oranges and grapefruit. Cut citrus into segments, discarding membranes, in a small bowl, squeezing juice from core of citrus. Whisk in honey until combined. Place segmented citrus, pineapple, and strawberries on a rimmed plate. Sprinkle with pomegranate seeds and coconut. Pour any juice over the fruit.

Cabbage rolls are a big hit in the fall and winter. This recipe makes it easy because you chop up the cabbage instead of rolling it. This soup is different than your vegetable or chicken noodle; it will be great on

the subzero day.

Soup Bowl Cabbage Rolls

1 lb. ground beef
1 garlic minced
1 small head cabbage, chopped
2½ C. water
2/3 C. uncooked long grain rice
1 T. Worcestershire sauce
1 t. onion powder
1 t. dried basil
¼ t. cayenne pepper
¼ t. pepper
1 can (28 oz.) crushed tomatoes
½ t. salt
Grated Parmesan cheese

In a nonstick Dutch oven, cook beef and garlic over medium heat until the meat is no longer pink; drain. Stir in the next eight ingredients and bring to a boil. Reduce the heat; simmer, covered, until rice is tender, 25 to 30 minutes. Stir in tomatoes and salt; heat through. Serve with grated Parmesan cheese.

The next two recipes are an easy way to make Chinese. The stir fry recipe asks for oyster sauce. If you don't have any, you can substitute hoisin sauce. Or you can just use 5 tablespoons of soy sauce and forget the oyster and hoisin. I always buy low sodium soy sauce because I think it is salty enough using the low sodium. You can substitute sirloin steak for skirt steak also. The second recipe is for vegetable fried rice. It calls for riced cauliflower. You rice cauliflower by cutting the cauliflower into florets and then grating the florets on a grater or pulsing them in a food processor. Then place the cauliflower in a skillet with 1 tablespoon of oil and sauté it covered so that the steam will make it tender. You can make this great Chinese dinner just as good as any restaurant.

Beef and Broccoli Stir Fry

1½ lbs. skirt steak, sliced ¼ inch thick against the grain
½ t. salt
¼ C. water
2 T. cornstarch
3 T. low-sodium soy sauce
2 T. oyster sauce
2 t. honey
2 T. rice vinegar
1 lb. fresh broccoli florets
1 large red pepper, seeded and chopped
2 T. oil, divided

2 cloves garlic, minced
2 t. grated fresh ginger
1 T. toasted sesame oil
Sprinkle steak with salt. In a large bowl, whisk together ¼ cup water and cornstarch until dissolved; whisk in soy sauce, oyster sauce, vinegar, and honey. Stir in steak until well coated; cover and let stand for 30 minutes.

Bring a large pot of water to a boil over medium-high heat; add broccoli and cook for 3 minutes. Remove broccoli using a slotted spoon, and transfer to ice water to stop cooking. Repeat the procedure with red pepper. Drain vegetables well.

In a large nonstick skillet, heat 1 tablespoon vegetable oil over medium-high heat. Add half of the steak, reserving marinade; cook for 1 to 2 minutes per side. Remove from skillet and repeat with remaining tablespoon of oil and remaining steak.

Add garlic and ginger to skillet; cook stirring frequently for 1 minute. Add broccoli, pepper and reserved marinade; cook, stirring frequently for 3 to 4 minutes. Stir in steak and cook until heated through, about 3 minutes. Drizzle with sesame oil and serve immediately.

Vegetable Fried Rice

½ T. butter
2 eggs
¾ t. salt, divided
1 T. plus 1 t. toasted sesame oil, divided
3 C. riced cauliflower
1 C. diced carrot
2 t. minced fresh ginger
3 C. cooked and cooled brown rice
½ C. sliced green onion
¼ C. soy sauce

In a large nonstick skillet, melt butter over medium heat. In a small bowl, whisk together eggs and ¼ t. salt. Add eggs to skillet; cook, stirring frequently, until eggs are just set but not dry. Remove from skillet and chop into small pieces. Wipe skillet clean with a paper towel.

Add 1 tablespoon of oil to skillet, and heat over medium high heat.

1½ C. Crisco
2 C. sugar
4 eggs, room temperature
4 t. water
4 C. flour
2 t. baking soda
2 t. cinnamon
½ t. salt
4 C. quick-cooking oats
2 C. chopped raisins
2 C. chopped nuts

Preheat the oven to 350. Cream shortening and sugar until light and fluffy. Add eggs, one at a time, beating well after each addition. Beat in water. In another bowl, whisk together flour, baking soda, cinnamon and salt; add to creamed mixture, and mix well. Stir in oats, raisins, and nuts.

On a clean surface sprinkle with additional sugar, roll dough to ¼ inch thickness. Cut with floured cookie cutters in desired shapes. Place 2 inches apart on greased baking sheets; bake until set, 12 to 15 minutes. Remove to wire racks to cool.

Need a quick dessert? This easy two-fruited cobbler will solve the

problem easily. This recipe specifically calls for large eggs as did the oatmeal recipe. Most baking recipes do remind you to have the eggs at room temperature. Enjoy this cobbler with vanilla bean ice cream!

Apple Cranberry Cobbler

6 C. thinly sliced peeled Granny Smith apples
2 C. fresh or thawed frozen cranberries
2 C. plus 2 T. flour, divided
2 T. firmly packed brown sugar
1 T. lemon juice
1 t. apple pie spice
2 C. sugar
1 t. salt
2 eggs, room temperature
¾ C. unsalted butter, cubed
Vanilla ice cream

Preheat the oven to 375. Spray a 9 x 13 pan with baking spray with flour. In a large bowl, stir together apples, cranberries, 2 tablespoons flour, brown sugar, lemon juice, and pie spice until well coated. Spread into prepared pan. In a medium bowl, whisk together sugar, salt, and remaining 2 cups flour. Whisk in eggs. Using a pastry blender, cut in butter until mixture is crumbly. Sprinkle onto fruit.

Bake until golden brown and bubbly, 45 to 55 minutes, loosely covering with foil to prevent excess browning, if necessary. Let cool for 30 minutes; serve warm with ice cream.

tractors to pick their partners and be hired as a team, expediting project completion by allowing early phases of construction to begin as the building design is still being developed. This legislation permits up to five design-build demonstration projects to be undertaken in Illinois. Each must be shown to be in a school district's best interest as determined by the State Board of Education.

"The State has proven the benefit of using the design-build method on vertical infrastructure projects," Rauner said, "and by piloting this valuable delivery method tool in the K-12 system, it will help to explore ways to increase efficiency and speed in school construction projects."

Before a school district can issue a request for proposals, its school

board would contract with a licensed professional to serve as the bridging firm. The bridging firm helps to develop the project scope and performance criteria. Once the school district develops a vision for what they would like to construct, the entity would engage in a two-phase selection process. Phase 1 focuses on the qualifications elements of the design-build team, and Phase 2 focuses on a technical and cost evaluation.

An added layer of transparency and accountability is included in this legislation, which requires the superintendent of a school, the State Board of Education and the design-build entity to annually submit reports to the General Assembly. The report must include comparative data on a given design-build project relative to if the

project was undertaken using the traditional design-bid-build construction delivery method. This oversight will help K-12 schools pilot this method and learn when and how to maximize the benefits of using design-build.

"As a state, we are always looking for better tools to enable Illinois public entities to construct and

renovate buildings more effectively and cost-efficiently," said state Rep. Thaddeus Jones, D-Calumet City. "Design-build has proven in national studies to deliver the lowest cost, fastest schedule and highest quality. As Representative, I will look to work with local officials to implement this important cost savings tool."
