Get the most cooling for your dollar

As the temperatures soar, there are simple ways to save money on energy bills this summer.

According to the Department of Energy, a typical home uses a 48 percent of energy expenditures just on the heating, ventilation, and air conditioning system. "Although a lion's share of that percentage goes to heating homes, Americans still spend \$29 billion every year to power their air conditioners," says Erin Hollinshead, executive director of Safe Electricity.

Aside from replacing central air conditioners with a newer, higher-efficiency model, there are some things one can do to increase efficiency during the hottest part of the year, which can help reduce energy bills.

Hot temperatures are hard on people, pocketbooks and electrical systems. Increased demand for electricity during the summer strains a home's electrical system, increasing the likelihood of an electric shock or fire. This high demand for electricity also makes it more expensive in summer months. "Cooling your home efficiently this summer does not have to be difficult," says Hollinshead. "Major projects will boost your home's efficiency, but simple behaviors are also important in increasing efficiency and are not to be overlooked. By preparing your home, you can save money, stay comfortable, and decrease demands on the electrical system."

Safe Electricity provides the following tips to save money on cooling costs:

- Close curtains, blinds and shades during the hottest part of the day. Not only is about one-third of a home's energy lost around windows, but about 76 percent of sunlight that falls on standard double-pane windows enters the home to become heat, according to energy.gov.
- If you don't already have one, install a programmable or smart thermostat. One can save up to 10 percent a year on heating and cooling by adjusting the thermostat seven to 10 degrees from its normal setting for eight hours a day, Hollinshead says.
- Clean the air filter and get the unit inspected by an HVAC professional.
- Keep the outdoor condenser unit clean and free from debris. Ideally, the unit should be in the shade.
- Consider changes to your landscaping. Greenery that includes shade trees and those that insulate the foundation can reduce energy costs.
- Ventilate the attic and check insulation. Adequately sized vents and an attic fan can help remove hot air from buildings. If your attic has less than 6 to 8 inches of insulation, consider adding more. By addressing air leaks around your home and adding insulation, homeowners can save around 10 percent annually on energy bills (energystar.gov).
- Use clothes dryers and ovens during the cooler parts of the day.
- Consider a professional energy audit to reveal where the home is inefficient, including air leaks and exposed duct work.
- Use ceiling fans that circulate air and take heat from the body's surface to create a cooling effect.
- Keep cool air in and hot air out.

Avoid unnecessary trips out the door, and do not leave the door open.

- Shade your home by installing awnings over windows in direct sunlight.
- Make sure your home has the insulation it needs. Energy.gov has information about the best insulation to use in different geographic areas.
- If you are building a new home or replacing your air conditioner, there are options to maximize efficiency. For starters, look for the Energy Star label for air conditioners that have met energy efficiency guidelines set by the U.S. Environmental Protection Agency.

Increased summer electric demand not only affects the monthly budget, but it can also seriously strain your home's electrical system, which may create dangerous shock and fire hazards. Flickering or dimming lights or frequent circuit breaker trips are signs of an overloaded electrical system or faulty wiring that should be checked immediately by a qualified electrician, Hollinshead says.

Death investigation related to suspected overdose

The Woodstock Police Department provided the following news release on Tuesday, Aug. 25:

On Thursday, Aug. 20, during the late evening hours, Woodstock Police Department officers and Woodstock Fire & Rescue Department officials responded to a residence located in the 500 block of Calhoun Street, for a suspected drug overdose.

The victim was identified as 35-year-old Woodstock resident Jessica N. Decker. Evidence of Decker consuming suspected narcotics was located at the scene, at which time a Woodstock Police Department detective also responded. Decker was subsequently transported to an area hospital, where she later died.

The investigation led to the identification of two suspects who provided the suspected narcotics to Decker. The suspects were identified as Anier L. Rose-Stovall and Deshawn T. Ingram.

Upon conferring with the McHenry County State's Attorney's Office, a search warrant for their residence was obtained along with multiple felony charges were approved against Rose-Stovall and Ingram.

With the assistance of the McHenry County Sheriff's Department, the search warrant was executed on their residence and both suspects were taken into custody without incident. Various amounts and types of suspected narcotics were located during the execution of the search warrant.

This investigation remains open and ongoing.

'Adopt an Artwork' program

As the number of farmers in the Greenwood area swelled, it became apparent that their children needed a place to learn. In 1859, School District 64 completed construction of a 28-40-foot, two-story brick school at 4614 Greenwood Road. Starting in 1917, high school classes occupied the top floor for a

few years with the first eight grades occupying the main level. However, the population continued to dwindle during the Depression and by 1943 enrollment had fallen to 23 students – about a third of the enrollment in 1860. The school operated for 37 years until it consolidated with Woodstock District 200.

Coincidentally, that also is where Ed LeCrone taught for 33 years. His wife, Darlene, also a District 200 teacher, said painting was an "inborn thing" for Ed. And he continued to paint, sometimes with daughter Mimi Book, also of Harvard, up until his death in 2017. Darlene and Ed were married near-

ly 37 years. Darlene speculated Bill Schuette, the celebrated former principal of current Greenwood Elementary School, may well have asked Ed to paint this watercolor of its predecessor – located just down the road. It was donated to the McHenry County Historical Society in 2013 by Suanne Habbly of Woodstock. The society is launching an initiative to restore this and many of the 150 pieces of artwork in its collection. Whether due to age, damage, or improper display before it arrived, several pieces are in need of restoration. This is necessary before they can be put on display in a new exhibit titled "Art of the Past: Discovering History through McHenry County Artists," which is slated to open next May. Those donating to the new Adopt an Artwork program directly support restoration efforts. Some pieces merely need archival materials

Lowest bid isn't always the best bet when buying equipment

Government officials typically will select the low bid when buying something. They usually base that decision on more than just getting the best deal for their constituents.

But sometimes factors will demand choosing the second lowest bid, as was the case in August, when the city did just that while buying a new snow blower.

First, however, Public Works Director Brent Anderson said it was "kind of a sad day" for the piece of equipment being retired. "That snow blower has been around longer than any employee in the Public Works Department," he reported.

Later in the meeting Alderman Daniel Arevalo asked if there was going to be a retirement party for the winter worker?

Not at the moment, Director Anderson relied, but he added he was thinking about asking those at the downtown historical museum if they would be interesting in having the snow blower donated to them?

Back to the subject at hand, Anderson said the department had re-

built the machine several times "and we just can't rebuild it anymore." He explained the process of replacing it and why street department officials decided to move up one size from the one they have right now.

Personnel went out this past winter season and saw the Larue D50, most costly of the two, and the Fair 948D, second in price, in action, he reported. "We feel the Larue is our best option," for the following reasons:

- The Larue is six-feet wider than the Fair. That extra six inches, he said, would allow for more efficient removal of snow, which would save on overtime costs and wear and tear on the equipment.

- The two-stage augers of the Larue unit would be better at feeding snow, especially wet, heavy, compacted snow, into a truck, than the single-stage Fair.

- The Larue has a straight-cutting edge; the Fair has an angled edge. He said the angled edge tends to leave windows, adding, "We have had to fabricate a straight cutting edge for our existing Fair snow blower."

- Larue operating controls are better protected from the elements than

the Fair.

- The discharge chute on the Larue unit has 18 inches of vertical adjustment and includes a quick-attach coupling that allows for easy maintenance.

A question

Alderman Marsha Freeman asked Anderson to refresh her memory on how the snow blower fit into the current budget?

He answered that it had been included in last year's budget, but the department only had enough money to replace it with the same size kind of unit. "We felt it was important to go the next size up to get those efficiencies, and economies of scale for us," he said. "So we agreed to forego the snow blower last year and put it into this year's budget with the higher amount."

In addition: "We decided to put the leaf blowers off to a future time. There were the unknowns of COVID-19 and the company we were dealing with went out of business."

There were four bids for the snow blower with the low quote coming from Bonnell Industries Inc. in Dixon, for \$153,502.60. Second-low

was for \$160,741 from Casper's Truck Equipment in Butler, Wis., which was the one recommended by Anderson.

Other bids also came from companies in Wisconsin: \$190,120, from Wausau Equipment Co., in Wausau, and \$220,000 from M-B Companies in Chilton. Nether of those offered a Larue or Fair snow blower.

A recommendation to accept the bid from Casper's Truck Equipment was approved by the committee, 10-0. One week later, at the Aug. 17 city council meeting, that purchase also was approved unanimously.

New snowplow

Also that night the committee voted 10-0 to recommend approval of spending \$6,176.48 for a new snowplow, to be put on the front of the recently purchased 2015 Ford F-250. Its recommendation was approved unanimously by city council on Aug. 17.

There were some questions at the committee level.

Alderman Wendy Frank asked what the new plow would be used for, like little areas and parking lots?

It will be used at the Sewage Treat-

ment Plant, Anderson replied, and at various lift stations around town.

"So, we replaced something with the Ford F-250," Alderman Freeman said. "I'm assuming whatever we replaced had a snowplow on it. So would we not have taken that snowplow and put it on the F-250? What happened to the other plow?"

Anderson explained the vehicle the city replaced was a 1995 GMC. It was not feasible to put that plow on the new truck. So the plow on that truck is staying with it. The 1995 truck will wind up at the Street Dept. for the mechanics to drive, which will replace the old Dodge Dakota that they've been using as a parts truck for down there.

"So, did we sell the old plow?" Freeman asked.

"No, it's still with the old truck," Anderson answered. While that equipment remains with the city, he said ultimately it will be put up for sale to replace the old Dodge Dakota.

The new plow will be purchased from Bonnell Industries, Inc. The only other bid came from Monroe Truck Equipment in St. Louis, Mo., for \$7,197.

Differing fates for two initiatives proposed by Belvidere aldermen

Committee of the Whole agenda items come from a variety of sources. Most of them are staff proposals for all kinds of expenditures, from infrastructure improvements to buying a new piece of equipment.

But occasionally, there will be a discussion item for the way the city does business submitted by staff or one of the 10 aldermen.

Such was the case recently when there were two items: Changing the hours of city council meetings to be the same as Committee of the Whole meetings, and correcting traffic problems along Gray St. behind Logan Ave., between East Ave. and Helen St.

The Gray Street issue, presented by Alderman Wendy Frank, ultimately was resolved.

In providing background, she said she had been dealing with that issue for more than 10 years, but more so in the past four months than in all of those 10 years combined. Here is the problem as she described it:

Cars are permitted to "enter" Gray

St. from the East Ave. end, at the former Logan Elementary School, and "exit" on Helen. People can only see the One-Way street sign coming "in" from the Logan Ave. side. Those coming "in" from East Ave. do not see any sign.

"What happens nine times out of 10 is all the cars will enter Gray St. and turn around in a driveway, and head back out in the wrong direction," Alderman Frank said.

Also, she said a lot of times cars will enter Gray St. from Helen, even though a Do Not Enter sign is clearly visible. "I think if it said 'One Way' they (motorists) may know why you are not to enter. (Public Works Director) Brent Anderson has told me they (motorists) do not know why it says Do Not Enter."

She asked for discussion among her colleagues "to find a remedy once and for all. Once school starts in the fall for the young children at the former Logan Grade School, it is dangerous for parents and children to have cars entering and exiting at the same time."

After discussion and a recommended approval at the committee level, city council unanimously approved a motion to add two One-Way signs and one Do Not Enter sign on Gray Street.

Didn't make it

The other alderman-led initiative, proposed by Daniel Arevalo, wound up getting two motions but each of them was defeated, 7-3.

City council currently meets at 7 p.m. the first and third Mondays of the month. Committee of the Whole meetings, with each discussing different subject areas, are held at 6 p.m. the second and fourth Mondays. It was Alderman Arevalo's request that council meetings be changed to 6 p.m.

Alderman Dan Snow opened discussion by saying he was "not a big fan, going to this (change). It can be a challenge, by the time I get off work and get dinner. I guess there's a reason for having it (council meeting) at 7 p.m. Those meetings shouldn't last a long time since most of the discussion is hashed out at these (committee) meetings."

Alderman Marsha Freeman didn't think it was a good idea, either.

"A lot of people that work in the city would have trouble coming to the (council) meeting if something was on the agenda," she said. "Now if they can't make it to the 6 o'clock one they can make it to the 7 o'clock one, if it's something that's important to them."

Arevalo countered that he commutes from the farthest point - the Chicago suburbs - and he's still back in Belvidere at 6 o'clock. "I've had my dinner, still mow the lawn. So if I have to leave work a little bit early I do, and then make it up afterwards."

"It's up to you guys," Mayor Mike Chamberlain offered, after seeing there was no clear consensus in the offering.

Freeman had a question for Arevalo: "What is the purpose of wanting every meeting at 6?"

"To have it (times) more fluid with everything that we do," he replied.

Alderman Matt Fleury suggested a compromise, making all four meetings at 6:30 p.m.

That was fine with Arevalo, who

said all he wanted to do was get some feedback from the other council members and "just have the (council) meetings start a little earlier than 7."

Alderman Frank countered that she thought they were "meeting for our constituents, not for our own means. It's not about us." But she did prefer 6:30 p.m. over 6 p.m.

Since there already was a motion on the floor, City Attorney Mike Drel-la said a motion to amend would be appropriate.

Arevalo made such a motion, seconded by Alderman Clayton Stevens, making all four meetings at 6:30 p.m.

That motion failed, 7-3. Voting Yes were aldermen Arevalo, Fleury, and Stevens. Voting No were aldermen Freeman, Mike McGee, Tom Porter, Tom Ratcliffe, Snow, Ric Brereton, and Frank.

The original motion approving all four meetings being held at 6 p.m. also was defeated, 7-3, with the same breakdown of aldermen.

"So, we will leave the meetings where they are," Mayor Chamberlain said.



Boone County COVID-19 update

Boone is reporting two new cases of COVID-19. Illinois announced 2,149 new cases, including 20 additional confirmed deaths.

Due to continued significant community transmission in Illinois and the region, Boone County Health Dept. continues to recommend testing for asymptomatic contacts of COVID-19 cases. Testing should also be considered for individuals

with potential exposures such as those attending large gatherings and those traveling from high incidence areas. If asymptomatic individuals are being tested, specimens should be collected 5 – 9 days after the last potential exposure. Testing has played a key role in Boone County in identifying cases of COVID-19 and supporting contact tracing to prevent the transmission.

Testing is available at the Community Based Testing Site at the University of Illinois Health Sciences Campus - Rockford, 1601 Parkview Ave., daily from 8 a.m. to 4 p.m. Testing is also available at the Community Based Testing Site at Rockton Ave. (former Schnuck's), 3120 North Rockton Ave., Monday through Thursday from 9 a.m. to 4:30 p.m. and Friday from 9 a.m. to 4 p.m.

Scratching the surface of sonny-side-up living: A brief and incomplete guide to the Beatitudes

Healthy people want to be happy. Jesus said anyone can be happy and explained how in the Beatitudes (Matthew 5:1-12).

Robert Schuller referred to Matthew 5:1-12 as "The Be Happy Attitudes."

People who ingest, digest, and enmesh these belief/behavior divine directives into their lives will overcome the meanness, madness, misery, and miscreance of life in the modern world.

Matthew 5:1-12 is our Lord's guide to Sonny-Side-Up Living.

Jesus begins each Beatitude by saying, "Blessed are..." Then He spells out how to be blessed.

The Greek transliteration of 'blessed' is 'makarios' and the Latin is 'beatitudo.' Both mean "to be happy and fortunate." Hence, an accurate translation is, "How happy... how fortunate... how blessed are people who... [live like this]..."

1. "How happy... how fortunate... how blessed are the poor in spirit, knowing their poverty apart from God, because the kingdom of heaven is theirs" (5:3). When we acknowledge our complete emotional, intellectual, spiritual, and physical dependence upon God, we

are whole, happy, joyful, safe, and eternally secure. As David sang in Psalm 1, we are happy/fortunate/blessed when we wrap ourselves around God's Word. Or as Jesus said, "Seek God first and foremost and God will take care of everything else" (see Matthew 6:25-34). BTW, people who dispute this divine directive have never done it!

2. "How happy... how fortunate... how blessed are those who mourn their sins and don't make excuses for them; for they will be comforted" (5:4). When we admit we have sinned – insulted God's holiness and injured His people – we are comforted by the knowledge of being forgiven by God. Read Psalm 32 and 1 John 1.

3. "How happy... how fortunate... how blessed are the meek, for they will inherit the earth" (5:5). Meekness is not weakness. The Greek transliteration is 'praos' and it means 'a humble disposition before God.' John MacArthur wrote, "Meekness means to be finished with me for good. It is to say, 'Thy, not my, will be done.'" Luke 5:3, it is knowing we need God. It's Philippians 4:13 faith.

4. "How happy... how fortunate... how blessed are those who hunger and thirst to be right with God. They will be satisfied" (5:6). He is saying

we are happy/fortunate/blessed when we are desperate for Him, pray and labor to be close to Him, and take every opportunity to increase intimacy with Him; or as David taught us, "God inhabits the praises of His people" (Psalms 22). It's like the experience of an immigrant man writing to his wife in Europe as recorded by Oscar Handlin in "The Uprooted": "As a fish thirsts for water, so I thirst for you" (cf. Psalm 42). Jesus promised such hunger and thirst for God yields satisfaction. The Greek for "satisfied" means to feel like a contented cow grazing in the field and doing what cows do as designed by God. Or as Augustine confessed, "Our hearts are restless until they find their rest in You, O God."

5. "How happy... how fortunate... how blessed are the merciful. They will receive mercy" (5:7). Here's how RC Sproul commented on this Sonny-Side-Up-Be-Happy-Attitude: "Pray for mercy but don't pray for justice because you may get it!" In short, want slack? Cut some. Want grace? Give some. Want forgiveness? Forgive. Read Matthew 6:12, 14-15; 7:1-6. It's axiomatic. Forgiving = forgiven. Conversely, well, uh, we don't want to go there!

6. "How happy... how fortunate... how blessed are the pure in heart. They will see God" (5:8). How do you know God does not expect actual perfection from us? Because of Jesus. If we could be pure and perfect in every way on our own, Father God would not have come in Son Jesus to save/deliver us

from our actual imperfections. To be pure in heart means we want to be actually perfect as we labor and pray to get better and more conforming to God's will as personified in Jesus and prescribed in Holy Scripture. People who are attitudinally perfect see God. They feel like He "walks and talks" with them; and "the joy they share" is beyond compare. People who want to be close to God and pray and work on it are Sonny-Side-Up believers. God puts an irrepressible smile on their souls radiating from their faces. Lloyd comes to mind. Whenever we'd get together, he'd ask, "Bob, are you more in love with Jesus than the last time I saw you?" Whenever I answered yes, I felt closer to God. If not, not.

7. "How happy... how fortunate... how blessed are peacemakers. They are kin to God" (5:9). Whether it's the Hebrew 'shalom' or Greek 'eirene,' Biblical/real/lasting peace/harmony with others is the product of peace/harmony with God; or as the Imperials sang, "There will never be any peace until God is seated at the conference table." Unless we move toward each other through Jesus with His mercy, grace, forgiveness, and agape, polemics will exceed peace/harmony. Through Jesus, we have more than a "fighting" chance. People who get closer to Jesus and act like it/Him are considered part of His family. It's like we say on the corner of Lincoln and Main: "The answer to every question is Jesus!" Do you want peace/harmony in your world, country, community, church,

school, job, family, marriage, and all of the below? You can have it! Just approach everyone through Jesus!

8. "How happy... how fortunate... how blessed are people who get into trouble and suffer because they love God. They are saved for sure and will go to heaven and live confidently between now and then" (5:10-12). Jesus was clear about what will happen to people who behave like they believe in Him: "If you follow Me, you will have to deny yourself and take up your cross... You will suffer if you follow Me... Yet if you follow Me, you will live confidently because you will live forever with Me in heaven... Everyone who endures suffering for loving Me by loving like Me will be saved!" (see Matthew 10, 16:24-28). If everybody likes you, you can't be a Christian! Jesus said that. He said true believers are hated by the worldly and spiritually dark because true believers pray and work to bring mercy, grace, forgiveness, and agape into the world for everybody without respect to color, class, or culture. In other words, persecution is proof of being a Christian. So, if everybody is speaking well of you and you're not catching a little to lot of hell in your life, that means you may be no heaven good. It's a choice. Catch hell now and go to heaven; or forfeit heaven and go to...

So, if you want to be happy for the rest of your life and forever, become part of the Sonny-Side-Up Living movement.

Concealed Carry is a viable option

We are living in a time of unrest, when groups that politicians seem reluctant to name as ‘domestic terrorist organizations’ are embedding members into legitimate peaceful protest rallies and marches, causing destruction, death, chaos, and fear.

As a result, applications for FOID cards and Concealed Carry Licenses in Illinois are growing by leaps and bounds as the police are hamstrung by politicians and citizens feel the need to protect themselves. Guns can be found but ammunition is in short supply.

In the days following violent looting across Chicago and the suburbs, Illinois State Police saw a massive surge in applications from people who want to own guns, but the processing delays are growing as well. State police say staffing was an issue, and their staff works about 40 hours of overtime every month. Even so, they are still not able to process those cards in the 30 days required by law. Despite all efforts, it is currently taking 90 to 120 days to process applications. The state police are currently hiring more people to handle the backlog but all new hires must go through a training process to handle the applications correctly.

And the applications continue to pour in, increasing the backlog.

Carrying a gun has been a necessity, a tradition, and a right in this country from the first time Europeans founded a colony here. Guns were utilized to hunt for food and for protection from the wild. The Revolutionary War was fought by men and boys who had learned to shoot accurately at a very young age – if they were not accurate, they did not bring supper home for their families. Even the famous Annie Oakley, at the age of five, would take out a rifle in the morning and bring home dinner for that night.

Right up through the 1950s, shooting was considered to be an essential skill. Handling firearms was taught in school along with reading, writing, arithmetic, history, and the Constitution. Photos still exist showing high school age boys practicing with firearms during class.

It wasn't until the 1960s that the peace movement, in opposition to U.S. involvement in the Vietnam War, began to demand that firearms should be controlled. Politicians caved to the demands and decided that guns should be registered and gun owners should carry Firearm Owner Identification cards.

Interestingly enough, Hitler began gun control that way as well. “Say the words ‘gun registration’ to many pro-gun Americans and you are likely to hear that one of the first things that Hitler did when he seized power was to impose strict gun registration requirements that enabled him to identify gun owners and then to confiscate all guns, effectively disarming his opponents and paving the way for the Holocaust.” - *On Gun Registration, the NRA, Adolf Hitler, and Nazi Gun Laws: Exploding the Gun Culture Wars*, by Bernard E. Harcourt, Columbia Law School.

That paragraph sounds disturbingly like current Democratic political ambitions.

Increasing governmental control of firearms only makes things more difficult for law-abiding citizens. It does nothing to disarm the law-breakers who don't care about the rules and regulations anyway. So, calling for more gun control does absolutely nothing to make

anyone safer.

The only thing that the Peace rallies accomplished with their gun control demands, was to create generations of children who are ignorant of firearm safety. When guns were commonly used in households, children learned how to handle guns safely and firearm accidents were rare. In recent times, children who get their hands on a gun have no idea how to handle it properly and someone gets hurt. Then people call for more control of firearms.

Perhaps training youngsters in safe firearm practices at home and at school would work better. It is ignorance that causes more casualties than the habits of those who are properly trained. (Funny, that sounds like the same argument that was used to promote sex education into schools. Teach kids to practice safe sex to prevent unwanted pregnancies.)

Happily, there are many firearm instructors in Illinois to teach those who wish to learn how to protect themselves. For people who would like to carry a firearm as they go about their day, there are 14 concealed carry instructors in Boone County and 56 in Winnebago County.

Craig Wilcox and Aaron Marie of 430 Apex in Boone County are excellent concealed carry instructors and answered all my questions. In the state mandated 16-hours of instruction for a concealed carry class, they covered the legal ramifications of using your firearm in any situation, how to handle a firearm safely and how to avoid using it if you don't have to. Your concealed carry gun is not to be used to intimidate or threaten someone, that person might take it away from you and use it to harm you. Your concealed carry gun is only to be used when you, or your family, are in imminent danger. ‘Imminent danger’ is a legal term that is used to describe situations that pose a direct and immediate danger to the individual affected by the action.


During class, you are informed of the legal ramifications of concealed carry, how to hold a gun correctly, how to stand, how to aim, and the results of a gun that malfunctions. You will also learn signs of someone else who is carrying and many other helpful tips.

Concealed carry is also something you do not boast about. What is the point of concealing a gun if you shout it to the world that you are carrying? The entire point is to keep an aggressor unaware of your ability to protect yourself. Let them underestimate you.

My advice? If you feel the need to have a concealed carry license for safety, you should take self-defense classes as well. Learn how to remove yourself from harm's way if it is at all possible before you are required to shoot that gun to preserve your life. Firing that gun is a last resort, not the first, or the second, or....

Plus, knowledge is power. Learn how to handle firearms safely. It doesn't have to be concealed carry, but take a class. Don't allow ignorance to put you or your kids in harms way.



Organ/Tissue Donor Registry hits seven million

Secretary of State Jesse White announced on Aug. 26 that the state's organ/tissue donor registry reached a milestone of seven million registrants.

"I am so proud that Illinoisans continue to show their giving spirit and commitment to others by signing up for this lifesaving program," said White. "Our mission is to strengthen the Organ/Tissue Donor Program through outreach and registration initiatives. We want to end the waiting for the approximately 4,000 people statewide. Each year about 300 people die waiting for a transplant in Illinois."

There are 10,764,540 individuals in Illinois who qualify to become organ/tissue donors. Of those, 65 percent have registered as organ/tissue donors. There are more than 12.6 million people living in Illinois, according to the U.S. Census Bureau in 2019.

In addition, more than 100,000 16- and 17-year-olds have registered with the program since 2018 when Secretary White initiated a law allowing

them to register as organ and tissue donors.

"I believe our public awareness campaign, including television, radio and social media ads have helped encourage people to register," said White. "It takes less than a minute to register and one person can improve the quality of life for up to 25 people."

Secretary White heads the state's Organ/Tissue Donor Registry. The lifesaving program has been one of his top priorities during his 21-year administration. He has visited countless hospitals, schools, libraries, Driver Service facilities as well as other venues to promote and register Illinoisans for the donor program. Secretary White has a personal connection to organ donation because his sister, Doris Ivy, received a kidney transplant from an anonymous donor that extended her life for 27 years.

When ordering food face-to-face, masks required

On Tuesday, Aug. 25, an update on safety guidelines for restaurants and bar establishments was announced statewide to operate safely and help prevent the spread of COVID-19.

Based on a recent increase in cases, these latest guidelines will require patrons to wear a mask during any interaction with wait staff, food service workers and other employees at bars and restaurants. Face coverings must be worn over the nose and mouth when patrons are approached and served by staff, including but not limited to when employees take patrons

orders, deliver food and beverages, and service tables. This guidance will also apply to other facilities with food services areas that are currently subject to the Restore Illinois guidance, such as indoor recreational facilities, museums and entertainment venues.

Unemployment rates up, jobs down in all fourteen metro areas in July

The number of non-farm jobs decreased over-the-year in July in all fourteen Illinois metropolitan areas, with five metro areas at record low payrolls, according to preliminary data released today by the U.S. Bureau of Labor Statistics (BLS) and the Illinois Department of Employment Security (IDES). The unemployment rate increased over-the-year in all metro areas and to record highs for the month of July in four metros. The official, BLS-approved sub-state unemployment rate and non-farm jobs series begins in 1990. Data reported prior to 1990 are not directly comparable due to updates in methodology. "As the state continues to monitor the safety of economic reopening, IDES is committed to continuing to help those who need services," said IDES Acting Director Kristin Richards. "With the support of the Pritzker administration, the Department is prepared to support working families who continue to be affected by this pandemic." The number of non-farm jobs decreased in all fourteen Illinois

metropolitan areas. Total non-farm jobs were down in Peoria (-12.0%, -20,700), Decatur (-11.2%, -5,700) and Elgin (-10.8%, -28,200). In Chicago-Naperville-Arlington Heights, jobs were down -8.1% (-311,900). No industry sector saw job gains in a majority of metro areas. Not seasonally adjusted data compares July 2020 with July 2019. The not seasonally adjusted Illinois rate was 11.3 percent in July 2020, was the highest unemployment rate the month of July since 1983, when it was 11.5 percent. The official, BLS approved, statewide unemployment rate series begins in 1976. Nationally, the not seasonally adjusted unemployment rate was 10.5 percent in July 2020, was a record high for the month of July, dating back to 1948. The unemployment rate identifies those individuals who are out of work and seeking employment. **Rockford MSA** The not seasonally adjusted unemployment rate increased to 13.8 percent in July 2020 from 6.7 percent in July 2019. The last time the

July rate was equal to or higher was in 2010 when it was 14.1 percent. Total non-farm employment decreased -12,100 compared to July 2019. Manufacturing (-3,600), Leisure-Hospitality (-2,500), Professional-Business Services (-2,000), and Educational-Health Services (-1,800) recorded the largest employment declines over-the-year. Transportation-Warehousing-Utilities (+100) had payroll gains from a year ago. **Note:** Monthly 2019 unemployment rates and total non-farm jobs for Illinois metro areas were revised in February and March 2020, as required by the U.S. BLS. Comments and tables distributed for prior metro area news releases should be discarded as any records or historical analysis previously cited may no longer be valid. The official monthly unemployment rate series for metro areas, counties and most cities begins in 1990. 

Government impostor scams prey on fear during pandemic

One of the most common scams in the U.S. and Canada today involves callers pretending to be government officials. Some claim to be tax officials and representatives from the Social Security Administration; others claim to be law enforcement officers and threaten legal consequences. All of them use fear and intimidation to trick victims into turning over personal information or money, often in the form of gift cards.

A new investigative study by Better Business Bureau (BBB) finds that while the number of government scam reports has fluctuated, scams have become more diverse and more sophisticated. Also, many scammers have taken advantage of the coronavirus (COVID-19) pandemic by posing as Centers for Disease Control and Prevention (CDC) officials, Internal Revenue Service representatives who can expedite economic impact payments or contact tracers employed with local government agencies.

The investigative study -- Government Impostor Scams: Reports Decrease, Scammers Pivot for New Opportunities, BBB Study Reveals -- highlights the risk of this common but costly fraud. Read the full study at bbb.org/fakegov.

"Government impostor scams are constantly evolving, and they prey on

people with threats of being arrested if money is not paid or personal information provided," says Dennis Horton, director of the Rockford Regional Office of the Better Business Bureau. "Consumers need to know how to recognize and avoid this upsetting and costly fraud."

In 2019, BBB reported about scammers impersonating tax officials dropped sharply while reports about Social Security Administration (SSA) impersonators quadrupled in the U.S.

"We, at IRS Criminal Investigation, are asking taxpayers to be alert to scam phone calls including those threatening arrest, deportation or license revocation regarding a bogus tax bill and to not open potential fake emails or websites looking to steal your personal information," states Special Agent in Charge Kathy A. Enstrom of the Chicago Field Office IRS Criminal Investigation. "The IRS will never demand immediate payment, threaten, ask for financial information over the phone or by email. These schemes are blasted to large numbers of people in an effort to get personal identifying information or financial account information, including account numbers and passwords. Please visit IRS.gov to learn more about phishing and online scams and how to protect yourself from scammers."

A recent AARP survey found that 44% of people in the U.S. have been contacted by one of these impersonators. Law enforcement officials have received hundreds of thousands of complaints. Complaints to the Federal Trade Commission (FTC) report \$450 million in losses since 2015. Many of these scams involve robocalls and most commonly originate from India, where call center expertise is plentiful.

Terri Worman, Associate State Director, AARP of Illinois says, "Scammers look to capitalize on the news of the moment, especially if the headlines can instill fear and motivate people to act. The coronavirus pandemic is no exception. They are working just as hard to steal your money or sensitive information. AARP cautions everyone to be suspicious of phone calls, emails and texts claiming to be from experts with breaking news about the virus."

In many cases, scammers insist they are law enforcement officers and threaten to arrest people immediately if they do not pay money, usually with gift cards. They may tell consumers their Social Security number has been associated with a crime or may threaten to deport recent immigrants or arrest people for missing jury duty.

A caller to BBB in June 2019 says, she received two robocalls on the same day that both purported to be from

"Social Security." The second one connected her with a live person, who told the woman her Social Security number had been compromised and asked for her full name and the last four digits of her Social Security number. When she provided a fake name and number, the caller told her Social Security number had been linked to crime reports in El Paso, Texas, and told her she needed to pay nearly \$10,000. The woman made the caller aware that she knew it was a scam, and the caller hung up.

Other scam callers lure victims with the promise of a "free" government grant, which they claim will be awarded if the victim pays a fee with a gift card or prepaid debit card. In reality, there is no grant.

Impostor calls from India must first go through a "gateway carrier" in the U.S. These carriers often provide "spoofed" phone numbers. The Department of Justice recently sued two of these carriers while the FTC and Federal Communication Commission issued warning letters to others. As a result, robocalls and individual calls coming from India have declined drastically over the last several months.

Other law enforcement efforts in the U.S. have led to the arrest of dozens of Indian nationals for laundering money related to these scams. However, the study notes that cases are rarely prosecuted in India.

The report recommends:

- The government of India should do more to prosecute and extradite those operating frauds from that country.
- Law enforcement should continue to take action against scammers who are physically present in the U.S. and Canada.

• Efforts by many retailers and banks to question people buying gift cards have had limited success in stopping the purchase of gift cards to pay scammers. The gift card industry and retailers should explore additional ways to stem fraudulent use of their products.

To better inform policymakers on the root causes of poverty and economic insecurity, State Representative Jeff Keicher (R-Sycamore) has been appointed to the Commission on Poverty Elimination and Economic Security. Keicher's appointment was made Aug. 21 by House Minority Leader Jim Durkin (R-Western Springs).

The commission consists of four members of the General Assembly, a member of the judicial branch and 20 members of the public, including people who have experienced deep poverty and advocates for youth, veterans, mental health, education equity, those experiencing homelessness, those differently abled and others. Jennifer Groce, Northern Illinois University's Director of Community Promotions, is one of the other community leaders who has been appointed to the commission.

"I am eager to get started on the important work we'll be doing through this commission, partnering with communities in need to engage in a collaborative effort with stake-

holders throughout Illinois," Representative Keicher said. "Our work to develop solutions that can create generational change, eliminate poverty and reduce economic disparities across our state are perhaps some of the most impactful work we can be focused on. Being raised by a single mother waiting tables, I know firsthand that a helping hand up can make all the difference in our collective futures."

NIU's Jennifer Groce offered her perspective on being appointed to

serve alongside Keicher on the Commission: "I take the opportunity to contribute to our state's efforts to eliminate poverty and ensure economic security to heart. I look forward to engaging campus and community stakeholders to help connect lived experiences and valuable expertise to this critical statewide effort," Groce said

The commission is tasked with educating policymakers on the impact poverty has on other measures of economic stability and economic outcomes, including educational attainment, rates of incarceration, lifetime earnings, access to health care, health care outcomes, and access to housing. The Department of Human Services will provide support for the commission to complete its work to produce a strategic plan that addresses poverty and economic insecurity in Illinois by November 30, 2021.

The Commission on Poverty Elimination and Economic Security was signed into law by Governor Pritzker in June as part of Public Act 101-636.
