Red Cross makes plea for blood, plasma donations

Recovered COVID patients could help those currently suffering

American Red Cross officials are urging people — especially those who have recovered from COVID-19 — to give blood and plasma during January, which is National Blood Donor Month.

“Blood and plasma donors who have recovered from COVID-19 may have the power to help critically ill patients currently battling the virus,” Dr. Erin Goodhue, Red Cross medical director of clinical services, said in a news release. “With hospital distributions for convalescent plasma increasing about 250% since October, these generous donations are vital in helping to save lives throughout the winter — a time that is often challenging to collect enough blood products for those in need.”

Individuals who have recovered from COVID-19 may have antibodies in their plasma that could provide a patient’s immune system the boost it needs to beat the virus, the release said.

There are two ways COVID-19 survivors can help — through a convalescent plasma donation or by giving whole blood. Plasma from

Cookie sales in full swing

Don’t worry if your holiday cookie supply is finally diminished. Northern Illinois Girl Scouts are taking cookie orders through Jan. 30.

Girls can accept orders safely in-person or through Digital Cookie 7.0, which allows them to take electronic orders for cookies.

Customers may order and pay for cookies online and have the option to have the cookies shipped directly to them (shipping charges apply), have a Girl Scout offer contactless delivery of cookies to their door or donate cookies (with no additional handling fees).

The cookies cost \$5 per package, with more than a half-dozen varieties available, including the popular thin mint, shortbread and peanut butter cookies.

Small business grant program ends

Less than 20 percent of applicants received money

The grant program for small businesses owners in Illinois who suffered losses during the pandemic has run out of money.

Illinois’ Business Interruption Grant program was the largest state program of its kind, but only about 20 percent, or 8,974 applicants, received a grant.

The Illinois General Assembly created the program using federal Coronavirus Aid, Relief and Economic Security Act, or CARES Act, money. The Illinois Department of Commerce and Economic Opportunity helped administer the program, and awarded more than \$275 million since the first round of grants were issued in August.

DCEO Director Erin Guthrie said this particular set of federal dollars

has been exhausted, but the department continues to look for ways to help businesses statewide.

“We know that businesses are hurting and we wish that Congress would provide more relief,” Guthrie said in an interview Friday. “This virus has shut down so much of our economy, and that is a struggle for every person and business across our state. The other thing I would say is, we’re constantly working with our federal counterparts, with other sources in ways that we can creatively provide relief to those businesses.”

She said government money is still available for business owners through the second round of the federal Paycheck Protection Program, which awards forgivable loans, as well as existing state loan programs dedicated to small businesses, such as Advantage Illinois.

More than a third of BIG funds went to businesses downstate, 40 percent of grants were made to minority-owned businesses statewide

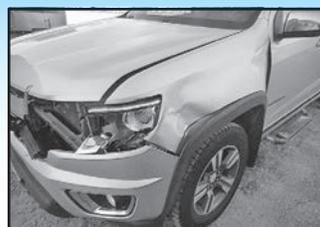

The not so skinny cook

We got through the big snow. The trees have been beautiful with the frost on them. I am hoping for some thawing so my driveway gets better. I guess we are in the middle of January, so this kind of weather is to be expected. This week's recipes will be great for some winter cooking.

Roasted Broccoli with Sharp Cheddar Crumbs

Try this appetizer if you like broccoli and a great Dijon dip. The cheddar crumbs can be used as toppings for salads or other roasted vegetables.

- 4 oz. sharp cheddar, grated
 - 2 large heads broccoli cut into florets
 - 2 T. olive oil
 - Salt and red pepper flakes
 - ¼ C. mayonnaise
 - 1½ T. Dijon mustard
 - 1½ t. honey
- Heat oven to 375. Line two baking sheets with parchment paper. Scatter

cheddar evenly on sheet and bake until melted and color has darkened slightly, about five minutes (keep a close eye on the cheese because it can burn quickly). Let cool. Break cheddar into crumbs. Set aside.

On a second sheet, toss broccoli with oil, ½ t. salt and a pinch of pepper flakes and roast until tender and charred in parts, about 15 to 20 minutes.

Make honey mustard dip: In bowl, mix mayo and mustard; add honey and a pinch of salt and pepper. Top broccoli with cheddar crumbs and serve with the honey mustard dip.

Winter Fruit Salad with Lemon Poppy Seed Dressing

This salad makes use of several fruits that are not common in a leafy salad. The tangy pear, crisp apple, and sweet cranberries along with the crunchy nuts make for a great winter salad.

- ½ C. sugar
- ½ C. lemon juice
- 2 t. diced onion
- 1 t. Dijon mustard
- ½ t. salt
- 2/3 C. canola oil
- 1 T. poppy seeds
- 1 head romaine lettuce, torn into bite-sized pieces (about 10 cups)
- 1 C. shredded Swiss cheese
- 1 C. chopped cashews
- 1 pear, cored and sliced
- 1 apple, cored and sliced
- ¼ c. cranberries

Blend together sugar, lemon juice, onion, mustard and salt in a blender or food processor. With machine running, add oil in a slow steady stream until mixture is thick and smooth. Add poppy seeds and blend a few seconds more to combine.

Toss together romaine, cheese, cashews, pear, apple and cranberries in a large serving bowl. Just before serving, pour dressing over salad and toss to coat.

Winter's Day Soup

You probably have all the ingredients for this soup in your pantry or refrigerator. It makes a nice pot that will feed your family on a cold winter's night

- 1 C. celery, chopped
- 1 C. carrots, chopped
- ½ C. onions chopped
- 3 medium potatoes, cubed
- ½ C. butter
- ½ C. flour
- 4 C. milk
- 3 C. grated Cheddar cheese
- 2 C. ham, diced
- Salt and pepper to taste

Cook vegetables in 3 cups water until tender. In a saucepan, melt butter and stir in flour. Add milk to flour mixture and heat over medium heat until boiling. Boil only one minute. Stir in cheese, then add salt, pepper and ham. Add mixture to cooked vegetables, including the water that vegetables were cooked in. Heat all together but do not boil.

Chicken, Wild Rice and Mushroom Casserole

This casserole is easy to put together because you use rotisserie chicken. You can use any sweet onion if Vidalia onions are not available. You can freeze this casserole if you wrap it up securely. You can keep it for four weeks in the freezer. Do not add the cracker crumbs until you are ready to bake.

- 2 C. chicken broth
- 2 T. unsalted butter, divided
- 1 pkg. (6 oz.) wild rice
- 1 C. chopped Vidalia onion
- 1 pkg. (8 oz.) sliced mushrooms
- ½ C. chopped carrot
- ½ C. chopped celery
- 3 cloves garlic, minced
- 3 C. shredded rotisserie chicken
- 1 can cream of mushroom soup
- 1 can cream of chicken soup
- ½ t. black pepper
- 25 buttery round crackers, crushed (Ritz)

Spray an 8-by-13 baking dish with cooking spray. In a medium saucepan, bring broth and 1 T. butter to a boil over medium high heat. Stir in rice. Reduce heat to low. Cover and cook until tender, 40 to 50 minutes. Remove from heat and set aside.

Preheat oven to 350. In a large skillet, melt remaining T. butter over medium-high heat. Add onion; cook, stirring occasionally, until translucent, four to five minutes. Add mushrooms, carrot and celery. Cook until vegetables are softened, three to four minutes. Add garlic; cook for one

minute. Remove from heat.

In a large bowl, place vegetable mixture. Stir in rice, chicken, soups and pepper until combined. Spoon mixture into prepared pan. Top evenly with crackers. Bake until browned and bubbly, 20 to 25 minutes. Let stand for 10 minutes before serving.

Buttermilk Spice Layer Cake

Are you looking for a nice winter dessert that is really striking as you serve it? The recipe calls for 1/8 of a teaspoon of cloves and nutmeg. I did see a 1/8 of a teaspoon in one of my cooking magazines that one could order. I investigated (via Google) about how to measure 1/8 if you didn't have a measuring spoon. The answer was pretty simple — a pinch is the same as 1/8 of a teaspoon. So if you would like a beautiful cake on a cake stand, this cake fills the bill; it is topped off by an orange cream cheese frosting

- ¼ C. unsalted butter, softened
- 1 C. sugar
- ½ C. firmly packed light brown sugar
- 5 large eggs
- ½ C. unsulphured molasses
- 1 t. vanilla
- ¾ C. flour
- 2 t. baking powder
- 1 t. baking soda
- 1¼ t. ground ginger
- 1½ t. cinnamon

Extension offers online series for corn and soybean producers

The University of Illinois Extension will offer the Northwest Illinois Agronomy Summit on a virtual platform this year. The live series will consist of weekly sessions providing updates for Midwestern corn and soybean producers while allowing them to ask questions and talk with experts.

"As we often try to do, there is a little bit of everything presented here, including research updates, producer recommendations and best management practices," Phillip Alberti, Extension commercial

agriculture educator, said in a news release. "The theme for this year's summit is updates in nutrient and pest management and we are really excited to bring in both specialists from the University of Illinois and University of Wisconsin-Madison to discuss production strategies including pest management, cover crop management ... grain safety and more."

All sessions will be hosted from 1 p.m. to 2 p.m. on their scheduled dates.

The schedule includes:

- Feb. 16, "Climate Change and Impacts in Northwest Illinois," featuring Trent Ford, Illinois state climatologist

- Feb. 23, "Corn Rootworm Management," featuring Nick Seiter, research assistant professor and faculty Extension specialist, University of Illinois

- Feb. 25, "Cover Crops in Northern Illinois/Southern Wisconsin and Combine Cleaning to Reduce Weed Seed Movement," featuring Dan Smith, UW-Madison southwest outreach specialist

- March 2, "Updates in Disease Management," featuring Nathan Kleczewski, research assistant professor and faculty Extension specialist, University of Illinois

- March 4, "Grain Bin Entry," featuring Salah Issa, assistant professor of industrial safety and health, University of Illinois

- March 9, "Will the Novel Soybean Herbicide Tolerance Traits Solve my Pigweed and Ragweed Problem?" featuring Rodrigo Werle, UW Madison cropping systems weed scientist and Extension spe-

cialist

- March 11, "The Importance of Scouting to Mitigate Risk for Fungicide Resistance Development," featuring Chelsea Harbach, Extension educator, University of Illinois Extension

Follow dentist recommendations to avoid dry socket

When you have to have a tooth extracted it is normal to experience some discomfort. However, if you suddenly experience increasing pain in the first few days after surgery, it is important that you notify your dentist so he/she can evaluate whether you have developed a condition known as dry socket.

The socket is the hole in your bone that remains after a tooth has been extracted. In the normal healing process, your body forms a blood clot in the socket to protect the bone and nerves. Granulation tissue then forms to protect the clot. While healing of the extraction site occurs between seven and 10 days, new bone formation will take about eight weeks. However, if a blood clot fails to develop, dissolves too quickly or becomes dislodged, it

can lead to painful inflammation of the bone that can leave you vulnerable to infection and delayed or prolonged healing.

There are a number of risk factors for developing dry socket, as well as a number of proactive steps that you can take both before and after surgery to avoid this painful complication.

Since chemicals in tobacco can not only prevent or slow healing and may

contaminate the wound, it is important to avoid smoking or any tobacco use before surgery and for three days after. You should also be aware that sucking on a cigarette can dislodge the blood clot. Birth control pills with high estrogen levels also can interfere with the healing process.

Always update your medical history so your dentist is aware of any medications that will affect clot formation, if you have had a dry socket in the past or if you are immunocompromised, as these will necessitate additional preventative precautions. Any concurrent oral infections will also require preventative actions.

Post-operative instructions will be individualized to any unique needs, but general steps to avoid dry socket

include:

- Leave the gauze that your dentist has placed over the surgical site for several hours to allow the blood clot to form.

- For the first 24 hours, limit activities and rest with your head slightly elevated.

- Do not rinse your mouth, but drink lots of water. Avoid alcohol, carbonated and hot beverages and do not drink/suck with a straw for a week.

- Do not explore the extraction site with your tongue.

- Eat only soft food and avoid chewing on the side of your mouth where the tooth was extracted.

- If the extraction was in the upper jaw, avoid blowing your nose.

- To decrease pain and swelling, put

cold compresses on your cheek. After the first 24 hours, use warm compresses.

- You can now brush your teeth but avoid the extraction site. Rinse gently with warm salt water several times a day.

- Avoid crunchy foods, popcorn, seeds or anything that can get lodged in the socket or disturb the clot.

Contact your dentist if bleeding continues for more than 24 hours or you develop any signs of infection such as continued swelling past the first few days, a bad taste in your mouth, sudden increase in pain, fever or pus.

and more than 80 percent were made to businesses with \$1 million or less in annual revenues, according to a DCEO press release.

"(Gov. JB Pritzker's) decision to respond quickly to the virus, and also support, economically, our workers and our businesses has been key in getting this all done. That's the big picture. It's really coming down from the top. It's really coming from his vision and carrying it out in an equitable way," Guthrie said.

Although the supply of funds could not match the demand, Guthrie said the agency continued to solicit for new applications because "we knew that we would continue to get those smallest, very smallest businesses to apply who were in the hardest hit industries, and that's exactly what happened."

The average grant size was \$30,000, and grants ranged from \$5,000 to \$150,000.

Robert Gomez, owner of Subterranean music venue in Chicago, received funding through the BIG Grant program in mid-November after shuttering his doors in March.

Gomez said Subterranean was in a dire situation before it received a \$30,000 program grant, as he weighed the possibilities of refinancing his home, or tapping into his kids' college funds.

Subterranean, which is in its 27th year, received federal PPP money but Gomez said he hasn't touched the funds because his workers are not on

his payroll, which is a requirement for loan forgiveness eligibility.

"We've had to rely on donations from individuals, and a gift certificate program that we put in place where people can redeem it later," he said.

"It's like, no, we can't go down like this. You work so hard to build something for almost 30 years, and then get wiped out because of the pandemic. It's so hard to wrap my mind around that. But our only alternative, my only alternative, was to fight, to get creative, to push," Gomez said.

Having spent his BIG funds, Gomez said he plans to apply for grant money that was allocated for venue operators in the second round of federal COVID-19 stimulus funding, which was passed by Congress in December.

"Thankfully, there seems to be a federal program that is specific for venues that would be the lifeline we need. But without the BIG grant, we wouldn't have been able to sustain ourselves without some major financial overhaul," Gomez said.

Nearly half of all BIG funds, or more than \$133 million, went to restaurants and bars, according to the DCEO release.

A recent survey from the National Restaurant Association, along with the Illinois Restaurant Association, found 58 percent of Illinois operators say it is unlikely their restaurant will be open in six months without additional relief packages from the federal government.

Pritzker's executive order that imposed an indoor dining ban on bars and restaurants, effective Nov. 18, has been especially painful for the industry.

Pat Doerr, managing director of the Hospitality Business Association of Chicago, said the fact that the agency awarded some grants to restaurants that never stopped serving customers indoors, in violation of the program's eligibility rules, is one of his top grievances.

For example, Fireside Grille in Sugar Grove has continued to operate indoor dining after the governor issued his executive order but was issued a \$150,000 grant.

Owners of Fireside Grille did not respond to requests for comment.

A DCEO spokesperson said the department hasn't received a formal complaint about Fireside Grille, adding that DCEO will be reaching out to this business owner to inquire.

Guthrie said the majority of grant recipients have followed the rules.

"If they aren't, we really try to work with grantees to get them back in compliance. And then the very last line of defense would be to potentially claw back funds," she said.

Guthrie said the department hasn't clawed back any grant funds so far but one grant recipient that was not in compliance voluntarily returned their funds.

Doerr said the agency also failed to communicate an applicant's realistic chance of getting money.

"They massively oversold the program," he said. "The ship went down, and only one in five businesses got a lifeboat. Everybody's happy for the one in five small businesses who made it in the lifeboat."

Matt Strauss applied for BIG funds to help his Chicago restaurant — Table, Donkey and Stick — and Danke, a Chicago sandwich shop, where he is

a managing member, but was denied funds for both businesses.

He said his businesses have remained afloat with PPP funds, and expects they will receive a second round of federal PPP money in the coming weeks.

"The bottom line is (DCEO) should have taken applications, determined eligibility, and then distributed funds across the pool — the full universe of eligible applicants. It's the only way to do it equitably," he said.

"Obviously, everyone wants free money. And I wouldn't say no, but I just know that there are thousands and thousands of businesses that are owned by people who have less than I have, and are probably going to struggle significantly because they didn't get any funding."

whole blood donations that test positive for COVID-19 antibodies may be used to help COVID-19 patients.

To protect the health and safety of Red Cross staff and donors,

individuals who do not feel well or who believe they may be ill with COVID-19 should postpone their donation. In addition, safety precautions such as temperature checks, social distancing and face

covering requirements are in place at each Red Cross drive or donation center.

Two area blood drives are coming up this week:

- 2 p.m. to 6 p.m. Thursday, Jan. 14, at the Stagecoach Events Center, 446 E. Hickory St. in Apple River
- 1 p.m. to 5:30 p.m. Friday, Jan. 15, at the Lena American Legion Hall, 316 Main St. in Lena

Potential donors may schedule an appointment by going online to RedCrossBlood.org, using the Red Cross blood donor app, calling 800-733-2767 or activating the blood scheduling skill for Amazon Alexa.

In addition, those who come to donate blood or platelets in January will automatically be entered to win two tickets to next year's Super Bowl LVI in Los Angeles. Those who come to give by Jan. 20 will also be automatically entered to win the "Big Game at Home package," which includes a 65-inch television and a \$500 gift card.

Finding the meaning of life on aisle 10

Today a strange man approached me. Well, he wasn't actually strange as in green ears and three arms; he was just strange to me. In other words, I didn't know the guy.

But there he was, walking straight in my direction, giving obvious eye contact, in aisle 12 at the grocery store — like we were old buds. He was an elderly gentleman, perhaps old enough to be my father, so I wasn't too threatened. Just surprised. And perhaps curious. It felt odd.

I looked to my left and to my right. Was he really approaching me or was there another person who served as the object of his purposeful gait toward my social-distanced, face-covered self?

No one was near me (or him). No one else could be the source of his attention. I stood, feeling a bit trapped, on aisle 12 pretending to examine the ingredients on the label of a pickle jar.

There was no escape path. I waited for the ball (or in this case, the pickle) to drop.

"Excuse me," he said. At least he was a polite sort.

I looked up from my jar. He was shorter than I'd thought. And thinner. Definitely old enough to be my dad, in fact he sort of resembled him. Somehow I found that comforting.

Illinois GOP wields little power these days

Written in quill pen (not literally; it was 1965), my master's thesis was about "Leaderless Politics: The Illinois Republican Party." Not much has changed.

That was an era when party organization mattered. My thesis was that when Republicans lost control of the governorship, the party became leaderless. Not much has changed.

Back then, political patronage provided party leaders with influence over elections. My research showed that under GOP Gov. Bill Stratton (1953-'60), 83 of the state's 102 Republican county chairmen held state jobs. Guess who ran the party? Without a governor and jobs, the party was rudderless.

First, TV in the 1960s and now billionaire self-funders and donors have replaced political party organizations as the primary conduits to the voters. Patronage

is mostly gone, by Supreme Court dictum.

Political parties have traditionally had three basic functions:

- Set forth a platform of values and policies for voters to consider;
- Recruit attractive candidates; and

• Work to nominate the candidates in the primary and then get them elected, so they can implement the platform inside government.

The Illinois Republican Party does little of this anymore.

The role of party platforms has been underappreciated. Party leaders used to wrestle over platform planks at their conventions. The platforms, by a kind of osmosis and over time, provided helpful cues for voters. That is, the GOP favors small business, while the Dems are for the working stiffs. Most of that

is gone today, and voters are adrift, captivated yet confused by a Tower of Babel issuing relentlessly from the internet.

The Illinois state GOP is a paper tiger. It has neither money nor clout over county parties. The county parties are mostly toothless as well. There are exceptions. For example, county GOP chairs Jan Weber in Henry and Aren Hansen in Grundy have in recent years almost singlehandedly turned local offices from Dem to GOP. Mary Brookhart in McDonough County also has a strong county party; her team knows how to get out the vote.

The Illinois GOP is at present recruiting a new statewide party chair. Different from a number of states that have large, professional staff and paid

chairs, the Illinois party has but one staffer (very sharp Derek Murphy) and a volunteer chair. With megabucks ex-Gov. Bruce Rauner gone, the state party has barely two nickels to rub together.

The struggle for party control, as if it mattered, is apparently between a Trump-thumping faction and an "establishment" faction, neither with a clear platform.

The old adage that "all politics is local" is no longer true. Successful local candidates in small town and rural Illinois tend to feel they must pay more than lip service to the Trump brand of nativist populism.

This effectively leaves lifestyle tolerant, pro-choice, balanced budget, free market, business-friendly folks like

me outside the party, or so I feel.

What does the future hold for the Illinois GOP? I expect to see Trump 2024 signs soon replacing the thousands of the 2020 versions on lawns and farmyards across mid-America; however, insiders I talk with predict the Trump brand will fade rather quickly, as he likely becomes ensnarled in nasty tax and legal problems.

Over the past half century, Republican leaders have also seen their base slip away, literally. Since about 1970, two million or so whites have departed the state in net terms, replaced largely by Latinos and, to a lesser extent, Asian-Americans.

When I was a state legislator in 1970, 12 percent of Illinois residents

were of a minority group; today, it is 36 percent. From 1977 to 2003, the Illinois GOP enjoyed a 26-year, unbroken string of Republican governors. In contrast, this year Joe Biden clobbered Trump in Illinois 57-40 percent, in what pundits call a firmly Blue state.

The big prize in 2022 will be the governor's mansion, not that anyone lives there anymore. Gov. JB Pritzker is considered vulnerable, following his botched, disastrous campaign for increased taxes on high earners, and because of the unenviable role he has in trying to corral COVID-19.

In a district on the edges of metropolitan Chicago, GOP Congressman Adam Kinzinger has been critical of Trump while supportive of his policies. He appears to be

positioning himself for a run for higher office – governor, close observers report.

I also find state Sens. Jason Barickman of Bloomington and Sue Rezin of Morris attractive. Both are smart and capable, and might have some appeal in the suburbs. But they and other aspirants from the political ranks must nowadays almost expect outsider megabucks sorts to crash into the GOP's party.

The race will be wide open, and the leaderless state GOP will be but a bystander.

½ t. salt
1/8 t. ground cloves
1/8 t. ground nutmeg
1¼ C. whole buttermilk
Preheat oven to 350. Spray three 9-inch round cake pans with cooking spray with flour. In a large bowl, beat butter and sugars with a mixer at medium speed until fluffy, four to five minutes, stopping to scrape the sides of the bowl. Add eggs, one at a time, beating well after each addition. Add molasses and vanilla, beating well. In another large bowl, whisk together flour, baking powder, baking soda, ginger, cinnamon, salt, cloves and nutmeg. Gradually add flour mixture to butter mixture alternately with buttermilk, beginning and ending with flour mixture, beating just until

combined after each addition. Divide batter among prepared pans.

Bake until a wooden pick inserted in center comes out clean, 25 to 28 minutes. Let cool in pans for 10 minutes. Remove from pans, and let cool completely on wire racks. Spread frosting between layers and on top and sides of cake. Garnish with cranberries and rosemary sprigs.

Orange Cream Cheese Frosting

2 pkg. (8 oz. each) cream cheese, softened
¾ C. unsalted butter, softened
6 C. powdered sugar
2 t. vanilla
1 T. orange zest

In a large mixing bowl, beat cream cheese and butter with a mixer at medium speed until smooth and creamy; stop and scrape sides of bowl several times. Gradually add powdered sugar, beating until smooth, stopping to scrape bowl. Beat in vanilla and zest. Use immediately.

Caramel Pecan Treasures

This cookie is a combination of a shortbread, caramel filling and melted chocolate. The top is sprinkled with chopped pecans. These will melt in your mouth. You must use butter and not margarine for these cookies.

1 C. butter, softened
¾ C. packed brown sugar

1 t. vanilla
1¾ C. flour
½ t. baking powder
30 caramels, halved and flattened
2 C. semisweet chocolate chips
1 T. shortening
½ C. finely chopped pecans

In a mixing bowl, cream the butter and brown sugar. Beat in vanilla. Combine the flour and baking powder; gradually add to the creamed mixture. Roll into 1-inch balls. Place 2 inches apart on baking sheets; flatten slightly. Bake at 325 for 12 to 15 minutes or until golden brown. Remove to wire racks to cool.

Place one caramel on each cooled cookie. Melt the chocolate chips and shortening and drizzle over the

cooled cookies. Sprinkle with the pecans. Let stand until firm.

Final thoughts

We are heading into the middle of January; time does fly. I will be taking a break for at least two weeks because I am having some eye surgery. I hope you have a great end of the month; hopefully there will be some Super Bowl recipes when I return. Stay healthy and safe.

USDA makes fifth round of food purchases

The USDA will purchase an additional \$1.5 billion worth of food for nationwide distribution through the Farmers to Families Food Box Program, officials announced recently. In total, USDA has distributed more than 132 million food boxes in support of American farmers and families affected by the COVID-19 pandemic.

"This new round of Farmers to Families Food Boxes will go a long way in helping American families access nutritious and healthy meals as we recover from the COVID-19 pandemic," USDA Secretary Sonny Perdue said in a news release.

The additional funding for the program was included in the COVID-19 relief package as part of the Consolidated Appropriations Act passed Dec. 21. In this fifth round of purchases, USDA will again purchase combination boxes to ensure that recipient organizations have access to fresh produce, dairy products, fluid milk and meat products. In addition, seafood products will be included in this round.

Agribusiness goes against the grain in 2020

Many boons found among changes forced by pandemic

Apple orchard and pumpkin patch operators can pick out a number of surprise benefits from doing business during the COVID-19 pandemic.

During a Thursday afternoon session at the virtual Illinois Specialty Crop Conference, operators of two of the state's biggest such companies went over unforeseen boons — from a more productive relationship with government officials to more fruitful use of social media.

The biggest surprise, perhaps? Sales went up year-over-year, according to Chris Eckert, president of Eckert's Country Store and Farms in Belleville.

"With everything we've learned, I expect (profits) to be even better this year, or at least to stay at those numbers," he said. "I certainly don't expect them to go back to where they were in 2019."

'Suddenly, we're on the front line'

Eckert and Randy Graham, chairman of the Illinois Specialty Growers Association and co-owner of Curtis Orchard & Pumpkin Patch in Champaign, helped form and lead a working group that wrote COVID-19 operating guidelines and protocols, as they pertain to agritourism, then presented them to legislators and the Illinois Department of Public Health.

Eckert said it was refreshing to have not just a seat at the table, but officials' undivided attention.

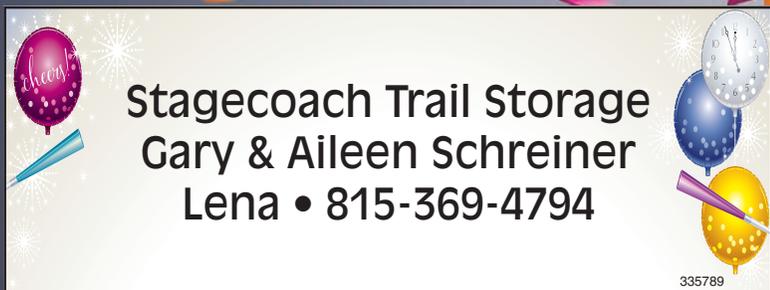
"They'd never really listened to us like this," Eckert said. "I think it's very easy for the governor, the administration or the public health department to make rules without thinking about us. Suddenly, we're on the front line of what seems like a war. Twelve months ago, we didn't necessarily think of ourselves as essential workers."

Graham said working with the group to write the guidelines opened his eyes to the wide range of ideas, opinions and gripes.

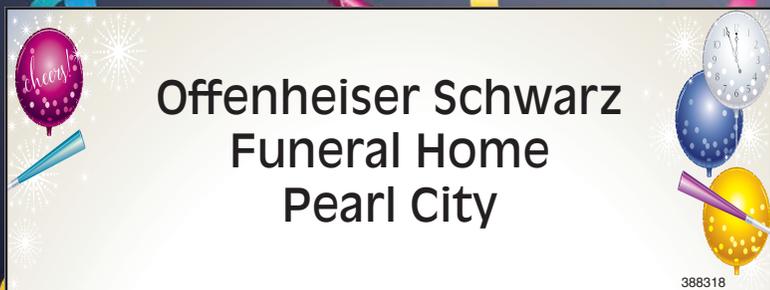

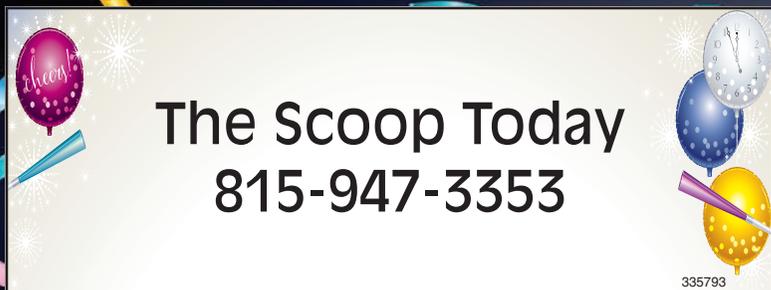

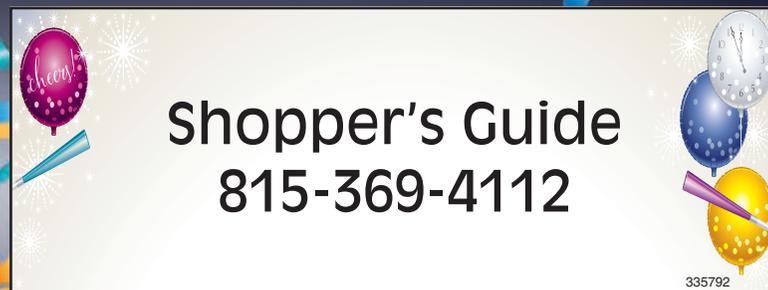

Bipartisan Illinois politicians condemn rioters, Trump

Hours after rioters seeking to block the certification of President-elect Joe Biden's November election victory first began storming the U.S. Capitol Jan. 6, Gov. JB Pritzker called on Congress to impeach and remove sitting President Donald Trump.

U.S. Rep. Adam Kinzinger, R-Channahon, called the scene a "coup attempt."

"The current president incited this coup and encouraged it and did little to protect the Capitol and the Constitution," Kinzinger said in a video posted on his Twitter account. "He is no longer the leader of our party. Our party must reject these treasonous acts."

Pritzker, in a statement, said, "Two weeks is too long for Donald Trump to remain in office, where he can continue to incite more untold violence." "Because of these events incited by the president, I had to ask the Illinois State Police and other law enforcement resources, engaged in important life-saving missions, to re-

deploy to heighten their presence at government buildings and the Capitol in Springfield," Pritzker added.

A small group of 75 to 100 protesters demonstrated peaceably Jan. 6 outside of the Illinois State Capitol, a far cry from the events in Washington, D.C.

"As the heart of our democracy was under siege and blood was literally being spilled in our most sacred halls, Donald Trump was praising the attackers. There are real questions about what efforts the president made to protect our Congress or what obstructions he committed that has prevented the ending of the siege," Pritzker said in the statement.

Trump, in a video statement released Jan. 6, urged the rioters to go home while still maintaining the election was "stolen" by Democrats. Trump has filed several lawsuits alleging voter fraud, repeatedly being rejected by judges for lack of evidence.

Trump also praised the rioters in the video statement, calling them "very special" and telling them he loved them.

On Twitter, the social media platform began removing some of the president's tweets after he criticized Vice President Mike Pence for not being more proactive in blocking the results of the November election. Twitter placed a 12-hour block on his account the evening of Jan. 6, noting it would continue until certain tweets deemed a threat to public safety were removed.

Several Republican members of Congress planned to object to Biden's certification Jan. 6 before it was waylaid by the rioters.

However, Congress certified the Electoral College votes for President-elect Joe Biden early morning on Jan. 7. Trump said there will be an orderly transition of power on Jan. 20.

"There is no doubt in my mind that his efforts to encourage a coup represent high treason to this democracy, our Constitution and all Americans," Pritzker said in his statement. "He poses a danger to our nation. He must be impeached and removed from of-

fice immediately. And every person in a position of public trust, elected or otherwise, who enabled the systematic dismantling of our democratic norms and failed to speak up or take action bears some responsibility for the culmination of four years of spreading bile."

Legislative Republicans in the state also rebuked the events in Washington.

"The events unfolding at the United States Capitol, and the inflammatory remarks by members of the Republican Party, are a disgrace to the core values and beliefs of our great nation," House Republican Leader Jim Durkin, R-Western Springs, said in a statement. "These actions do not represent our Republican Party, and are against everything we stand for as Americans. I am sickened and deeply saddened by what I have witnessed today. Any public officials who condone these actions have no place in the Republican party or in our democracy."

Dan McConchie, Senate minority leader designate, also issued a statement.

"The horrible violence at our nation's capitol is a disgrace to all Americans," McConchie said. "This violence does not reflect the United States that generations of Americans have fought so hard to build. I stand with members of all parties in condemning these un-American acts of violence and treachery, and will do my part here in Illinois to repair the devastating divide that has been created in our country."

Senate President Don Harmon, D-Oak Park, and House Speaker Michael Madigan, D-Chicago, also issued statements condemning the rioters.

"The peaceful transition of power is a hallmark of our great democracy," Harmon said. "To disrupt that transition is an affront to the very fabric of the United States of America. The U.S. Capitol has stood strong in the face of attacks by confederates and terrorists. We will survive today's sad acts to once again be a beacon of hope, change and equality for the world."

GOP lawmakers introduce 'fair maps' legislation

Republicans in the Illinois House said last week that they hope to use legislation, instead of a constitutional amendment, to change the way state legislative and congressional district lines are redrawn every 10 years.

The so-called "fair maps" proposal would authorize the General Assembly to set up an independent, nonpartisan commission to redraw the lines, taking that highly political process out of the hands of legislators who currently are able to use that process to protect themselves politically, a process known as "gerrymandering."

Redistricting is a process that all states go through following each decennial federal census and one that Illinois must complete in the upcoming session so that districts can be established in time for candidates to file for office in time for the 2022 elections.

Rep. Tim Butler, R-Springfield, said the measure is similar to the proposed constitutional amendment

that supporters tried to put on the ballot in 2016 before being blocked by a sharply divided Illinois Supreme Court. The main difference is that it would put the process into statute instead of the constitution.

"This is a great way to do it through statute to make sure that we have an independent commission that draws our maps this year, gets it out of the hands of the leadership of the General Assembly and puts it in the hands of a commission of citizens to draw fair and equitable maps across the state of Illinois," Butler said during a virtual news conference.

In 2016, supporters of such a change circulated petitions to put a constitutional amendment on that year's general election ballot. That's one of three ways the current Illinois Constitution allows amendments to be considered. The others are by a constitutional convention or by a resolution approved by a three-fifths majority in both the House and Senate.

However, the constitution also

limits the scope of citizen-initiated amendments to "structural and procedural subjects contained in Article IV," which pertains to the General Assembly.

In a 4-3 ruling, the Supreme Court blocked the proposal from going onto the ballot because the proposed amendment contained elements that also dealt with the attorney general and the auditor general.

The legal challenge to the amendment was brought by several individuals led by John Hooker, a former Commonwealth Edison lobbyist who is now under indictment for allegedly taking part in a bribery scheme aimed at buying the favor of House Speaker Michael Madigan.

Former Justice Thomas Kilbride, who lost his bid for retention in November, wrote the majority opinion in that case, and that was a factor in the GOP-led campaign to remove him from the court.

"And that decision really still burns me to this day," said Rep. Ryan Spain, R-Peoria, who was among the

nearly 600,000 people who signed a petition to put that amendment on the ballot.

"So something has to change," Spain added. "And since the Supreme Court decision many years ago, I have repeatedly supported and been either the sponsor or the chief cosponsor of a number of different initiatives to change the way we approach redistricting in the state of Illinois."

Rep. Jackie Haas, R-Bourbonnais, said her district is an example of how gerrymandering can be unfair to certain communities. She said her 79th House District excludes three-quar-

ters of the small town of Momence, whose 2010 population was 3,171, and includes only three streets in the village of Beecher, which has about 4,500 residents.

"These moves were not based on township, village, or meaningful divisions, but on pure partisan maneuvers to advantage (House Speaker Michael) Madigan, to keep his majority in his power," Haas said.

Butler filed the bill, House Bill 5873, on Jan. 5.

IDES responds to GOP criticisms

Department adding staff, balancing need for prompt payment, fraud checks

House Republicans continued to criticize the Pritzker administration last week as the Illinois Department of Employment Support works through ongoing staffing and fraud issues related to the COVID-19 pandemic.

Since handling a historic number of unemployment assistance claims at the outset of the pandemic in March, IDES has added staff, changed processes and implemented additional measures to prevent fraudulent claims.

On Jan. 6, some House Republicans continued calls for additional measures to be implemented, such as moving staff from other state departments to assist with the overload of unemployment assistance claims, implementing more anti-fraud measures and holding public hearings to discuss issues at the department.

"It is unacceptable how the governor and the department have responded to this crisis that they themselves have caused," said Rep. Mike Marron, R-Fithian. "It is my hope that someone at the administration cares enough to listen to our ideas and to start a dialogue."

IDES officials pushed back on criticisms offered by the Republicans, stating that it is not possible to move employees from other state agencies without substantial training, and that many of the anti-fraud measures being proposed by the Republicans are already in use by the department.

"We are working hard to respond to an economic crisis and stand up five new, complex federal programs while battling fraudsters who have used stolen identities to file for benefits nationwide," said IDES Acting Director Kristin Richards in a statement.

Richards said the department was already short-staffed as a result of years of budget cuts which left IDES ill-equipped to handle the unprecedented number of claims last spring. The current employee head count is roughly half of what it was 10 years ago, she said.

Since the pandemic began, the department has contracted over 1,000 employees to assist in handling un-

employment claims, and has been approved for an increase in staffing and resources for the current fiscal year, which is fiscal year 2021. It continues to hire more employees, she said.

It has also implemented a callback only system which allows an applicant with a question to be placed in a queue to be called back, rather than having to experience extensive waits.

"IDES was given an increased headcount for FY21, but adding full-time employees, as all state hiring does, takes time," Richards said. "This is especially true for IDES, whose employees possess a unique and complicated skillset to work on issues and deliver services to claimants."

Richards said a proposal to move employees from other state agencies would be ineffective in fixing delays.

"The legislators' call for moving state employees from one hollowed-out agency to another ignores the nuance of what is involved in these jobs and positions and would create productivity deficits in the agencies from which state employees would be pulled," Richards said.

Richards said the department has worked to stabilize its operations in order to meet the needs of unemployment support applicants in a timely manner.

"The idea that IDES has disproportionate trouble processing new claims or paying out claims is misleading," Richards said. "A claimant who provides all the necessary data and submits their claim will be processed in a timely and efficient manner and will receive benefits if they are deemed eligible and continue to certify."

She said the state has also begun paying out Federal Pandemic Unemployment Compensation, which adds an extra \$300 per month to claims from certain individuals collecting unemployment assistance.

But the federal rush to expand unemployment assistance amid the pandemic and associated government shutdowns has led to widespread exploitation of unemployment systems across the nation, including in

Getting farm to table faster

Ag leaders, nonprofits address food insecurity in Illinois

It takes a lot of moving parts to connect fresh produce with the communities that need it most.

You need farmers growing quality food. Funding to pay them. Food banks, pantries and food marts in place to store and distribute. And don't overlook one of the biggest roadblocks: transportation to get the food from farm to kitchen table.

"Transportation is a critical, critical issue, in terms of time and cost," Steve Miller, an at-large board member of Illinois Specialty Growers Association, said during a Jan. 7 virtual session at the annual Illinois Specialty Crop Conference.

Here's the rub, though: To assure that food is fresh when it arrives, the fewer literal moving parts, the better.

"If produce comes in from a producer on Thursday or Friday, then sits in a ware-house over the weekend, it doesn't get to the families until Monday or Tuesday," said Dan Kenney, the founder of DeKalb

County Community Gardens, who attended the virtual conference.

In DeKalb, nonprofits have finally cut out the middleman.

Since late spring, Klein's Farms in Elgin has been selling produce directly to non-profits in the county at wholesale prices.

"The quality is night and day," said Joey Moore, who runs the Barb Food Mart that has served the DeKalb School District 428 community since 2012. "When they're out picking produce that morning, it's the highest quality."

She and Kenney took part in a Zoom discussion with the Illinois Press Association on Friday afternoon.

"And there's the nutritional value," Kenney added. "Once you harvest something, it starts losing its nutritional value right away."

Even before Klein's partnered with DCCG and the food mart, DeKalb County was light years ahead of other parts of the state in terms of getting food from farm to table as quickly as possible.

Kenney founded DCCG a couple of months after Barb Food Mart launched in 2012. DCCG has since produced more than 200,000 pounds of food, according to its website. In 2017, it launched its Grow Mobile refrigerated truck program. In January alone, two trucks will make 11 distribution stops around the county.

The end result? Rather than receiving produce that's sat on shelves at food pantries, or been donated by grocers who can no longer sell it, families in need in DeKalb are getting farm-fresh produce.

"The message it sends out to people attending food pantries is that they deserve fresh, high-quality food," said Heather Edwards, DCCG's associate director who has overseen the launch of the Genoa Area Community Food Hub in the northern reaches of the county. "We all deserve that. Nobody should feel that they get a lesser quality than they deserve. It's about their dignity."

Illinois. In particular, a federal Pandemic Unemployment Assistance program which allows certain independent contractors to collect benefits has been ripe for fraud.

Richards and the administration have said the fraud is due to a nationwide scheme enabled by data breaches of private companies that have made individuals' information, such as Social Security numbers, available to scammers. It is not the result of a breach to state unemployment systems.

Rep. Mike Murphy, R-Springfield, called for the department to implement additional anti-fraud measures, such as a flagging system for out-of-state applicants and multiple failed claims, measures which IDES said it already has in place.

"The above-mentioned anti-fraud measures, and many others that are already in place, have the effect of slowing down the process of distributing (unemployment insurance) benefits — and that is an unavoidable and necessary thing," Richards said. "But it demonstrates the cruel irony that IDES is being simultaneously besieged by historic unemployment claims and be-

sieged by a globally orchestrated fraud scheme, and that solutions to these problems work against each other. Legislators are telling us to hurry up and make payments but slow down and put more barriers in place to stop fraud."

Richards said that IDES has been in routine communication with legislators and has done its best to provide timely answers to questions from lawmakers and constituents. But she said additional training and information will be necessary moving forward, citing a "misunderstanding some legislators have of IDES and unemployment insurance."

The lawmakers, however, continue to call for public hearings to discuss the department's pandemic response, rather than being reduced to input only through personal conversations with the administration.

"IDES will work with these legislators to create the first cohort of targeted training for elected state officials," Richards said.

"There was a lot of give and take, and you'd think it would be a little easier to come to an agreement on some topics, but we discovered a lot of diversity in opinion," he said. "That really helps us view the situation through different eyes."

After the state health department issued its guidelines, businesses were at the mercy of their local health departments.

Things were more strict in Champaign than, say, St. Clair County.

"Very strict, I would say," in Champaign, Graham said.

For instance, those inflatable play areas that keep patrons on-site all day, after they've bought their children an all-day wristband? The Champaign-Urbana Public Health District took the air out of those structures.

But whereas some other health departments around the state required rigorous ticketing and appointment systems for orchards and pumpkin patches, the Champaign department didn't.

"Having the strength of numbers document maybe helped sway them to work a little more with us in some areas," Graham said.

No one likes to stand in line

Eckert braced for blowback when his business instituted a picking appointment system in Belleville.

"It was a challenge," Eckert said. "We had been charging some field admission for years, but we'd never pushed for advance ticketing. We didn't know how much resistance we were going to get."

Eckert's started with 100 patrons per 30-minute timeframe, \$2 to \$5 apiece per slot, to gauge how many people they could safely put on a wagon, and determine how many wagons they could run without issues. They slowly increased the number until they reached 300 per half-hour.

"While there was a lot of fear of it, acceptance was very high," Eckert said. "Don't get me wrong. There's always complaints."

On the flip side, he said he and his staff got more compliments than in years past.

He and Graham said there were fewer cars in the parking lots during typical peak times. But there were cars in the lots all day, and sales went up. With no long lines to stand in, pumpkin sales "skyrocketed," Graham said.

"They were through the roof," Eckert said, admitting he didn't know exactly why.

Gail Devilbiss, an agriculture and natural resources program coordinator with the University of Illinois Extension, pointed out in the session's chat that decorating pumpkins is "a family tradition," and a more cherished one in 2020 "because everyone was home. Same with Christmas trees."

Going against traditional grain

Graham admitted it was tough to make decisions that flew in the face of conventional, perceivably successful practices.

He winced when the decision was made to eliminate that play-all-day wristband.

"Usually the longer they stay on the farm, the more money they'll spend," he said.

This year, the Champaign farm

couldn't use its store as a sort of funnel, and a gateway into the pumpkin patch. But patrons spent more money in the store when they had elbow room, when the store wasn't packed to the gills. The plan going forward is to sell pumpkins at an outdoor structure, as well.

Some forced decisions were not only easier to carry out than expected, but saved a lot of time and resources. For instance, replacing the clunky, foot-pedal hand-washing stations with dozens of hand sanitizer stations cut down on maintenance, while making patrons feel safer.

Eckert said industrywide, apple sales have been declining in recent years. Whereas a grain farmer can change up his planting patterns, apple trees are where they are.

So in an effort to buoy sales and cut down on food waste, Eckert's partnered with grocery chain Schnucks to sell apples wholesale.

"It's the first time we've done wholesale in 30 years, in any meaningful way," he said.

'Video is going to be the real winner'

Graham said he and his staff saw a lot of new faces this past season. The trick now is bringing them back, especially when, as Eckert pointed out, other entertainment options, such as minor-league professional sports, are bound to return this fall.

"Video is going to be the real winner," Eckert said, before laughing a little. "It's something we're not really good at yet."

It takes a real mindset shift to go from traditional marketing like billboards and broadcast advertisements to leveraging social media.

"I used to view social media as the free advertising medium where you'd get a little bonus," he said. "When we started focusing on it I realized if you really want to do it well, you have to invest your promotional dollars into it. It takes a lot of effort to put together videos."

He said social media is the most measurable medium he's worked with, and its immediacy is invaluable when you're dealing with, say, the rapid changes of apple varieties in a season.

"You really see an immediate impact," he said. "If we announce honey-crisp apples are ready, in five minutes, you'll see people walking through the doors."

A major breakthrough for Curtis Orchard & Pumpkin Patch was using more video this past season. For instance, its Cooking with Kids videos, each just a few minutes, were an instant hit.

living room-type environment until they can be transferred or until a care plan can be established and the patient is better prepared to go home.

The CSC's open floor plan allows staff to monitor patients in a home-like setting where they are free to read, watch TV, sleep or talk when they are not in individual or group counseling sessions, which are scheduled daily. A multidisciplinary team cares for patients, including a psychiatric provider, psychiatric nurses and mental health therapists, all dedicated to helping them cope.

Graham said the kids were a joy to work with – and surprisingly well-behaved. It drove home a reminder that agribusiness is about more than selling apples and pumpkins.

"We're this bastion of nostalgia — the way things used to be," Eckert said.

Emphasis on education and public trust

In the mid-'90s, apple cider got a bad rap when unpasteurized batches caused three e coli outbreaks.

"We'd eroded the public trust, and we needed to get it back," Eckert said. "Being good stewards of the industry is an important part. We have an important role in connecting people with food, and them feeling good about that."

He and Graham agreed that in 2020, families were willing and eager to come to the farm and see how food is grown, and how the products they buy in the store are produced.

"Our guests really felt safe coming to us and seeing where food was produced," Eckert said. "There was some security that came with that."

Organic, locally grown food has been trendy in past years, but 2020 felt different, he said.

"Before, it was more of a luxury, and now I think people see us as critical."

Patients appropriate for this care setting are those experiencing a behavioral health crisis without present aggressions. The patients must be voluntary to access treatment and willing to participate in the treatment program. This is a 24/7 program, with patients spending the night in the care environment.

Due to COVID-19 safety restrictions, no ribbon-cutting or public open house is planned, and no tours are available.
