State school board gets pushback on mask man

Parents, school officials argue for local control

Education room on Aug. 18 as choose," said Ruby Johnson, a mother of seven children from New Lenox. "Our kids did not choose to be masked all day, unable to see their friends or teachers smile at them, to have to COVID test to stay in school, to be burdened with the idea that they

carry an invisible disease that they could make their friends sick with.

Gov. JB Pritzker issued the mask mandate in an executive order Aug. 4, shortly after the U.S. Centers for Disease Control and Prevention issued updated guidelines for schools in response to a surge in the highly contagious delta variant of COVID-19. Those guidelines urge "universal indoor masking" by all students over the age of 2, staff, teachers, and visitors to K-12 schools, regardless of vaccination status.

Since then, ISBE has put more than two dozen public and nonpublic school systems on probationary status for refusing to comply with the mandate, although some have since had their status restored after later agreeing to comply.

Under the state's administrative code, schools can be placed on probation for "deficiencies that present a health hazard or a danger to students or staff." When that happens, the schools are given 60 days to submit a plan for correcting the deficiency and, if they fail to do so, risk losing their state recognition altogether.

492 acres added to local state parks Officials at the Jo Daviess like JDCF that can help the Community Foundation and

have announced the expansion of two local state parks in Jo Daviess County.

In March, JDCF transferred its 159-acre Oneota Preserve to the Illinois Department of Natural Resources, which will manage the property as an addition to the IDNR's existing Hanover Bluff State Natural Area located just outside of Hanover.

Simultaneously, **JDCF** transferred its 333-acre Dvorak Property to the IDNR, who will manage the property as the Dick Dvorak Unit of Apple River Canyon State Park in rural Stockton.

'The Apple River Canyon and Hanover Bluff are two areas that the IDNR has been working to protect for a very long time," IDNR Assistant Director John Rogner said in a news release. "We're so happy to have a local partner IDNR conserve these incredible landscapes for wildlife and the people of the state of Illinois for generations to Bluff State Natural Area lo-

"Since the DNR already owns the land adjoining both of these properties, it just made sense to transfer these properties to the state so they could be managed as cohesive units." JDCF Executive Director Steve Barg said in the release. "In the short-term, JDCF will continue to provide some land management and ecological restoration services on these properties to help maintain these habitats in a healthy, natural state."

Both properties are open for low-impact recreational uses such as hiking, birding and fishing.

The Oneota Preserve was purchased by JDCF in 2016 with grant funding provided by Illinois Clean Energy

Grand Victoria Foundation. Visitors can access this site via the original Hanover cated at 8995 S. Hanover Hill Road. Hanover.

The Dick Dvorak Unit of Apple River Canyon State Park is located at 1794 S. Scout Camp Road, Stockton. JDCF purchased the property in 2019 with grant funding support from ICE-CF, GVF, and a loan from The Conservation Fund. The property is named in honor of the late Richard F. Dvorak, who owned and managed the property for nature for more than 40 years.



With the 2020 season pushed back to the spring of 2021, it was far from normal for the Panthers, as they played knowing there would be no postseason.

The Panthers made the most of the spring experience, posting a record of 4-1. The short season and lack of a postseason left the Panthers feeling hungry and eager to get to the fall sea-

"I think there will be a lot more excitement and buzz in the hallways on Fridays, and throughout the weekend during the playoffs," Arand said about this fall season. "I think it will definitely be a change for the

Lena-Winslow will hope to be one of the best teams in Class 1A again, as they appear to be gearing up for another state title run. The team's strong work ethic is a big reason Arand said he is not concerned about the shortened offseason and how the stujam-packed sports schedule. "I don't think it's going to

have any impact. I think the kids were so ready to get back into something normal," the coach said. "It was a crazy winter and spring with everything being packed together and shortened seasons. Everything overlaps, so during basketball season we were practicing football; the same thing happened during the spring, when we were practicing baseball and football.

"The kids did not mind that. I think they are just ready for normalcy, but they are so resil-

Another big reason for the high expectations is the special group of seniors leading the way this season. The Lena-Winslow coaches are hoping senior quarterback Luke Benson will take that role in

"Luke has really developed into a great leader for us." Arand said. "It is tough as a junior, to try to be that guy in charge. Even though we as coaches probably wanted him to be that guy, you are fighting upperclassmen and things like

did not take the initiative a year ago, but he has really taken control of our team along with Marey Robey."

Robey is set to play a key role in Arand's offense this season, and he has a chip on his

"Marey has got some big points to prove this year, with coming off the broken leg and he is really back in full strength now and wants to get after it," Arand said. "I think those two have probably been our biggest leaders so far, along with Brody Mahon."

Arand had a multitude of nice things to say about what Mahon does for the team.

"(Mahon) played tight end and outside backer for us. He got acknowledged at the All-Conference meeting, he got what he deserved, but I think he is so much better right now than he was a year ago,' he said. "He is bigger, faster, stronger and will, hopefully, be more physical for us up front. He has done a great job for us in seven on seven. I expect for him to have an even bigger and better year than he did a year

This group of seniors runs deep and they share a special connection on and off the field.

"It is a really tight class. Probably, the most tight class of kids we have ever had, and that goes back 25 years," Arand said. "The majority of these kids were hanging out together long before junior high. A lot of them, their parents are pretty good friends. They have spent a lot of time together. Whether it is in sports, or hanging out at each other's houses, or going on vacations together.

But a number of local and regional superintendents argued that the decision about how to reopen safely should be left to local leaders, just as it was during the early phases of the pandemic.

"For decades now in Springfield, our school leadership across the state has fought one battle after another over state mandates," said Kyle Thompson, the regional superintendent for Region 11 in east-central Illinois. "Our politicians at the state capitol are often well intentioned when they

the curriculum we provide, the meals we serve, our dress codes and much more. However, too often they don't realize the costs that come from these more isolated decisions. Under COVID-19, mandates have become politically polarizing and our students are suffering as a result of it.'

"My district did choose to follow the mandate, by a 4-3 vote," he said. "Quite honestly, this decision was one made out of fear of this organization and the consequences associated. I'm before you today to add to our daily demands over express that fear is no way to er school districts? Generally

govern, and fear is no way to lead.'

Since that vote. Gordon said, he and members of the Bluford school board have been targets of harsh criticism in the community.

"I wish to express the current situation created by Springfield is untenable in many school districts across the state," he said. "Good people are leaving as a result of this."

But not all superintendents who spoke opposed the mask mandate or ISBE's enforcement of it.

Sheri Smith, superintendent of the Forrestville Valley School District in northwest Illinois, argued that putting districts on probation might be too lenient because it actually gives districts additional time to continue defying the executive order.

'Why do I care about oth-

"However, without immediate consequence and accountability, superintendents and local school boards are left to once again navigate impossible scenarios. Probationary status does not limit a school's ability to participate in (interscholastic) events. That means locally we're left to determine if our students are placed in undue risk by participating with noncompliant districts.'

Those statements during the public comment portion of the board's meeting. The board took no further action on the mask mandate, and Ayala gave no indication that she intends to ease up on the enforcement of it.

"We Mark Gridley and FHN infection preventionist Margie Kochsmier talk about the delta variant of the COVID-19 virus and the importance of slowing down the spread of infection in the latest FHN COVID-19 update video available at www.fhn.org/ coronavirus.

Gridley said state laboratories have identified cases of the COVID-19 delta variant in northwest Illinois, and that local case numbers and hospitalizations are rising.

"We are doubling down on precautions to help stop the spread of the virus," Gridley said, noting that the vast majority of FHN team members and providers are vaccinated and that masks must be worn

are using all of our tools, the most important of which is vaccinations, to protect the health and safety of our patients and communities.'

According to Kochsmier, vaccines are the key to stopping the spread of COVID-19 - and the way to stop the virus from mutating into more transmissible strains like the delta variant.

"The more opportunity we give a virus to spread, the more it will mutate and become stronger," she said. 'When most people have been vaccinated, the virus has nowhere to go."

Though vaccinated people can contract a "breakthrough" case of COVID-19, their bodies are better prepared to fight

off the virus, Kochsmier said. "The vaccination has been

very successful in preventing more severe illness and death," she said.

"Right now, the best thing we can do to protect ourselves and our loved ones especially children younger than 12, who can't yet get the vaccine - is to get vaccinated and take the proper precautions when needed," Kochsmier said. "Wear a mask, have good hand hygiene, stay away from crowds and if you spend time inside, like children in a classroom, have a window open to increase airflow throughout the room."

Northwestern Illinois Community Action Agency announces the start of the **PY22 Energy Assistance Program**

Northwestern Illinois Community Action Agency, as administrator of the Home Energy Assistance Program in Stephenson and Jo Daviess Counties, is pleased to announce that funds are available to assist income-eligible households with their natural gas, propane, and electric bills, and LIHEAP eligible homeowners with furnace assistance.

The program will begin September 1, 2021 for all income-eligible households. Applications will be taken on a first-come first-served basis through May 31, 2022. There will be no priority groups this program year. All households in need are encouraged to apply. Propane customers are encouraged to apply when the program opens in September to take advantage of lower propane prices.

Applicants may apply for a DVP payment or the PIPP program. The Direct Vendor Payment (DVP) provides a one-time benefit payment for income eligible households to gas or propane and electric utilities and for reconnection assistance.

Applicants with ComEd and /or Nicor Gas as utility providers may have the option of choosing the Percentage of Income Payment Plan (PIPP) instead of the DVP. The PIPP program is a bill payment program that assists eligible customers by paying a monthly state benefit while the customer pays a monthly payment based on a percentage of their household income. PIPP applications will be taken on a first-come first served basis until March 31, 2022 or until NICAA has reached maximum capacity of households for the program.

Completed application packets and documents must be submitted by mail, email, drop box, or fax. Limited appointments for special needs may be made, depending on current conditions.

½ C. fresh baby spinach 8 slices bread, crusts removed

In a small bowl, combine chicken, egg, pineapple, mayo, salt and pepper. Cover and refrigerate for at least an hour. Just before serving, stir in pecans. Place spinach on four slices of bread; top with chicken salad and remaining bread. Cut sandwiches into quarters.

Baked Chicken and Zucchini

Two weeks ago this chicken and zucchini recipe was published. The column writer messed up. One of my friends called and asked how come there were two different amounts for the zucchini. I have no idea what happened, and my proofreader (me) missed it also. Here is the corrected recipe. My friend made it and loved it;

I hope you try it and like it oil until crisp-tender; drain. too.

1 egg 1 T. water

3/4 t. salt, divided

1/8 t. pepper 1 C. dry breadcrumbs

4 boneless skinless chicken breast halves

4 T. olive oil, divided

5 medium zucchini, sliced 4 medium tomatoes, sliced

1 C. shredded mozzarella cheese, divided

2 t. minced fresh basil

In a shallow bowl, beat egg, water, ½ t. salt and the pepper. Set aside 2 T. breadcrumbs. Place remaining crumbs in large shallow dish. Dip chicken into egg mixture, then place in crumbs and turn to coat. In a large skillet, cook the chicken in 2 T. oil until golden brown, two to three minutes per side; remove and set aside. In the same skillet, sauté zucchini in remaining

Transfer to a greased 9-by-13 baking dish. Sprinkle the reserved breadcrumbs over the zucchini. Top with tomato slices; sprinkle with ½ cup mozzarella cheese, basil and remaining salt. Top with chicken. Cover and bake at 400 until a thermometer reads 170 — about 25 minutes. Uncover; sprinkle with remaining cheese. Bake until cheese is melted —about 10

Lemon Poppy Seed Cake

I have several recipes that use pudding in Bundt cakes. I think it gives an extra moistness to them. This pudding gives this cake extra citrus flavor. If you put it on a cake stand, it is a beautiful dessert.

1 pkg. (15.24 oz.) yellow cake mix

1 pkg. (3.4 oz.) instant lemon pudding

3 eggs

½ C. oil

1 T. poppy seeds

½ C. canned vanilla frost-

Lemon slices, raspberries, mint sprigs for garnish

Preheat oven to 350. Coat 10-C. Bundt pan with baking spray with flour. On low speed, beat cake mix, dry pudding mix, 1 C. water, eggs and oil until blended,

about 30 seconds; on medium speed beat two minutes. Fold in poppy seeds; transfer batter to pan. Bake until toothpick inserted near center comes out clean, 35 to 40 minutes. Let cool 15 minutes. Transfer from pan to rack; let cool completely.

microwave-safe In bowl, microwave frosting in five-second intervals, stirring until melted and smooth. Transfer cake to a serving plate. Drizzle with glaze and garnish with lemon slices, fresh raspberries and mint sprigs.

Root Beer Float Sheet Cake

This sheet cake is easy to make and tastes like a root beer float. Serve it with ice cream, and it is really a great dessert! Just a reminder: Place bowl and beaters in freezer before whipping cream.

1 (16.25 oz.) box white cake mix

11/4 C. root beer (not diet) ¹/₄ C. vegetable oil

3 eggs

1/4 t. ground cardamom

1/4 t. ground allspice

2 C. cold heavy whipping

1/4 C. powdered sugar

½ t. vanilla

½ C. chopped roasted pea-

Preheat the oven to 350.

Spray rimmed baking sheet with cooking spray with flour. In a large bowl, whisk together the cake mix, root beer, oil, eggs, cardamom and allspice until smooth, about two minutes. Pour batter into prepared pan. Bake until a wooden pick inserted in center comes out clean, about 20 minutes. Let cool completely

In large bowl, beat cream with a mixer at medium speed until thickened. Add powdered sugar and vanilla; beat at high speed until light and fluffy. Spread onto cooled cake; sprinkle with peanuts.
