Fatal crash under investigation

On Tuesday, Sept. 14, at approximately 5:40 a.m., the Huntley Police Department responded to a single vehicle traffic crash off the roadway of Charles Sass Parkway, east of the retention pond. The preliminary investigation revealed that a 2007 GMC pickup truck was traveling westbound on Charles Sass Parkway near the curve when it left the roadway, struck a light pole and rolled partially into the shallow retention pond.

The sole occupant of the GMC was ejected from the vehicle and found deceased near the water. The driver's identity was not being released as of press time pending further investigation.

This traffic crash is currently under investigation by the Huntley Police Department, with assistance from the McHenry County Coroner's Office.

Mortgage-burning celebration at church

The First United Methodist Church of Belvidere held a ceremony on Sunday, Sept. 12, to celebrate their financial freedom. They have just paid off the mortgage that allowed them to construct a new church at their present location on Bonus Avenue. The district superintendent, Rev. Fabiola Grandon-Mayor, came to the service to give a special message.

"Paying off a church mortgage is a major accomplishment," she said. "We are called to generosity and gratitude at all times. This congregation is now debt-free and today is the beginning of a new chapter for this congre-

gation." At the end of the service, Pastor Jim Bell set fire to a replica of the actual mortgage note and the Emerge praise team and dance team performed in celebration. Everyone filed out past tables of food and took their brunch outside to eat in fellowship under the shelter of tents. Ken Terrinoni said a few words, kids played and adults chatted or answered trivia questions.

The history of the First United Methodist Church began before Belvidere was a town or even a village. In 1836, Methodists of this area were holding their worship services in the homes of the several pioneers of Methodist

in the wilderness where Native Americans still roamed the northern prairies.

Early in 1838, these Methodists felt the need of services of a regular pastor and of a church building. The Rev. Jesse Walker was appointed and became the first Belvidere Methodist pastor. Building a church was not easy. Much of the material had to be brought overland from Chicago by team and wagon, making it difficult and costly work. Mr. Samuel Longcor provided financial backing for the erection of the new church, which was finished before the year was out.

Within 10 years, the small building would no longer house the membership of a growing community and plans were made for a larger structure. In 1850, a new brick building was built, located on the corner of North Main and East Perry streets.

In 1866, it was deemed advisable to have a separate church on the south side of the Kishwaukee River. In April of that year, 29 families took their letters and formed a south side congregation, calling themselves the Second Methodist Episcopal Church of Belvidere.

Later that same year, they completed their building, which was located at the

Canine Shep back on the job; tracks, finds missing child

It didn't take one of the police department's two canines, Shep, long to resume earning his keep after an extended time away from the job.

Police Chief Shane Woody was giving the Committee of the Whole his monthly report on activities at the police department, when he mentioned that Shep was back on duty.

"Recently, we had a report of a missing 13-year-old child that Shep was able to track and locate," he said. "That is a perfect example of why these canines are beneficial to the communi-

Shep had undergone surgery and then follow-up surgery to correct a related problem before he was able to rejoin his handler, Officer Zach Reese, on patrol. Given the medical difficulties, Woody said the dog did have some restrictions attached to his returning to work.

The department now has the full, two-dog complement in its canine division with the addition of Solo. The chief said Solo had graduated from training and would be "going into deployment in the near future." Solo's handler is Officer Rich Zaph. He replaced Frank Sinatra, better known as Franky, who retired and was sold to his former handler, Officer Brandon tional Night Out, a nationwide Parker, who also retired earlier

"It looks like we made a good investment in Canine Shep,' Mayor Clint Morris said.

Yes, he rebounded quite well," Woody responded. "We were concerned about the infection scare, but he seems to have gotten over that quite nicely."

The chief also made the following points in his report:

 Since his last presentation to the committee, he said the department swore in four new officers, three laterals and one entry level. He added that he appreciated the aldermen who were able to attend the ceremony.

The department has equipped about 98 percent of its officers with body cameras. "Just a couple more squad cars need to be equipped with what they need," he said.

 Another police academy has started at the Public Safety Building. "We are doing it a little bit differently this time," he explained. "There has been some interest in the Hispanic community. Some members of that community only speak Spanish, or mostly Spanish. So Deputy Chief Matt Wallace has considered how we can accommodate that."

 Police participated Aug. 3 in the local observance of Naevent started in 1984 to enhance the relationship between law enforcement officers and the community. Woody said participation from the community was down a bit this year.

Alderman Dan Snow said he wasn't aware National Night Out was held that day. He suggested Woody provide more of an advanced announcement when that event was coming, saying that might encourage better attendance.

Woody replied he would do that. But he added some of the lack of participation was for reasons other than the lack of advance announcements.

SWAT rifles

In another police-related matter. the committee voted 8-1 with Alderman Marsha Freeman dissenting to purchase two Daniel Defense 5.56-millemeter, 14.5-inch barreled rifles for the Special Weapons And Tactics (SWAT) team, at a cost

"When I initially requested to purchase these rifles five years ago, my request was to purchase two a year for four years, in order to outfit our eight-person SWAT team," Woody recalled. "At that time, I also informed the council that the SWAT team was using rifles with a 20-inch barrel and an overall length of

it difficult to traverse terrain inside houses, businesses and other structures found in an urban area. Going to a shorter barreled rifle allowed the team to move through the terrain much easier, while still having the benefits of

If approved, he said, the outfitting of all SWAT operators with rifles conducive to urban environments will be complet-

Freeman said she looked at some videos and found "they're pretty bad rifles.'

She also looked at reports and the SWAT team was only deployed five times in the last two years. Three of those five times were to serve warrants. "So I'm not sure each eight-member SWAT team needs one of these certified automatic weapons."

Woody replied, "First of all they're semi-automatic, not automatic. They fire one round at

After reiterating what had been stated in the memorandum received by the committee, he added, "Yes, it is important to have all of the officers have one of these rifles. You can't always count on the same eight officers being at an incident."

City council at its Sept. 7 meeting voted 9-0 to approve purchase of the rifles.

Church streets. In a little more than a year, its membership doubled. In 1880, the church had moved from Main and Church to Logan and Whitney Boulevard. Church services were held in both the north and south side churches until they

corner of South Main and united in the south side church in 1855

In 1891 construction began on a new church building, built of brick in Venetian-style. Two years later, it was finished and dedicated on Feb. 12, 1893. On the cold, bright day of Jan. 12, 2003, the church members held

a groundbreaking ceremony at its present location of 610 Bonus Ave. Having purchased 17 1/2 acres of land, construction began soon afterwards. The decommissioning of the Logan and Whitney church was held on June 27, 2004, concluding with a procession to the new

church, and the first services at the Bonus Avenue church were held on July 4, 2004. Dedication of that building was Sept. 12 of that year. It has been God's continual direction and guidance that has allowed our Beacon of Light to shine within our community.
