Valerie Brudi, a club leader in Jo Daviess County, was recently named to the Illinois 4-H Hall of Fame for her leadership and mentoring role as a volunteer.

The hall of fame honors volunteers and former staff members for their dedication to the University of Illinois Extension 4-H youth development program. Brudi was nominated by Jo Daviess County Extension staff and is one of 71 people who were recognized during a virtual ceremony last month.

Brudi has been a volunteer with the Jo Daviess County 4-H program for 11 years, serving in roles including club leader, horse superintendent, swine superintendent and awards committee member.

In her role as a club leader, she offers support and counsel to the club organizational leader and 4-H families. Some of her duties as a club leader include assisting with club meetings and activities, helping to recruit

new youth, helping to organize club officers and helping 4-H youth stay updated on deadlines and 4-H opportunities.

“Valerie is a dedicated 4-H leader, valued volunteer and a proud parent to four children. Three of her children are still active 4-H,” Angela Miller, University of Illinois Extension 4-H youth development program coordinator, said in a news release. “Valerie does so much behind the scenes for our program and is one of those volunteers that I have on speed-dial because she is always willing to lend a hand no matter the circumstance.”

Historical exhibit highlights influential women

The Lena Historical Society museum will be open from 1 p.m. to 4 p.m. Saturday, Sept. 18, for visitors to enjoy a new exhibit, “Impacting History: Lena Women Who Made Their Mark.”

The 10 women featured, all born in the 19th century, probably aren’t known by most Lena citizens, said Sharon

Welton, executive director of the Stephenson County Historical Museum.

“The women were chosen because they did things that, for the time, took courage; they helped pave the way toward women’s equality,” Welton said. “They did work that was mostly thought to be ‘men’s work.’ Many went on to do these things outside of Lena, but they all considered Lena their home and all are buried here.”

The women are Mary Ann Curtis, Martha Burbridge, Mary Buss, Rachel Schermerhorn, Elvira Montague, Lucinda McEathron, Nellie Snider, Beulah Shoemith, Rosalie Taylor and Helen Cooper.

The exhibit will be on display until the summer of 2023.

Museum readies for public art installation

Officials at the Freeport Art Museum have announced the planned Sept. 29 installation of Atlanta-based artist Corrina Sephora's site-specific sculpture, "Bridge Beyond Time: Past, Present and Future" at the Freeport Arts Plaza located at the corner of Douglas Street and Chicago Avenue in downtown Freeport.

In Sephora's words, "The installation represents the meaningful journey of inclusion that the museum, plaza and community have traveled over time. The sculptural components of the installation will represent the plaza's past, which is "anchored in

the generosity" of Jack Myers, who donated the land, its present role as a civic space for the community to gather and enjoy arts and culture, and its future as a space to facilitate artistic growth and community engagement," she said in a news release.

The sculpture is comprised of three rowboats, which are elevated 14 feet to 16 feet in the air and supported by elongated oars that run from the boats to the ground. It will be installed near the northwest corner of the plaza's greenspace.

Sephora described the artwork as a bridge connecting the larger Freeport commu-

nity to the museum in that it links the interior to the exterior by bringing the art experience outside of the institution.

Sephora specializes in metal sculpture, painting and installation. She draws inspiration from the natural and spiritual worlds and often includes imagery from the surrounding environment and community, the release said. Sephora works with themes of loss, life and transformation within the context of contemporary society and personal reflection.

For Sephora, public art "allows for art to be accessible and attainable for the entire community," she said.

"Through nautical and natural symbolism such as boats, oars, and trees, my sculptures engage the imagination of each viewer to create their own story," Sephora said.

The mixed-metal sculpture will be a permanent fixture at the plaza.

The museum worked with a public art committee that included several members of the community who helped select Sephora's proposal from more than 30 artists who submitted their qualifications. The artist fees for the creation of the sculpture were partially funded through an Our Town grant through the National Endowment for the Arts and proceeds from this year's Paint the Port event will help finance installation costs.

"It has been a pleasure working with Corrina on this exciting element for the arts plaza," museum Director Jessica Modica said in the release. "This is just one of the many pieces of art planned for the space, which will include interactive sculptures

and large mural installations. Together, these will create a place where Freeport can display its art and history in a highly visible, public setting."

Established in 1975, the Freeport Art Museum has a collection of more than 4,000 artifacts from all continents and all time periods.

The museum is located at

121 N. Harlem Ave. and is open 10 a.m. to 5 p.m. Tuesday through Friday and noon to 5 p.m. Saturday. Tours may be scheduled by calling 815-235-9755.

Bird count shows diminishing numbers

Eagle Nature Foundation President and Executive Director Terrence Ingram conducted his sixth Fall Big Bird Day on Saturday, Sept. 4.

Ingram started the annual bird count in 2016 "to document the loss of birds to the agricultural sprays and the devastation that they have been causing to our bird life in the area," he said in a news release.

Each year Ingram is seeing fewer and fewer birds, he said

in the release.

This year he was able to see 111 birds of 31 different species. This is in comparison to last year's count of 33 different species, the second year's count of 42 species, and the first year's count of 230 birds of 54 different species.

"Before that there had always been many more birds and bird species in the fall," Ingram said.

Only one bird of each of 12 species were seen: Ameri-

can kestrel, great-horned owl, flicker, red-bellied woodpecker, hairy woodpecker, downy woodpecker, eastern wood pewee, catbird, robin, house wren, orchard oriole and goldfinch.

Two birds of seven different species were seen: ruby-throated hummingbirds, red-headed woodpeckers, bank swallows, purple martins, crows, white-breasted nuthatch and cardinals. Three birds of two species were seen — mourning doves and black-capped chickadees.

There were four starlings, four rock doves and four blue jays seen. Six birds each of barn swallows and house finches were seen, along with eight house sparrows.

The most birds of any species seen were a flock of 15 Eurasian collared doves, a flock of 12 tree swallows, a flock of 10 chimney swifts and a flock of 10 cedar waxwings.

Bird families not seen during this Big Bird Day include hawks, ducks, geese, cuckoos, titmice, warblers, vireos and kinglets.

"The agricultural sprays have got to be stopped ... Not only are these sprays killing the birds, they are killing the insects as well," Ingram said.

He said he has not been able to keep any honeybee

Gather up unwanted items for Oct. 2 recycling event

Northern Illinois residents and businesses are invited to participate in a recycling and paper shred event set for 9 a.m. to noon Saturday, Oct. 2, at the Carroll County Highway Department just off Route 64 at 10735 Mill Road, Mount Carroll.

The Jo-Carroll Solid Waste Agency is organizing the event.

Several categories of items collected at the event include fees to cover a portion of recycling expenses, while some categories are free.

Paint, tires and household hazardous waste items will not

be accepted.

A recycling fee of 70 cents per pound will be charged for all small household, rechargeable and power unit batteries. These batteries will be weighed at the event to determine the recycling fee amount due. Large lead-acid batteries will be accepted for free.

Electronics with a screen of any kind will be collected for a \$25 fee per item. This includes computer monitors/screens, laptops and all types of TVs. Large household appliances will be accepted for \$10 each, including refrigerators, washers, dryers, stoves, air conditioners, dehumidifiers and microwaves.

Paper shredding is also being offered with a \$5 fee per participating household or business. No magazines, newspapers, inserts, paper clips or binder clips are allowed among the papers to be shredded.

Trumpers have a point: We deserve better than what we're getting in Washington

We live in Trump country. Seven of 10 voters in our respective central Illinois counties voted for Donald Trump in the 2020 presidential election. We are not Trump fans, yet many of our friends are. Trump will go away; his base won't, so what gives with our friends?

Based on chats and overheard conversations over

the past year at our Legion post, country club, pubs, coffee shops and outdoor cookouts, we sum up here the continuing Trump loyalties, as we have heard them, but in our words. Our Trump friends range from working stiffs to successful entrepreneurs living in once-proud, now hollowed-out cities like Peoria and Decatur. As both of us are retired, our sample is skewed toward the mature set, yet not wholly so.

Our overall "finding" is that of a profound disenchantment with America's political, business, academic and social policy leadership, across both political parties — our elites, you might say. The roots of disenchantment go back as far as the Vietnam War,

House passes energy bill with labor, environmental groups on board

Measure heads to Senate

The Illinois House approved an energy regulation and decarbonization bill Sept. 9, a major step forward for a wide-ranging omnibus bill that had eluded lawmakers throughout the legislative session and the governor's three years in office.

The measure that aims to bring Illinois' energy generation sector to 100 percent carbon-free by 2050 and 50 percent renewable by 2040 will still need approval from the Senate, which planned to caucus Sept. 10 to discuss the measure, Senate Bill 2408, before a Monday return.

It passed the House 83-33 shortly before 9:30 p.m. Sept. 9. Gov. JB Pritzker quickly issued a news release saying he would sign it.

"This is what legislating is supposed to look like," House Speaker Emanuel "Chris" Welch, D-Hillside, said in closing floor debate. "It's about good faith negotiating. It's about advocating for the interests in our districts back home. And it's about compromise in order to arrive at a product that benefits people in your districts, and ours."

Environmental groups extolled the decarbonization language, which aims to take coal, gas and other carbon-emitting power plants off the grid between 2030 and 2045, depending on the energy source and ownership structure.

Union groups praised the bill's language requiring that all major renewable construction projects must have project labor agreements in place to hire union labor, while non-residential projects, with few exceptions, would be required to pay a prevailing wage.

Republicans, meanwhile, warned of losses of downstate jobs, substantial consumer bill increases and potential grid reliability issues as fossil fuel plants are forced offline, although it passed on a bipartisan roll call.

Decarbonization, renewables

Environmental and labor groups were in opposition on the issue of municipal coal-fired power plants coming into Sept. 9. Two plants that were at issue include Springfield's City, Water, Light and Power, and a plant funded by several municipalities in Illinois that is located in Marissa in the Metro East Area, called the Prairie State Energy Campus.

The final language requires the plants to be carbon-free by 2045, either by going offline or installing sequestration technology. By 2035, municipal plants must cut emissions by 45 percent. If a plant doesn't

meet that goal by the end of 2035, the power plant will have until June 30, 2038 to either retire a portion of carbon-emitting units or meet the decarbonization goal some other way.

The bill also provides more than \$600 million over five years to three nuclear plants owned by Exelon Corporation—in Byron, Dresden and Braidwood. The company has stated it will not refuel the Byron plant after Monday, and it would begin decommissioning at that time, unless the General Assembly passed legislation to ensure its financial viability.

All told, negotiators believe the new bill is expected to raise residential electric bills by about 3-4 percent, commercial bills by about 5-6 percent, and industrial bills by about 7-8 percent, although the roll-out for the various programs would be staggered over time and increases would vary by year.

The ratepayer money will fund equity programs for the clean energy workforce and new investment in renewable energy, among other initiatives.

It would also incentivize the transition of coal plants to solar facilities or battery storage sites, and it permits downstate utility Ameren to establish two utility-scale solar plants.

In a late addition to the bill, the city of Zion in Lake County, which is the site of a closed nuclear plant, would be eligible for grants "in proportional shares of \$15 per kilogram of spent nuclear fuel stored at such a facility," according to the bill.

The charge on a customer bill for renewables would increase over time from about 2 percent to 4 percent, a \$360 million annual increase to fund projects such as wind and solar.

That investment is an effort to increase the portion of the

state's energy contributed by renewables, which is currently between 7 and 8 percent. Nuclear made up about 58 percent of the state's electricity generation in 2020, according to the U.S. Energy Information Administration.


Downstate Republican lawmakers raised concerns that the portion of the state south of Interstate-80, on the MISO electric grid, is served by only one nuclear plant. The part of the state on the PJM grid, for the most part north of I-80, has the state's other five nuclear plants.

"You're not doing what you think you're doing with this bill," Rep. Tim Butler, R-Springfield, said in floor debate, warning that closing the Springfield and Marissa coal plants would make downstate reliant on out-of-state coal while putting central Illinoisians out of work.

Ethics bill clears House on second try, will head back to governor

Vote to accept Pritzker's changes passes on party lines

The Illinois House on Sept. 9 voted to accept changes to an ethics bill that Gov. JB Pritzker had requested, paving the way for it to become law once the governor signs it.

The vote came a little more than a week after an earlier attempt fell short in the House. That happened during a late-night session Tuesday, Aug. 31, after many Democrats had left the Capitol following a one-day special session that was called mainly to reconsider a legislative redistricting plan.

But Rep. Kelly Burke, D-Evergreen Park, renewed her motion Sept. 9 at the start of another one-day session that was called mainly to consider a comprehensive energy package. This time, with nearly all House members present, the measure passed, 74-41, largely along party lines. Reps. Amy Elik, R-Alton, and Jeff Keicher, R-Sycamore, were the only Republicans to vote yes.

Senate Bill 539 originally cleared both chambers during the spring session by overwhelming margins, 56-0 in the Senate and 113-5 in the House, even though Republicans at the time complained on the floor that it had been watered down. But it contained enough reforms, such as increased financial disclosure requirements and limits on the ability of elected officials to lobby other units of government, so that many lawmakers said they believed it was the best they could get at the time.

But a few weeks after it passed, on July 14, the General Assembly's top ethics watchdog, Legislative Inspector General Carol Pope, submitted her intent to resign by Dec. 15, saying the bill would actually weaken her office by

limiting the types of investigations she could conduct.

Among other things, the bill gives the LIG independent authority to launch investigations, but only upon the filing of a formal complaint. Currently, investigations must first be authorized by a bipartisan group of lawmakers known as the Legislative Ethics Commission.

But it also limits the office's authority to only investigate matters related to a person's government service or employment, not outside activity. As a result, Pope said in her letter, the LIG would not be allowed to investigate "conduct unbecoming a legislator that results from such things as posting revenge porn on social media, failure to pay income taxes on non-legislative income, and other conduct that I and the public think the LIG should be able to investigate."

"This legislative session demonstrated true ethics reform is not a priority," Pope wrote. "The LIG has no real power to effect change or shine a light on ethics violations, the position is essentially a paper tiger."

In response, many Republicans called on Pritzker to issue an "amendatory veto" by asking lawmakers to strike the language that prompted Pope's resignation. Instead, though, Pritzker issued a different amendatory veto, asking lawmakers to delete language related to the executive inspector general.

When that veto came back to the General Assembly Aug. 31, the Senate accepted Pritzker's request unanimously, 58-0. But in the House, Republicans pulled their support while several Democrats had already left the building, leaving the amended bill with only 59 votes, far short of the 71 votes needed to pass.

"I just want to remind the members that we have an excellent bill that has many needed reforms and it was overwhelmingly supported by Republicans in the House and Senate, and in fact, on the

motion in the Senate (to accept the governor's amendatory veto) it was unanimously supported," Burke said during debate on the House floor.

The bill originally came about in response to several high-profile scandals in recent years, including the indictment of Rep. Luis Arroyo, D-Chicago, who has since resigned. He also had a lobbying business that lobbied the city of Chicago and he was charged with attempting to bribe a state senator to support legislation that would have benefitted his client.

One of the provisions of SB 539 prohibits elected officials, including lawmakers, from engaging in "compensated lobbying" of other units of government, with the exception of Chicago municipal government. That was a carve-out specifically requested by Chicago city officials who argued that the city's own lobbying regulations were already stronger than those in the bill.

But Rep. Blaine Wilhour, R-Beecher City, urged rejecting the governor's amendment and returning to negotiations over a stronger ethics bill.

"There's a lot of talk from your (Democratic) side of the aisle about how this is just a start and we need to do more and, you know, yada, yada, yada, everything else," he said to Burke on the House floor. "I don't think anybody has ever really answered, what's keeping us from doing more right now? ... Do we not know what needs to be done? I mean, what's keeping us from giving the legislative inspector general the power that the last three say that they need to be to be the proper watchdogs over this body?"

Burke, however, replied that SB539 was the bill that lawmakers had approved during the spring session. She also said the House has a standing committee that deals with ethics and that it will continue to work on other bills when lawmakers return for the 2022 session.

Stockton football defeats Pearl City, falls to Dakota

After dropping the season opener to Forreston, the Stockton Blackhawks managed to bounce back in week two with a win over the Eastland-Pearl City Wildcatz.

The game got off to a bit of a slow start as both teams were still settling in through the first quarter. The excitement began in the second quarter, when Stockton jumped out to the first lead of the evening.

Quarterback Caleb Mammoser connected with his favorite target in Drew Mensendike for an 11-yard touchdown pass with just over seven minutes left in the second quarter. The passing duo tried to reconnect on the two-point conversion but failed, leaving the Blackhawks with a 6-0 lead.

The Wolves managed to take their first lead in the evening with a successful drive just before halftime. EPC matched Stockton with a passing touchdown of their own as their quarterback connected on a 17-yard score. A successful point-after attempt allowed the Wildcatz to take a 7-6 lead with just over a minute left until half. The slim lead would hold, as the Blackhawks went into the break trailing 7-6.

Stockton got the first points of the second half, as well, when Jace Phillips plunged into the end zone from five yards out. The Blackhawks failed the point after conversion, and held a five-point lead, up 12-7.

EPC would respond, however. Early in the fourth quarter, the Catz' quarterback scrambled for a five-yard touchdown,

allowing EPC to retake the lead.

Stockton would only surrender the lead for less than two minutes, though, as Karl Hubb ran in a 21-one-yard touchdown with nine minutes left in regulation. Up 18-13, the Blackhawks would hold onto their five-point advantage for the remainder of the game.

Parker Luke led the team in total yards with 70 yards rushing on 14 attempts. Phillips was close behind with 62 yards and a score on the ground. Hubb had just seven carries for 42 yards, but he had the biggest run of the night as his fourth

quarter score gave the Blackhawks their first win of the season. Mammoser was just one of six through the air, but that one completion was essential as the score was crucial in their victory.

A week later, Stockton found themselves facing another tough opponent as they traveled to face off with the Dakota Indians on Sept. 10. The Blackhawks were in for another draining game, as it was the second game in a row that would come down to a one-score difference.

The Stockton offense struggled to get the ball moving all

night as they averaged a little under four yards-per-play on the evening. A trio of turnovers cost the Blackhawks, as three fumbles lost made it nearly impossible for Stockton to gather any lasting momentum.

Dakota jumped out to an early lead with a long touchdown run with just under four minutes left in the first quarter. Their 8-0 lead would hold all the way through the halftime break.

The Indians would expand their lead in the third quarter as another long touchdown run and a failed two-point conversion allowed them to go up 14-

0. The Blackhawks would attempt to claw their way back, but time was ticking down on their comeback hopes. Phillips plunged into the end zone from three yards out for Stockton's first score of the night. That touchdown did not come until there was just 5:25 left in the fourth quarter, however, as the clock eventually struck zero and the Blackhawks' hopes ran out.

Stockton could not get the run game going last Friday. Phillips led the team with just 23 yards and one score on 11 attempts. The Blackhawks

managed to find some success through the air, as Mammoser completed eight of his 14 passes for 116 yards. Mensendike was the favorite target with three receptions for 41 yards. Colby Tucker had Stockton's biggest play of the evening with a 50-yard pass reception.

Despite the success through the air, head coach Matt Leitzen's offense was unable to capitalize for most of the night. The Blackhawks fell by a score of 14-6 as they dropped to 1-2 on the season. They will be back in action on Friday, Sept. 17, with another tough opponent in the Galena Pirates.

Stockton girls holding their own in competitive volleyball season

The Stockton Blackhawks are off to a solid start in their 2021 volleyball campaign. After posting a 6-9 overall record and going 5-7 in conference play in the alternate spring season, the Blackhawks appeared hopeful to improve on those numbers this fall. They have already eclipsed their spring win total and they are doing so with a younger roster. With just three seniors on the varsity roster in Vanessa Ernst, Kenze Haas and Brynn Haas, a number of underclassmen have earned significant playing time.





The not so skinny cook

We have had a lot of beautiful weather this past week. If we could have a fall like these past few days for a couple of months, I would be a happy camper. We still are able to have some garden vegetables, and apple orchards are opening up. I love the smell of cinnamon in the air. This

week's recipes are full of fun cooking.

Red Pepper Jelly

A quick and delicious appetizer is red pepper jelly over softened cream cheese. Serve it on a pretty glass plate with a butter knife and assorted crackers, and everyone will dive into it.

Note: An example of a non-reactive pan is stainless steel; the next two recipes call for the use of one.

- 1 jar (18 oz.) apple jelly
- 1 fresh jalapeño, seeded and minced
- ½ C. chopped red pepper
- ½ C. honey

5 T. apple cider vinegar
¼ t. crushed red pepper
In a medium nonreactive saucepan, bring all ingredients to a boil over medium-high heat; cook, stirring occasionally for five minutes. Divide mixture among 1 C. canning jars, and let cool to room temperature. Refrigerate for at least 12 hours or up to two weeks.

Pickled Tomatoes

Someone asked if I had a recipe for pickled tomatoes. I found one in one of my cooking magazines. They really like pickled things and had a lot of tomatoes, so they won-

dered if they could pickle. Let me know if it is something we all should be trying.

- 1 C. apple cider vinegar
- ¼ C. water
- 4 t. kosher salt
- 2 t. sugar
- 12 ounces assorted cherry or grape tomatoes
- 3 lemon rind strips
- 8 sprigs of thyme
- 4 cloves garlic
- ¼ t. crushed red pepper

In a small nonreactive saucepan, bring vinegar, ¼ C. water, salt and sugar to a boil over medium high heat. Remove from heat. In a quart-size, wide-mouth canning jar, layer tomatoes, lemon rind strips, thyme, garlic and red

pepper. Pour vinegar mixture onto tomatoes. Cover and let stand at room temperature for one hour. Refrigerate for at least 24 hours or up to one week.

Roasted Tomatoes with Summer Vegetables

If you are at the end of garden vegetables, this recipe will help you serve them in a unique way. If you don't have fresh lima beans or corn, you can thaw frozen vegetables. It is great to use these beautiful garden-fresh tomatoes while we still can.

- 8 tomatoes (8 to 10 oz. each), cored
- Olive oil
- Salt and pepper
- 1 strip bacon, diced
- 1 C. diced red pepper
- 1 C. corn kernels
- 1 C. lima beans
- 1 C. diced red onion

Preheat oven to 425; brush tomatoes with oil and season with salt and pepper. Transfer to a shallow roasting pan. Roast tomatoes until soft to the touch, five minutes. Transfer tomatoes to a cutting board. When cool enough to handle, scoop out seeds and center flesh to fit in vegetables. Discard seeds and flesh.

Cook bacon in a skillet until crisp. Add peppers and corn and sauté over medium-high heat until starting to soften. Add lima beans and onion. Cook until tender, three to five minutes. Season with salt and pepper; fill each tomato with vegetables (about ½ C.) Serve with a sprinkling of Parmesan cheese.

Creamy Hot Chicken Salad

Normally you would say that chicken salad is served

in a lettuce cup or on toast or even croissants. This chicken salad is a yummy casserole. Change your chicken salad thoughts and enjoy this easy casserole.

- ¼ C. coarsely crushed potato chips
- ½ C. chopped pecans
- 6 C. chopped cooked chicken (rotisserie will work)
- 2 C. shredded cheddar cheese
- 2 C. chopped celery
- 1 C. chopped red pepper
- ¼ C. sliced green onions
- 1 can cream of chicken soup
- 1 C. mayonnaise
- 1 (8 oz.) carton sour cream
- 1 t. dried thyme, crushed
- ¼ t. pepper

Preheat oven to 400. In a bowl, combine the crushed potato chips and the pecans. Set aside.

In a bowl, stir together chicken, cheese, celery, pepper and green onions. In another bowl, combine soup, mayo, sour cream, thyme and pepper. Pour soup mixture over chicken mixture; fold gently to combine. Transfer to a 3-quart rectangular baking dish. Sprinkle with potato chip topping. Bake 25 to 30 minutes or until heated through and bubbly around the edges. Serve with toasted cheese bread.

Lemon Cookie Bars

- 2½ C. flour
- ½ t. baking soda
- ½ t. salt
- 2 C. sugar
- 6 T. unsalted butter, melted
- 1/3 C. vegetable oil
- 2 oz. cream cheese, cut into 8 pieces and softened
- 1 egg plus 1 egg yolk
- 5 t. grated lemon zest plus 3 T. juice
- 2 t. vanilla

Fluoride helps defend against tooth decay

Tooth enamel, the visible outermost covering of your teeth, is the hardest substance in your body. However, once the enamel of your tooth has been lost through demineralization and decay, the body does not regenerate it. That is why a good offense strategy is so critical in maintaining the integrity of your enamel, and the MVP of your offensive team is fluoride.

While many of you are aware that fluoride helps to prevent decay, you may not understand how it serves this critical role. The process of demineralization and caries (cavity) formation begins when bacteria convert carbohydrates in your diet (especially sugars) to acids. These acids demineralize and weaken the enamel.

Your saliva will attempt to buffer or neutralize these acids and provide the calcium and phosphate ions to help prevent this demineralization. When your saliva has fluoride in it, from fluoride products like toothpaste, mouth rinses and varnish or by drinking fluoridated water, the fluoride can penetrate the

tooth enamel. Once absorbed, the fluoride bonds with the calcium and phosphate in your enamel to form fluorapatite, which makes the enamel even stronger and therefore more resistant to decay.

In addition, fluoride retards bacterial growth and tooth decay. It can even reverse tooth decay in the very earliest stages. Fluoride's demonstrated cavity prevention capabilities are recognized by numerous international health agencies, including the World Health Organization. Fluoridation of public water is considered to be one of the most successful preventative public health acts in cities throughout the world.

Numerous studies show that the earlier children are exposed to fluoride, the less likely they are to develop

cavities.

But children are not the only ones to benefit from fluoride. Adults often experience gum recession and xerostomia (lack/reduction of saliva and/or poor-quality saliva from systemic diseases and medications). Orthodontic patients at any age, patients with a history of cavities, and patients with periodontal disease (especially those who require periodontal surgery) and patients with developmental disabilities and/or physical disabilities that limit their ability to perform daily oral hygiene can all benefit from fluoride's ability to prevent the pain and destruction of decay and avoid restorative treatment.

One of the most common applications of fluoride is in the form of a varnish that is applied to the teeth following a dental cleaning. The varnish sticks to the teeth for a period of four to six hours, which allows it to be absorbed into the enamel. To make sure that the fluoride is not disturbed before it is fully incorporated into the enamel, it is imperative that

you do not eat or drink for 30 minutes following the procedure. After 30 minutes you can drink and eat soft food, but do not chew hard foods or brush your teeth for four hours. For this reason, parents of young children should make sure that they are fed and well hydrated before their dental appointment.

Your dentist may also order a prescription-strength fluoride toothpaste to be used in place of your regular toothpaste. It is beneficial to brush your teeth right before bed, so the fluoride is on your teeth longer. This is particularly important for patients with xerostomia. Floss and brush your teeth for two minutes, then spit but don't rinse.

Fluoride is a key defense in your preventative routine. If you have any questions about the appropriate amount of fluoride for you or your child, do not hesitate to contact your dentist.

Glaze

1/2 T. lemon juice
1 T. cream cheese, softened

1 C. powdered sugar

Bars: Adjust oven rack to middle position and heat oven to 325. Make foil sling for 9-by-13 baking pan by folding two long sheets of aluminum foil; first sheet should be 12 inches wide and second sheet should be 9 inches wide. Lay sheets of foil in pan perpendicular to each other, with extra foil hanging over edges of pan. Push foil into corners and up sides of pan, smoothing foil flush to pan. Spray foil with cooking oil spray.

Whisk flour, baking soda, and salt together in bowl. Whisk sugar, melted butter, oil and cream cheese together in second bowl (some lumps of cream cheese will remain but will smooth out later). Add egg and yolk, lemon zest and juice and vanilla to sugar mixture and whisk until smooth. Add flour mixture and mix with rubber spatula until just combined. Transfer batter to prepared pan, smoothing top with spatula. Bake until light golden brown and tooth pick inserted in center comes out clean, 33 to 38 minutes. Let bars cool completely in pan on wire rack, about two hours.

Glaze: Once bars are cooled, whisk lemon juice and cream cheese in bowl until combined. Add sug-

ar and whisk until smooth. Spread glaze evenly over bars. Let glaze set fully, about one hour.

Using foil overhang, lift bars out of pan and transfer to cutting board. Cut into 24 pieces and serve. Bars can be stored in airtight container at room temperature up to three days.

Berry Pretzel Fluff Dessert

This is the perfect potluck dish. It can be made ahead, and you don't have to heat up the oven to make it.

2 C. crushed pretzels (not seasoned)

3/4 C. sugar
3/4 C. butter, melted

2 pkg. (8 oz. each) softened cream cheese

1 C. whole milk ricotta cheese

1 1/2 C. powdered sugar
1 t. vanilla

1/2 t. grated lemon zest
1 C. heavy whipping cream

3 C. quartered fresh strawberries

1 1/2 C. fresh blueberries
2 T. apricot preserves

In a large bowl, toss the pretzels with sugar and melted butter. Press mixture into an ungreased 9-by-13 pan. Refrigerate 30 minutes. In a large bowl, beat cream cheese, ricotta, powdered sugar, vanilla and lemon zest until smooth. In another bowl, beat the whipping cream until soft peaks form; fold into

cream cheese mixture. Spread the mixture over pretzel layer. Refrigerate covered at least four hours. Just before serving, toss the berries with apricot preserves; sprinkle berries over the top of the dessert. You can top with whipped cream if desired.

harm. In return, Europeans look down their noses at us with barely concealed contempt.

At home, Trump fans yearn for the good old days of two-parent families, with some respect and discipline in the home. Yet, our social policy experts push Congress to adopt scores of costly social programs that appear to diss traditional family life, instead encouraging dependence on government handouts, rather than building the resilience needed in the home.

All the while, the political and economic classes reap the benefits. Washington is seen as a widening

cesspool of big-paying jobs for politicians, lawyers, lobbyists and staffers. hives alive for the past six years. If these poisons are killing the birds and the insects, they are definitely having an affect on humans as well. But maybe it will be too late when this is finally determined.

The Big Bird Day count also indicates that birds that are nesting further north also are struggling, the release said.

“Without our insect-eating

birds to help control insect populations, some of these insects will become a very real problem in the near future,” he said. “Mosquitoes, gnats, locusts and flies will be the first to get out of control. These local insect population outbreaks will expand and become widespread.

“We must work now to develop new nonchemical ways to grow our needed crops.”
