Apple Canyon Lake goes global with water safety program

The ability to swim is a life-saving skill for children and a vital tool to prevent drowning, the second leading cause of unintended, injury-related death for U.S. children ages 1-14. Research shows risk of drowning can be reduced by 88 percent if children participate in formal swimming lessons between the ages of 1-4. The World's Largest Swimming Lesson™, created by the World Waterpark Association in 2010 seeks to accomplish just that goal and is a global public relations event supported by aquatic facilities, water parks, pools, swim schools, YMCA's, among others

"We are participating in the WLSL again this year and we had 131 people come out to be a part of the event," said Apple Canyon Lake Aquatics Manager Julie Janssen.

The event requires a structured swimming curriculum, so everybody involved is taught the same lessons.

"We worked on entering the water and rules of the pool and blowing bubbles and getting our face wet, the front and back float, kicking and a front arm crawl," Janssen said. "We only had 30 minutes because it was all pretty timed out that you need to be at a certain spot in the lessons so you can hit a window and everyone across the world that was participating could be counted."

Janssen said because the event is involved with the Guinness Book of World Records there are a lot of rules.

"We had to have a minimum of 25 participants and witnesses and a sign-in sheet and we had to follow the curriculum," she said. "I was just hoping to hit that 25 and get through the day, but to go beyond that and have 131 was awesome. Everyone was so excited. Hopefully next year it will be bigger still."

ACL General Manager Shaun Nordlie said water safety is a top priority.

"We've got a pool and we've got a lake, so water activities are our main

thing out here and we want to make sure that anyone that is using those amenities knows about safety and knows what to do when they are in the water," Nordlie said.

ACL Communications and Recreation Director Cynthia Donth-Carton said the community's participation in the World's Largest Swimming Lesson highlighted their ongoing focus on water safety.

"The goal is to introduce as many people to safe swimming practices as possible," said Donth-Carton. "We know that swimming lessons save lives and Julie has done a really good job of making swimming lessons a priority for our members here at Apple Canyon Lake."

She said the entire aquatic ACL staff was involved.

"Everyone from our Aquatics manager to our life guards to our gate keepers to our pool maintenance staff had a hand in the day's success," Donth-Carton said. "It takes a lot to pull something like this off and they did very well."

Each of the water venues at ACL has its own unique group of safety issues and swimming and boater safety are always the priority.

"We have our new swimming pool and we have a lot of younger people using it," she said. It is a zero-entry pool meaning a toddler can walk into the pool because it slowly slopes to a depth of one foot."

Many of the ACL property owners choose to swim from the community's groomed Nixon Beach while others hit the water from their boats out on the lake.

"Some of the day's lessons dealt with helping someone who might be in peril right next to you," Donth-Carton said. "It's possible a situation might arise where you would just reach over and offer a hand or lifesaving device to someone who might be struggling or tiring. Lessons are always important."

Stockton Board of Education holds regular June meeting

The regular meeting of the Stockton Community Unit School District #206 was called to order at 7 p.m. on Monday, June 19, in the High School Library. Members present included Roger Groezinger, Kim Mapes, Neill Cahill, Todd Vincent, and Deb Gille. Member Kirk Schubert was absent. Nicole Haas took the oath of office to fill the vacant seat on the board. The regular and closed session minutes of May 15, 2017, and special meeting minutes of June 12, 2017 were approved 6-0 following a motion by Gille and second by Mapes. Bills totaling \$56,927.18 were approved for payment 6-0 following a motion by Gille and second by Mapes. The financial report was approved 6-0 following a motion by Groezinger and second by Mapes.

The state still owes the District over \$300,000. Technology Director Gary Baglin presented a detailed technology report complete with recent accomplished goals, future goals, and budget needs.

Dr. Gilliland reminded the board that beginning with the July 17 meeting, the start time will be 6:30 p.m. In addition, he informed the board that the Personnel Committee will meet at 5 p.m. before the July 17 meeting to discuss and make a recommendation on the 2018-2019 superintendent/principal selection process. Principal Casey Downey congratulated the Warhawk baseball team for their Regional and Sectional Championships, Emily Offenheiser for her fourth place finish in the shot and discus at the IHSA State Track Championship, and Madison Glass for her Illinois Art Education recognition. In addition, Principal Downey reported that a district-wide DCFS training was recently held, the Software Committee met with the NWEA MAP universal assessment representatives in preparation for the 2017-2018 school year, and the junior class SAT results, which were about at the state average with 22 students scoring over the state average. Principal Brad Fox congratulated Konnor Laity for winning the swimming pool pass from the Arrowhead drawing and thanked the PTO, the Stockton Park District, the Stockton Bowling Lanes, McDonald's, and Casey's for donating positive behavior rewards. In addition, Mr. Fox reported that the fourth graders visited the Mid-

dle School in preparation for the fall. In her written report, Ms. Fox thanked Ms. Alt and staff for running the Day at the Park activities, the Stockton Bowling Lanes, and the Stockton Park District for donating prizes for the End of Year Assembly, and also thanked the kitchen staff for their end of year picnic lunch preparation. 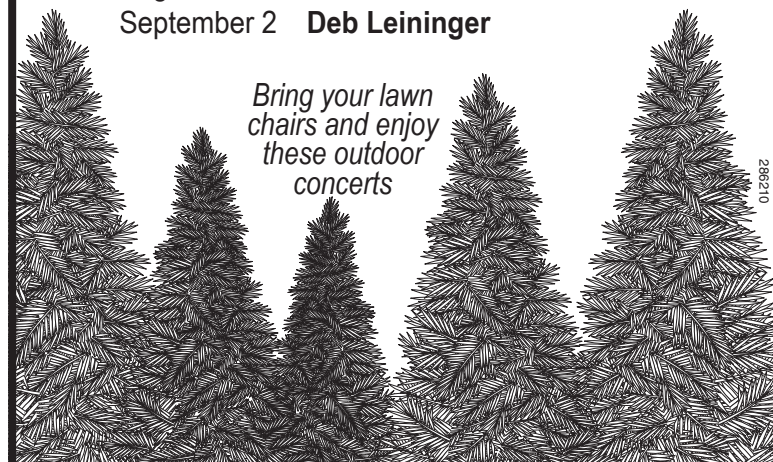

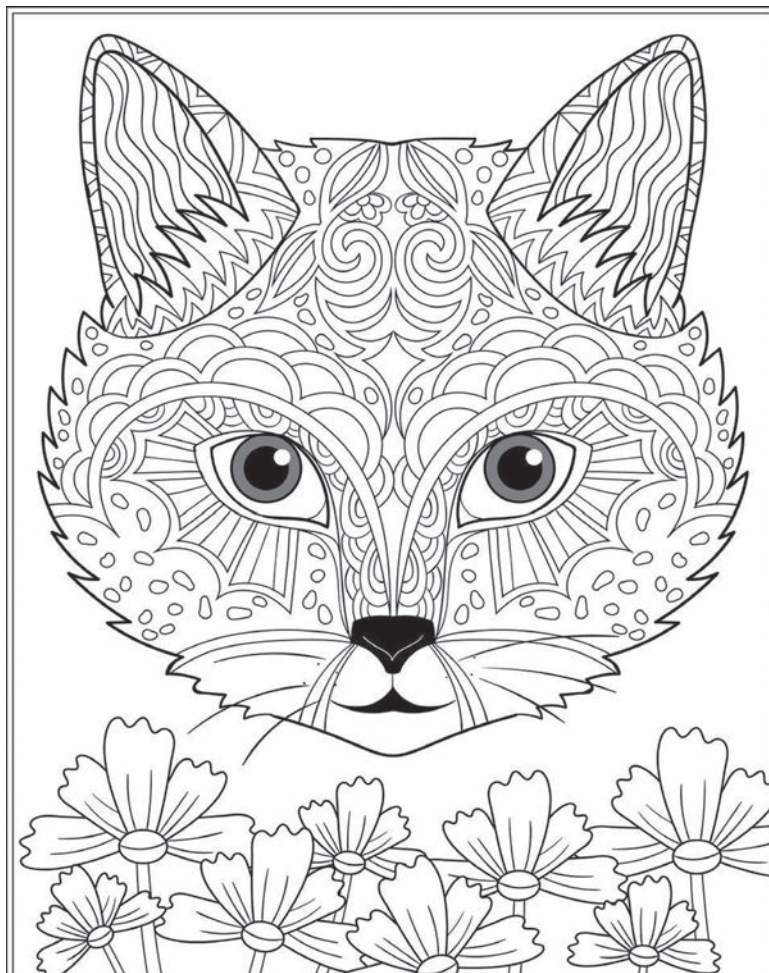

FROM LENA'S KITCHEN

According to the metrological calendar, we are now on the downside of summer. Tom Skilling, the WGN weatherman, said that we would notice about 15 to 30 seconds a day for about a week of the days getting shorter. Who knows 15 or 30 seconds in a day? I know that it is still light out after 8:00 p.m., and I am happy! We are only one week away

from the 4th of July, and because the paper will come out right on the holiday, we are celebrating the Fourth in this week's column.

The first recipe is for a great and tangy red pepper dip. The recipe suggests serving it with carrots and broccoli, but I like it with celery too! It is an easy dip to make and involves no oven. Enjoy this tasty dip at your

picnic or at home.

Creamy Red Pepper Dip

2 large eggs lightly beaten
2 T. sugar
2 T. cider vinegar
1 T. butter softened
1 T. flour
1 pkg. (8 oz.) cream cheese, softened
1 small sweet red pepper, chopped
4 green onions, chopped
Fresh baby carrots
Fresh broccoli florets

In a small saucepan over low heat, whisk together the eggs, sugar, vinegar, butter, and flour. Increase heat to medium, whisk until thickened, 4-5 minutes. Remove from heat. Stir in cream cheese, pepper and onions; mix well. Refrigerate 2 hours and serve with carrots and broccoli.

I like a good creamy coleslaw, and the addition of paprika to the seasonings gives this coleslaw just a little

blueberries. I have had spinach and strawberries, raspberries, and mandarin oranges; however, I have never paired spinach with blueberries. The raspberry vinegar and the Dijon mustard make for a great and refreshing dressing. I like Stillton blue cheese—someone told me that if you want to learn to eat blue cheese, don't smell it. I think that is good advice. You could also substitute feta or gorgonzola cheese.

Spinach Blueberry Salad

¼ C. raspberry vinegar
2 t. Dijon mustard
1 t. sugar
½ t. salt
½ C. canola oil
12 C. fresh baby spinach
1 C. fresh blueberries
1 C. crumbed blue cheese

zip. If you are not a fan of mayo, you can use ¼ cup of sour cream and ¾ cup of mayo. The combination cuts the mayo flavor. I prefer to shred my cabbage because the dressing catches better on cabbage. This recipe has you cubing and chopping. You can decide how much work you want to put into the salad.

This salad mixes spinach and

½ C. chopped pecans, toasted
Mix the vinegar, mustard, sugar and salt together in a bowl. Gradually whisk in oil until blended. In a large salad bowl, combine the salad ingredients and toss with the dressing.

This pasta salad would make for a great picnic salad—no mayo. It is easy because you use a prepared salad dressing. The combo of the dressing, cocktail sauce (shrimp sauce if you will) and the Worcestershire makes for a pasta salad with a zip—just like a virgin bloody Mary. I think you could use the tricolor pasta for a really festive holiday dish.

Bloody Mary Pasta Salad

2/3 C. Sun dried Tomato Vinaigrette Dressing

1/3 C. Cocktail sauce
3 T. Worcestershire sauce
4 C. rotini pasta, cooked
1½ C. cherry or grape tomatoes, cut in half

2 stalks celery, cut into thin slices
1/3 C. sliced Spanish olives
Mix the dressing, cocktail sauce and Worcestershire sauce until blended. Combine the remaining ingredients in a large bowl. Add the dressing mixture and mix lightly. Refrigerate 1 hour before serving

This next main meat entrée is much like the pasta fagioli that is served at the olive garden in soup form. This recipe is for a great casserole. You can use whatever kind of sausage you want. If you want the dish spicier, then use Italian sausage. It says to chop up the whole plum tomatoes; the Barefoot Contessa says it is much better to use your hands and squeeze them into pieces. I don't know if it is better, but it is more fun.

Pasta Fagioli al Forno

3 C. uncooked penne pasta
1 can (28 oz.) whole plum tomatoes

1 lb. sausage
1 medium onion, chopped
1 medium carrot, chopped
1 celery rib, chopped
4 garlic cloves, minced
2 T. tomato paste
1 t. dried oregano
½ t. salt
½ t. dried basil
¼ t. crush red pepper flakes
¼ t. pepper

1 can (15 oz.) white kidney beans or cannelloni white beans, rinsed and drained

½ C. grated Parmesan cheese, divided

½ C. minced fresh parsley, divided
2 C. shredded provolone cheese
Preheat oven to 350. Cook pasta until dente, drain. Drain tomatoes, reserving juices, chop tomatoes. In a 6 quart pot, cook and crumble the sausage with onion, carrot, celery, and garlic on medium high heat, 6-8 minutes; drain. Stir in tomato paste, seasonings, tomatoes and reserved juices; boil. Reduce the heat; simmer, uncovered, 10 minutes.

Stir in the beans and ¼ cup each of the Parmesan and parsley. Stir in pasta. Put in a greased 9 x 13 baking dish; top with remaining provolone and Parmesan cheeses.

Bake, covered, for 20 minutes. Uncover and bake until the cheese is melted, 10-15 minutes. Sprinkle

with remaining parsley.

Need a festive dessert for the holiday? This easy slab pie makes for a great looking pie that feeds a batch of people. You make it in a jelly roll pan, so you can get lots of slices out of it. The hardest part in making a red, white, and blue, cake or pie is placing the blueberries in the corner in a neat pattern—my attempts at things like this usually end up with crooked rows or the fruit sort of listing to the right! However, this recipe is one I love because you just pile the blueberries in that corner with no rhyme or reason. You will like the crust of this pie because it is different than a regular pie crust. You can get the frozen cherries at A.J.'s in a large bag. I often use a combo of regular cherries and the dark tart cherries.

Stars and Stripes Berry Slab Pie

3 C. flour
1 pkg. (8 oz.) cream cheese, cubed
1 C. cold butter, cubed
1½ C. fresh blueberries
1 pkg. (3.4 oz) Jell-O Vanilla instant pudding, divided
9 C. frozen tart cherries, thawed and well drained
1 T. milk
1 T. sugar

Using the pulsing action of a food processor, process the flour, cream cheese and butter until mixture is well blended and pulls away from the side of the bowl of the food processor. Remove dough and shape into a ball. Cut in half; flatten each half into a disk.

Preheat the oven to 425. Press 1 disk between 2 lightly floured sheets of waxed paper, and roll into a 15 x 10 inch rectangle. Use a 1½ inch cookie cutter to cut dough into 6 stars; cut remaining rolled out dough into 6¼ inch wide strips. Do not discard the trimmings.

Spray a 15 x10 x1 inch pan with cooking spray. Tear the remaining dough, including the trimmings, into small pieces. Place in prepared pan. Press onto the bottom and up the sides of the pan to form a crust.

Toss the blueberries with 1 tablespoon of dry pudding mix; spoon onto one corner of the crust. Toss cherries with remaining dry pudding mix; spread onto remaining crust.

Decorate with stars on the blueberries and place cut strips to resemble flag, cutting the dough strips as necessary to fit. Brush the dough with milk, sprinkle with sugar.

Bake 35 to 40 minutes or until the edges of the crust are golden brown, and fruit is hot and bubbly.

Need a dessert that doesn't require any baking? This one is for you. You use the ginger thin wafer cookies and layer them with the cheese mixture. I think you could use the lemon or chocolate wafer thin cookies as well. If you can't get mascarpone cheese, you could substitute cream cheese. The mascarpone has a much milder and smoother flavor. I suggest you try it if you have never used it before. I also think this could be a great dessert that you could make with kids. They would love to layer everything, and it could keep them busy for a while! Serve this easy icebox cake anytime of the year.

Fresh Raspberry Icebox Cake

1 carton (8 oz.) mascarpone cheese
3 C. heavy whipping cream
2 T. sugar
2 pkg. thin ginger cookies
5 C. fresh raspberries, divided

Stir mascarpone cheese; let stand at room temperature for 30 minutes. Beat whipping cream until it begins to thicken. Add sugar, beat until soft peaks form. Reserve ½ cup cream; cover and refrigerate. Add lemon

peel and mascarpone to remaining whipped cream; beat until stiff peaks form, 30-60 seconds.

On a serving plate, spread ½ cup of the cream mixture in a 7 inch diameter circle. Arrange six cookies in a circle on top of the cream, placing a seventh cookie in the center. Gently fold 4 cups of raspberries into the remaining cream mixture. Spoon about 1 cup raspberry cream mixture over the cookies. Repeat layers six times, ending with cookies (there will be eight cookie layers in all). Spread reserved whipped cream over the cookies and drop with remaining raspberries. Refrigerate, covered, overnight.

There will be another Wednesday Gathering in downtown Lena this week. I heard that the rib cooker will be here, and the ribs are award winning. The sandwiches last week were great, and a good crowd came to check things out. The Farmer's Market continues to offer more vegetables and baked goods. There was even a flower wagon there this past week. The usual great cheese curds, ice cream, and coffee drinks were available. We even had two baby goats for kids to look at. They were

very patient with everyone (and they were as cute as the dickens). They were at the stand that sold the wonderful goat milk soap and lotion. There continued to be great strawberry pie, wonderful specialty teas, and braided bread and fresh turnovers. Bill Dietz entertained the crowd, and people continue to bring their interesting motorized vehicles. If you come downtown, be sure and stop in at the stores because this whole event is sponsored by the Lena Business and Professional Association. Most downtown retail stores are open for business. There will be no Wednesday Gathering on July 5th, but Barb Wire contacted me that there will be a Farmer's Market that week. It should be a good one because more vegetables are beginning to mature.

We hope you all have a safe and enjoyable Fourth of July. We continue to look for summer recipes that feature rhubarb, strawberries, radishes, onions, and asparagus. Murphy's Gardens produces wholesome fare

Fresh wholesome food is important for everyone. Fresh greens and fruits are essential for anyone who wishes to have a healthy diet. Whether it's salad or a side dish, garden fresh ingredients not only enhance the taste of a meal, but provide a more nutritious meal as well. Newly picked greens that are apart from the normal fare are not as far out of reach as many people would think. We have to think local.

Local farmers markets have become popular because in addition to offering that farm to table freshness, produce from local growers can often provide different and unusual kinds of tomatoes, greens, squash and herbs. An alternative farming enterprise near Galena that offers fresh and out of the ordinary produce is Murphy's Gardens. Owner Lori Portner has been in business for 23 years. Portner's roots are in southern Wisconsin and her heritage is con-

nected to two farm families. Portner said, "Growing things and farming is in the blood."

Portner has a large 2 acre plot behind the retail store and garden center. The meticulously well-ordered garden is covered with tomato plants and pumpkins as well other crops. The planting at Murphy's Gardens begins around Memorial Day. Portner said, "About that time, the soil is warmer and the plantings get off to a better start."

Looking over the garden plot Portner said, "We've harvested about 100 quarts of raspberries. At the moment there are tomato plants in the ground as well as eggplant and several varieties of peppers. On the other side of the field we grow pumpkins, squash and gourds. Many of the pumpkins and squash are heirloom variety. The pumpkins aren't just for decorations. They make wonderful food as well as pie.

"We have 25 different varieties of pumpkins and gourds. We usually

harvest about 1000 pumpkins."

In addition to offering the produce grown on site, Portner said, "We purchase potatoes, onions, radishes and other crops grown by local Amish farmers in southwest Wisconsin."

Some of the unusual items that Murphy's Garden's has to offer are things such as the Melrose Pepper, which came to Portner's garden from Melrose Park, a Chicago suburb, via Italy. It is a sweet bell pepper. There's also Sun Sugar which is a cherry tomato, ideal for use in a

green salad.

One of the different tomatoes on hand at Murphy's garden comes with a great folklore story. The tomato is the Radiator Charlie's Mortgage Lifter Tomato. Portner said, "A farmer in Logan, West Virginia during the Great Depression of the '30's sinks into financial trouble and to try and ease his debts he develops a tomato which has a mild sweet flavor and weighs up to two pounds. Being that size the tomato quickly becomes popular and eventually he

sells enough tomatoes and plants to lift his mortgage, hence, the name."

Murphy's Gardens has all kinds of other growing things as well as vegetables. Portner said, "We have potted herbs such as lemon grass, basil and other items for the home herb gardener."

There's also a huge variety of flowering plants and shrubs available as well as garden supplies. Murphy's Garden is located at 12550 West Norris Lane in Galena. The phone number is 815-777-4273.

Protecting your pet from the summer heat

Summer time means more time to play outside, go swimming, and soak up the sun. However, warmer temperatures also mean that pets may be more susceptible to heat exhaustion or heat stroke. To help pet owners avoid these risks, Dr. Stacy Eckman, clinical assistant professor at the Texas A&M College of Veterinary Medicine & Biomedical Sciences, offered some insight.

"Heat stroke and heat exhaustion are major problems for pets in the summer, especially in short nosed breeds, such a pug or a bulldog," Eckman said. "These conditions can occur during hot and humid days and even cooler days, if your pets aren't accustomed to the heat."

Heat exhaustion is the early stages of a heat stroke and causes lethargy, vomiting, and weakness. Following continued exercise or exposure to heat, Eckman said a heat stroke can occur with more severe

signs, including extreme lethargy, vomiting, diarrhea, and pale mucous membranes. This can lead significant problems up to and including death if not recognized and treated immediately.

Other dangers pets may face in the summer heat include paw pad burns from walking on hot concrete. If your dog is going to be active outside when it is hot, be sure to keep them off concrete or asphalt for extended periods of time. You can also provide your pet with other means of exercise, such as playing indoors or in the grass.

Eckman added that leaving pets in the car or bed of a truck is also a bad idea. This can also lead to heat exhaustion or heat stroke.

"Even if there is a breeze outside, there is no shade or water in the bed of a truck, so the temperature can really heat up," Eckman said.

Though it may seem like a quick-

fix to put your pet in cold water if they do become overheated, Eckman said it is best to slowly cool down your pet to avoid causing more internal heat.

"Some people will try to provide ice water baths for overheated pets; this can actually make them retain heat internally," Eckman said. "Instead, bring the overheated pet inside and provide them with cool water and a fan. Wetting a towel and putting it on the pet's coat also may be helpful."

Other tips for keeping your pet cool during the summer include providing a dog house, a shallow kiddie pool, and enough cool water. Also, try to exercise your pet during the cooler parts of the day, such as the morning or evening.

Whether your pet lives primarily indoors or outdoors, it is important to protect your pet from the heat this summer season.

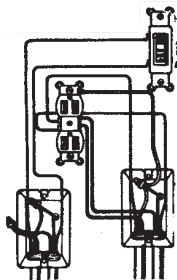

FSA issues maintenance reminders for CRP acres

The Jo Daviess County Farm Service Agency (FSA) is informing producers with land in the Conservation Reserve Program (CRP) to inspect the cover on their CRP land.

"There is a real concern in our office about weeds on CRP land, especially Illinois noxious weeds consisting of Canada thistles, musk thistle, perennial sowthistle, common ragweed, giant ragweed, marijuana, kudzu, Columbus or sorghum grass, and Johnson grass," said Cory C. Cassens, County Executive Director of the Lee County FSA Office.

Cassens is asking that all CRP participants check their CRP land to make sure they do not have any weedy patches that would threaten the approved cover on their CRP land. If you do have any weedy patches, Cassens asks that you please spot mow or spray these areas to control the weeds, once you have requested to do so from the Jo Daviess County FSA office.

Participants need to also inspect the general condition of the acreage devoted to CRP and the crop lines have not changed. This is especially important with sod waterways enrolled in the continuous CRP. Waterways are designed for a unique width and shape for that watershed to be eligible to be in CRP. Waterways or buffers not being properly maintained will have to be corrected to the original de-

sign and specs issued by the Natural Resource Conservation Service (NRCS).

The Jo Daviess County FSA Committee is poised to follow the Illinois State FSA Committee following rates for 2017 for failure to control noxious weeds or undesirable vegetation that competes or prohibits the establishment of the approved conservation practices:

- Non-control of weeds \$12.50 per acre (times 2)
- Non-control of wind or water erosion \$25.20 per acre (times 2)
- Failure to establish or maintain eligible cover \$25.20 per acre (times 2)
- Unauthorized haying or grazing Value x Acres x 2

All CRP maintenance activity, such as mowing, burning, and spraying, is to be conducted outside the primary nesting or brood rearing season of April 15th thru Aug. 1st for wildlife and according to the conservation plan, except that spot treatment of the acreage may be allowed during the primary nesting or brood rearing season if the weeds, insects or undesirable species would adversely impact the approved cover and approval is granted by the Jo Daviess County FSA Committee. Requests for spot mowing can be quickly initiated by calling the Jo Daviess County FSA office at 815-858-3418 ext. 2.
