# Stockton Chamber engages social media to market area highlights

Using the term social media is another way of saying Facebook, Twitter, Snapchat or Instagram as well as many other internet sites that can carry messages across cyberspace. When we hear the term social media we think of staying in touch with friends, finding out about what's happening in entertainment or making appointments for a haircut or reservations for dinner. Times are changing and new possibilities for the use of social media have become recognized.

Marci Schubert and Amanda Pierce have hit on the idea of taking the use of social media to a new level. Shubert, who is the manager of the Stockton branch of Furst Staffing also heads the Stockton Chamber of Commerce. Pierce has been involved in marketing for several years and at present is a marketing specialist with the Forreston State Bank. The two concluded that an outlet such as Facebook and other popular apps can be used in ways more substantial than just sending messages to friends. Schubert and Pierce have been looking at several different ideas to broaden the outreach of the Stockton Chamber of Commerce. Looking inwards the two friends realized how much they rely on social media for many things beyond messaging and asked, "Why aren't we using social media to promote Stockton in a as many different ways as possible?"

In addition to her duties at the bank, Pierce owns See It Signs and Apparel in Stockton. She appreciates the need to market local businesses, but has come to realize the need to bring Stockton into people's view about a wide range of issues. For example, local merchants can inform visiting shoppers about residential or commercial properties that are for sale. Linking people who are visiting Stockton with like-minded residents can create almost unlimited possibilities. People who share a common interest in entertainment or history can link to upcoming events.

"In addition to linking people to one another on social media we'll be looking to have Brand Ambassadors," Pierce said. "Those would be people who can represent the town of Stockton when someone has reached out through others, looking for specific information about local businesses, or a specific product or service. These ambassadors would be realtors, health care workers or someone who just shares specific interests."

To get this program underway The Chamber of Commerce will be sponsoring an event to familiarize everyone with this new idea. Pierce said, "On July 12 the Chamber will be hosting Lunch & Learn: Social Media. The program will be held at Main Street Parties & Events located at 113 S. Main from 12 noon to 1 p.m. This event is open to Chamber members and non-members. The public is also welcome to attend. as well. We'd like to get feedback from people with different points of view."

# Jo Daviess County Farm Service Agency acreage reporting dates

U.S. Department of Agriculture (USDA) Farm Service Agency (FSA) County Executive Director (CED) Cory C. Cassens in Jo Daviess County announced that producers who file accurate and timely reports for all crops and land uses, including failed acreage, can prevent the potential loss of FSA program benefits. Please pay close attention to the acreage reporting dates below.

"In order to comply with FSA program eligibility requirements, all producers are encouraged to visit the Jo Daviess County FSA office to file an accurate crop certification report by the applicable deadline," said CED Cassens.

The following acreage reporting dates are applicable for Jo Daviess County:

July 15, 2018: All other crops, Perennial Forage (year of the seeding).
Dec. 15, 2018: Fall-Seeded Small

Grains, Canola, Perennial Forage.
The following exceptions apply to the above acreage reporting dates:

• If the crop has not been planted by the above acreage reporting date, then the acreage must be reported no later than 15 calendar days after planting is completed.

• If a producer acquires additional acreage after the above acreage reporting date, then the acreage must be reported no later than 30 calendars days after purchase or acquiring the lease. Appropriate documentation must be provided to the county of

• If a perennial forage crop is reported with the intended use of "cover only," "green manure," "left standing" or "seed," then the acreage must

be reported by July 15, 2018.

According to CED Cassens, Noninsured Crop Disaster Assistance Program (NAP) policy holders should note that the acreage reporting date for NAP-covered crops is the earlier of the dates listed above or 15 calendar days before grazing or harvesting of the crop begins.

# Stockton Community Unit School District #206 BOE June meeting minutes

The regular meeting of the Stockton Community Unit School District #206 was called to order at 6:30 p.m. in the High School Library. # hanges in tax law aren't helping Medicare

Is Medicare going broke? That scary thought raced through the media a few weeks ago when the program's trustees issued their annual report to Congress.

The media reported the "news" in its predictable fashion; painting a bleak picture of the program some 59 million older and disabled Americans depend on for their health care. Every year the media fail to give the full or nuanced picture of what's happening, instead opting for dramatic headlines announcing the program is broke. This year is no

"Medicare is not going broke," savs Tricia Neuman, senior vice president at the Kaiser Family Foundation. "It does face a financing challenge." By 2026 the program will be able to pay only 91 percent of covered benefits for hospital services. "But it's not true to say the program is going broke."

First, it's important to understand that policymakers are talking only

about shortfalls in the Part A trust fund, which pays for inpatient hospital care. That care is financed by payroll taxes paid by employers and their employees. Part B, which pays for outpatient care, lab tests and physician services, is financed by beneficiary premiums and general tax revenues, and those sources can be adjusted as needed.

#### Why this year's gloomy predictions?

A lot of those financial challenges identified this year by the program's trustees have been caused by recent changes in the law, Neuman told me. Some changes reduce the revenue that supports Medicare, and others increase the costs of preserving health care for all Americans.

Changes in the tax law passed late last year result in lower than expected revenues. Trustees noted that lower payroll tax revenue, which results from lower wages and lower economic growth projections for the future, also played a role in their assessment.

individual mandate that called for almost all Americans to have health insurance or pay a financial penalty. The mandate was never popular with the public, but eliminating it has consequences for Medicare. Neuman said the repeal of the mandate is expected to lead to higher spending out of the Part A trust fund to cover uninsured Americans when they need hospital treatment. Medicare helps cover those costs.

Higher than expected payments to Medicare Advantage plans also figure into the trust fund shortfall. This is due to the relatively aggressive way in which those plans document or "code" the health conditions of members of their plans. This results in higher payments from Medicare.

The Bipartisan Budget Act of 2018 also adversely affected the Medicare trust fund by repealing the Independent Payment Advisory Board (IPAB) designed to lower program spending. The board had been expected to make recommendations about spending that could trigger

of opposition from the health care community, the IPAB never got off the ground. Last summer a group of sellers, including drug and device companies, hospitals, and insurers, waged a campaign to convince Congress to wipe the IPAB off the books. Lawmakers did that in February, eliminating a potential path for Medicare to control its costs

Neuman says it's important to remember that Congress "has faced even worse shortfalls and in the past has taken action to strengthen the trust fund. That used to be standard to keep the program stronger."

So to sum up, Congress itself has worsened the state of the Medicare trust fund and made the program less stable, a point rarely discussed in the gloom and doom news accounts about the trust fund going broke. That's not to say that the Part A trust fund can't use an infusion of money as more Americans turn 65 while the cost of medical services continues to rise without serious cost control.

The new tax law also repeals the automatic spending cuts. Because care trustee, told me it wouldn't take much to put the program on a sound financial footing. But it would require an increase in the payroll tax, which is never discussed as a solution. Instead the answer seems to be to encourage more Americans to join Medicare Advantage plans, a private market alternative to Medicare that requires beneficiaries to shoulder more of their medical costs.

But as someone who just went through a serious illness, spent four months in the hospital, and racked up bills totaling more than more than \$4 million, I can attest to the value of traditional Medicare.

It's worth recalling what President Lyndon Johnson said when he signed Medicare into law in 1965. "No longer will illness crush and destroy the savings that they (Americans) have so carefully put away over a lifetime." Nor would young families see their own incomes and hopes eaten away as they carry out moral obligations to their parents.

That's reason enough to make sure the Part A trust fund is well funded.

"Much of our efforts to improve the lives of Illinois children could be undermined with an inaccurate census count in 2020," said Tasha Green Cruzat, president of Voices for Illinois Children. "Low-income children, particularly low-income children of color, and children in immigrant families stand to be most hurt by an inaccurate count and subsequent reduction in federal funds for education and health programs."

Census data is used to allocate federal funds for hundreds of child-focused federal programs annually. Illinois receives more than \$5 billion per year for the 10 largest programs that enable children to thrive, including Medicaid and the Children's Health Insurance Program (CHIP), as well as Head Start, grants to Title I schools and the Supplemental Nutritional Assistance Program (SNAP).

As a state, Illinois has made progress in key areas related to children's health and education yet continues to face challenges in improving family economic securi-

fact that more than 150,000 Illinois ty. The 2018 KIDS COUNT Data effort, and the administration needs Book places Illinois at 22nd in the nation for overall child well-being. This ranking puts Illinois ahead of neighboring Midwestern states like Indiana and Missouri, but far behind top-five states Minnesota and Iowa. Ŝixteen indicators are used to rank each state across four areas — health, education, economic well-being and family and community — as an assessment of child well-being. Illinois ranks:

- \* 24th in health
- \* 13th in education
- \* 27th in economic well-being
- \* 27th in the family and community domain

The information in the 2018 Data Book underscores the need to have reliable data driving the decisions we make about programs and investments," said Anna Rowan, KIDS COUNT manager at Voices for Illinois Children.

Rowan noted the recommendations of the Annie E. Casey Foundation to achieve a more accurate

Maximize the Census Bureau's capacity: Federal legislators need to fully fund the census outreach

to appoint a qualified and permanent director to lead the agency to provide support for a more accurate census than in 2010.

Fund state and local outreach: State and local governments and community organizations need to invest in educational outreach around the census to ensure that the most vulnerable communities are

Expand the pool of trusted messengers: Broaden the circle of people (from child care providers to members of the clergy) and organizations (from public schools to libraries) who can provide outreach in their communities to reach hardto-count households and encourage participation among people most likely to be missed.

Address the digital divide: Provide online access for all families to participate in the census, either in local libraries or schools.

Address privacy and confidentiality concerns: Given the growing distrust and fear of online data breaches, it is critical that government officials ensure the protection of respondents' data.

# NFPA underscores electric shock hazards in pools and at marinas

With the start of summer, the National Fire Protection Association (NFPA) is reminding people about the potential electrical hazards in swimming pools, hot tubs and spas, on board boats and in the waters surrounding boats, marinas and launch ramps.

Electric shock drowning (ESD) happens when faulty wiring sends an electrical current into the water. The current then passes through the body and causes paralysis. When this happens, a person can no longer swim and ultimately drowns.

"Most people are not aware, including boat and pool owners and swimmers, are not aware of the risks of electric shock drowning," said Lorraine Carli, NFPA's vice president of Outreach and Advocacy. "NFPA is raising awareness of this troubling trend and sharing our water safety resources so that everyone can safely enjoy summer water activities."

Here are tips for swimmers, pool and boat owners:

#### Tips for swimmers

Never swim near a marina, dock or boatyard, or near a boat while it's

While in a pool, hot tub or spa, look out for underwater lights that are not working properly, flicker or work intermittently. If you feel a tingling sensation while in a pool, immediately stop swimming in your current direction. Try and swim in a direction where you had not felt the tingling. Exit the water as quickly as possible; avoid using metal ladders or rails. Touching metal may increase the risk of shock.

#### Tips for pool owners

If you are putting in a new pool, hot tub or spa, be sure the wiring is performed by an electrician experienced in the special safety requirements for these types of installations.

Have a qualified electrician periodically inspect and — where necessary — replace or upgrade the electrical devices or equipment that keep your pool, spa or hot tub electrically safe. Have the electrician show you how to

turn off all power in case of an emer-

Make sure any overhead lines maintain the proper distance over a pool and other structures, such as a diving board. If you have any doubts, contact a qualified electrician or your local utility company to make sure power lines are a safe distance away.

Each year, and after a major storm, have the boat's electrical system inspected and upgraded by a qualified marine electrician to be sure it meets the required codes of your area, including the American Boat & Yacht

Council (ABYC). Check with the marina owner who can also tell you if the marina's electrical system has recently been inspected to meet the required codes of your area, including the National Electrical Code® (NEC).

Have ground fault circuit interrupters (GFCI) installed on the boat; use only portable GFCIs or shore power

cords (including "Y" adapters) that are "UL-Marine Listed" when using electricity near water. Test GFCIs monthly.
