Panther-Hawks dominant in Winnebago

It was yet another impressive day on the mats for the LeWin-Stockton wrestling squad last Thursday when they traveled to face off with Winnebago and Polo.

The PantherHawks collected six pins over Winnebago alone as Zach White (106), Simon Rillie (120), Tanner Kalkbrenner (138), Case Harmston (160), Colin Dvorak (170), and Ian Keuhl (285) each dominated their opponents. Their pins led the way towards a blowout victory with a score of 64-9 over Winnebago. Winston McPeck (132) was also impressive as he won with a Major Decision scoring 13-5. Marey Roby (126) and Jason Hermann (152) each had to battle it out until the end as Roby won by a score of 12-9 and Hermann pulled out a 4-0 victory.

The results were similar, if not even more impressive with their matches against Polo. It seemed every single PantherHawk was getting a pin in this one, as the team collect-

ed 10 pins over the Polo boys.

Zach White collected his second pin of the evening just 53 seconds into the match, as did Simon Rillie just one minute 51 seconds into his. Marey Roby also collected an early pin, his first, just 51 seconds into the match.

Andrew Haas (145) bounced back after losing his match, earning a pin midway through his match giving him a 1-1 record on the evening. Harmston and Dvorak each collected their second pins of the evening as well.

Hermann got the pin this time rather than battling it out, as he got the fall just 1:10 into his match, and Gavin Keefer (182) collected a pin just 1:40 into his match. Gennings Dunker (220) topped it all off with a pin at the 2:49 mark.

All the pins led towards yet another blowout, as the PantherHawks took home a 72-6 victory. Last Thursday was arguably their most dominant event, as it seems the PantherHawks improve each week.

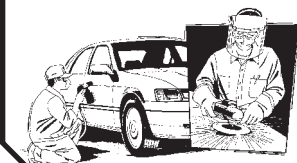

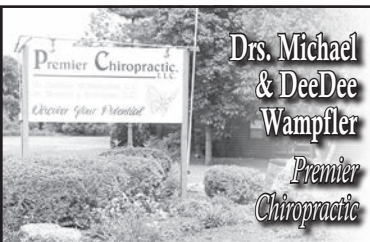

Your spine and your heart

The medical community defines heart arrhythmia as a potentially life-threatening irregular heart beat or rhythm. Heart rhythm problems (arrhythmias) occur when a malfunction exists in the electrical impulses within the heart which coordinate how a person's heart beats. 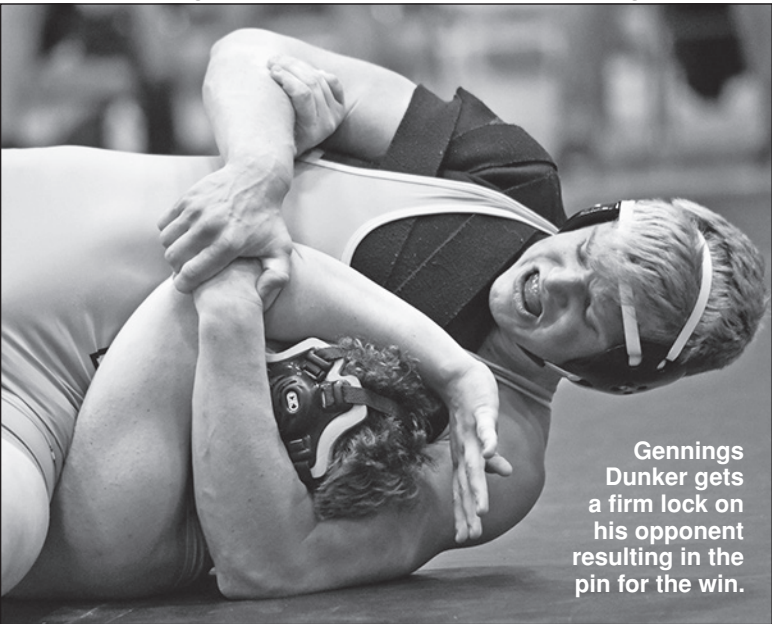

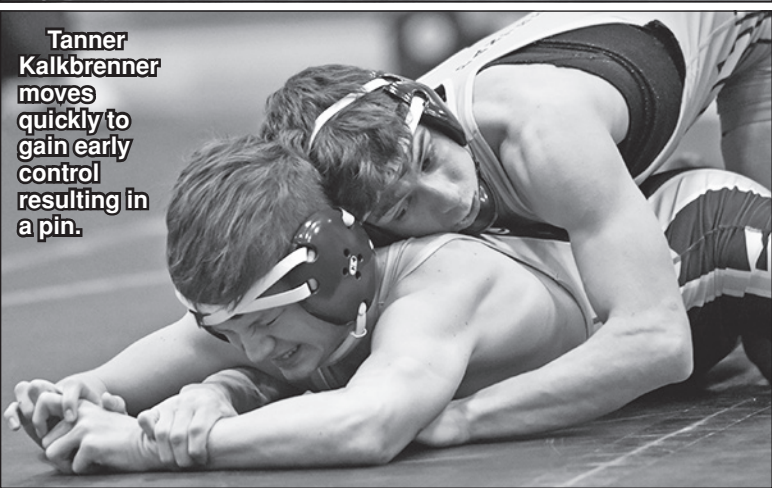

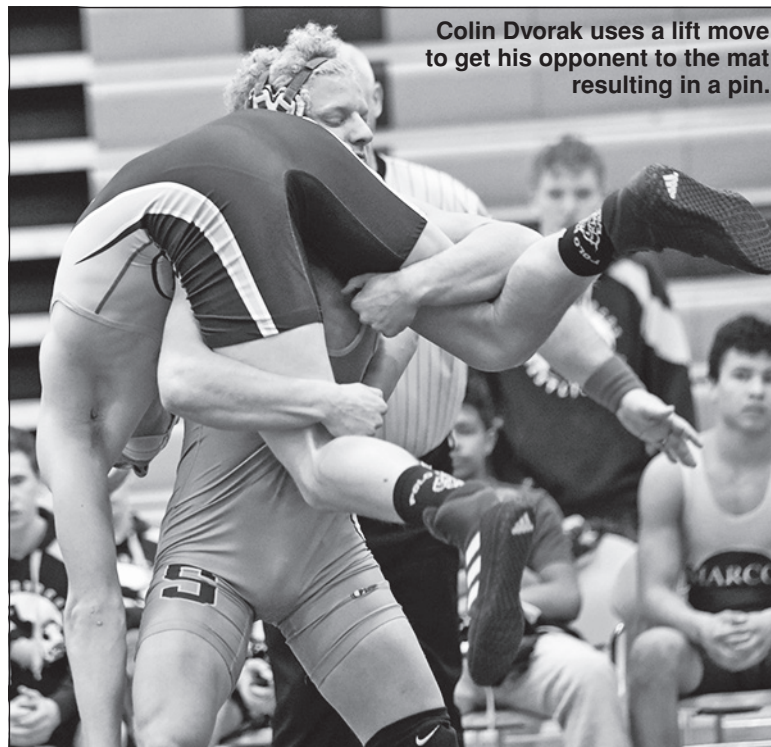

The not so skinny cook

Hope you all had a great beginning to 2019! Christmas decorations are coming down. It will be sad to not have the decorations downtown; the streets were so sparkling and pretty. We now go into the "dark" side with winter months; however, the days are getting longer. (Not by much, but if you are like me, every bit of light is a gift!). This week's recipes will include a soup, a vegetable, two main dishes, and a great cookie bar.

This month is truly soup month. This delicious bean soup uses bacon. If you have ham left from the holidays, you could use a cup of diced ham instead of the bacon. You can also use traditional great Northern beans; just remember they will need an overnight soak. The canned ones (or jarred) are a time saver. If you don't have an immersion blender, you can use a regular blender. Just be sure you have a towel wrapped around the blender, and only fill the blender a third full for your safety, and you won't have a mess to clean up.

Bean and Bacon Soup

8 oz. bacon, diced
1½ C. diced onion
1 C. diced carrots
1 C. diced celery
1 T. minced garlic
3 T. tomato paste
½ t. smoked paprika
4 C. chicken broth
1 t. red pepper flakes
4 cans (15 oz. each) great northern beans, drained, rinsed, and divided
Salt and pepper to taste
1 T. minced fresh thyme
1 T. white wine vinegar

Cook bacon in a pot until crisp; transfer to a paper-towel lined plate and drain all but 3 tablespoons of drippings. Sauté onions, carrots, celery, and garlic in drippings over medium heat, stirring often, until vegetables soften, about 5 minutes. Stir in tomato paste, paprika, and pepper flakes; cook for 1 minute. Deglaze the pot with broth, then stir in 3 cans of beans. Bring soup to a boil over medium-high heat, reduce heat to medium-low, and simmer for 20 minutes. Season with salt and pepper. Partially puree the soup with a handheld blender or a regular blender. Stir in remaining can of beans, thyme, vinegar and three-fourths of the bacon. Top servings with remaining bacon.

Are you looking for an interesting side? This side melds the starch and vegetable together. It uses a bottled dressing to make things easier. If you have a recipe for Asian sesame dressing of your own, you can certainly use it. The edamame makes for a little crunch in this side. Just

a reminder: edamame is baby soy beans.

Orange Cauliflower with Rice

1 T. cornstarch
3 T. apple cider vinegar
1 navel orange
½ C. Kraft Asian Toasted Sesame

Dressing

1/3 C. ketchup
2 t. sugar
2 t. chili sauce
5 C. cauliflower florets
1 C. frozen edamame, shelled
3 C. hot cooked long grain white rice

Mix cornstarch and vinegar until blended. Use a vegetable peeler to cut 5 strips of peel from the orange;

place strips in a large saucepan. Cut orange in half; squeeze juice over the orange strips. Add the dressing, ketchup, sugar, chili sauce, and cornstarch mixture; mix well. Bring just to a boil on medium heat; simmer on medium-low about 3 minutes, stirring frequently.

Add the cauliflower and stir. Cover and cook on medium heat 10 to 11 minutes or until cauliflower is tender; uncover and stir occasionally after 5 minutes. Meanwhile microwave edamame in large microwaveable bowl on HIGH for 2 minutes. Add rice and mix lightly. Remove and discard orange peel strips from

cauliflower mixture. Serve over rice mixture.

Last week I had a Hungarian soup, so I guess I am into Hungarian this year. This next dish is a Hungarian dish that features paprika. I ate several Hungarian dishes when I was in Europe many years ago. One of the staples in our house was Hungarian Goulash. Try this interesting take on chicken. It is best served over noodles, but mashed potatoes will also be a good starch for this dish.

Chicken Paprikash

1 fryer chicken but into 8 pieces
1 t. salt
½ t. pepper
1 T. canola oil
1 medium onion, halved and sliced
1 large garlic clove, chopped
1½ T. flour
½ T. sweet paprika
1 C. hot chicken broth
½ C. sour cream
Minced fresh parsley and paprika for garnish
Cook noodles or mashed potatoes
Season chicken with salt and pepper. In a Dutch oven heat oil

over medium-high heat. Brown chicken in batches. Remove with a slotted spoon; drain and keep warm. Reduce heat to medium-low. Add onions; cook stirring to loosen browned bits from pan, until onions begin to soften, 6-8 minutes. Add garlic, cook for 1 minute longer.

Stir in flour and paprika; reduce heat to low. Cook until paprika is fragrant, 3-5 minutes. Add broth, cook, stirring constantly, until smooth, 6-8 minutes. Return chicken to pan, simmer, covered 3-minutes. Transfer chicken to platter. Skim fat and stir in sour cream; heat just until warmed through, 3-5 minutes—do not allow to boil. Sprinkle with parsley and paprika. Serve over noodles or mashed potatoes.

There are still cranberries available in most grocery stores, so this recipe is a good one to use up any in your freezer or if you want a good cranberry cookie bar. If you don't have apple pie spice in your cupboard, you can make your own by using 1 teaspoon of cinnamon, ¼ teaspoon of nutmeg, and ¼ teaspoon of allspice. You will probably have those three spices.

Spiced Cranberry Pecan Bars

Crust:

2½ C. flour
½ C. sugar
1½ t. apple pie spice
¾ t. baking powder
½ t. ground ginger
½ t. salt
1 C. cold butter, cubed
1 large egg

Filling:

5 C. fresh cranberries, divided
¾ C. sugar
½ C. applesauce
½ C. maple syrup
2 T. orange zest
2 T. fresh orange juice
¼ t. salt
1½ T. cornstarch
1½ T. water

Topping

½ C. roughly chopped pecans
½ C. old-fashioned oats

Preheat the oven to 350. Line a 9 x 13 baking dish with parchment paper, letting excess extend over sides of pan. For crust: in a large bowl whisk together the flour, sugar, pie spice, baking powder, ginger, and salt. Add cold butter, and

beat with a mixer at medium speed until crumbly. Add egg, beating until combined. Reserve 1 cup flour mixture for topping. Press remaining mixture into the bottom of prepared pan. Bake until lightly golden, about 18 minutes. Leave oven on.

Meanwhile, for the filling; in a large saucepan, bring 3 cups of cranberries, sugar, applesauce, maple syrup, orange zest, juice, and salt to a boil over medium-high heat. Cook, stirring constantly, until cranberries begin to burst. Reduce heat to low, and simmer for 10 minutes, stirring occasionally. In a small bowl, whisk together the cornstarch and water. Stir cornstarch mixture into cranberry mixture, and cook until thickened, about 2 minutes. Remove from heat; fold in remaining 2 cups of cranberries. Spread mixture in an even layer over prepared crust.

Topping: in a small bowl, combine the pecans, oats, and reserved 1 cup flour mixture. Sprinkle over cranberry mixture. Bake until crust is golden and filling is bubbly, about 30 minutes. Let cool completely in pan. Using excess parch-

ment as handles, remove from pan, and cut into squares.

We are moving quickly into January, and so far the weather hasn't been as brutal as it has been in past Januarys. I know some of you probably wonder why I still tell time by the school calendar. I taught 40 years, so the school calendar is still part of my thinking. Basketball and wrestling are going full throttle as well as speech contests and music contest preparation. I know people have already started planting seeds in their porch areas that are heated and in small green houses.

When the holidays are over, it seems as if we start to race through winter.

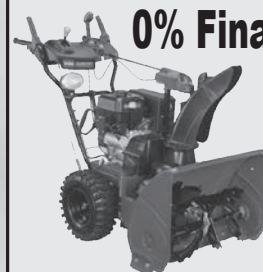
