Problem solving skills bring cross-country skiing to Stockton

The Valley of Eden Bird Sanctuary is a one of the preserves protected by the Jo Daviess Conservation Foundation (JDCF). The preserve is a 409 acre site situated in the gently rolling hills near Stockton. The land has become an oasis for native plants and birds. The property is open to the public year round allowing those with an interest in birding the opportunity to hike the trails and view avian life in its most natural setting. This year, the sanctuary will also be open for those who enjoy cross country skiing. This past Autumn, Tom Saccomanno and Julie Bruser, both long time members of JDCF, were hiking in the Valley of Eden Sanctuary. Julie is no stranger to conservation having served on the JDCF Board and currently operating Wild Birds Unlimited in Galena. The two began talking about what a great place the location would be for those who enjoy cross country skiing. An idea was hatched and they contacted JDCF.

Deb Kelly, JDCF Communications Director said, "Tom and Julie called and I arranged a meeting between them and Steve Barg, our Executive Director. Steve thought it was a great idea and gave it the green light."

With an opportunity to bring a new cross country ski trail to Jo Daviess County Saccomanno had to get to work in a hurry. Saccomanno said, "Cross country skiing is one thing. Building a course and constructing trails is something very different, so I began reaching out to friends. The first was Bill Perrin, my partner at Exact Pest Solutions. We were in this together. In the first snow fall of the year our snowmobile got stuck in a drift and we couldn't figure out how to layout trails. We realized we were going to need help."

Sacomanno began gathering information about cross country trails and found a couple of men who had answers. Saccomanno said, "Perrin

and I reached out to Aaron Birkett and Chris Jackson both of whom are with Chris Jackson Landscaping. Birkett and Jackson both are avid snowmobilers and members of The Winter Warriors Snowmobile Club. Birkett explained the difference between different types of snowmobiles. The utility type, which is more of a work horse variety, is what we needed. The utility type has the width and power to pull itself through deep drifts and enough power to pull a lot of weight which is needed for the grooming of trails. We would need trail grooming equipment as well."

Sacomanno asked Birkett to try and find a suitable vehicle. Birkett located an older utility snowmobile that he reconditioned and put in working order. Birkett then sold the machine to Saccomanno at a bargain price. The last piece of the puzzle was the grooming equipment needed to form and maintain the trails. Jackson who had developed a keen interest in this project told Saccomanno, "I can build those myself, as good as anything we might purchase."

Sacomanno had learned that there are two types of trails. Saccomanno said, "The traditional ski trail utilizes two parallel grooves and the skate skiing trail, which is a much faster track and has narrow, shallow grooves."

"Using his experience and ingenuity Jackson created one groomer for traditional trails by welding together several pieces of flat steel and for a skate skiing trail, he used a plastic culvert attached to a tow bar."

"The project has been completed. Valley of Eden is open to the public daily from dawn to dusk. We're all very happy with this project. It's the kind that couldn't have been done without the help and generosity of so many."

Trucking regulations can be complicated, and farm exemptions compound that problem. Seems everyone has a different answer to your question. Come join the Jo Daviess and Stephenson County Farm Bureau's at 1 p.m. on Feb. 8, at the Stephenson County Farm Bureau Building, 210 W. Spring St., Freeport to find out what you need to know.

We're hosting a two-hour seminar that focuses on trucking laws—old and new—specifically for farmers. We'll introduce you to new rules, remind you of the old ones that still ap-

ply and help you to figure out whether exemptions are available.

Throughout it all, you'll have the chance to ask those farm trucking questions that everyone seems to have an opinion about, but no one can agree on an answer.

Trucking laws have been reshaped in recent years with more changes yet to come. Rules recently affected include: farmer exemptions, Harvest Season permit, Electronic Logging Devices (ELDs), waivers for insulin-related diabetic drivers, a new class "C" license plate, Cov-

ered Farm Vehicle options for small trucks, and the UCR payment schedule and fees for 2019.

Presenting the seminar will be Kevin Rund and Kirby Wagner who specialize in farm transportation issues for the Illinois Farm Bureau®. And they'll provide take-home materials covering these topics.

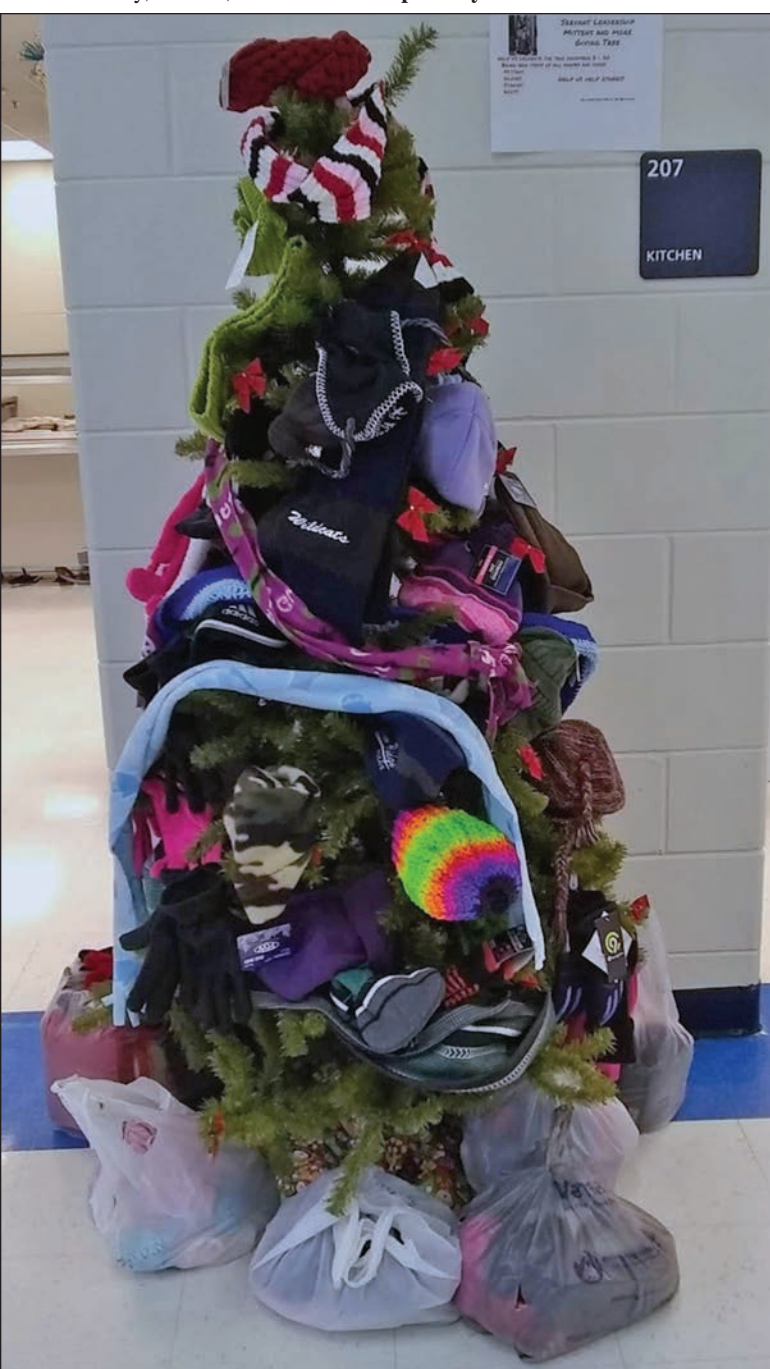

Stockton tops Pearl City

Last Friday, despite the abysmal weather and even a school cancellation, the teams decided to tough it out and compete anyways.

The Pearl City Lady Wolves hosted the Stockton Blackhawks for an inner conference matchup and the Wolves knew it would be a fight. Coming into the game with a 5-15 overall record, and sitting near the bottom of the conference, it was David vs. Goliath in this one. Stockton came in holding a 20-3 overall record and sat in second place in the Northwest Upstate Illini-West Conference at 6-1.

The Blackhawks got off to a hot start in the first quarter as they doubled up the Wolves, outscoring them 20-10. Elizabeth Eisfeller had her shot falling early as she dropped 10 points in the first.

Savanah Brandt provided nearly all of the Wolves first quarter points as she totaled nine for the quarter.

Stockton would extend their lead in the second quarter as they more than doubled up the Wolves, this time outscoring them 18-8. Tiana Timpe hit a pair of three-pointers in the quarter and helped the Blackhawks go into halftime up 38-18.

Timpe stayed hot in the third quarter as she hit another pair of three-pointers coming out of the break. Eisfeller added six points of her own as they worked their way towards putting this game out of reach.

Pearl City's Cheyenne Handsaker provided a pair of third quarter three-pointers of her own. The Wolves would go into the fourth quarter facing a large deficit, down 55-28.

The Blackhawks began to work and focus on keeping the ball moving in the fourth quarter as they were well on their way to another victory.

Handsaker wasn't quite ready to give up as she hit her fourth three-pointer of the evening, and Audra Lartz provided a three of her own in the final quarter.

The Stockton girls came in and showed off their chemistry in this one as nearly every one of their players got on the scoreboard. Eisfeller led the way with 19 while going three of four from the free throw line and scoring the rest of her points from underneath the basket. Timpe was incredible from beyond the arc as she dropped five three-pointers and would finish the evening with 17.

Brandt led the way for Pearl City as she totaled 16 points on the evening. Handsaker was right behind as she showed off her three-point ability as well, nailing four of them and finishing with 14 total.

The victory was Stockton's third win in a row as they now sit at 21-3 on the season.

Stockton wins Warkins Cardinal Classic

The Stockton girls competed in the Warkins Cardinal Classic during the holiday season and came out champions. The tournament took place on Dec. 22 -29. The returning Warkins Cardinal Classic Champion Blackhawks came into the tournament holding an 11-2 record and running with a four game win streak.

Thanks to a 52-41 victory over Rockridge, and a convincing 66-28 victory over Morrison, the Blackhawks were able to put them in a position to come home with the championship following Christmas.

On Dec. 27, the Stockton girls continued with their winning ways as they completed a 53-46 victory over Bureau Valley.

After going 3-0 in pool play, the Blackhawks would have one final pool game in order to return to the championship game for a consecutive season. Opponent Monmouth-Roseville would look to make it as challenging as possible for the Blackhawks to return.

Monmouth held a slight 32-30 lead over Stockton heading into halftime. Late in the fourth quarter one of Stockton's leading scorers, Tiana Timpe, found herself in foul trouble as she picked up her fourth while the Blackhawks held a two point lead, up 51-49. Timpe was careful enough to remain in the game for the remaining minutes, and managed to score nine fourth quarter points while doing so. Timpe finished the final pool game

with 28 points, while Elizabeth Eisfeller followed up with 17 of her own. The offensive tandem combined for 45 points as they led the Blackhawks towards a 63-58 victory, and set them up for a rematch of last year's Cardinal Classic Championship, against Knoxville.

Knoxville, who also went 4-0 in pool play, would prove to be a tough opponent for the Blackhawks.

Knoxville held a slim two point lead at the end of the first, as Stockton went into the second quarter trailing 12-10. The Blackhawks would take the second quarter, however, outscoring the Blue Bullets 13-9. The teams went into halftime with Stockton holding a slim 23-21 lead.

Stockton came out of the break looking to expand on their lead as they outscored the Blue Bullets once again in the third quarter. The Blackhawks went into the fourth with a 39-33 lead, as they inched closer to

consecutive championships.

Knoxville did everything they could to complete the late comeback, but the Blackhawks were able to hold them off in a 52-48 victory. Despite an off night offensively from Tiana Timpe, she still finished with a double-double going 10-10. Elizabeth Eisfeller went off in the championship as she shot 90% from the field on her way to a 27 point game. Eisfeller played a huge role in holding off Knoxville as she also shot 75% from the free throw line going 9 of 12.

Stockton defended their championship from last year as they are now consecutive Warkins Cardinal Classic champs.

The championship pushed the Blackhawks win streak to eight as they bumped their overall record up to 15-2. They remain just behind Eastland in the Northwest Upstate Illini-West Conference.

FDA update on heart med recalls including valsartan, losartan and irbesartan

Federal regulators say they've identified the source of the cancer-causing impurities that have tainted millions of bottles of commonly used generic blood pressure and heart failure medications recalled by drugmakers over the last seven months.

The carcinogens are a chemical byproduct of the process used to synthesize the active ingredient in the drugs, which include valsartan, losartan and irbesartan. People who take those drugs may have been exposed to trace amounts of impurities for at least four years, after a switch in how companies manufactured the active ingredient, according to the Food and Drug Administration.

Torrent expands its voluntary recall of losartan

Update [1/23/2019] Torrent Pharmaceuticals is further expanding its voluntary recall to include six additional lots of losartan potassium and hydrochlorothiazide combination tablets, for a total of 16 lots of losartan-containing medicines. This recall is due to unacceptable amounts of N-Nitrosodiethylamine (NDEA) in the losartan active pharmaceutical ingredient manufactured by Hetero Labs Limited.

Torrent is only recalling lots of losartan-containing medication containing NDEA above the interim ac-

ceptable intake limits of 0.27 parts per million (ppm).

Irbesartan distributed by Solco Healthcare voluntarily recalled

Update [1/18/2019] FDA is alerting patients and health care professionals to a voluntary recall of one lot of irbesartan and seven lots of irbesartan and hydrochlorothiazide (HCTZ) combination tablets distributed by Solco Healthcare LLC, a Princeton Pharmaceutical Inc. subsidiary. The recall is due to unacceptable amounts of N-Nitrosodiethylamine (NDEA) in the irbesartan active pharmaceutical ingredient manufactured by Zhejiang Huahai Pharmaceuticals (ZHP).

Solco is only recalling lots of irbesartan-containing medication where NDEA has been detected above the interim limit of 0.088 parts per million. FDA is working with manufacturers to reduce and remove nitrosamines from angiotensin receptor II blockers (ARBs).

FDA alerts patients and health care professionals to Aurobindo's recall of valsartan medication due to NDEA

Update [1/2/2019] FDA is alerting patients and health care professionals to Aurobindo Pharma USA's voluntary recall of two lots of valsartan tablets, 26 lots of amlodipine and valsartan combination tablets, and 52 lots of valsartan and hydrochloro-

thiazide (HCTZ) combination tablets due to the amount of N-Nitrosodiethylamine (NDEA) in the valsartan active pharmaceutical ingredient. Aurobindo is recalling amlodipine and HCTZ only in combination medications containing valsartan. Neither amlodipine nor HCTZ is currently under recall by itself.

Gift cards: don't save them, spend them

Odds are that you or someone you know received a gift card during the holiday season.

It is easy to see why. The cards are easy to purchase and (typically) easy to use. They can be the perfect primary gift for that difficult-to-buy-for friend or a great stocking stuffer for a college student.

However, too many times I have heard stories about a gift card that was saved for a rainy day only to find out that there was no money on the card because too much time had elapsed.

One of the lesser-known roles of the Illinois State Treasurer's Office involves gift cards. That is why I hear the stories. Here is what you can do to protect yourself:

Know that retail gift cards and bank

gift cards are the two most common types of cards. Retail gift cards only are redeemable at the specific retailer or restaurant that issued the card. Bank gift cards, which carry a payment network such as American Express or Visa, can be used at any location that accepts that specific brand.

Resist the urge to save the card for a rainy day. Doing so may increase the likelihood that some of the card's value will be consumed by fees. Instead, use the card and set aside an equal amount of cash for a rainy day.

Remember that while money on a typical bank gift card cannot expire for at least five years, depending upon the circumstances, inactivity fees can begin in as little as 12 months. Therefore, it is possible that inactivity fees could consume the cash value of a card before the five-year window has expired.

Businesses that close likely will not honor an outstanding gift card.

Treat a gift card like cash. If lost or stolen, report it to law enforcement. Contact the card's issuer to determine if a replacement card is possible and at what cost.

Today, the state treasurer's office holds more than \$3 billion in unclaimed property. Because our records are updated twice each year,

IMPORTANT: Medications containing only amlodipine or hydrochlorothiazide (HCTZ) are not being recalled. Manufacturers are recalling medications containing amlodipine in combination with valsartan or losartan, and medications containing hydrochlorothiazide HCTZ in combination with valsartan or losartan.

Jo Daviess County establishes Veterans Assistance Program

In November of 2018 the Jo Daviess County Board adopted a resolution to establish the Jo Daviess County Veteran Assistance Program Fund and appropriated funds in their fiscal year 2018 Annual Budget for a "Veterans Assistance Program". The purpose of this program is "To alleviate financial burdens that menace the well-being of veterans and their families".

Within the State of Illinois Public Acts is the Military Veterans Assistance Act. Its provisions include that sums of money as may be just and necessary to financially assist veterans and their families be made available by counties within the state. These funds are to be managed and distributed by members of local vet-

eran service organizations and supervised by county officials.

In Jo Daviess County, there are nine Veterans Service organizations that have been approved by the United States Congress. Five are American Legion Posts, three are Veterans of Foreign Wars Posts, and one Vietnam Veterans of America. Initially, the program will be administered by a representative of each group.

The amount budgeted was determined by comparing existing similar surrounding county programs. The Jo Daviess County budgeted amount is far less as it will be administered by volunteers rather than paid employees.

A veteran in need of financial assistance will be required to show proof of an honorable military discharge, proof of Jo Daviess County residency, and complete an application.

Great care will be given to assure the privacy of applicants. When it has been determined that a valid need exists, payment will be made directly to the providing vendor no funds will be paid directly to the veteran. The goal of the program is to provide these funds as a path for the veteran and his or her family to regain financial independence, thus, limits will be placed on amount and duration.

Senior Center initiates tax program sign up

As a new year begins, the Senior Resource Center is focusing on one of its most popular programs: the AARP Tax-Aide Program. From February to April, trained volunteers will prepare 1040 federal and state tax returns for low-and middle-income taxpayers focusing on seniors in Stephenson and Jo Daviess counties. This free program serves about 1,000 people each year.

The 2019 tax season officially begins at the Senior Resource Center on Monday, Jan. 21, when we begin taking Tax-Aide appointments. Call 815-235-9777, ext. 221, to make an appointment. Because the Senior Resource Center is closed that day, leave a message and we will return your call the following day in the order received. Or call on Tuesday, Jan. 22. Schedule your appointment for a time after you believe you will have all your documents; you can schedule before you have actually received all your documents.

Appointments in the Freeport office will be available from Friday, Feb. 1, to Friday, April 12. Hours are 8:30 a.m. to 4 p.m. Mondays through Thursdays with half-days on Fridays. No service is available on weekends.

Tentative dates for service in the Hanover office are from 9 a.m. to 3 p.m. on Feb. 20, March 6, March 20 and April 3. All are Wednesdays. To make appointments at one of these sessions, call 815-235-9777, ext. 221, and request an appointment in Hanover. If you are a Jo Daviess County resident and cannot attend one of these Hanover dates, appointments are available in the

Freeport office.

All tax preparers undergo training and are certified by the Internal Revenue Service. The same number of preparers are available this year as were last year. There is still time for volunteers to join and be certified for this year's program. Additional preparers are especially needed in Jo Daviess County. Contact Betsy Vittinghoff, AARP Tax-Aide supervisor, for more information on volunteering at 815-235-9777, ext. 234.

The Tax-Aide Program's certification does not allow it to prepare tax returns that include farm income (except if only land rental), military returns, ministerial income, cancellation of mortgage debt, business income that involves depreciation, rental income, and K-1 forms with ANY other entries than interest, dividends, capital gains or royalties.

Vittinghoff's biggest tip to all those who are using the Tax-Aide Program is simple: Come organized. Make sure you bring everything that is asked.

The Senior Resource Center offers programs, education and activities for people 50 and beyond, their families and caregivers in Stephenson and Jo Daviess counties. The programs include Adult Protective Services, AARP Tax-Aide, Information & Assistance, Money Management Program, Community Care Program, Transit and Ed-

ucation & Activities.

AARP Tax-Aide Details

Items to Bring to Appointments

- A photo ID.
- A Social Security card for each person on the return. (New Medicare cards do not have Social Security numbers.)
- Proof of all income (including Social Security benefits).
- Proof of medical insurance coverage for each person on the return.
- For joint returns — both persons must be present.
- Your previous year's return.
- Before You Come
- Ensure you have all the required documents (see above). If not, reschedule your appointment.
- If you are on Medicare, you are considered to have coverage for the Affordable Care Act (ACA). If you have received a Premium Tax Credit for 2018, that requires us to fill out additional forms with your return. If you do not have a 1095-A, B, or C form, you can obtain one from your employer or from healthcare.gov before your appointment.
- We ask that you arrive at least 15 minutes before your appointment to fill out required IRS intake information forms. If you have itemized deductions, we ask that you summarize and list all deductions before you come, in order to optimize the 45- to 60-minute appointment schedules.

The not so skinny cook

Trying to stay warm! We have been thinking about winter weather and knowing we have had several near misses, but we got hammered this week. The people who are happy about this are snowmobilers and skiers. I got my column done early because I was housebound for three days. Enjoy the soups and desserts this week.

This refreshing fruit salad would

be good any time of the year. There have been some great specials on berries the last couple of weeks in the supermarkets. This salad will help you think of warmer weather! You can substitute mint extract for the fresh mint. Remember that mint extract goes a long way; I would start with 1 teaspoon and add more as you taste.

Minty Berry and Grape Salad

- 1 t. orange zest
- 3 T. fresh orange juice
- 2 T. minced fresh mint
- 1 T. honey
- 3 C. quartered fresh strawberries
- 2 T. fresh blackberries
- ½ C. seedless red grapes, halved
- ½ C. green grapes, halved

In a large bowl, whisk together the zest, juice, mint and honey until smooth. Place the fruit in a large glass bowl. Stir in the dressing until

the fruit is well coated. Refrigerate for 1 hour before serving.

This soup is a great one that combines ham, cheese, potatoes, and carrots. You will like how easy it is. It will be a quick one to serve on a cold winter night.

Ham Cheddar Chowder

- 3 C. cubed peeled potatoes, 1 inch pieces
- 2 medium carrots, chopped
- 2 t. salt
- 3 C. water
- 6 T. butter,
- 1 medium onion, chopped
- 2 celery ribs, chopped
- 6 T. flour
- 1 t. pepper
- 4 C. whole milk
- 3 C. shredded cheddar cheese
- 1 C. cubed fully cooked ham

Place the first four ingredients in a saucepan and bring to a boil. Reduce

heat; cook, uncovered, until vegetables are tender. Stir in flour and pepper; slowly stir in milk. Bring to a boil, stirring occasionally; cook and stir until thickened. Remove from heat; stir in cheese. Stir in ham and potato mixture; heat through over low heat.

My friend, Karen, had sent me two soup recipes before Christmas. I put the black bean one in earlier, and this second one is a good potato soup that is as easy as her black bean soup. You will enjoy the flavor of the bacon in this hearty winter soup.

Loaded Baked Potato Soup

- 4 potatoes, peeled and diced into ½ inch pieces
- 1 onion, diced
- 4 T. flour
- 4 T. unsalted butter
- 8 slices of bacon
- 3 C. chicken stock
- 3 C. whole milk
- ½ C. sour cream
- 1½ C. shredded sharp cheddar
- Chopped green onions
- Salt and pepper to taste

In a large Dutch oven or soup pot, cook the bacon until it becomes nice and crispy, about 4 minutes. Remove to a paper towel lined plate using a slotted spoon and set aside.

Discard any fat that the bacon rendered and add the butter and onion and sauté until the onion becomes translucent and develops a bit of color, about 4 to 5 minutes. Add the flour and stir constantly for 1 minute, add the milk, stock and potatoes and bring to a simmer and cook for about 20 minutes or until the potatoes are tender. Add the sour cream, cooked bacon and cheese and stir everything together and cook for 5 more minutes. Adjust the seasoning to taste and serve. Garnish with green onions and extra sprinkle of cheese.

You have to have a chicken noodle soup in a winter soup column. This one has a little bit of depth to it due

to the cream in it. It will be great to serve if you have any colds in the house. My grandmother used to always say that chicken noodle soup was good for whatever ailed you. Here is to you Grandma B.; I still remember all of your great sayings after all of these years.

Creamy Chicken Noodle Soup

- 2 T. butter
- 1 medium onion, finely chopped
- 1 C. chopped celery
- 1 C. copped carrot
- 4 cloves, garlic, minced
- 6 boneless skinless chicken thighs
- 4 C. chicken broth
- 3 C. half and half
- 1 t. poultry seasoning
- 1 t. salt
- ½ t. pepper
- 6 oz. egg noodles
- Fresh parsley for garnish

In a large Dutch oven, melt butter over medium heat. Add onion, celery, and carrot; cook until softened, 5 to 7 minutes. Add garlic; cook for 30 seconds. Push vegetables to sides of pot and add chicken; cook until browned, about 3 minutes per side. Add broth, half and half, poultry seasoning, salt, and pepper. Add egg noodles; bring to a boil. Reduce heat; cover and simmer for 15 minutes. Remove chicken, and transfer to a cutting board. Chop chicken and return to soup. Garnish each serving with chopped parsley.

You all know how much I love bar cookies; I really like these because they use a cake mix base. Enjoy these yummy chocolate treats after you have eaten some soup.

Monroe Clinic offers patients 'A Clinical Approach to Weight Loss'

A new program at Monroe Clinic aims to tear down the barriers standing between people's good intentions and permanent weight loss. "HealthSmart: A Clinical Approach to Weight Loss" bypasses the diet trends and product tie-ins to focus on evidence-based practices and accountability.

"There's no fad diet. No food group elimination or pricey supplements to buy. It's an approach based on the American Heart Association's guidelines, focused on permanent behavioral change," said Laura Holverson, clinical dietitian.

She explained that the year-long program is intensive, especially in the early stages. Holverson meets with patients once weekly for four weeks, then every other week for the following five months, decreasing to one meeting per month in the final six months. All meetings are currently one-on-one. They focus on:

- developing a personalized plan based on individual capabilities
- learning what healthy eating looks like in the perimeters of real life
- setting realistic and measurable

goals

- identifying tools and resources that support those goals
- finding ways to tap into personal strengths and motivation

Launched in July 2018, over 50 patients are currently enrolled. Holverson said she's already witnessed some amazing success stories.

"It's really up to the patient. One of my most successful patients has mobility issues, but this individual is willing to try new things with food, use the tools we discuss in our meetings and is committed to putting in the effort," said Holverson.

The program does require a referral by a primary care provider, and coverage varies by insurance plan. While the commitment to regular meetings is a key component of the program, she said she can customize the program to work with each participant's schedule. To achieve results, however, the person must be committed to the program.

"This is not a quick fix. The program is about the long haul, and if a person is willing to give up old habits and be open to new ones, he or she can achieve change," said Holverson.

To qualify for the LIHEAP Emergency Furnace Program, the household must first apply for and be approved for LIHEAP assistance.

The household must have active service with both primary and secondary heating utilities. Households with disconnected utilities are not eligible for this assistance.

Filling:

1 pkg. (8 oz.) cream cheese

1 egg, lightly beaten
1 C. miniature semisweet chocolate chips

Mix cake mix, oil and egg until blended. Reserve 1 cup of cake mixture for topping. Press remaining mixture into a 9 x 13 baking pan coated with cooking spray. Bake at 350 for 10-12 minutes or until set.

Filling: beat cream cheese and sugar until smooth. Beat in egg. Spread over crust. Sprinkle with chocolate chips and reserved topping. Bake until set, 18 to 20 minutes. Cool on a wire rack. Cut into bars and store any leftovers in the refrigerator.

I have made chocolate sheet cake, white sheet cake, lemon sheet cake, and probably many more sheet cakes. I have never had a recipe for peanut butter sheet cake. What is better than peanut butter in a cake? Try this one and find out.

Peanut Butter Sheet Cake

Cake:

2 C. flour
2 C. sugar
½ t. baking soda

¼ t. salt

1 C. water
½ C. butter, softened
½ C. chunky peanut butter
2 eggs
½ C. buttermilk
1 t. vanilla

Frosting:

2/3 C. sugar
1/3 C. evaporated milk
1 T. butter
1/3 C. miniature marshmallows
1/3 C. chunky peanut butter
½ t. vanilla
Chopped peanuts for garnish

Preheat the oven to 350. Grease a 10 x 15 jelly roll pan. In a large bowl, stir together flour, sugar, baking soda, and salt. In a saucepan, add water, softened butter, and peanut butter; bring to a boil. Stir peanut butter mixture into dry ingredients.

In a small bowl, stir together the eggs, buttermilk, and vanilla; stir into peanut butter mixture until well blended. Spread batter evenly to prepared pan. Bake until a toothpick inserted into the center comes out clean, about 25 minutes.

Frosting: Stir together the sugar, evaporated milk, and butter in a saucepan. Bring to a boil, stirring constantly. Cook, continuing to stir for 2 minutes; remove from heat.

Stir in remaining ingredients until marshmallows are melted and mixture is smooth. Evenly spread frosting over warm cake. Let cool about 1 hour before garnishing with peanuts and cutting into 20 pieces. Chill in refrigerator any leftover cake.

The Mediterranean diet, or eating plan is influenced by the cultures,

lifestyles and typical dietary patterns of those living within the Mediterranean region in the early 1960s. The Mediterranean eating plan, gained notoriety when Ancel Keys, a researcher from the University of Minnesota, noted a correlation between cardiovascular disease and diet. During Keys research, he noted a phenomenon in which poorer communities around the Mediterranean region had healthier individuals, compared to wealthier individuals

living in the United States. This led to the Seven Countries Study and from this study the concept of the Mediterranean eating plan was developed.

The Mediterranean eating plan or pattern, varies greatly. And which foods should be included within the plan is controversial, given the variation between the counties within the region. However, there are common foods and health behaviors that we can all agree on. Join University of

Illinois Extension, Nutrition and Wellness Educator, Diane Reinhold to learn what those foods are and more as we explore the Mediterranean Eating Plan.
