## Lena-Winslow falls to Pearl City in conference battle

The Lena-Winslow boys came into the Pearl City gym holding a 16-6 overall record, while sitting at 5-2 in their conference. The 5-2 record is good enough to put the Panthers in fourth place, as the Northwest Upstate Illini-West Conference features a four way battle for first between Pearl City, East Dubuque, River Ridge, and Lena-Winslow. Pearl City came in at the top of the conference with an undefeated 6-0 in league record, while they held an 11-4 record on the season.

These teams faced off just over two weeks ago, when they both traveled to the United Center for what would be considered a non-conference game. Lena-Winslow would take home the victory 45-39; however it wouldn't benefit their conference standings, which is how Pearl City remained undefeated in the

Last Friday's match would be the third time these teams faced off this season, and it surely did not disappoint. Both teams have struggled to play scheduled games with recent weather. The weather also caused a lack of practice for both squads, and it showed early on in Friday's match

Pearl City had a fantastic first quarter from beyond the arc. Lucas Petersen and Brock Smargiassi each delivered a pair of three-pointers as they led the Wolves to a 16 point first. Parker Magee provided most of LeWins'; offense early on, hitting a three-pointer and a pair of jumpers, giving him seven in the quarter. The Panthers would trail the Wolves 11-16 as they began the second.

Pearl City hit a drought in the second as they went 0 for 9 from the field through most of the quarter. In fact, for the first seven minutes, their only points came off three Jayden Kempel free throws.

LeWin's Sean Ormison managed to hit a spin move in the lane and land a tough layup which brought the Panthers within four, down 19-15. The Wolves finally got their first basket of the half with just over a minute

remaining when Braden Smargiassi hit a three-pointer. Collyn Kuberski would also hit a layup just before the buzzer, putting Pearl City up by nine just before halftime. Both teams would struggle offensively in the second, as the Panthers managed to get just four points of their own. The Wolves would hold a 24-15 lead as they went into the break.

Brock Smargiassi would score the first basket of the second half which would temporarily give the Wolves a double digit lead. Magee and the Panthers would answer quickly with a layup of his own, cutting the score to 26-17.

The teams would go back and forth on their next couple possessions, eventually coming to a 30-21 Pearl City lead.

While Jayden Kempel was at the free throw line, a technical was called on Lena-Winslow which allowed the Wolves to extend their lead to double digits once again, as they went up 32-21.

The Wolves and Panthers would head into the fourth with Pearl City

Parker Magee would then go on an absolute tear. Magee would hit a three, a tough layup, and another three-pointer as he scored 10 straight points for the Panthers and brought them within just two, down 33-31. Ormison would then hit a layup of his own, completing the Panthers 10 point run and tying the game at 33

Jarod Kempel would end the Panther run by going two for two at the free throw line, giving the Wolves a 35-33 lead. Brock Smargiassi would steal the Panthers ensuing in-bound pass, leading to another foul, in which Brock would go two for two, and extend the Pearl City lead to four.

Parker Magee would continue his hot hand, however, as Magee hit two straight three-pointers right in the face of Pearl City's defenders. Magee almost single handedly tied the game for the second time Friday night, bringing the score to 39-39 with just under 40 seconds remaining.

Pearl City would hold the ball until the final seconds, as they set up the

play they wanted to run. Brock Smargiassi dribbled at the top of the arc until the clock hit 11 seconds; he ran a fake pick and roll until he found his brother Braden in the left corner with a matchup the Wolves liked. Braden then hit a pump fake which allowed him to drive to the basket where he hit a layup that bounced around the rim and eventually fell with just four seconds remaining.

The Panthers did what they had to do, which was give Magee the ball. However, they had to drive the length of the court in just four seconds, and the Pearl City defense held Magee to just a half court heave, which would fall short.

The loss puts a damper on the Panthers Conference championship

hopes. With just two conference games remaining on the schedule, and Pearl City sitting at 7-0, it puts the Panthers just out of reach of passing up the Wolves.

These teams could meet up for a fourth time this season, however. It

# Lena-Winslow/Orangeville Speakers head to state tourney

close on Saturday, Jan. 26. Some schools began competing in October, some in November, and most in December, but after the fourth Saturday in January fades into history, the "real thing" starts- the IHSA State Series, consisting of Regional, Sectional, and State competition.

"Real thing" may be a bit of a misnomer. The preceding invitational speech tournaments are important in that they prepare the students to be at their best in the State Series. They also help coaches determine who will be on the State Series team to begin with. Unlike the other tournaments where, within reason, the coaches can enter as many students as they wish in each of the fourteen speaking categories, the "Regional Team" as it's also called, is limited to one student per team per category. But unlike many other high school sports and activities, there is no regular season win-loss record to take into account. Speech teams are not seeded in the post-season. Come the first weekend in February, the slate is wiped clean and a new competition begins featuring the best that the competing teams have to offer.

The Lena-Winslow/Orangeville speech team certainly ended their regular season on a high note taking first place in the Small School Division (Ninth overall out of seventeen teams) at the Rockford Jefferson Top of the State tournament. A first place award in an invitational tournament

"regular" speech season came to a cate that a team is the "best" in that tournament, the local region, or even the entire state.

Subjectivity is intertwined into the DNA of competitive speech so much that any notions of "best" are purely speculative. The Le-Win/Orangeville team did have many quality performances that day including three first place awards. But, the key to the first place award was to have speakers earn high ranks in all fourteen categories. Invitational tournaments that follow well-established, but unofficial protocol award team points as a result of individual rankings of all participating students. The higher a student places, the more team points are awarded. Add up all of the points across the fourteen categories, and you have your rankings.

A common technique for a team to increase its tournament ranking is to "double-enter" students, meaning they compete in more than one category thereby earning more points. Typically, Le-Win/Orangeville has about half of its students double-entered. If a comparably-sized team has more double-entries, that team earns more points, and thus a higher ranking. So, a high ranking is a matter of quality and quantity.

So how, with high-quality performances from veterans and rookies alike did the Le-Win/Orangeville team wind up with such a high rank-

Two of the three individual first place prizes were given to the Orangeville radio-speaking pair of Malone and O'Brien, names that sound like they would be attached to a 1920s Dublin vaudeville act or a company that produces Irish spirits, but of course being Irish has nothing to do with anything. Some of the last names of IHSA Radio State Champions in the last few years have included Volkman, Surabhi, Sommerfeld, Georgiou, Patel, and Cavazos.

And what do all of those names' owners have in common? They were good at what they did, which was to take an extensive pile of news, sports, and weather clippings, plus a commercial, and given a mere forty-five minutes, assemble them into a newscast that must fit into a tight little window of four minutes and fifty seconds to five minutes and five seconds. Think that's easy? Try it.

Volkman, Surabhi, Sommerfeld, et al, like Malone and O'Brien are just good at what they do. They take God-given ability and apply it. That's their secret. And it's the secret of many other students in the state that have reached the top of their game, or are rapidly approaching it. And speaking of Lucas Schoaf . . .

The Lena-Winslow sophomore receives this year's "What Took You So Long? It's About Time" award to go along with his first place Next-In varsity award in Original Comedy, given to him at the Jefferson tournament. Lucas had a fantastic breakout year as a novice freshman, winning three varsity awards as well as many novice prizes. But, the coach with whom Lucas primarily worked last year resigned his Lena-Winslow teaching position last summer to take a similar job downstate, and sometimes that can wreak havoc with a coaching continuity.

A second fake award is the 'You're Really Good and We've Been Waiting Two Years for You to Join the Team" prize, which is given to rising star Kierra Lynn Schulz, a Le-Win junior and veteran of the

Lena-Winslow stage. Even though she has performed in the Humorous Interpretation category just a small handful of times this year, she finished a very respectable eighth place at the Jefferson tournament, beating out top-flight talent from Freeport, DeKalb, and Bartlett, a large suburban school with an enrollment of nearly 2,500.

The "Break Time's Over, Back to Work" award goes to Le-Win senior Ella Brunner, who took her junior year off after a very successful freshman year and representing the team in the Prose Reading category at the 2017 Regional Tournament as a sophomore. She finished fifth in the Next-In Dramatic Interpretation category at Jefferson. Ella also teamed up with Kierra Lynn to form the team's strong Humorous Duet Acting pair.

And, if there was an award called "Getting Better and Better," Le-Win sophomore Andrea Sutter would win it, because her weekly rankings have been getting just that, better and better. Andrea won the fourth place Next-In prize (10th place overall) in Prose Reading at Jefferson out of a field of thirty-seven competitors, the biggest category in the tournament.



Congratulations to Freeport Area Church Cooperative (FACC) on being the recipient of the November quarterly donations! They were presented with cash and checks totaling \$13,200!

Every year the FACC serves over 3,000 adults and 1,700 children through its food pantry. Though the number of families served through the food pantry has been fairly steady over the past several years, food donations from the community (that the pantry heavily relies upon to fight food insecurity) has been on the decline. Last year, FACC received almost \$11,000 less in food donations than in 2016. 2018 looks as though the pantry will again fail to raise enough food donations to adequately serve those in need.

## \$15 minimum wage is first major legislation of 101st General Assembly

Illinois Senate Assistant Majority Leader Kimberly Lightford, a Maywood Democrat, said the chamber is ready to push ahead with a bill to increase the state's minimum hourly wage from \$8.25 to \$15 over an undefined period of years.

The only rate structure mentioned at a Senate Labor Committee hearing on Wednesday, Jan. 30, was a \$1 increase to the \$8.25 rate for each of the next six years, then a 75-cent increase in the seventh year. Lightford said the rate would be phased in by 2025.

Business interests also preferred a regional rollout of the tax increase. In Oregon and New York, high costs of living areas have a minimum wage that is higher than in more rural areas. Lightford said this would be discussed, but she was not sure it would be permissible per the Illinois constitution.

Senator Dave Koehler, a Peoria Democrat, raised the idea of regional tax breaks for employers in lower costof-living areas to counteract the \$15 minimum wage.

The committee also heard testimony from employers who said a \$15 minimum wage would be a "job killer," and a nursing home advocacy group pro-

posed a measure to increase the state's reimbursement rate to Medicaid facilities as the wage increases.

The Illinois Association of Park Districts, small business lobbyists and the Illinois Restaurant Association all raised concerns that the hike could mean layoffs for minimum wage workers as well.

While the group agreed to several points of discussion, the clock was ticking for the interest groups to get their preferred language in the bill, as Gov. J.B. Pritzker wants the bill on his desk to sign prior to his budget address scheduled for Feb. 20.

DIGITAL DAYS: If a bill mandating five hours of direct teacher-student supervision becomes law this session. schools would no longer be able to count digital day alternatives to snow days as an official school day.

The Senate Education Committee advanced the bill unanimously Tuesday, Jan. 29, while agreeing to discuss more calendar flexibility for school districts.

State Sen. Jennifer Bertino-Tarrant (D-Shorewood), the bill's lead sponsor and Education Committee chair, said she understood that more flexibility is needed for school districts and was committed to working toward it. But she warned of the "wild, wild west" created by the repeal of the five-hour mandate.

"Right now a district could choose to have four days of school in a year,'

If the bill passes both houses and is signed by the governor, the five-hour mandate would go into effect immediately. Superintendents, many whose districts were employing digital days due to the recent extreme cold, had concerns about the confusion this would cause for the current school

GOVERNMENT EFFICIENCY COMMISSION: Woodstock Republican Rep. Steve Reick wants a private-sector commission to examine the spending habits and management practices of state agencies by minimizing redundancies in funds the state already allocates.

His legislation, House Joint Resolution 6 and House Bill 275, would create an 18-member commission to comb through reports from the auditor general's office and recommend ways to reduce spending, boost performance and adapt management strategies for state agencies. The group would be funded through private donations.

Commission members would be chosen by each of the four legislative leaders and Democratic Gov. J.B.

Among the proposal's detractors is the Center for Tax and Budget Accountability Executive Director Ralph Martire. The Center is a nonpartisan think tank that "promote[s] social and economic justice for everyone," according to its website.

Martire said the commission's organization as a 501(c)(4) could allow dark money to manipulate the process.

HOUSE RULES COMMITTEE: The five-member Illinois House Rules Committee will maintain its power over the legislative process for the 101st General Assembly despite objections from Republican members of the committee this week.

Illinois House Deputy Minority Leader Tom Demmer, a Dixon Republican and member of the House Rules Committee, said the three Democrats on the panel have the power to hold any bills in the committee indefinitely for any reason.

Democratic Rep. Greg Harris said the process is old, efficient and necessary to sort the 6,000-plus bills that are filed each year - and it originated with Republicans in the 1990s.

Thousands and thousands and thousands of bills are referred out to other committees," Harris said. "I think it's sort of a solution in search of a problem to find, out of 6,000 bills, the two or three that do not advance and say "Aha! Something is going on."

One day after the rules passed committee by a 3-2 vote, the House voted 73-42 along party lines Tuesday, Jan. 29, to keep the rules in place with only minor adjustments.

**GOVERNMENT** BILLS: A pair of Republican lawmakers filed government reform bills this

Rep. Margo McDermed of Mokena introduced a bill to ban any retired lawmaker from registering as a lobbyist, or receiving or making payments as a lobbyist, for one year or the remainder of their term — whichever is longer.

GOP Rep. David McSweeney of Barrington Hills put forth a bill to end to lawmaker pensions for new members after Nov. 3, 2020.

House committee assignments have not been handed out, so both McSweenev's and McDermed's bills are stuck in the powerful, Democrat-controlled House Rules Committee. McDermed said it's possible her bill never makes it out of the committee.

COLLEGE ILLINOIS: Eric Zarnikow, executive director of the Illinois Student Assistance Commission, an agency that administers the program known as College Illinois, urged Illinois lawmakers this week to give the "full faith and credit backing" to the state college savings program.

He said the backing, which would give the program's debt obligations the same status as those of general obligation bonds, may be the only way to restore public confidence in the program

By 2011, Zarnikow said, rising college costs and other market factors caused the program to rack up a \$536 million "unfunded liability" - the difference between its assets and expected earnings on the one hand, and the anticipated cost of all its current obligations on the other.

Officials expect that by 2026, the program will need an infusion of about \$81 million from the state in order to meet its "moral obligation."

The Tuesday, Jan. 29, meeting was for informational purposes only and no action was taken.

REDISTRICTING PROPOSAL: For the second consecutive legislation, CHANGE Illinois is proposing a constitutional amendment that would change how the state's political boundaries are drawn.

The coalition of interest groups has been working since 2012 to change Illinois' redistricting process, which occurs every 10 years, after each U.S. Census. The next redistricting period will be in 2022

CHANGE Illinois proposes no longer allowing the General Assembly and governor to decide the boundaries of districts. Instead, those decisions would be made by a commission that "demographically, politically geographically" represents the prairie

The group's twin measures, sponsored by Sen. Julie Morrison (D-Deerfield) and Rep. Ryan Spain (R-Peoria), would place map-drawing under the purview of the state Supreme Court. The chief justice and most senior justice "who is not elected from the same political party" would together select 16 citizens to form a commission seven Democrats, seven Republicans and two independents. It would require state Supreme Court justices to have political party affiliations.

The redistricting revamp would require a constitutional amendment, which carries a high burden of approval to be successful. Both chambers of the General Assembly must give their support by a three-fifths majority before it can go to voters. Then, 60 percent approval by voters is needed.

COMPTROLLER'S WORDS OF CAUTION: Illinois Comptroller Susana Mendoza is imploring the General Assembly to be realistic with revenue projections this year to avoid adding to the state's backlog of unpaid bills.

A compromise budget passed last year was hailed as balanced by many lawmakers, but will actually add \$1.5 billion to \$2 billion to the state's backlog, which was estimated about \$7.3 billion as of Thursday, Jan. 31

One year ago, the General Assembly passed Mendoza's Debt Transparency Act, mandating state agencies to provide accurate monthly reports on liabilities, including the escalating cost of interest penalties. This allowed budgeteers to identify which agencies lacked adequate appropriations to process their bills and account for it in ne-

Even with the adequate debt information, Mendoza said, a budget cannot be balanced without accurate revenue

Shortfalls in last year's budget come from various sources, including false revenues from the non-existent sale of the James R. Thompson Center in Chicago. It also included savings from proposals, such as a pension buyout plan, that will potentially fall short for the current fiscal year, the comptroller's news release said.

Other key findings Mendoza listed in her report include:

- The unpaid bill backlog continues to force the Office of the Comptroller into crisis management, impede timely bill processing, cause instability for state programs, and creates unnecessary and costly late payment interest penalties.
- Given that the fiscal year 2019 budget also failed to address the current backlog of bills, taking significant steps in fiscal year 2019 to pay down the backlog of unpaid bills - or even keep it static – is impossible.
- · Temporary tools to manage the backlog granted under the current budget do not resolve systemic budgetary issues. Dedicated funding is needed to lower the bill backlog.

STEP INCREASES FOR WORK-ERS: Illinois AFSCME union employees will receive their scheduled and long-withheld pay step increases starting in April, a spokesperson for Gov. J.B. Pritzker announced Thursday, Jan.

Step increases are required by state law to be paid to employees in their first eight to 10 years because they start at a below-market rate as a savings to government. Former Gov. Bruce Rauner halted them in 2015 when AFSCME's last contract expired.

Pritzker promised to pay the step increases - which were mandated to be paid by court order anyway - in his first week in office.

The increase is expected to cost about \$50 million, and Pritzker's office said employees will begin seeing this reflected in their paychecks in the first half of April, although some agencies could require more time to adjust paychecks.

OPIOIDS ALTERNATIVE: Patients over the age of 21 who are prescribed opioids will have temporary access to medical marijuana as an alternative treatment after the state's Opioid Alternative Pilot Program began accepting patients Thursday, Jan.

Under the program, patients must obtain a physician's certification of a condition which could require the pre-



FHN offering special pricing on heart tests for American Heart Month

Most heart attacks could be prevented with early diagnosis of risk factors for coronary artery disease (CAD). FHN is celebrating American Heart Month in February with special pricing on two heart health tests.

Call between Friday, Feb. 1 and Thursday, Feb. 28 to schedule a Standard Walking Treadmill Stress Test or Calcium Scoring CT Heart Scan and pay just \$139 for the test.

The treadmill stress test is a screening test for determining a patient's heart health when they have no known history of heart trouble," said FHN cardiologist Bhadresh Patel MD, FACC, FACP. ## Martin Luther King's influence resonates in Illinois

"He would have been 90 this year," says the Rev. Jesse Jackson, founder and president of the Rainbow PUSH

Jackson was reflecting on this year's holiday honoring his mentor

Jan. 15 was Dr. Martin Luther King Jr.'s birthday, celebrated nationally on Jan. 21.

As the years go by, there are fewer of those who marched with him to share their memories. But Jackson, one of his closest aides, can still recount milestone moments from King's Chicago Freedom Movement of 1965-66 like it was yesterday.

"Our offices used to be at 366 E. 47th St., in what's now Bronzeville, and we used to meet every Saturday morning at Chicago Theological Seminary," says Jackson, 77, who first met the man of peace at an airport in 1964, when King was en route to pick up his Nobel Peace Prize.

Jackson then marched with King in the 1965 Selma to Montgomery

He soon joined the team of the charismatic civil rights leader and was assigned to run Operation Breadbasket, the Southern Christian Leadership Conference's anti-pover-

When the Baptist preacher who espoused nonviolence brought the fight for equal rights north to Chicago, Jackson was at his side. Here are

speech at the Illinois Rally for Civil Rights at Soldier Field, days after the Civil Rights Act of 1964 was passed. Then, after being asked by the Coordinating Council of Community Organizations to come help Black Chicago fight for quality schools, King led a July 26, 1965 march on City Hall; gave a fiery speech before tens of thousands at the July 10, 1966, Freedom Sunday Rally at Soldier Field; and on Aug. 26, 1966, held a globally covered "Summit Agreement" with Mayor Richard J. Daley.

As part of his "End Slums" campaign, King famously moved his family into a dilapidated, third-floor walk-up at 1550 S. Hamlin Ave. in North Lawndale on Jan. 1, 1966, the building is long gone but the Dr. King Legacy Apartments and Fair Housing Exhibit Center now marks

King's open housing marches, and the attendant violence from angry residents on the Southwest Side, are most remembered, culminating with the infamous Aug. 5, 1966, march through Marquette Park, where the Baptist preacher was felled to the knee by a rock to the head, lending credence to his famous quote: "I have never seen, even in Mississippi and Alabama, mobs as hateful as I've seen here in Chicago."

"When King came to Chicago, we couldn't live west of Ashland, and blacks were hemmed into these ghettos," Jackson says, taking a reporter down memory lane.

Born Jan. 15, 1929, in Atlanta, Ga., King was ordained and became assistant pastor at his father's Ebenezer Baptist Church in 1948. He married the beautiful Coretta Scott King in 1953, with whom he had four

It was in 1955 that his civil rights efforts began in earnest, when he became president of the Montgomery Improvement Association, the group that led the 13-month Montgomery Bus Boycott after Rosa Parks refused to give up her seat to a white man on a city bus. It ended with the U.S. Supreme Court ruling segregation on public buses unconstitutional.

King gave his tide-turning "I Have A Dream" speech at the 1963 March on Washington for Jobs and Freedom, and in 1964 came the Nobel

The Selma to Montgomery marches, following the infamous "Bloody Sunday" at the Edmund Pettus Bridge, followed in 1965. And King would spend most of the following year in Chicago, marking the expansion of the civil rights battle from the South to northern cities, with key activists Jackson, James Bevel and Al

King's mark — while combating racial segregation and discrimination in Chicago — extended to suburban and Downstate Illinois, such as his Feb. 10, 1966, speech before thousands at the Fred Young Fieldhouse of Illinois Wesleyan University in Bloomington.

Some still debate the success of King's Chicago campaign — Illinois' largest city remains one of the

House of Representatives, president of the Senate, minority leader of the House or minority leader of the Senate.

Per the amendment, legislative leaders would be limited to serving for a total of eight years in any one position and 12 years combined in two or more

Speaker Madigan is the longest-serv-

ing state house speaker in U.S. history and was first elected in 1983.

The powerful House Rules Committee headed by one of Madigan's main lieutenants - Rep. Greg Harris (D-Chicago) – controls the flow of any bill filed in the House and would have the power to prevent its committee





The not so skinny cook

Trying to stay warm! I think that s how I started last week's column. I had intended to have some Super Bowl recipes in this week, but time (actually a whole week got away from me), so I hope you all had good eats for the game. It seems as if I can't keep my days straight. I spent last year at this time having the same problem but for different reasons. When you can't go outside, you tend to have trouble keeping tract of what date it is and where you are in terms of weeks of the month. The first recipe is for another soup. This one is based on the Reuben sandwich. It is easy to make and if you like corned beef, you will like this one. Be sure you rinse your sauerkraut to keep a handle on the salt. I also always use the reduced sodium beef and chicken broth. You can find deli corned beef in most grocery stores. Keep warm with this great

#### Reuben Soup

2 T. olive oil

1 sliced onion

1½ C. drained sauerkraut

1½ t. caraway seeds

5 C. beef broth

8 oz. corned beef, chopped into bite size pieces

3/4 C. sour cream

Shredded Swiss cheese

Marble rye bread, toasted and cut into squares

Heat olive oil in a large pot over

onion and salt and cook, stirring often, until onion is soft, about 8 minutes. Add sauerkraut and caraway seeds and cook for 2 minutes. Add beef broth and increase heat to high. Bring mixture to a boil. Reduce heat to a simmer and stir in corned beef. Simmer until corned beef is warmed through, about 10 minutes. Turn off heat and stir in sour cream. Ladle into bowls and top with shredded Swiss and marble rye squares.

This is an easy way to change the traditional lasagna. I have had chicken lasagna made with a white sauce, but this recipe makes chicken parmesan into lasagna. Funny thing about the recipe is that it doesn't use Parmesan cheese-thought I should mention that in case you thought I didn't have the recipe correct. Remember that you can substitute dried basil and oregano. If the recipe asks

blespoons, use one teaspoon of dried or one tablespoon. I really like the freeze dried herbs that are available near the fresh ones in the produce aisles. They are much better and fresher than the ones in the spice aisle. Also use any kind of pasta sauce other than the traditional for more flavor.

#### **Chicken Parmesan** Lasagna

11/2 lbs. chicken cutlets, browned and cooked

1 can (28 oz.) crushed tomatoes

1 jar (24 oz.) pasta sauce

2 (15 oz.) containers ricotta cheese

2 T. chopped fresh oregano

2 T. chopped fresh basil

1¼ t. salt

1 t. garlic powder

½ t. pepper

16 lasagna noodles, cooked and drained according to package direc-

4 C. shredded Italian cheese blend, divided

11/2 C. shredded mozzarella cheese <sup>1</sup>/<sub>4</sub> C. panko

Coarsely chop the chicken breasts into bite size pieces. Preheat the oven to 350. Spray a 9 x 13 pan with cooking spray. In a small bowl, stir together crushed tomatoes and pasta sauce. In a medium bowl, whisk the ricotta, eggs, oregano, basil, salt, garlic powder and pepper. Spread ½ C. tomato mixture in the bottom of the prepared dish. Arrange 4 egg noodles over tomato sauce. Place one-third of ricotta mixture onto noodles. Spread one-third of the chicken and 1 cup Italian cheese blend onto ricotta mixture. Drizzle

with about 1½ cups tomato mixture. Repeat the layers twice, ending with remaining 4 noodles and remaining tomato sauce. Spray a sheet of foil with cooking spray; cover lasagna with spray side down. Bake until hot and bubbly, about 1 hour. Uncover and sprinkle with mozzarella, bread crumbs, and remaining 1 cup cheese blend. Increase oven temperature to broil. Broil on middle rack of the oven until the cheese is melted and bread crumbs are lightly browned, about 1½ minutes. Let stand for 20 minutes before serving. Garnish with parsley or basil if desired.

This spice cake has the flavor of an old fashioned spice cake that my grandmother used to make. It makes a really pretty cake on a stand. Enjoy this spice cake that gives you a nice warm feeling when you eat it.

#### Mama's Spice Cake

1½ C. sugar

1 C. raisins, chopped

1 C. water

34 C butter, cubed

1 t. cinnamon

½ t. allspice

1/4 t. ground cloves

½ t. ground nutmeg

4 eggs, separated

2 C. Flour

3 t. baking powder

½ t. salt

1/4 t. baking soda

<sup>1</sup>/<sub>4</sub> C. chopped pecans

Frosting: 1 pkg. (8 oz.) cream cheese, softened

1/4 C. butter, softened

1 t. vanilla

4 C. powdered sugar

Pinch of salt.

In a large saucepan, combine the sugar, raisins, water, butter, cinnamon, allspice, cloves, and nutmeg; cook and stir over medium-low heat until sugar dissolves. Remove from the heat: let mixture cool.

In a large bowl, beat egg yolks, gradually stir in the spice mixture. In a separate bowl, combine the flour, baking powder, salt, and baking soda. Gradually add the dry mixture to the batter and stir until blended. Stir in pecans. In a small bowl, beat the egg whites until soft peaks form; fold egg whites into batter.

Pour into two greased and floured 9-inch round baking pans. Bake at 325 until a toothpick inserted in the center comes out clean, about 35 to 40 minutes. Cool for 10 minutes before removing from pans to wire racks to cool completely.

For the frosting: in a large bowl, beat the cream cheese and butter until fluffy. Add vanilla and salt. Gradually beat in powdered sugar until smooth. Spread the frosting between layers and over the top and sides of the cake, leaving the sides slightly exposed. If desired top with pecans. Store in the refrigerator.

These candy-like bars would be great for Valentine's Day. You can get the Ghirardelli candy melting wafers at most large grocery stores. I find they work the best. Be careful you don't get really cheap melting wafers because they have wax in them and are hard to melt. If you want to substitute pistachios or walnuts for the nuts you could.

#### **Sweet and Salty Chocolate Bake**

2 (10 oz. each) white chocolate melting wafers

1 C. crushed pretzels, divided <sup>1</sup>/<sub>4</sub> C. chopped dried cherries

<sup>1</sup>/<sub>4</sub> C. chopped dried cranberries <sup>1</sup>/<sub>4</sub> C. chopped salted pecans

1/3 C. dark chocolate melting wa-

Line a 12 x 9 baking sheet with parchment paper. In a large microwave safe bowl, melt white chocolate melting wafers, according to package directions. Stir in 3/4 cup of pretzels. Spread onto prepared pan. Sprinkle with cherries, cranberries, nuts, and remaining pretzels; gently pressing into white chocolate. In a small microwave safe bowl, melt dark chocolate melting wafers according to package directions. Place melted dark chocolate in a piping bag, and drizzle over bark. Let cool until set, about 2 hours. Break into pieces. Store in an airtight container up to a week.




