Illinois State Police (ISP) officials continue to mourn the loss of Trooper Brooke Jones-Story

Trooper Brooke Jones-Story grew 13, 2012 in Galena. up in Stockton, Illinois where she attended Warren High School. She received her Bachelor of Science Degree in Criminal Justice from University of Wisconsin-Parkside in 2006. Trooper Jones-Story began her career with the ISP in June of 2007 as a member of Cadet Class 115. Upon her graduation from the ISP Academy, she was assigned to District 16 in Pecatonica; where she remained for the duration of her career. Throughout her career with the ISP, Trooper Jones-Story was recognized for her hard work, positive attitude, and for being a rising leader amongst her peers. Brooke married retired Master

Trooper Brooke Jones-Story is survived by her husband, parents, sister, brother, stepchildren, step-grandchild, maternal grandmother and family and friends who loved her dearly. The ISP would like to thank the public for their support and condolences during this difficult time.

On March 28, 2019, at approximately 11:24 a.m., Trooper Brooke Jones-Story conducted a traffic stop on a commercial motor vehicle on United States Route 20 westbound, just west of Illinois Route 75 in Stephenson County, to conduct a truck inspection. During the inspection at approximately 12:20 p.m., a Sergeant Robert Story on October truck tractor semi-trailer combina-

tion veered off the roadway, struck Trooper Jones-Story's squad car, struck the commercial motor vehicle Trooper Jones-Story was inspecting, and fatally struck Trooper Jones-Story, who was outside of her squad car at the time of the crash.





Village of Stockton to begin water system improvements

The Village of Stockton opened bids on December 5, 2018 for work needed to complete water system improvements. These improvements include water main loop replacements and other improvements as

*Approximately 1,300 linear feet of 8-inch PVC and 6-inch PVC along Hillside Lane;

*Approximately 890 linear feet of 8-inch PVC, 6-inch PVC, and 4-inch PVC along Summit Avenue;

*Approximately 1,050 linear feet of 8-inch PVC along Willis Street (water services are to be directionally drilled);

*Directionally drilled 1-inch copper water service

*Standby generators for municipal water wells #4 and #6.

Civil Constructors, Inc. was awarded a construction contract in the amount of \$978,519.10. The contract has been executed by the Village and the Notice to Proceed has been issued and construction is scheduled to begin in early April.

The Village's total project budget is \$1,227,074.67. The Village has received a DCEO CDBG grant totaling

\$453,700, that will pay for 100% of the construction costs for the Willis Street and Summit Avenue improvements. The Village also received \$580,031 in forgivable IEPA loan monies, which means for a total project cost of \$1,227,074.67, the Village will have to repay \$193,344 towards the project which will be covered by existing user fees.

ABORTION BILLS OPPOSI-TION: Leaders of Illinois' Catholic Church denounced a package of reproductive health care bills in the General Assembly, calling them "dangerous" and "mounting challenges to human dignity."

One measure would repeal a law mandating a minor notify her parent or guardian before getting an abortion. The other would repeal the state's abortion law and replace it with language creating reproductive health care as a fundamental right.

The Bishops of Belleville, Joliet, Peoria, Rockford and Springfield joined Cardinal Blase Cupich of the Archdiocese of Chicago at a news event Thursday, March 28. Cupich said it is "critically important" lawmakers oppose the legislation.

"This is a radical departure from what we have. This is not about the issue of a right to an abortion, although we would question that, but it is about vacating any rights or dignity that ... were not decided by Roe v. Wade," he said. "This is coming at it from a different direction."

Cupich argued the Reproductive Health Act, which backers and detractors agree would be the most liberal reproductive health care statute in the country, would remove protections in current law for health care workers who refuse to participate in abortion procedures due to moral, ethical or religious objections.

The legislation exists in both chambers of the General Assembly. Both House bills are seemingly stuck in a subcommittee, as is the Senate version of the Reproductive Health

Only the Senate version of the effort to repeal the Parental Notification of Abortion Act has moved to the chamber floor for a possible vote.

SPORTS GAMBLING: Legislative momentum is in place to bring sports betting to Illinois.

That process started Thursday, March 28, with more than three hours of testimony during a House Revenue and Finance Committee hearing.

Committee members balanced the opinions of various representatives of the state's gambling, horse racing, sports and technology industries.

Industry representatives, meanwhile, were tasked with choosing the best of five different plans to legalize sports betting in the state.

Those plans take shape in five separate amendments added to Rep. Michael Zalewski's (D-Riverside) gaming bill, House Bill 3308.

They can be separated into two categories. Four plans would have legalized sports gambling overseen by the Illinois Gaming Board. One would put all sports betting in the state under the Illinois Lottery's authority.

Advocates for the Lottery plan, led by Rep. Lisa Hernandez (D-Cicero). say it could benefit the more than 10,000 small retailers, such as convenience stores and gas stations that already sell Lottery tickets.

But the plan does not allow for hugely popular online or mobile betting, and would limit the types of bets that can be made.

The "New Jersey model" plan has been championed by Zalewski. It is one of the four plans that would be overseen by the state Gaming Board.

That plan would allow sports betting at the state's brick-and-mortar casinos and racetracks, as well as

Next week, Zalewski said, will be a 'work week," where lawmakers and their staff can look closer at each of the sports betting options. Hearings on the matter will continue afterward.

SCHOOL FUNDING: Illinois' new evidence-based school funding model is effectively driving added funding to the state's neediest school districts, but the state must double its annual added investment in the formula if districts are to reach funding adequacy in a timely manner, according to a report released Wednesday, March 27, by the bipartisan Center for Tax and Budget Accountability.

The evidence-based model was passed in 2017, giving each public school district an adequacy target based on several factors tied to student performance. Those furthest new funds are added to the formula.

Illinois has 707 districts that do not meet their adequacy target, and CTBA President Ralph Martire said if the statutory minimum of \$350 million is added to the formula each year, the earliest all districts could meet adequacy levels is 2050.

That leaves generations of students in underfunded schools," Mar-

For the state to make up a \$7.35 billion education funding shortfall and meet adequacy levels within 10 years as specified in the legislation, Martire said, the actual annual funding increase would have to be closer to \$779 million.

At a Capitol news conference detailing the report Wednesday, Martire said the numbers show how necessary a graduated tax structure touted by Gov. J.B. Pritzker will be to the process of increasing investment in schools.

"It's crucial we start making these needed, long-term fiscal structural reforms or we cannot fund fully the evidence-based formula, and that will continue to shortchange the education for millions of children in our state," he said.

ABORTION **DISCUSSIONS:**

The issue of abortion needs to be treated as less of a "political football" so individuals on both sides of the debate can have "fundamental and ideological discussions," Sen. Elgie Sims, Jr., said Wednesday, March 27.

In a conference call with members of the national media, the Chicago Democrat said reproductive health care decisions are "very, very personal," whether a woman decides to carry her pregnancy to term, give her child up for adoption or choose to have an abortion. Sims said he thinks people must be able to have conversations about what it means to exercise health care rights.

"They have very, very visceral responses on one side or the other to these discussions and that's OK. There is nothing wrong with us having discussions that are heated," he said. "But let's have discussions that are focused on enacting good, sound policy. That is what this entire discussion is all about."

Sims is leading the push for legislation that would allow a minor to have an abortion procedure without consulting with her parent or guardian. He told reporters that under Illinois law, a pregnant minor can make a number of health care decisions without the involvement of her par-

"You can simply not have justice without equity," he said.

His measure would repeal the Parental Notification Act, which mandates a minor speak with her parent or guardian before getting an abortion. It provides an avenue for her to petition a court for permission if she does not feel safe having that conversation with her parent, for example.

SCOTT'S LAW: Already in 2019, motorists have hit 15 squad cars stopped along Illinois roads. Two of those incidents killed Illinois State Police troopers..

"This information is obviously extremely concerning," acting ISP Director Brendan Kelly said Tuesday, March 26, during a news conference at the capitol in Springfield.

In January, trooper Christopher Lambert was struck and killed along Interstate 294 near Northbrook while he was assisting at an accident scene. It's the worst-case scenario among incidents occurring more often, Kelly said, despite a law that requires motorists to move over and slow down for emergency vehicles that are stopped and have their hazard lights

Two days after Kelly's news conference, another trooper was killed. Trooper Brooke Jones-Story died in the crash that occurred Thursday, March 28, on U.S. Route 20 near Illinois Route 75 in Freeport, state police officials said, when she was struck by a truck while making a traffic stop. Jones-Story was a 12-year veteran of the Illinois State Police District 16 in Pecatonica

Scott's Law was passed in Illinois in 2002. In 2013, the law was extended to apply to other vehicles, including ambulances and tow trucks.

Kelly said so far in 2019 there have been 494 recorded violations of the law, compared to 184 during the same period last year.

This year's 14 collisions, occurring statewide at a rate of more than 1 per week, are already more than the yearly totals for 2016 (5), 2017 (12), and 2018 (8).

Kelly blamed the increase on distracted and impaired driving.

Those who violate Scott's Law face fines from \$100 to \$10,000 and a possible loss of a driver's license.

LEGIONNAIRE'S REPORT: Illinois' auditor general detailed delays, mishandling and poor communication from former Gov. Bruce Rauner's administration in its response to a deadly Legionnaires' disease outbreak at the Illinois Veterans Home at Quincy which began in

The report from Auditor General Frank Mautino said at least 220 residents and staff became ill in August and September 2015, with 57 testing

positive for legionella and 101 testing negative. In total, 66 residents and eight employees or volunteers have tested positive for legionella since 2015, and 13 related resident deaths occurred, the report, released Monday, March 25, said.

The report traced a "likely cause" of the contamination to a water tank that was out of circulation from July to August 2015. While it was offline, it was unheated until it was cycled back into service on Aug. 6, 2015, two weeks before the initial outbreak was identified. Shortly after that, the Illinois De-

partment of Public Health began recommending water restrictions and remediation efforts, and by December 2015, the Centers for Disease Control and Prevention had recommended filters be installed on all fixtures in the hot water system.

Those filters were not installed until April 2018, the report said, shortly after another Legionnaires' disease outbreak was identified - the fourth since the initial 2015 outbreak. Other outbreaks took place from March to April 2016, July to December 2016, and another from May to November 2017 which resulted in one death.

The report said no cases of legionella ĥave been diagnosed since those in February 2018.







The Freeport Post Office will host a Passport Day event on Saturday, April 6, May 11, and June 8 from 9 a.m. – 12 p.m. "This is a great opportunity for Freeport area residents planning to travel outside the United States to apply for a passport without making a reservation," said Freeport Postmaster Deborah Graves.

In addition to the familiar passport book, travelers can also apply for a
