River Ridge stays hot in playoff against Hilltoppers

Last Friday night the River Ridge Wildcats faced off with the Danville-Schlarman Hilltoppers in round two of the I8FA playoffs. Following their big win over North Fulton in the opening round, the Wildcats came in feeling hot when they battled the six seed in the Hilltoppers. Both teams finished their regular season with a 6-3 overall record. This would be the second time these teams played each other as River Ridge won their regular season matchup against the Hilltoppers by a score of 52-34.

Things got rolling early on for the Wildcats when Caleb Rhodes showed off his athleticism on a 29 yard touchdown run less than five minutes into the game. The score would remain 8-0 until the end of the first quarter. It did not take them long to get on the board in the second quarter as Bryton Engle broke off an eleven yard touchdown run on the first play of the quarter. The missed two point conversion left them with a 14-0 lead.

Schlarman was able to erase their zero from the scoreboard when they connected for a touchdown pass, cutting the lead down to six points as they trailed River Ridge 14-8.

Late in the second quarter the Wildcats were driving once again. It seemed that things were about to stall when a false start turned a fourth and four into a fourth and nine, but Engle was able to find a wide open Trevor Grube in the middle of the field for a game changing first down. The big play set up a

four yard touchdown run for Engle's second score of the first half, and opened up their lead to 20-8. The impressive drive took nearly seven minutes off the clock as they left the Hilltoppers with just over a minute until halftime.

The Hilltoppers were driving but it came to an end when Daren Winter and Rhodes combined for a sack to force a third and long with the clock under thirty seconds. Eventually, we went into halftime with the score remaining 20-8.

The Wildcats would start with the ball but were forced to punt, which pinned Schlarman deep in their own territory. Unfortunately, the Hilltoppers took just one play to get near the fifty yard line. The River Ridge defense remained strong though, as Winter got his second sack of the game to force a Hilltopper punt. The exchange of possession led to an impressive, 45 yard run by Rhodes as he was showing off his breakaway speed once again to put his team up 28-8.

Schlarman was able to cut that lead in half at the end of the third quarter, however. They connected for their second touchdown pass of the game to bring the score to 28-14. Aside from those two plays, the River Ridge defense was playing at a high standard all game long and continued to give their offense a chance to expand their lead.

Just when it looked like the Wildcats were about to punt again, Engle pulled off the near impossible. A bad snap forced him to try and make something happen and he came

through in the clutch, finding an open man to give them another key first down. It did not take long for Rhodes to get his third score of the game, as he took it in from five yards out to go up 34-14.

Winter seemed to be making a living in the Hilltopper's backfield as he gathered his third sack of the game. This time, forcing and recovering the fumble to give his offense the ball back. The turnover set up a big, 28 yard touchdown run for Rhodes' fourth score of the game to put them over the forty point mark.

The Hilltoppers were able to get a late touchdown but it was all for naught as the clock ticked zero on what would turn out to be a 42-20 victory for the River Ridge Wildcats. Rhodes and Winter were the players of the game as Winter racked up three sacks and a fumble recovery and Rhodes surpassed the 100 yard mark and tallied four touchdowns. Not to be overlooked was Engle, who continued to come through in clutch situations and drove in two scores of his own.

The Wildcats move on to level

three where they will face off with Polo this Friday night, at 7 PM.

They have a tough opponent coming up in the Marco's, as Polo won the regular season matchup by a score of 36-8. Despite that, the postseason is an entirely different atmosphere and you can not count the Wildcats out with how well they have been playing.

As they enter the Semifinals of the I8FA playoff bracket, I think it is safe to say this is the best football season in the history of the River Ridge Wildcats.

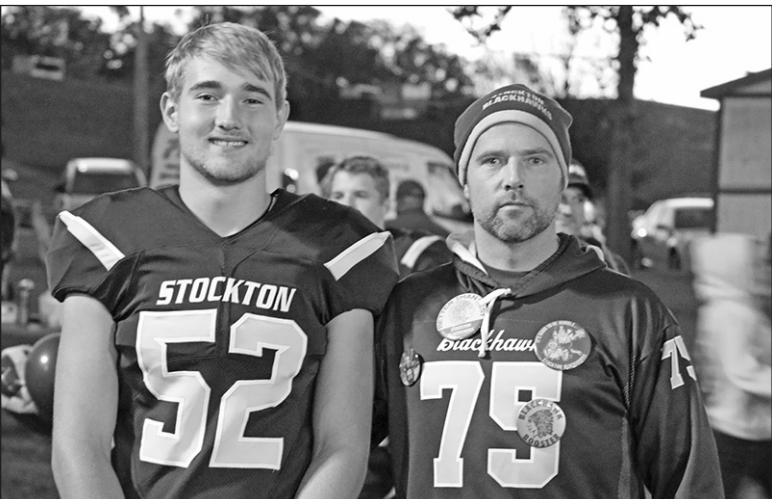

From Lena's kitchen



Boy was it chilly this week. Heavy sweatshirts wouldn't cut it; I had to roll out the quilted winter jacket. Hopefully we will return to more fall like temperatures. This week's recipes are a potpourri of tastes. There is something for the upcoming holidays, two great dinner ideas, and some yummy desserts.

This cheese ball is a mixture of a lot of cheeses. The interesting ingredients are pimentos and pickle relish. Enjoy this ball

Bacon, Cheddar and Swiss Cheese Ball

1 pkg. (8 oz.) cream cheese, softened
 1/2 C. sour cream
 2 C. shredded Swiss cheese
 2 C. shredded sharp cheddar cheese
 1 C. crumbled cooked bacon (about 12 strips), divided
 1/2 C. chopped pecans, toasted, divided
 1/2 C. finely chopped onion
 1 jar (2 oz.) diced pimentos, drained
 2 T. sweet pickle relish
 1/4 t. salt
 1/4 t. pepper
 1/4 t. minced fresh parsley
 1 T. poppy seeds

In a large bowl, beat cream cheese and sour cream until smooth. Stir in shredded cheeses, 1/2 cup bacon, 1/4 cup pecans, onion, pimentos, pickle relish, salt and pepper. Refrigerate covered for at least one hour.

In a small bowl mix parsley, poppy seeds, remaining bacon and pecans. Spread half of parsley mixture on a large piece of plastic. Shape half of the cheese mixture into a ball; roll in parsley mixture to coat evenly. Wrap in plastic. Repeat. Refrigerate the ball for at least 1 hour. Serve with crackers

If you are looking for a different side dish for the holidays, try these tasty carrots. I like to buy the ones with the tops still on, but they are pricier than just a bag of regular carrots. Both are much sweeter than the mini carrots and have a lot more flavor.

Sweet and Tangy Carrots

2 lbs. carrots, sliced
 1/4 t. salt
 1/2 C. packed brown sugar
 3 T. butter
 2 T. Dijon mustard
 1/4 t. pepper
 2 T. minced fresh parsley

Place 1 inch of water and carrots and salt in a large saucepan; bring to a boil. Reduce heat; cover and simmer until tender; 15 to 20 minutes. Drain. Return car-

rots to pan; add the brown sugar, butter, mustard and pepper. Cook over low heat, stirring carrots until well coated. Sprinkle with parsley. Serve with a slotted spoon.

This recipe is a good one for a week-night dinner. You can make it ahead of time, and then all you have to do is put it in the oven. Most grocery stores have the Mexican four cheese shredded cheese. If you want it a little spicier, use hot salsa instead of medium; if you want it much less spicy, use the milk salsa. If you make homemade, your homemade salsa would be great.

Cabbage Roll Enchiladas

8 large cabbage leaves
 2 T. water
 1 lb. ground beef
 1 container (16 oz.) cottage cheese
 1 egg, beaten
 2 cloves garlic, minced
 1 1/2 C. finely shredded Mexican four cheese, divided
 8 green onions, chopped, divided
 1 jar (16 oz.) thick and chunky medium salsa

Preheat oven to 350. Place cabbage in large microwaveable bowl. Add water; cover with waxed paper. Microwave on High 4 to 5 minutes, or just until cabbage leaves are softened. Spray a 9 x 13 baking dish with cooking spray. Mix meat, cottage cheese, egg, garlic, and 1/2 cup of shredded cheese and 1/2 cup of onions just until blended. Spoon onto centers of cabbage leaves, adding about 1/4 meat mixture to each leaf. Fold over opposite sides, then opposite ends of each leaf to completely enclose filling. Place, seam sides down, in prepared baking dish; top with salsa and remaining shredded cheese. Cover and bake for 1 hour

or until filling is bubbly. Sprinkle with remaining onions.

This chicken recipe uses thighs and ziti to make a different chicken dish with a unique taste. The thighs have a lot of flavor and using Italian seasoning makes the spice mixture easy to add. Enjoy a different kind of chicken cacciatore.

Chicken Cacciatore

2 T. olive oil
 6 boneless skinless chicken thighs
 1 1/2 t. salt, divided
 1/2 t. pepper
 1 C. sliced mushrooms
 1 small onion, chopped
 1 large yellow pepper, seeded and sliced
 3 cloves garlic, thinly sliced
 1 t. dried Italian seasoning
 1/4 t. red pepper flakes
 1 can (15 oz.) tomato sauce
 1 can (14.5 oz.) of diced tomatoes
 1/4 C. chopped fresh parsley
 1/2 of a 16 oz. pkg. ziti, cooked according to package directions.

In a large Dutch oven, heat oil over medium-high heat. Sprinkle chicken all over with 1 t. salt and pepper. Add chicken to pan; cook until golden brown, 2 to 3 minutes on each side. Remove from pan. Add mushrooms, onion, bell pepper, garlic, Italian seasoning, red pepper flakes, and remaining salt to pan; cook, stirring occasionally until tender, about 5 minutes. Stir in tomato sauce, tomatoes, and parsley; nestle chicken in vegetable mixture. Reduce heat to medium, cover, and cook until sauce is thickened and a meat thermometer inserted in thickest portion of chicken registers 165, about 20 minutes. Serve with pasta. Garnish with

Northwestern Illinois Community Action Agency PY20 LIHEAP, PIPP and Weatherization Assistance Programs

Northwestern Illinois Community Action Agency has funding from the Department of Commerce & Economic Opportunity (DCEO) to assist residents of Jo Daviess and Stephenson Counties with home heating utility costs (gas, propane, electric) through the Home Energy Assistance Program (LIHEAP), Percentage of Income Payment Plan (PIPP) and Weatherization Programs.

LIHEAP clients with ComEd and/or Nicor Gas as utility providers may have the option of choosing between the traditional Direct Vendor (DVP) one-time payment or the Percentage of Income Payment Plan (PIPP). The choices will be explained to clients during their application visit. PIPP applications will be taken until Dec. 31, 2019 or until funding is exhausted. LIHEAP applications will be taken until May 31, 2020 or until funding is exhausted.

Beginning Monday, Oct. 1, 2019, income eligible seniors (age 60 and older) and people receiving disability benefits may call to schedule an appointment to apply for assistance.

Starting Nov. 1, 2019, income eligible households without home energy service (are disconnected or have a disconnect notice from their primary and/or secondary heating utility) and families with children age 5 and under may also call to schedule an appointment to apply.

Starting Dec. 2, 2019, all other income eligible households may call to schedule an appointment to apply.

Eligible households may call 800-883-1111 or 815-232-3141 from 8:00 a.m. to 3:30 p.m. to schedule an appointment to apply for assistance at one of the following locations.

Income Guidelines: To qualify, a household must have a 30 day gross income at or below the level shown below for 30 days prior to and including the application date.

1 person household - \$1,561	2 person household - \$2,114
3 person household - \$2,666	4 person household - \$3,219
Add \$553 for each additional person in the household	

**** The following documents will be required to apply for assistance. ****

- Social Security Cards for all members of the household. **No other document can be accepted as proof of social security number.**
- Proof of all gross income for all household members for 30 days including the application date including pay check stubs, SSA/SSI/SSD current benefit letters, pension/retirement statements, child support, unemployment reports, TANF/AABD/Township GA assistance notices, self employment reports, and proof of zero income
- Complete current heat and electric bills **and** disconnect notices you may have received.
- Medical Card from Illinois Department of Human Services
- Copy of current lease or rent receipt
- Proof of Homeownership (Title for Mobile Homes) and tax bill are required for weatherization assistance.

PY 20 LIHEAP Emergency Furnace Program

An Emergency Furnace Assistance Program is available for LIHEAP households of Stephenson and Jo Daviess Counties who are **homeowners** and whose **existing** heating systems are not functioning or have been red-tagged by their utility.

The purpose of the LIHEAP Furnace program is to restore heat to the household and is available from October 1, 2019 through March 31, 2020 or until funds have been exhausted.

Priority periods for the LIHEAP Emergency Furnace Program are the following:

Beginning Monday, Oct. 1, 2019, income eligible seniors (age 60 and older) and people receiving disability benefits may call to schedule an appointment to apply for assistance.

Starting Nov. 1, 2019 families with children age 5 and under and households with an imminent disconnect notice may also call to schedule an appointment to apply.

Starting Dec. 2, 2019 all other low-income eligible households may apply.

To qualify for the LIHEAP Emergency Furnace Program, the household must first apply for and be approved for LIHEAP assistance.

The household must have active service with both primary and secondary heating utilities. Households and disconnected utilities are not eligible for this assistance.

In addition to LIHEAP documents, the following homeownership documentation must be provided:

1. Copy of real estate tax bill

AND

2. One or more of the following:

- Copy of warranty deed, contract for deed, or quit claim deed (all of these must be stamped and registered with the county clerk)
- Copy of current mortgage statement
- Copy of the original Mobile Home title

NICAA Golden Meals Program serves senior citizens in Stephenson, JoDaviess, Carroll, and Whiteside Counties.

NICAA Golden Meals delivers hot mid-day meals to persons 60 years of age and older who are homebound and are unable to make their own meals or are unable to attend a congregate site. Hot meals are delivered Monday through Thursday with a cold tray for Friday and frozen meals for the weekend.

The Golden Meals menus provide one-third of the USDA recommended daily allowances for senior citizens and are approved by a registered dietitian. Each meal included 3 ounces of protein, two ½ cup servings of fruits or vegetables, bread, and milk.

Congregate meal sites are located at:

- 524 West Stephenson St. in Freeport,
- Mest Manor at 525 3rd St. in Savanna,
- Dew Drop Inn at 104 Main St. in Rock City.

Meals are served from 11:00 a.m. to 12:45 p.m. Monday through Friday.

A confidential donation of \$3.00 per meal is requested. No one will be denied service due to their inability to donate.

parsley.

This cake is an easy one because you use a white cake mix. If you have never used coconut milk, you can find it in most grocery stores. You really have to like coconut to like this cake; I know some of you will skip right over it. If you try it, you will like it.

Coconut Poke Cake

1 box white cake mix
1 can (15 oz.) coconut milk
2 C. heavy whipping cream
½ C. powdered sugar
1 t. vanilla
2/3 C. toasted sweetened flaked coconut

Preheat oven to 350. Spray bottom of a 9 x 13 pan with baking spray with flour. Prepare cake according to package directions. Spread batter in prepared pan. Bake until a wooden pick inserted in center comes out clean, about 30 minutes. Let cool for 5 minutes. Using the handle of a long wooden spoon, poke holes in cake. Pour cream of coconut over cake. Cover and refrigerate until chilled, about 4 hours.

In a large bowl, beat cream, powdered sugar, and vanilla with a mixer at high speed just until stiff

peaks form. Spread onto cake. Sprinkle with coconut. Cover and refrigerate for at least 1 hour before serving.

I am always looking for a good bar cookie recipe, although these are a little higher than most bars probably because of the 2 teaspoons of baking powder. Just a reminder: peppermint extract is pretty powerful, so be careful when you are adding it. (I have experienced too much peppermint.) The frosting is really good and sprinkling peppermint candies that have been crushed really makes them pretty.

Peppermint Blondies

½ C. unsalted butter
2 C. firmly packed brown sugar
1 C. sugar
2 t. baking powder
4 eggs, room temperature
1 t. salt
2 t. vanilla
½ t. peppermint extract
3 C. flour
1 C. white chocolate chips

Frosting:
1 C. unsalted butter softened
6 C. powdered sugar
½ C. heavy whipping cream
½ t. peppermint extract
¼ t. salt

Preheat oven to 350. Line a 9 x 13 pan with parchment paper, letting excess extend over sides of pan. In a medium heavy bottomed saucepan, melt butter over medium heat. Cook, stirring occasionally until butter turns golden brown and has a nutty aroma, 5 to 9 minutes. Pour into a small bowl and let cool for 5 minutes.

In a large bowl whisk together sugars, baking powder and salt. Gradually add browned butter whisking just until combined. Add eggs, one at a time, whisking well after each addition. Stir in extracts. Fold in flour just until combined. Fold in white chocolate

chips. Spread batter into prepared pan. Bake until a wooden pick inserted in center comes out with just a few moist crumbs, about 40 to 45 minutes. Let cool completely in pan. Using excess parchment as handles, remove from pan. Spread frosting onto blondies, and cut into bars. Garnish with crushed peppermint candy.

Frosting: In a large bowl, beat butter with a mixer at medium speed until smooth. Add powdered sugar, 1 cup at a time, alternately with cream, beating until combined and smooth. Add extract and salt, beating until smooth., about 2 minutes more. Frost blondies immediately.

I remember when we used to get out of school, and I know most kids had no idea why they got a vacation day. Having special events on Veteran's Day I think is a good idea. I know that when I was teaching, they begin the celebrations. I am glad they still continue them, and I love the fireworks! 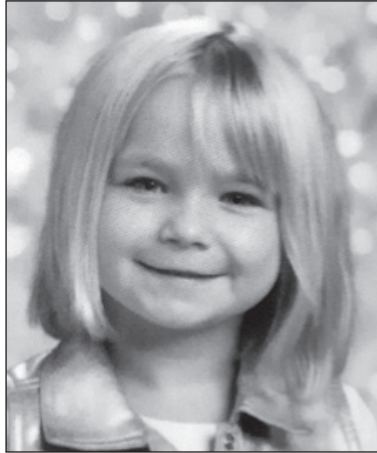
