## **LeWin tops O'ville Broncos and Aquin Bulldogs**

Earlier last week, head coach Kyle Benson and the Panthers boys' basketball squad hosted the Orangeville Broncos for their second meeting of the season. The Broncos came into Lena with a record of 9-4 and looking to avenge their prior loss to Panthers. LeWin came in with a 14-4 record as they hoped to complete the season sweep over Orangeville.

The Panthers held the early advantage as Kolton Heun had an incredible first quarter. Heun put up nine quick points to help give LeWin an early 17-9 lead. Heun took advantage of his opportunities, hitting on all three of his free throw attempts in the first quarter. Brayden Cahoon had five points to help keep the Broncos in reach as they went into the second quarter.

Sean Ormiston and Heun each had four points in the second as they helped the Panthers extend their lead. Nate Anderson hit a three for the Broncos as they combined for nine points in the quarter but found themselves going into halftime trailing by a score of 29-16.

The Panthers had an all-around team effort in the third quarter as they combined for thirteen with no single player scoring more than three points individually. Orangeville put up another nine points in the third quarter, but they found themselves facing a tough task as they went into the final quarter trailing 42-25.

Each team put up ten points in the fourth as the Panthers went on to win by a score of 52-42. Ormiston led the Panthers with sixteen and Heun finished right behind him with fifteen. After scoring just two points in the first half, Zach Baker racked

up eleven points in the second half as he finished the game with thirteen for the Broncos. Cahoon led Orangeville with fifteen points. The duo's play was impressive but not enough to keep up with LeWin in this one.

On Friday night, the Panthers made the trip to face off with the Aquin Bulldogs in another big matchup. The Bulldogs came into the game with a record of 11-7 and looking to pull off the upset over LeWin. The Panthers held the upper hand early on as they combined for fourteen points in the first quarter. Luke Benson had five quick points to help LeWin go into the second quarter up 14-9.

The Panther offense was even more impressive in the second quarter as Ormiston put up nine points to help his team go into halftime with a thirteen-point lead, up 31-18.

Aquin climbed their way back into the game in the third when they put up twenty-three points to cut into the deficit. A pair of three-pointers from Alex Daughenbaugh helped the Panthers hold onto their lead, however, as they went into the fourth quarter up 47-41.

The Panthers were able to make a difference in the game when they shot an impressive eleven of sixteen from the free throw line in the fourth quarter. Their solid shooting from the charity stripe helped them go home with a 65-53 victory. The Panthers had three scorers reach double digits as Daughenbaugh led the team with eighteen, Ormiston had thirteen, and Heun had thirteen.

The trio's play helped the Panthers get their sixteenth win of the season, but they fell to Easton Valley on Saturday, which brought their record to an overall 16-5 on the year.



## Two Chicago area residents test positive for novel coronavirus after trip to China

Health officials say risk to public is 'low' despite unknown strain of virus

Two Chicago residents are among the confirmed cases of the novel (new) coronavirus, which originated in Wuhan, China, and has killed at least 26 people in that country and sickened 900 worldwide.

"At this time, the risk to the general public remains low," Gov. JB Pritzker said at an unrelated news conference Friday.

The individual who tested positive for the virus is a Chicago woman who recently returned from Wuhan. Pritzker said the number of people she came into contact with since returning to the U.S. is "small."

"We are closely monitoring this sit-

uation and taking every precaution," he said, adding that state and city health and aviation departments are working with the federal Centers for Disease Control and Prevention on

He said the public should take the same precautions as in the flu season that is, washing hands and visiting a doctor if symptoms show.

Illinois Department of Public Health Director Dr. Ngozi Ezike said while the virus bears the same name as known viruses, this strain is different than those that are known.

"As it is novel and emerging, we are still trying to learn all that we need to learn about this virus, both in terms of its symptomatology, how people

get infected, the length from exposure to symptoms, all of that we are still trying to master," she said.

The CDC said in a news release coronaviruses are "a large family of viruses, some causing respiratory illness in people and others circulating among animals including camels, cats and bats."

"Rarely, animal coronaviruses can evolve and infect people and then spread between people, such as has been seen with Severe Acute Respiratory Syndrome (SARS) and Middle East Respiratory Syndrome (MERS)," the news release said.

Ezike said CDC officials had arrived in Chicago on Friday afternoon and others were on the way.

not symptomatic during her travels from Wuhan when she returned on Jan. 13, but started experiencing them in "the following days."

The patient is stable and hospitalized, she said. Authorities are working with the hospital to identify any other people who may need to be assessed for possible exposure.

"Health officials in Illinois are looking retrospectively to identify other individuals who have symptoms of coronavirus who may have traveled from Wuhan before the heightened

airport screenings and before the case was confirmed in the U.S.," Ezike

According to the CDC, there are 63 cases being monitored across the country. The other confirmed U.S.

case was in Washington State.

Chicago O'Hare airport is currently screening passengers as they arrive from China.

The CDC recommends travelers avoid all nonessential travel to Wuhan and encourages those making the trip to practice safe hand hygiene and avoid any people experiencing illness.

## Pritzker signs bill capping insulin costs

Patients to pay no more than \$100 for 30-day supply under state-regulated insurance plans

Democratic Gov. JB Pritzker signed a bill into law Friday capping the out-of-pocket cost of prescription insulin for many people in Illinois.

Senate Bill 667, sponsored by Sen. Andy Manar, a Bunker Hill Democrat, caps the cost at \$100 for a 30day supply, a significant reduction for many diabetes patients currently paying hundreds of dollars per month for the life-saving medication.

The law takes effect Jan. 1, 2021. Each year after that, insurers are allowed to raise the out-of-pocket cost by the rate of health care inflation.

"Diabetes affects people from all walks of life. It doesn't discriminate between those who can afford med-

and those who cannot," Pritzker said during a bill-signing ceremony at a public health clinic in Springfield.

Megan Blair, a diabetes patient from Harristown, said she has frequently been forced to ration her insulin supply because she couldn't afford the \$1,800 per month she was being charged.

"I've been in and out of the hospital, close to being in a diabetic coma more than once due to not taking my medication like I should - not because I wanted to, but because I had no choice but to ration the insulin I did have," she said.

Diabetes affects more than 30 million people in the United States, including an estimated 1.3 million in

ication and unconscionable costs Illinois. According to the American Diabetes Association, it's a condition in which the body does not properly regulate its blood sugar level, either because it doesn't produce its own insulin, known as Type 1 diabetes, or because the body doesn't use insulin properly, which is Type 2 diabetes.

All patients with Type 1 diabetes, and many with Type 2, rely on regular insulin injections. Without them, they can suffer severe health consequences, and even death. But the price of insulin has been skyrocketing in recent years, nearly tripling between 2002 and 2013, according to the ADA.

With the signing of SB 667, Illinois became only the third state to cap out-of-pocket insulin prices. The law applies to people who are covered by health plans subject to state regulation. That includes most kinds of private insurance, the state Medicaid plan and the state employees' health plan.

It does not, however, apply to self-insured plans, which many large companies with thousands of employees offer. Those plans are regulated under federal law.

The law also does not limit what prices insulin manufacturers are allowed to charge for the medication. It controls only how much of an outof-pocket cost insurers can require patients to pay, essentially shifting a greater share of the cost onto insurance companies.

"I think one thing that we've all recognized in this process is there are an awful lot of middlemen that have caused a spike in the price and they need to work out among themselves how they're going to deal with that change," Pritzker said.

The law also calls on the Illinois Department of Insurance and the Department of Human Services to conduct a study of insulin pricing practices and the variables that contribute to the pricing of health insurance plans. The agencies are supposed to submit a report on that study by Nov. 1, along with other policy recommendations to control the cost of prescription insulin.

## Secretary Perdue statement on **EPA WOTUS Rule**

U.S. Secretary of Agriculture Sonny Perdue this week praised the Environmental Protection Agency (EPA) for defining the Waters of the United States (WOTUS) rule with the Navigable Waters Protection Rule:

'President Trump is restoring the rule of law and empowering Americans by removing undue burdens and strangling regulations from the backs of our productive farmers, ranchers, and rural land-owners. The days are gone when the Federal Government can claim a small farm pond on private land as navigable waters," Secretary Perdue said. "I thank President Trump and Administrator Wheeler for having the backs of our farmers, ranchers, and producers and for continuing to roll back Federal overreach. With reforms and deregulation, Americans once again have the freedom to innovate, create, and grow.'

Background

On January 23, 2020, the U.S. Environmental Protection Agency (EPA) and the Department of the Army (Army) fulfilled yet another promise of President Trump by finalizing the Navigable Waters Protection Rule to define "waters of the United States" (WOTUS) For the first time, the agencies are streamlining the definition so that it includes four simple categories of jurisdictional waters, provides clear exclusions for many water features that traditionally have not been regulated, and defines terms in the regulatory text that have never been defined before. Congress, in the Clean Water Act, explicitly directed the Agencies to protect "navigable waters." The Navigable Waters Protection Rule regulates these waters and the core tributary systems that provide perennial or intermittent flow into them. The final rule fulfills Executive Order 13788 and reflects legal precedent set by key Supreme Court cases as well as robust public outreach and engagement, including pre-proposal input and comments received on the proposed rule.

The Navigable Waters Protection Rule protects the environment while respecting states, localities, tribes, and private property owners. It clearly delineates where federal regulations apply and gives state and local authorities more flexibility to determine how best to manage waters within their borders. Assertions have been made that the new rule will reduce jurisdiction over thousands of stream miles and millions of acres of wetlands. These assertions are incorrect because they are based on data that is too inaccurate and speculative to be meaningful for regulatory purposes. The final rule along with state, local, and tribal regulations and programs provide a network of protective coverage for the nation's water resources.

I would like to assume that we are all well-intentioned, yet I must share with you my humble experience and ask that we are all more sensitive and conscious of those we give to and what the Gospel calls us to. Last year we were accepting clothing for the people of Pine Ridge Indian Reservation. Our hope was and is that we give new clothes and clothes in excellent, almost unused condition. We received much in the way of new and good, decent clothes, for which we are truly grateful, and the people of Pine Ridge are deeply appreciative. However, we also received some items that were oil stained, ripped, torn, filthy, unusable even as rags, beyond repair, dirty and stained underwear, used makeup and lotion items and soaps. Was I surprised...well I have seen this done elsewhere and was just hoping I wouldn't see such again. I represent the Parish of Holy Cross and its every member. In our name I would never give ripped or torn clothes, or oil-stained and filthy clothes, or half-used items/toiletries to anyone to wear or utilize. As Catholics and followers of Jesus, this is not who we are or what we do, not to the rich and not to the poor, not to anyone. Imagine how

one would feel if they had to wear these unusable items and what they would think of the giver of some filthy, tattered piece of clothing and half-used bar of soap. Jesus said clearly, "Whatever you do to or for another, you do to or for me." How shabby and neglected Jesus would look if he donned some of the stuff we could not take to Pine Ridge. Do the people of Pine Ridge deserve better than our least worthy, stained, unusable discards? Does Jesus deserve less than what we deserve or give to ourself? We will accept clothes that are new and in new-condition only. We will inspect everything you bring while you wait so that you can take home what we cannot give to our brothers and sisters at Pine Ridge. We will establish times for you to bring what the people of Pine Ridge deserve and this will also give us the opportunity to personally thank you for your generosity and thoughtfulness. I firmly believe that we are all well-intentioned and I know on occasion things slip through and get overlooked. As your Parish representative, I do want you to be proud of what we offer to our brothers and sisters, and know that you are closely following the example of Jesus and the Gospel of Christ. Throw-aways are not for anyone. They are to be thrown out and not given to other human beings to further desecrate them or further injure their dignity as children of God. I appreciate your understanding and care for the people of Pine Ridge.



The not so skinny cook

It seems our rotten weather loves weekends. Maybe this one will be over by Saturday. We have recipes for a Super Bowl get together this week. Hopefully we all won't be snowed in. It has even been chilly in Florida this week.

The first recipe this week is for a really good crab dip. It is warm and great

or butter crackers. I have put this in the crock pot after I baked it to keep it

#### **Cheesy Baked Crab Dip**

- 2 C. shredded Monterey Jack cheese 1 pkg. (8 oz.) cream cheese, softened
- 1 C. sour cream
- ½ C. mayo
- <sup>1</sup>/<sub>4</sub> C. minced red bell pepper
- <sup>1</sup>/<sub>4</sub> C. minced green onion
- 2 T. chopped parsley
- 2 T. lemon juice
- 1½ t. Old Bay
- 1/4 t. ground red pepper
- 16 oz. crab meat
- ½ C. grated Parmesan

Preheat the oven to 350. In a large bowl, combine Monterey Jack cheese, cream cheese, sour cream, mayo, bell pepper, green onion, parsley, lemon juice, Old Bay seasoning, and red pepper. Gently fold crab into cheese mix-

Spoon mixture into a 11/2 qt. casserole. Sprinkle Parmesan cheese on top of crab mixture. Bake for 30-35 minutes, or until bubbly. Serve hot with toasted French rounds or crackers.

This dip has some really good flavors in it: cranberries, bacon, and Swiss cheese. It is another warm one, and it makes for a different appetizer. Sometimes it is good to have an appetizer that isn't buffalo wings or salsa based.

#### Cranberry and Bacon Swiss Cheese Dip

- 2/3 C. mayonnaise
- 1/3 C. spreadable chive and onion cream cheese
  - 1 t. ground mustard
  - 1/4 t. garlic pepper blend
  - 3 C. shredded Swiss cheese
  - 1 C. chopped onions

- 8 pieces bacon, fried crisp and Broccoli and Cauliflower Salad chopped
- ½ C. sliced almonds, divided
- 1/3 C. dried cranberries, chopped
- Mini bagels sliced and toasted and cut into pieces


Preheat oven to 325. In a large bowl, combine mayo, cream cheese, mustard and garlic pepper blend. Add the Swiss cheese, mustard and mix well. Stir in onions, bacon, 1/4 cup almonds and cranberries. Spread into a greased 3 cup baking dish. Sprinkle with remaining almonds. Place on a baking sheet. Bake dip, uncovered, until bubbly, 25 to 30 minutes. Serve warm with tasted

  - 6 green onions with tops, sliced
  - 2 C. shredded mozzarella cheese
  - 2 C. mayonnaise
  - <sup>1</sup>/<sub>4</sub> C. Parmesan cheese
  - 2 T. sugar
  - 2 T. white vinegar
- ½ to 1 lb. sliced bacon, cooked and crumbled

In a large bowl, combine the cauliflower, broccoli, grapes, onions, and mozzarella. Combine mayo, Parmesan, sugar, and vinegar in a small bowl. Pour over the vegetable mixture and toss to coat. Cover and refrigerate for at

## **Industrial Hemp Production** Workshop slated for March 24

The signing of the Illinois hemp bill has provided opportunities for the cultivation, distribution, and processing of hemp for fiber, grain, and CBD. This versatile cash crop has the potential to empower small farmer, but is not without its own set of challenges regarding planting methods, fertility, harvesting, storage and extraction. To help give some perspective on the lessons learned from the 2019 growing season, University of Illinois Extension will be hosting its 2nd annual "Industrial Hemp Production Workshop" at Highland Community College's Student Conference Center on March 24th, 2020. "We learned a lot this year, but I am not sure that anyone was truly ready for the challenges associated with growing hemp," Extension Educator Phillip Alberti said. If you want a ham bone, and you didn't have one over Christmas or New Years, A.L's Lena Maid Meats has ham hocks. that will serve you well. I was actually at Walmart the other day, and the lady in front of me was singing the praises of our local meat market. She was going to make ham and bean soup!

#### Ham and Lentil Soup

6 C. water

13/4 C. dried lentils, rinsed


