Blackhawks start strong in Warkin's Classic Tournament

Last Monday, the Stockton Blackhawks began their play in the Warkin's Classic Tournament. Stockton came into their first game of the tournament with a 7-4 overall record as they were set to face off with the Orion Chargers.

The Blackhawks got off to a hot start offensively as they quickly put up fifteen points to go into the second quarter, up 15-10. Their defense would lock down the Chargers for the rest of the game, as they allowed a total of thirteen points through the final three quarters. Thanks to a strong, nineteen point performance from Tiana Timpe, and another eleven points from Elizabeth Eisfeller, the Blackhawks were able to walk away with a 49-23 victory.

For their second game of the day, the lady Blackhawks were squared up to battle the Mercer County Golden Eagles. Game two was quite different from the first. The Golden Eagles were able to keep things close for Stockton up until the very end. The teams went into the second quarter tied at 13-13, but Stockton was able to outscore them before the half as they held a 27-22 lead at the break.

The Blackhawks came out of halftime with momentum and outscored the Golden Eagles once again, as they established a 42-31 lead going into the final quarter. The Golden Eagles were able to slightly cut into the Blackhawk lead, but it was not enough to come back as Stockton went on to win 51-40.

Tiana Timpe was even more impressive in game two. She totaled twenty-three points to go along with two steals. Timpe, who recently received a college offer from Central Michigan University. A big offer from the successful, Chippewas' basketball program. The Chippewas are currently 7-3 on their season. Playing out of Mt. Pleasant, Central Michigan plays in the Mid-American Conference in division one competition. Timpe is well known as a dangerous shooter, and she proved that once again as she hit five three-pointers in their win against the Golden Eagles. Congratulations on the offer to the Junior, who will surely receive many more before she finishes her high school career.

The two wins pushed the Blackhawk's record to 9-4 on the season.

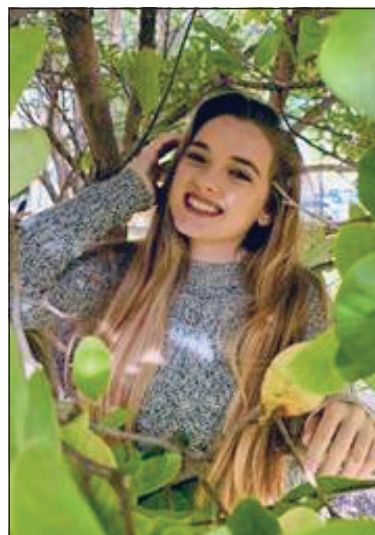

Capitol recap

New year will bring a higher minimum wage, legalization of cannabis

The state's minimum wage will increase by \$1 hourly, recreational cannabis will go on sale to those over 21 years of age, and some state taxes and licensing fees will increase when the calendar hits January.

The changes are among hundreds resulting from laws passed during a busy legislative session which adjourned in early June.

MINIMUM WAGE: The minimum wage will increase by \$1 to \$9.25 hourly on Jan. 1, the first such increase since 2010. The wage will increase to \$10 hourly in July before increasing \$1 each January until it hits \$15 by 2025.

Cannabis Legalization: With the legalization of adult-use cannabis in the state, Illinois residents will be allowed to possess 30 grams of cannabis flower, 500 milligrams of a cannabis-infused product and five grams of cannabis concentrate. Non-residents can possess half those amounts.

Consumption of cannabis will still be banned in public places, however, unless a licensed cannabis facility or certain lounges obtain local government clearance for allowing use at their facilities.

Cannabis legalization will also provide for the expungement of low-level cannabis convictions and criminal records in the state, the first of which were filed in Chicago this month.

New Taxes, Fees for Capital Plan: Some new taxes and fees which will

help fund a multi-year \$45 billion capital infrastructure plan will also take effect starting in January.

Registration fees for passenger vehicles will increase to \$151 from \$101, while electric vehicle registration fees will increase to \$251 annually from \$34 every other year.

The licensing fee for a trailer weighing less than 3,000 pounds will increase to \$118 from \$18, with every weight class above that also seeing a \$100 increase.

A new tax on parking garages will also take effect next month, with a 6 percent rate applied to hourly and daily garages and a 9 percent rate applied to monthly.

The state will also begin taxing the value of traded-in vehicles starting after \$10,000 of value, down from \$20,000.

EARLY CHILDHOOD PROGRAMS: Democratic Gov. J.B. Pritzker's office announced Monday, Dec. 23, that the state will receive \$40.2 million in federal grants over the next three years to improve early childhood programs.

The competitive grants are administered by the U.S. Department of Health and Human Services and they require a 30-percent cost-sharing commitment from non-federal funds. The grants are used to build early childhood program infrastructure and expand high-quality preschool programs in targeted communities, the governor's office said in a news release.

"From our aggressive efforts to secure federal funding to our historic investments in early childhood programs and facilities, Illinois will become the best state in the nation for families raising young children," Pritzker said in the release.

Last week, Pritzker announced that the state is increasing child care provider reimbursement rates by 5 percent statewide and by 20 percent for providers in what the Illinois Department of Human Services calls "Group 2" counties, which are primarily rural counties.

The budget that lawmakers passed during the 2019 session included a \$50 million increase in the state's Early Childhood Education Block grant. In addition, the capital improvements program known as "Rebuild Illinois" provides \$100 million for construction of early childhood facilities across the state.

LGBTQ HEALTH CARE: Illinois Attorney General Kwame Raoul has joined with 18 other state attorneys general in opposing proposed new federal rules that they say could strip many LGBT individuals of many health care rights.

The proposed rule deals with non-discrimination policies within the U.S. Department of Health and Human Services. It would delete current language in HHS regulations, adopted in the final weeks of the Obama administration, that prohibits discrimination in the agency's programs "based on non-merit factors such as age, disability, sex, race, color, national origin, religion, gender identity, or sexual orientation."

That rule was based, in part, on the 2015 U.S. Supreme Court decision that legalized same-sex marriage nationwide. The proposed new rule would replace that language with a generic ban on discrimination "to the extent doing so is prohibited by federal statute."

The proposed change was published in the Federal Register Nov. 19. In that notice, the agency cited concerns that the Obama-era rule violates the Religious Freedom Restoration Act of 1993, which prohibits the federal government "from substantially burdening a person's exercise of religion." That law, however, also allows exceptions when there is a "compelling state interest" in do-

ing so and the burden is the "least restrictive means of furthering that interest."

In a letter to HHS dated Dec. 19, the deadline for public comment on the rule, the 19 attorneys general challenged that assertion.

"Our federal tax dollars should not be funneled towards organizations that openly discriminate against certain groups," Raoul said in a separate statement. "I am committed to ensuring that all Americans are protected against discrimination and have an equal opportunity to apply for and take advantage of programs funded through federal grants."

RECREATIONAL CANNABIS: With less than two weeks before adult-use recreational cannabis becomes legal in Illinois, the state Department of Agriculture announced Monday, Dec. 23, that all 21 cultivation centers that have been licensed to grow medical cannabis are now licensed also to grow for adult use.

The final three companies to be approved were Bedford Grow LLC, in Bedford Park; IL Grow Medicine LLC in Elk Grove Village; and JG IL LLC in Edgewood.

Under the cannabis legalization law passed during the 2019 legislative session, cultivation centers already licensed to grow medical cannabis were allowed to apply for early approval of licenses to grow for adult use.

Other applicants will have an op-

portunity to apply for licenses in an upcoming phase of the implementation process, with priority going to "social equity applicants" - generally, applicants from communities "disproportionately impacted" by the war on drugs, or individuals with previous arrests or convictions for minor cannabis violations.

Illinois State Police remind motorists to obey Scott's Law

The Illinois State Police (ISP) continues to urge motorists to obey the Move Over Law — also known as Scott's Law — and use caution when approaching stationary emergency vehicles or any other stationary vehicle displaying flashing lights on the interstates and roads.

2019 has been an especially tragic year for the Illinois State Police. 27 ISP stationary squad cars have been struck by vehicles, higher than the number of all ISP crashes of this sort that occurred in all of 2016, 2017, and 2018. We also continue to mourn the tragic deaths of Trooper Christopher Lambert and Trooper Brooke Jones-Story.

Enforcement has increased as a result. In 2019, ISP has issued nearly 6,300 citations thus far for violating Scott's Law — which is nearly 5,300 more than the combined totals of the two previous years. Effective Jan. 1, 2020, violators of Illinois' Move Over (Scott's) Law will be fined no less than \$250 for a first offense and no less than \$750 for a subsequent offense. If the violation involves property damage, the violator's driver's license will be suspended for a mandatory period anywhere between 3 to 12 months. If the violation results in injury to another person, the violator's driver's license will be suspended for a mandatory period of anywhere between 6 months and two years.

"Following Scott's Law is a matter of life and death for our brave first responders who are just trying to do their jobs," said Governor JB Pritzker. "The law is simple: slow down and move over if you see a first responder on the side of the road."

Governor JB Pritzker has been heavily involved in the effort to

bring awareness to the Move Over (Scott's) Law and has signed two pieces of legislation this year as a part of his ongoing effort. Public Act 101-173 increases the fines for those violating this law. Additionally, a Move Over Task Force, implemented through Public Act 101-174, has been created to study the issues of violations of the Move Over (Scott's) Law and how to protect emergency responders. Both Senate bills are effective Jan. 1, 2020.

As chair of the Move Over Task Force, ISP Director Brendan F. Kelly continues to make the Move Over Law a top priority. "As an agency, we have responded to the preventable loss of four ISP troopers with resiliency and a focused mission to protect those who are trying to protect all of us. And as long as the danger to our first responders exists, we will continue to raise awareness and aggressively enforce the Move Over (Scott's) Law," said ISP Director Brendan F. Kelly.

The Move Over Law was enacted in 2002 in memory of Lt. Scott Gillen of the Chicago Fire Department who was struck and killed on Dec. 23, 2000, by an intoxicated driver on the Dan Ryan Expressway while assisting at a crash scene.

Scott's Law requires drivers to change lanes when approaching stationary emergency vehicles, including highway maintenance vehicles displaying flashing lights, and any stationary vehicle with their hazard lights activated. The law also states, if changing would be impossible or unsafe, drivers are required to proceed with due caution, reduce the speed of the vehicle and leave a safe distance until safely passing the stationary vehicle.

The not so skinny cook

I hope you all had a wonderful Christmas. The day was beautiful. There were no problems traveling after the fog lifted. It was one of the most picture-perfect December 25th I have ever seen. I know there was some disappointment because there was no snow, but the weather let people travel safely and get places on time. This week's recipes can help you get ready for a New Year's Day celebration.

These are great appetizers that require just a little work. The nuts in the filling give them a good crunch and flavor. This appetizer will be a good one for a Super Bowl party.

Nutty Stuffed Mushrooms

- 20 large fresh mushrooms
- 3 T. butter
- 1 small onion, chopped
- ¼ C. dry bread crumbs
- ¼ C. finely chopped pecans
- 3 T. grated Parmesan cheese
- ¼ t. salt
- ¼ t. dried basil
- Dash of cayenne pepper

Preheat the oven to 400. Remove stems from mushrooms; set caps aside. Finely chop stems. In a large skillet, heat butter over medium heat. Add the chopped mushrooms and onion; sauté until liquid evaporates; about 5 minutes. Remove from heat; set aside.

Combine remaining ingredients; add mushroom mixture. Stuff firmly into mushroom caps. Bake, uncovered, in a greased jelly roll pan until tender, 15 to 18 minutes. Serve warm.

Finding different ways to use cauliflower seems to be one of the food crazes for this year. We have cauliflower mashed potatoes as well as pizza crust. This simple recipe uses the spiciness of hot sauce with a great dipping sauce. Enjoy this unique cauliflower dish.

Buffalo Cauliflower

- Head cauliflower, cut into florets
- 2 T. olive oil
- Salt
- Dip
- ½ C. plain Greek yogurt
- ¼ C. crumbled blue cheese
- 1 T. buttermilk
- 1 T. mayonnaise
- 1 T. fresh lemon juice
- ½ t. minced fresh garlic
- Salt and cayenne pepper to taste
- Sauce:
- 1/3 C. hot sauce
- 2 T. unsalted butter
- 1 T. fresh lemon juice
- ½ t. garlic powder

Celery Sticks

Preheat oven to 500. Toss cauliflower with oil and season with salt in a large bowl. Transfer to a baking sheet and roast until charred and tender, about 20 minutes, flipping halfway through.

Dip: whisk together yogurt, blue cheese, buttermilk, mayo, lemon juice and fresh garlic; season with salt and cayenne. Place in small bowl.

Sauce: heat hot sauce, butter, lemon juice and garlic powder in a saucepan over medium until butter melts. Toss cauliflower with hot sauce mixture and arrange on a serving platter with celery sticks. Serve cauliflower and celery sticks with dip.

Along with cauliflower, Brussels sprouts are the vegetable we all should be eating. Since these are really little cabbages, they are a great New Year's dish. My German relatives always believed that if you had some sort of cabbage the first day of the year, you would have lots of luck and good fortune. So, eat that cabbage dish!

Honey Mustard Brussels Sprouts Salad

- 1 lb. fresh Brussels sprouts, trimmed and shredded
- 2 medium tart apples, chopped
- 1 medium red onion, chopped
- 1 small orange pepper, chopped
- ½ C. chopped walnuts
- ½ C. green grapes, sliced
- ½ C. shredded cheddar cheese
- 3 bacon strips, cooked and crumbled
- ¼ C. olive oil

- 2 T. red wine vinegar
- 2 T. honey mustard
- 1 garlic clove, minced
- ¼ t. salt
- ½ t. pepper

In a large bowl, combine the first 8 ingredients. In a small bowl, whisk remaining ingredients. Pour over salad; toss to coat.

If you need a good casserole for a crowd, this dish is an easy one to make. Serve it with some good bread and a salad or the Brussels sprouts from the last recipe.

Beef Goulash

- 1 T. olive oil
- 1 lb. ground beef
- 1 T. Montreal steak seasoning
- 1 small sweet onion, chopped
- 1 medium red pepper, seeded and chopped
- 2 cloves garlic, minced
- 1 can (28 oz.) whole plum tomatoes, undrained
- ¾ C. water
- 2 T. ketchup
- 1½ t. hot sauce
- 1 t. dried basil
- 2 C. cooked elbow macaroni
- Garnish shredded Parmesan cheese, chopped fresh parsley

In a medium Dutch oven heat oil over medium-high heat. Add beef and steak seasoning; cook until browned and crumbly, about 8 minutes. Drain. Add onion, pepper, and garlic to pot; cook over medium-high heat; stirring occasionally, until vegetables are tender, about 5 minutes. Stir in tomatoes, ¾ cup water, ketchup, hot sauce and basil; bring to a low boil. Reduce heat to medium; cover and cook for 20 minutes, stirring occasionally and using the back of a spoon to break up tomatoes. Stir in macaroni; cook until heated through, about 5 minutes. Garnish with cheese and parsley.

I have had this easy chicken dish in a long time ago. One of my friends lost her copy of the recipe. She thought she knew it by heart, but really needed a refresher. Enjoy this easy chicken dish some night when you need a quick supper.

Cheesy Chicken Crescent Supper

- 1¾ C. cooked chicken or 2 cans (5 oz. each) drained boned chicken

- ½ C. shredded Cheddar cheese
- 1 C. milk
- 1 can (8 oz.) refrigerated crescent rolls

1 can cream of chicken soup
Preheat the oven to 375. In a small bowl, combine the chicken and 2 T. cheese. Separate crescent dough into 8 triangles. Place about 2 T. chicken mixture on wide end of each triangle; roll up. In medium pan combine soup, milk and ¼ C. cheese. Heat until cheese melts. Pour half of soup mixture into ungreased 8 or 9 inch square baking dish. Arrange filled crescents over soup mixture and bake 20-25 minutes. Sprinkle with remaining cheese. Return to oven 5-10 minutes. Serve with remaining sauce.

If you would rather eat your margaritas flavoring, a dessert, this cheesecake bar is for you. You start out with a cake mix, so it already is easy. Enjoy this tasty lime recipe.

Margarita

Cheesecake Bars

- 1 box lemon cake mix prepared as box directs

- 1 t. freshly grated lime peel
- 1/3 C. fresh lime juice
- 1 pkg. (2½ t.) unflavored gelatin
- 3 pkgs. (8 oz. each) cream cheese
- ½ C. sugar
- 1 lime for garnish

Heat oven to 350. Spray bottom of 10 x 15 inch jelly roll pan. Spread cake batter in pan. Bake as directed on box. Cool.

Pour lime juice into a small saucepan. Sprinkle with gelatin. Let stand 1 minute and then stir over low heat for 3 minutes or until gelatin is completely dissolved. Remove from heat. Beat cream cheese, sugar, and lime peel in large bowl with mixer on medium speed 2 minutes until fluffy. Slowly beat in gelatin mixture. Beat 1 minute to blend. Spread on cake evenly to edges. Refrigerate 1 hour to set. Loosely cover and refrigerate at least 2 hours or overnight. Cut into 42 bars. To garnish, cut peel off lime with a citrus zester. Cut the lime in quarters lengthwise then crosswise in 11 slices. Top bars with lime and zest.

These decadent bars take a little time in preparation, but they are well worth the extra work. Enjoy these pecan praline treats.

Pecan Praline Sheet Cake

- 1¾ C. firmly packed brown sugar
- ¾ C. unsalted butter, melted
- 3 eggs
- 1 T. vanilla
- 3 C. flour
- 1 T. baking powder
- 1 t. baking soda
- 1 t. salt
- 1½ C. buttermilk
- 1 C. roughly chopped pecans

each addition; whisk in vanilla.

In a medium bowl, whisk together flour, baking powder, baking soda and salt. Gradually add flour mixture to butter mixture alternately with buttermilk, beginning and ending with flour mixture; stirring just until combined after each addition. Fold in pecans. Spread batter into prepared pan. Bake until a wooden pick inserted in center comes out clean, 35 to 49 minutes. Using excess parchment as handles, remove from pan and let cool completely on a wire rack. Spread Caramel Buttercream onto cooled bars and sprinkle with pecans. Serve with remaining caramel from Buttercream.

Caramel Buttercream

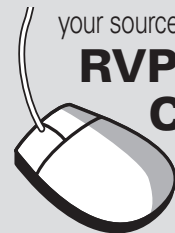
- 3 large whites, room temperature
- 1 C. sugar
- 1½ C. unsalted butter, softened
- ¼ t. salt
- 1 jar (12.25 oz.) caramel topping

In a bowl of a stand mixer, whisk together egg whites and sugar. Place mixer bowl over a saucepan of simmering water. Cook, whisking occasionally, until mixture registers 155 to 160 on an instant read thermometer. Carefully return bowl to stand mixer. Using the whisk attachment, beat at high speed until stiff peaks form and bowl is cool to the touch, 5 to 7 minutes. Add butter, 2 tablespoons at a time, beating until combined. Beat in salt. Slowly add 2/3 C. caramel topping, and beat until smooth, about 2 minutes. (Reserve any remaining caramel to serve with cake).

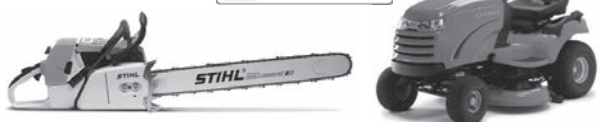

Illinois Extension develops industrial hemp resources

Illinois producers did you grow hemp in 2019? Are you interested in giving it a shot in 2020? With the end of the growing season here,

there are many hemp growers who will be looking to find processors and end buyers for their product. As this is an emerging industry without

a developed supply chain, there are a lot of holes to fill in. In response to this, University of Illinois Extension has created several production resources to help producers navigate this new industry which can be found here: go.illinois.edu/hemp.

First, Illinois Extension has created a "buyer/seller" database which will help connect hemp growers, processors, and end buyers in Illinois. Information will be filled out using the "Industrial Hemp Buyer/Seller Form" and will then be posted to a document labeled "Industrial Hemp Buyer/Seller List." Please note that this information will be

public and as such you are able to enter the amount of information you feel comfortable with sharing. This tool may take some time to develop but is meant to help our growers across the state as a supply chain is developed. Similar tools have been shown to be effective in other states in which hemp production has been legalized.

Secondly, the University of Illinois Extension has created a "Needs Based Assessment" for industrial hemp production in Illinois. As this is an emerging industry, we are looking for the best ways in which we can serve our stakeholders, you!

In order to help us with our research and extension efforts, we ask that you take the time to fill out this quick needs-based assessment to help us develop research trials and educational programs. Capitol dome damage study nears completion

A Capitol dome study conducted earlier this month revealed "some obvious flaws on the exterior of the dome," a state employee said Tuesday, Dec. 17.

Inspectors also found cracks inside the structure and changes made over the years that have altered the Statehouse's historical profile. The flagpole atop the Capitol needs to be replaced and the holiday lights will probably need to be hung in a different manner, Harl Ray, senior project manager for the secretary of state's Department of Physical Services, said at a Capitol Architect board meeting.

Secretary of State Jesse White's office is tasked with overseeing buildings in the Capitol Complex.

Chicago-based, women-owned firm Bailey Edward performed an inspection from the top of the Statehouse dome to the fourth floor, where access to the inner dome is located right outside the House gallery. That dome, standing about 235 feet tall, is what Illinoisans see from inside the building. The outer dome is the silver-colored, 361-foot tall structure seen from outside the building.

The firm's final report, expected by mid-January, will include "a detailed and prioritized list of recommended corrections and repairs to guide future preservation efforts of the Illinois State Capitol Dome," according to its website.

Ray said examiners found open seams in the outer dome's protective metal skin and other spots where the sheet metal overlaps incorrectly. Those areas are "actually catching rain," as opposed to allowing the rain to run from one metal shingle to the next, and causing "active leaks."

Secretary of state crew members are using plastic sheeting to guide water into buckets so it does not seep below the inner dome to occupied ar-

eas of the Statehouse.

Inspectors also "discovered a crack on all four compass points" of the bracket structures supporting the stone columns visible outside the Capitol.

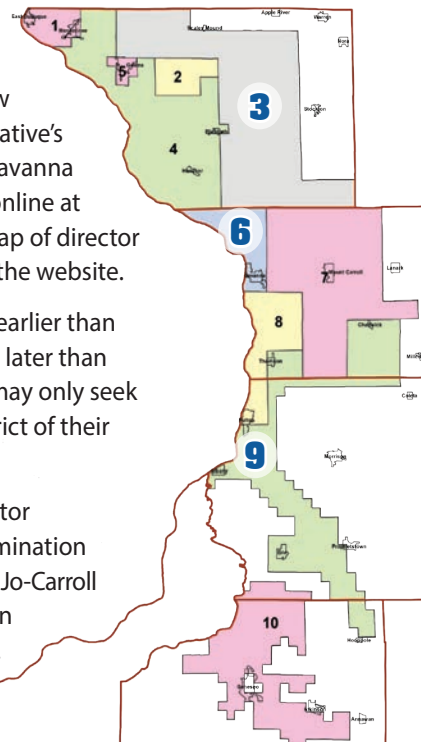
