JDCF webinar focuses on its latest land acquisition

This spring, the Jo Daviess Conservation Foundation announced the largest land purchase in its 27-year history, the Dick Dvorak addition to Apple River Canyon.

The new land preserves 1.2 miles of frontage along the Apple River and 333 acres of forests, cool season grassland, remnant prairie and agricultural land.

It connects two existing units of

Apple River Canyon State Park, so it will broaden wildlife corridors while increasing outdoor recreational opportunities.

Plans include activities such as fishing, hiking, cross-country skiing and other seasonal pursuits, along with restoration of prairie and forested areas in 2021 and beyond.

JDCF staff and the Northwest Illinois Stewardship Co-op will

be removing invasive species, installing a trail system and planting 56 acres of sedge meadow habitat during the next several years.

To bring this acquisition into perspective, a live webinar is scheduled at 7 p.m. Wednesday, July 22.

The program will feature Daryl Watson, a historian, educator and former executive director of the Galena-Jo Daviess County Historical Society and Museum.

And George Bellovic, a

landscape architect for the northwestern region of the Illinois Department of Natural Resources, will provide a conservation perspective.

Watson is a lifelong resident of the Apple River Canyon area, and his family's roots run deep in the region. His histories of the earliest European settlers feature maps and photographs, as well as memoirs, some from his own family.

His stories of the town of Millville, founded in 1835, provide

a window into the life and livelihood of these early settlers as well as their life at the mercy of nature. Located within the canyon itself at the confluence of the Apple River and Clear Creek, Millville was swept away by a flood in 1892.

But canyon's lure for outdoor recreation and observation of nature continued, and the state established Apple River Canyon State Park in 1932.

Late River Ridge High School teacher earns Ag Educator of the Year

Late Illinois agriculture teacher Ed Curry, of River Ridge High School, recently was honored as Illinois' first-ever Ag Educator of the Year through Nationwide's 2019-2020 Golden Owl Award.

As a grand prizewinner, Curry's family was recognized for a m a l l y during the virtual IAVAT conference and will receive the coveted trophy and \$3,000 to help support future educational efforts.

The announcement came after Nationwide recognized Curry and four other Illinois teachers as finalists, as well as individuals in four other states.

In partnership with the Illinois FFA, the insurer recognized Curry, who passed away in July 2019.

"Agriculture teachers play such a critical role in preparing the next generation of industry leaders," Nationwide's President of Agribusiness, Brad Liggett, said in a news release. "Nationwide has deep roots in agriculture, and we're honored to be able to recognize the above and beyond efforts of teachers across the country."

"As an agriculture education

teacher and FFA adviser, Ed's passion was to make a difference for the students and the community in which he served, providing a compelling link for career opportunities and goals," Curry's family said in a statement. "We were deeply honored to be presented with the 2019-2020 Illinois Ag Teacher of the Year Golden Owl Award posthumously for Ed."

After accepting nominations in late 2019 and early 2020, Nationwide and partners announced 31 finalists across five states. Each finalist was recognized and presented with \$500 to support their programs before being entered into a final selection stage for the chance to be crowned as their state's Ag Educator of the Year.

Nationwide initiated the Golden Owl Award in 2018 and recognized the contributions of 17 Iowa and Ohio agriculture teachers. As a result of the positive response from the communities in which Golden Owl Award nominees make a difference, the 2019-2020 Golden Owl Award was expanded to include California, Illinois and Pennsylvania.

"We're excited by the growth we've seen in participation and nominations since beginning the program in 2018," Liggett said. "We hope to be able to continue expanding our efforts to recognize the work of teachers in every state."

The not so skinny cook

Once again our week was a scorcher. Every morning and night I am thankful for my air conditioner. My hats go off to those people who are keeping all air conditioners running.

About eight years ago mine quit during a long stretch of 90-degree days and found out I needed a new one. Hopefully mine will stay running because I was told there are no air conditioners to be found. Keep those fans of coolness running!

So, this week I have featured some hot-weather recipes.

The first appetizer is for delicious crab and mushroom treats. You spread them on English muffins and they don't need long to bake. Enjoy these tasty treats at any time during the year.

Mushroom Crab Melts

- 3 bacon strips, diced
- 1 C. sliced fresh mushrooms
- 1/4 C. chopped onion
- 1 C. imitation crabmeat, cut into bite-size pieces
- 1 C. shredded mozzarella cheese
- 1/2 C. mayonnaise
- 1/3 C. grated Parmesan cheese
- 2 T. butter
- 6 English muffins
- Dash of paprika
- Sauté bacon, mushrooms and

onion in butter until tender. In a large bowl, combine crabmeat, mozzarella cheese, mayo, mushroom mixture and Parmesan cheese.

Spread butter over English muffin halves and top with crab mixture; sprinkle with paprika. Place muffin halves on an ungreased baking sheet. Bake at 400 degrees for 10 to 15 minutes, until golden brown.

Summer Fresh Pasta Salad

This dish is interesting because it blends some vegetables, fruit and tuna for a good summer salad. You can use any dressing you want. If you want to use a Caesar salad dressing on it or an Italian, I think it would be great.

- 4 C. uncooked spiral pasta
- 2 medium carrots, finely chopped
- 2 medium peaches, chopped
- 1 pouch (11 oz.) tuna in water
- 1/2 C. sliced celery
- 1/2 C. julienned cucumber
- 1/2 C. fresh broccoli florets, chopped
- 1/2 C. grated red cabbage
- 1/2 t. salt
- 1/2 t. pepper
- 2 C. buttermilk dressing

Cook pasta according to package directions for al dente. Rinse with cold water and drain well. Transfer to a large bowl. Add carrots, peaches, tuna, celery, cucumber, zucchini, broccoli, cabbage, salt and pepper. Drizzle with dressing and toss to coat. Refrigerate, covered, at least 3 hours before serving.

Buttermilk dressing

- 2 T. buttermilk
- 2 T. sour cream
- 2 T. mayonnaise
- 1 T. lemon juice
- 1 T. minced celery
- 1 t. minced parsley
- 1 t. minced dill

1/2 t. Dijon mustard
 1/4 t. onion powder
 1/4 t. salt
 1/4 t. pepper
 Whisk together dressing ingredients in a small bowl until well blended. Chill, covered, up to one week.

Simple Chicken Casserole

If you are looking for a good casserole that is easy to put together, this one is great. Add a salad and crusty bread, and you have a whole meal. Once again, I would urge you to use rotisserie chicken. Sometimes it is hard to find the large can of chow mien noodles; I have bought a large bag and used one half.

- 1 can cream of mushroom soup
 - 1 can chicken with rice soup
 - 1 small can evaporated milk
 - 1 C. cut-up chicken
 - 1 can chow mien noodles (half a pkg. of chow mien noodles if you can't find the large can)
 - French fried onion rings
- Mix soups, milk, chicken and noodles together in a large bowl. Place in 2-quarter casserole dish that has been sprayed with cooking spray. Bake at 350 for 45 minutes. Top with onion rings and bake for 10 to 15 minutes longer until onion rings have browned.

Cheeseburger Casserole

I didn't want to leave the beef people out again this week, so I had this recipe pointed out to me in a cookbook put together by some cooks in the Stockton and Kent area.

It is a take-off on one of Americans' favorite foods, the cheeseburger. The great thing about this recipe is that you can make it during this blistering weather because you don't bake it!

- 1 lb. ground beef
- 1/2 C. chopped onions

1/2 t. pepper
 2 C. water
 2/3 C. ketchup
 2 t. yellow mustard
 1 t. salt
 2 C. uncooked instant rice
 2 slices of American cheese, cut into 1-inch strips

Brown beef and onion; add water, ketchup, mustard, salt and pepper. Mix well and bring to a boil; stir in rice. Cover and remove from heat. Let stand 5 minutes. Top with cheese, cover and let stand for 3 to 5 minutes or until cheese is melted.

Blackberry Upside Down Cake

Blackberries are starting to ripen in our area. If we get a little more rain, I think we will have some good ones. This cake is an easy one to make, and the good thing about it is that it only makes a 9-inch cake, which is perfect for a dessert without leftovers.

- 2 1/2 C. blackberries
 - 1/4 C. plus 2 T. sugar, divided
 - 1 1/2 C. flour
 - 1/2 T. minced rosemary
 - 3/4 t. baking powder
 - 1 t. zest of lemon
 - 2 t. lemon juice
 - 6 T. butter, softened
 - 2 eggs
 - 2 t. vanilla
 - 3/4 C. sour cream
 - 1/3 C. powdered sugar
- Preheat oven to 400. Spray a 9-inch round pan with cooking spray and line with parchment paper. Toss blackberries with 2 T. sugar and spread onto bottom of prepared pan. In a small bowl, combine flour, rosemary, baking powder and lemon zest. Beat butter and remaining sugar with the mixer until light and fluffy. Blend in eggs and vanilla. Gradually add the dry ingredients alternately with sour cream, mixing well after each addition. Spoon over

blackberries and smooth top. Bake 30 to 35 minutes or until toothpick inserted in center comes out clean. Cool 10 minutes. Loosen cake from side of pan with knife. Invert onto wire rack and gently remove parchment and pan. Place on a cake plate. Cool cake completely.

Mix powdered sugar and lemon juice until blended and drizzle over cake. Garnish with mint leaves and blackberries.

Ultimate Berry Crumble

This dessert uses lots of different berries. If you can't find all three, you can double up on two. This is a yummy dessert that you will be glad you tried.

Filling:

- 1 C. blueberries
- 1 C. raspberries
- 1 C. blackberries
- 1/3 C. sugar
- 1 t. lemon zest
- 2 t. lemon juice
- 2 t. cornstarch

Crumble:

- 2 C. flour
- 3/4 C. sugar
- 3/4 t. baking powder
- 1/4 t. salt
- 1 1/4 C. unsalted butter, frozen
- 1 1/2 t. vanilla
- 2 egg yolks
- 1 to 2 t. cider vinegar

Filling: Preheat oven to 375 degrees. Stir together blueberries, raspberries and blackberries in a bowl. Add sugar, lemon zest, lemon juice and cornstarch. Mix until sugar and cornstarch are mostly dissolved.

Crumble: Whisk together flour, sugar, baking powder and salt in a bowl until thoroughly combined. Using a coarse shredder, grate frozen butter, stopping occasionally to toss

Another 39K file jobless claims in the state of Illinois

The state of Illinois saw slight decreases in the number of people filing first-time unemployment claims as well as the number of people receiving continuing benefits during the week that ended July 4.

But those gains were more than offset by increases in the number of people applying for and receiving benefits under another program designed for people who don't qualify for traditional unemployment benefits.

The Illinois Department of Employment Security said July 9 that it processed 39,015 initial unemployment claims during the week, which was shortened by the Independence Day

holiday weekend. That was down from 43,934 initial claims filed the previous week, a decline of 11 percent.

At the same time, however, the U.S. Department of Labor reported a sharp increase in first-time claims for Pandemic Unemployment Assistance, the federally funded program for independent contractors and others who don't qualify for traditional unemployment insurance. Initial filings under that program rose 31 percent to 42,785.

That brought the total number of people filing first-time claims under both programs to 87,682, up from 78,339 the week before.

Those numbers mirrored national trends as many states, including Illinois,

have started reopening their economies. Nationwide, initial claims for traditional unemployment benefits fell 2 percent, to 1.4 million, while initial PUA claims rose more than 4 percent to just over 1 million.

Meanwhile, the number of Illinois workers receiving continuing benefits under traditional unemployment insurance fell to 667,460, a decline of about 1.4 percent from the previous week.

Nationally, the number of people receiving continuing benefits fell 3.6 percent to 16.8 million.

Data on continuing benefits in the PUA program lags behind that of the traditional unemployment program by two weeks. The Department of Labor

said 108,112 people in Illinois were receiving continuing PUA benefits during the week that ended June 20, up 15 percent from the prior week.

Effective July 9, IDES also implemented a "callback only" model for assisting applicants with unemployment questions or issues. On its website, the department called it a "temporary solution to effectively honor the order in which callers attempt to reach the call center for assistance."

The new model will be in effect for the Claimant Services Center (800-244-5631), IllinoisJobLink.com (877-342-7533), Benefit Payment Control (800-814-0513) and the Employer Hotline (800-247-4984).

As complaints about an inability to

reach IDES about issues with claims continue to mount, the new system aims to return calls in the order they were received, rather than forcing callers to wait on hold or call multiple times.

Callbacks will occur Mondays through Fridays. Claimant Services Center hours are 7:30 a.m. to 7 p.m., while IllinoisJobLink.com, Benefit Payment Control and Employer Hotline hours are 8:30 a.m. to 5 p.m.

Only one pending callback can be scheduled in the system at a time. The call from IDES should display on Caller ID as 800-244-5631, but in certain cases, phone carriers could block this number.

If a callback is missed, IDES staff will attempt to leave a voicemail and will call again shortly after the first attempt, according to a news release. Those who miss both calls will be required to contact the call center to schedule another callback.

shredded butter into the flour mixture to coat. Drizzle in vanilla and add egg yolks. Stir with a fork until egg is mostly absorbed. Add 1 t. vinegar and mix briefly. Use your hands to finish mixing, squeezing until clumps form but mixture remains mostly dry.

Add 1 t. additional vinegar if needed to moisten. Spoon about half of crumble into a 2-quart baking dish sprayed with cooking spray. Press down using a flat bottom cup until well compacted. Spoon and spread filling on top of crumble. Sprinkle remaining crumble over filling, squeezing some into clumps. Bake until top is well browned, 40 to 45 minutes. Let cool to room temperature, about 30 minutes. Serve with whipped cream.

FHN offering COVID-19 testing on July 28

The Stephenson County Health Department and FHN have teamed up to offer additional testing for the COVID-19 coronavirus for individuals age 18 and older.

The free testing, including those without symptoms (asymptomatic) is scheduled from 5 to 7:30 p.m. Tuesday, July 28, at Taylor Park School, 806 E. Stephenson in Freeport — it may be rescheduled if there's bad weather.

But no appointments or health care referrals are required for this first-come, first-served nasal pharyngeal testing.

Participants must bring valid photo ID and wear a mask. Those driving to the testing must remain in their vehicle. Results, which will be communicated by the Stephenson County Health Department to those who are tested, will take at least five days.

Note that this is not an antibody test; it will only tell if a person has the coronavirus at this time, not if they have had it previously.

People are asked to consult with their health care provider with any questions.

• FHN and Freeport High School have collaborated to create a safe

plan for sports physicals for the 2020-21 season.

The physicals will be done on the high school campus to ensure social distancing within the gymnasium while providing a safe environment for participants due to COVID-19 concerns.

Attend during the designated time for a student's intended sport to ensure capacity is held to the appropriate safety standard. Only the athlete and a parent/guardian are permitted in the building; no siblings or individuals not receiving a physical will be allowed entry. Anyone entering the school must wear a mask at all times.

Participants should enter through the south main gym doors on Empire Street; exit will be through the west parking lot by the grass field. Park in the west parking area.

Physicals cost \$20 upon registration via cash or check only (ATM on-site if needed). As in previous years, FHN donates this fee back to the school. The IHSA exam and FHN consent forms can be downloaded at fhn.org/sportsphysicals. All forms must be filled out and signed before arriving

for the physical.

Bellovics' work extends throughout 25 Illinois counties. He is responsible for site planning decisions for 43 state parks and historic sites, as well as fish and wildlife areas in northwestern Illinois.
