# **Emergency rules create fines for** disregarding mask, capacity guidelines

#### Warnings, orders would precede any fines

Illinois Gov. JB Pritzker announced Friday his administration would be filing a new emergency rule allowing health authorities to levy fines on establishments that flout masking and capacity guidelines.

The rules "would provide multiple opportunities for compliance' regarding facemask requirements and capacity limits, including attempts to "educate" and warn the establishment before an order is issued for some patrons to leave the premises.

If the establishment is still not in compliance after those steps are taken, health officials can levy a Class A misdemeanor charge and a fine ranging from \$75 to \$2,500.

Pritzker said all establishments in Illinois are beholden to capacity limits of 50 people or 50 percent of a building's maximum occupancy, and schools must limit the number of people in one space to 50 or less.

The Illinois Department of Public Health and local authorities will have power under the rule to "seek cooperation with businesses in COVID-19 related investigations," according to the governor.

The fines would apply to establishments, not individuals, and the governor's office noted the rules focus on businesses, schools and child care establishments.

"These rules are a common sense way to enforce mask requirements without jumping immediately to the extremely tough consequences that exist on the books today," Pritzker said at a news conference announcing the rules in Chicago. "They'll give local authorities a step-by-step guide on how to enforce masks and distancing and an opportunity to help businesses act in good faith."

He said the existing law allows for

more costly than the fines allowed in the new emergency rules.

Because they are emergency rules, they can only be in place for up to 150 days. The General Assembly's bipartisan Joint Committee on Administrative Rules, or JCAR, has the authority to review emergency rules, and would have to approve the rules if they are to be adopted long-

#### Try, try again

Pritzker's push for the new rules follows a similar attempt that failed before JCAR in May as the committee, after hours-long negotiations behind the scenes, appeared uninterested in imposing a fine structure for businesses that were already hurting due to the COVID-19 pandemic.

At that time, a lead Democrat from the committee said he planned to bring the proposed rule changes before the full General Assembly after the Pritzker administration withdrew the emergency rules amid the opposition. General Assembly action would have bypassed JCAR, enshrining the rules into law, but such a bill never came up for a vote in the abbreviated May session.

Pritzker suggested it would be different this time around, as the new version of the rule allows for education and warnings before the

'What's different about this rule is it focuses on warnings, and then a fine," Pritzker said. "What's available to us in the (existing) law is only essentially a misdemeanor immediately as a solution to the problem. And that was something that JCAR did not want us to move forward with, and so we made alterations."

Pritzker made the announcement various teachers' union representatives, a restaurant trade group president and elected officials

license revocations, which would be at the James R. Thompson Center in Chicago.

Sam Toia, president of the Illinois Restaurant Association, said the measure is necessary so that the state does not enter another stay-at-home order or mandate other closures in the hospitality industry.

"If we want to stay on a steady path and keep our progress with reopening, it's up to every individual to work collectively toward a common goal," Toia said. "It's simple. If you choose not to adhere to public safety guidelines or house rules at businesses, your favorite restaurants, shops, bars, salons, hardware stores and more will pay

The governor also said the order will be important to enforcing mask requirements at schools.

"There are parents that are encouraging school boards in some areas of the state to open without masks. That is against the rules in the state of Illinois, and we now are giving the authority to county public health boards and county public health administrators to work with schools on improving those mitigations that they should have in place," he said.

Kathi Griffin, president of the Illinois Education Association teachers' union, said in order for

district must develop a "practical, enforceable safety plan" following public health guidance.

"I ask you, please, wear face coverings. Maintain social distancing. Do the right thing for your family, for your neighbors, for your community, and most of all, for the over 2 million students in the state of Illinois," she said.

A trade group representing the state's retailers released a statement later Friday opposing the rule, noting that the virus is increasingly spreading at private parties.

# HCC reaches agreement with faculty negotiations

After a joint effort to reach an agreement, negotiations between Highland Community College and the faculty have come to terms on a new contract.

Board of Directors Chairman Jim Endress said that the administration's confirmed commitment restates Highland's commitment to the faculty and to higher education for the greater good of the community.

"Getting this joint agreement complete allows this group to look forward to fall and deliver quality education."

# Ingram out as Teachers' Retirement System director

Leader of troubled pension system resigns after being put on administrative leave

Richard Ingram, the long-serving executive director of the Illinois Teachers' Retirement System, resigned from that position last week after being placed on administrative leave.

In a brief statement, the TRS Board of Trustees said it voted unanimously on July 31 to place Ingram on administrative leave "due to performance issues covered by his employment contract." He then resigned on Aug. 3, effective immediately.

Stan Rupnik, chief investment officer at TRS, has been named interim director. The board said it will "conduct a thoughtful, thorough and vigorous national search" for a permanent director.

TRS did not immediately provide a copy of Ingram's contract, which Capitol News Illinois requested under the state's Freedom of Information Act.

According to the state comptroller's office, he had been receiving a salary of \$283,250 per year.

Ingram began his career at TRS in January 2011. Before that, according to his LinkedIn page, he was executive director of the New Hampshire Retirement System.

TRS manages retirement, disability and survivor benefits for more than 434,000 members, including teachers, administrators and other public school employees in Illinois outside of Chicago Public Schools

With \$51.2 billion of assets under management, it ranks as the 37th largest pension system in the United States.

As of December 2019, however, TRS reported it was only 40-percent funded and it carried an "unfunded actuarial liability" of roughly \$78 billion. That's the current deficit between the system's assets and expected future earnings against the pension obligations it has already accrued.

Citizens State Bank, with locations in Lena, Stockton and Freeport, has awarded


\$500 college scholarships to 12 area 2020 graduates who have displayed excellence in academic achievement, community service and extracurricular activities.

### Research drone photos spot invasive species

University of Illinois Extension hunts for amur bush honeysuckle

have a new friend in the fight against

The University of Illinois Extension forestry program has taken to the skies to see if drones can be used to survey evidence of the invasive shrub amur bush honeysuckle.

"This is an exciting time for technological advances in natural conservation.' resource Kevin Rohling, Illinois Extension forestry research technician. "Drone technology is a game changer. It has the potential to drastically increase our ability to quickly detect and assess issues in Illinois forests without allocating a lot of resources."

Invasive insect, animal, plant and aquatic species threaten native populations, disrupt ecosystems, and cost the U.S. billions of dollars to manage. The most effective way to control invasive species is through a strategy of early detection and rapid response, says Nick Seaton who collaborated with the drone research in his role as project coordinator for the River to River Cooperative Weed Management Area. But manual surveys to find plants are time consuming and expensive, and invasives move fast.

The forestry team is determining if images captured by drones can quickly identify invasive infested areas. Extension foresters can then deliver advice and training to private landowners, managers, businesses, and nonprofits on how to treat and efficiently control further spread.

The research project took place

The forests of Southern Illinois in Southern Illinois, a unique and biodiverse area. The region's patchwork of protected state and federal natural areas is home to 107 state threatened and endangered species that are jeopardized by invasive species.

"Invasive plants do not recognize political boundaries," Rohling says. 'So private areas near the Shawnee National Forest managed with the aid of this technology will reduce seed sources that would otherwise contribute to the spread of bush honeysuckle."

Starting in 2018, the team organized more than 40 flights during spring and fall when the forest canopy was clear of leaves, but when the greenery of bush honeysuckle was still visible in the understory.

The forestry team collaborated with the River to River Cooperative Weed Management Area on the research, and funding was provided by the USDA Forest Service Northeastern Area State and Private Forestry.

The forestry team identifies its target site and sets up automated flights to take high-resolution photos. The images are combined into a mosaic of the forest canopy that is loaded into the mapping program ESRI ArcGIS for analysis.

Early results show that the drone surveys provide access to remote areas while saving time and resources, but there are limitations. The foresters were able to identify mature plants, but small or firedamaged plants escaped detection, Rohling says.

Aerial surveys took less time than walking surveys, only two hours compared to more than 11; however, there is a narrow window of time to get photos.

'Timing is absolutely critical," Rohling says. "We're still working on improving that component."

Early fall flights photographed canopies still full of leaves, but invasive species had browned out in later flights. In the spring, early buds and leaves blocked the understory. And the drones can only fly when the weather cooperates.

Looking ahead, the team expects they can use drones to survey for other invasive plant species, but the potential for maintaining forest health doesn't stop there. They plan to find blooming chestnut trees and propagate them in other areas for agroforestry purposes. A student is also using the aerial images to identify new habitats for rare plant species.

"We're only now scratching the surface with drone technology," Rohling says. "For example, future projects could include very targeted herbicide applications that would save money as well as reduce environmental impacts.'

# **Downy mildew** threatens basil **Crop in Illinois**Presence in northeast, east-central

part of state increasing concerns

mildew in northeast and eastcentral Illinois is raising concern for commercial and home growers as temperatures begin to cool.

"Illinois has become one of the leading basil producers in the country," says Travis E. Cleveland, University of Illinois Extension crop science specialist. "With 600 acres in production, valued between \$10,000 and \$20,000 per acre, there's a lot at stake.3

Basil downy mildew disease symptoms first appear as yellow areas on the tops of leaves. The undersides of leaves are covered with spores and dirt. Under magnification, the leaves appear to be covered in grey fuzz.

Basil downy mildew is caused by Peronospora belbahri, a fungal-like oomycete. The spores travel large distances by wind, and a few spores can quickly lead to a huge infestation.

The mildew flourishes in cooler, wet weather, making it more of a concern at the beginning and end of the growing season, Cleveland says. The disease progresses quickly, with affected leaves turning brown and falling from the plant. A plant can defoliate in a few days.

Mohammad Babadoost, an Illinois crop sciences professor specializing in vegetable crop diseases, has performed basil downy mildew fungicide trials since 2009.

Because this pathogen is known to develop resistance to fungicides quickly, chemicals with different modes of action should be used," Cleveland says.

For commercial producers, there

The presence of basil downy are a few chemical fungicides that are effective, but require a pesticide applicator license and may need up to 17 applications per season.

Babadoost recommends alternating the following fungicide combinations at weekly intervals: Azoxystrobin, Cyazofamid, Revus 209SC. Illinois Extension provides additional information in its online Home, Yard and Garden newsletter.

The non-selective fungicide Chlorothalonil has shown to be somewhat effective and is available under numerous trade names to home gardeners.

"To treat an infestation, quickly remove and destroy any diseased plants," Cleveland says. "Because the pathogen needs moisture to thrive, reducing humidity and leaf wetness is important."

distances, Increase planting planting in areas of full sun and air movement, and watering at the base of the plant helps reduce moisture on or around the plant.

Several basil cultivars resistant to downy mildew have been recently released; however, even resistant basils can be infected in moist conditions.

Basil downy mildew is less virulent toward red or purple basil, which can be used as an alternative to the popular sweet basil, Babadoost says. Carefully inspect purchased plants at the nursery or garden store before bringing them home.

# From Lena's Kitchen



The not so skinny cook

What a beautiful week we had; everyone got a chance to open Unfortunately, the windows. humidity returned, but it was hard to remember that it is still August.

This week's recipes have many different flavors, so enjoy making

The German side of my family loved Braunschweiger. In fact, my grandfather's favorite sandwich was Braunschweiger and onions on bread. I never could get past the smell; however, in an old cookbook I found this dip recipe using this sandwich spread. If you are up for a challenge, you can buy Braunschweiger in most grocery stores in the meat section.

#### **Braunschweiger Dip**

10 oz. Braunschweiger

1 C. sour cream

1 pkg. dry Lipton onion soup mix

½ T. Worcestershire sauce

Assorted crackers

Mix all above together well. Place in a small serving dish. Refrigerate for at least 30 minutes before serving. Serve with crackers. Refrigerate leftovers.

#### **Cucumber Crunch** Coleslaw

The name of this salad is misleading. When you see coleslaw, you usually think some kind of cabbage. Well, the slaw part of this salad is the julienned cucumbers.

This salad marries a lot of interesting flavors into a new kind of slaw.

Dressing:

1/3 C. olive oil

<sup>1</sup>/<sub>4</sub> C. white wine vinegar

1 T. minced fresh basil

1 T. limejuice

1 jalapeno pepper, seeded and minced

1½ t. minced fresh mint

11/2 t. molasses

1 t. sugar

1 garlic clove, minced

3/4 t. salt

3/4 t. grated lime zest

½ t. pepper

#### Colesiaw:

3 English cucumbers, julienned

2 C. fresh baby spinach, coarsely chopped

1 C. snow peas, cut into ½ inch pieces

½ C. sliced almonds, toasted

1 C. dried cranberries

In a small bowl, combine the first 12 ingredients. In a large bowl, combine cucumbers, spinach, snow peas, almonds and cranberries. Just before serving, pour dressing over the salad and toss to coat.

#### **Harvard Beets**

Gardens are producing a lot of red beets. Some people like them boiled, roasted, grated for salads, pickled or steamed; these are the many ways you can fix them.

If you have never done anything with them, you should cut the tops off and peel them before starting to make them.

2 T. sugar

2 T. white vinegar

¾ t. flour

2 t. butter 1/4 t. salt

Place beets in a small saucepan and cover with water and simmer; cover and cook until tender, 15 to 20 minutes. Drain, reserving 1 T. liquid and set beets aside. In same pan, combine sugar, white vinegar, flour and reserved liquid. Cook over low heat until thickened. Stir in beets and top with butter and salt. Simmer for 5 minutes.

#### Cheeseburger Meatloaf

I think one of the greatest comfort foods is meatloaf. I would not order it in a restaurant because I think I make a pretty good meatloaf at my house. I am always looking for different ways to serve it, and this one fills the bill. Enjoy a favorite comfort food in a different way.

11/2 lbs. ground beef

1/3 C. breadcrumbs

1/3 C. finely chopped onion

1 egg, lightly beaten

1 egg yolk

1 t. salt

1 t. pepper

2 C. shredded cheddar cheese

½ C. ketchup

<sup>1</sup>/<sub>4</sub> C. packed brown sugar

2 t. yellow mustard

Preheat oven to 350. Line a 10-by-15-inch baking pan with foil. Spray with cooking spray. Mix together beef, breadcrumbs, onion, egg, egg yolk, salt and pepper in a large bowl. Pat meat mixture into a 10-by-12-inch rectangle on wax paper. Sprinkle cheese over meat, leaving 3/4 inch border around the edges. Starting with a long end, roll up jellyroll style. Pinch the ends and seam together to enclose.

Transfer to prepared baking pan and bake 35 minutes. Stir together the ketchup, brown sugar and mustard in a small bowl and spread on meatloaf. Continue baking 25 minutes more or until an instant-read thermometer inserted in center registers 160. Tent lightly with foil and let stand 10 minutes before serving.

#### **Southwest Chicken** Parmesan and Rice

If you are looking for a different

chicken breast recipe with a little kick, you will enjoy this recipe. It is relatively easy even though there are a lot of ingredients.

11/2 t. cumin, divided

1 pkt. Shake and Bake Extra Crispy seasoned coating mix

4 small boneless, skinless chicken breasts

½ C. long-grain white rice, uncooked

1 can (8 oz.) tomato sauce

½ C. thick and chunky salsa

½ C. Mexican Style, finely shredded four cheese

½ C. rinsed, canned red kidney

½ C. frozen corn, thawed

<sup>1</sup>/<sub>4</sub> C. loosely packed fresh cilantro, chopped

<sup>1</sup>/<sub>4</sub> C. vinaigrette dressing

2 t. limejuice

Preheat oven to 350. Mix 1 teaspoon cumin with coating mix before using to coat chicken as directed on package. Place chicken in single layer in an 8-inch square pan sprayed with cooking spray. Bake 20 to 21 minutes or until done (165).

Cook rice as directed on package, omitting salt. Mix tomato sauce, salsa and remaining cumin in a bowl until blended. Top each chicken breast with 1/4 cup of the tomato sauce mixture and 2 T. cheese. Pour remaining tomato sauce mixture around chicken. Bake 5 minutes or until sauce is heated through and cheeses melted. Combine beans, corn, cilantro, dressing and lime in large bowl. Add cooked rice and mix lightly. Serve chicken on top of rice

#### **Cherry Grunt**

I guess I am into old recipes this week. In an old farmer's wife cookbook, I found a recipe for grunt. I did a little research on why any dessert was named grunt. The traditional grunt was made with blueberries. Basically it is a fruit with dumplings. Colonists named it grunt because the blueberries made a sound when they were bubbling under the dumplings. This recipe is really easy to make and really tasty, especially if you serve it with ice cream!

1 can (16 oz.) pitted tart red cherries, undrained

1½ C. water

3/4 C. sugar, divided 1/4 C. butter, divided 1 C. flour

11/2 t. baking powder Pinch of salt

1/3 C. 2 percent milk ½ t. vanilla

Place cherries and juice in a straight-sided skillet or Dutch oven along with water, ½ C. sugar and 2 T. butter. Simmer for 5 minutes.

In a separate bowl, sift together flour, baking powder, salt and remaining sugar. Cut in remaining butter with a pastry blender. Add milk and vanilla. Drop by teaspoonfuls over cherry mixture; cover and simmer until dumplings are cooked through, about 20 minutes.

#### Apricot Pecan Crumble

I don't bake a lot with apricots. I know I was always assigned to make apricot pies for the historical society bake sales at the Lions Fall Festival pork chop barbecue. I used canned apricots, and my good friend Margie Scholtz always told me to add dried apricots to the canned filling.

One of my mother's high school friends bought a piece of it and told me that my mother had taught me well. It was the best apricot pie she had ever eaten. I think she was being nice, but I thought it was good, too!

It was one of the first pies to sell out, so there are apricot lovers out there.

Back to this dessert. I don't give you a lot of apricot recipes, but this one is really good. This recipe uses fresh apricots and fresh peaches. The crumble uses pumpkin pie spice for flavoring. Enjoy the meshing of tastes that these two fruits bring.

11/4 C. firmly packed brown sugar, divided

3/4 C. flour

1 t. cinnamon

6 T. cold butter, cubed

½ C. old-fashioned oats

½ chopped pecans

1 T. cornstarch

1 T. water

3/4 t. pumpkin pie spice ½ t. ground ginger

5 C. sliced peeled fresh apricots

2 C. sliced peeled fresh peaches





# Aid for struggling small businesses to start flowing

#### \$636M in Business Interruption Grants to help firms hit by COVID-19

Financial aid is about to start flowing for Illinois businesses that have been affected by the COVID-19 pandemic.

The Department of Commerce and Economic Opportunity published emergency rules recently to implement the Business Interruption Grant program, or BIG.

Those rules took effect July 21 when they were submitted to the secretary of state's office.

State lawmakers authorized the program in the budget they approved during their special session in May. It will make \$636 million in federal CARES Act money available to small businesses that have been forced to close or that have seen a substantial loss of customer activity due to COVID-19.

"The Business Interruption Grant program, otherwise known as BIG, is a key component of Gov. Pritzker's comprehensive response to COVID-19 and the economic distress it's caused for Illinois businesses and communities," DCEO spokeswoman Lauren Huffman said in an email. "This historic \$636 million program will provide immediate relief for small businesses, which have experienced significant revenue losses as a result of the ongoing pandemic, and focuses on businesses and communities hit hardest by the

The bill also provides that at least 30 percent of the money must go to businesses located in "disproportionately impacted areas," or DIAs, which are ZIP codes where there are high concentrations of lowincome households and high rates of COVID-19.

Huffman also said that at least \$159 million in grants will go to entities located outside Chicago and the surrounding collar counties.

Although the application window for the first round of grants totaling \$60 million already has closed, the new rules enable the agency to begin processing those applications and awarding grants.

During the first round, priority is being given to small businesses located in DIAs. Specifically, \$20 million will be distributed to small businesses located in DIAs where there was property damage during recent civil unrest. Another \$20 million is set aside for bars and restaurants; \$10 million for barbershops and salons; and \$10 million for gyms and fitness centers.

Those businesses must have met certain income requirements during 2019. They also must have been in business for at least three months prior to March 2020 and have incurred at least \$10,000 in qualifying expenditures since March

The BIG program also sets aside

centers. An initial round of those grants are to be awarded by Sept. 30.

Those grants are administered by the Department of Human Services and will be awarded to facilities that receive at least 25 percent of their revenue through the Child Care Assistance Program and whose operating capacity has been reduced due to group size restrictions imposed by the Department of

\$270 million for licensed day care Children and Family Services to combat the spread of the novel coronavirus.

If funds allow, another round of grants will be awarded for the period Oct. 1 through Nov. 30, according to

Grant awards may be used to cover operational costs such as staff wages and benefits, occupancy costs, materials, supplies and professional services that are eligible Fund reimbursements and are not otherwise covered by another grant or loan program such as the Payroll Protection Program or other disaster relief programs.

#### Pritzker warns of deep cuts without federal economic aid

#### Congress still debating whether to help states make up for lost revenue

Gov. JB Pritzker said last week that Illinois faces the prospect of having to make deep spending cuts over the rest of the fiscal year if Congress does not pass an economic relief package that helps states make up for the massive loss in revenue they've seen since the start of the COVID-19 pandemic.

"I continue to do my part to make calls, to make sure that people understand that Republican-led states and Democratic-led states all have this challenge of revenues that fell off a cliff because of COVID-19," Pritzker said during a news conference in Springfield.

COVID-19 first appeared in Illinois in January and it quickly spread to all corners of the state, prompting Pritzker to issue a stay-at-home order that virtually shut down major segments of the economy. Similar economic restrictions were imposed in other states as well, although many were less

strict than those in Illinois.

As a result, base revenues flowing into state coffers fell during the fiscal year that ended June 30 by a little more than \$1.1 billion.

In May, state lawmakers passed a budget for the new fiscal year that began July 1. That budget was roughly \$5 billion out of balance compared to revenue estimates available at the time, but the plan was to fill in the gap by borrowing from the Federal Reserve and by passage of a proposed constitutional amendment to allow the state to levy a "graduated" income tax that would impose higher tax rates on higher levels of income.

The budget authorized borrowing roughly \$4.5 billion through the Federal Reserve's Municipal Liquidity Facility, something the Fed board approved earlier this year as a way to help state and large local governments make up for the loss of revenue they've

In Illinois, the plan was to borrow that money and pay it back with aid that lawmakers expected Congress to

Republicans in the General Assembly argued against that plan, saying it would be unwise to rely on short-term borrowing to balance the

budget, especially when it was still unknown what, if any, kind of relief package Congress would authorize in the future.

But Democrats argued that using the Federal Reserve's credit program was the best option available because it enabled the state to continue spending and spurring economic activity at a time when businesses and consumers

Now, as negotiations between the Democratic-led U.S. House and Republican-led U.S. Senate have dragged on, many observers say it looks increasingly less likely that the next economic relief package will include aid to states.

Although the House has passed its own version of a relief package that includes about \$500 billion to help states make up for their lost revenue, the latest Senate proposal does not include such aid.

And as recently as July 23, U.S. Treasury Secretary Steven Mnuchin told CNBC that, "the president is not going to bail out Chicago and New York and other states that prior to the coronavirus were mismanaged."

Without federal aid, however, Pritzker said Monday that there will be significant cuts and job layoffs in Illinois and throughout the country.

"But this is going to be up to the Congress. They're the ones who have the ability to help us and to help all 50 states with the challenge we all have. But there are going to be layoffs across the country, not just related to state government, but when you don't fund state and local governments you're going to see, and you've already seen to some degree, layoffs," Pritzker said.

"Not to mention those who provide services to state and local governments, private companies whose contracts no doubt will be put aside because the money isn't flowing, because we don't have the ability to balance the budget in the way that we had originally intended to.'

# Mendoza warns of dangers ahead for Illinois budget

#### Comptroller says federal aid critical for state to survive pandemic

Illinois Comptroller Susana Mendoza is adding her voice to those warning that the state will face dire consequences if the federal government does not approve an economic aid package for state and local governments.

"Without question, Illinois—and every other state, frankly—will need financial support from the federal government to bring much-needed stability back to state and local government," Mendoza wrote in the latest edition of distributed in a news release last week.

Taxpayers, bond houses, businesses, human service providers, schools, and colleges and universities need to know that together we will pull through this unprecedented time.

Mendoza, a Democrat who has served as comptroller since December 2016, noted that the state began the fiscal year on July 1 with a backlog of past-due bills totaling nearly \$5.4 billion. But that was only because the state borrowed \$1.2 billion from the

She said the total amount due in the

from the Fed, the treasurer's office and interfund borrowing is \$1.63 billion.

But as the COVID-19 pandemic continues to ravage Illinois and the rest of the country, revenues flowing into state coffers are expected to fall significantly. The state's unemployment rate in June stood at 14.6 percent, and depending on how long the pandemic lasts, that could cut deeply into individual income tax and retail sales tax collections.

The budget that state lawmakers passed in May called for \$42.8 billion in general revenue fund spending. It also authorized spending the \$5.5 billion that the state expects to receive in federal CARES Act money—funds Congress approved in March to help pay for COVID-19 response and relief efforts which cannot be used to replace lost revenues.

Mendoza noted, however, that the budget was predicated on the idea that the state could borrow between \$5 billion and \$6.5 billion through various sources, including the Municipal Liquidity Facility, "depending on whether the federal government provides direct relief to states for revenue failures as a result of the pandemic."

Without the borrowing, Mendoza noted, lawmakers would have been faced with the prospect of making 35-percent cuts across the board.

This would have been catastrophic to schools; public safety; and the medical, social, and human service programs upon which the state's most vulnerable citizens rely," she said.

But Mendoza also warned about the consequences of further short-term borrowing without a dedicated source of revenue to repay it.

"As Illinois considers the possibility of engaging in additional borrowing, it must be cautioned this is not 'free money.' It must be repaid," she said. "Adding some \$6.5 billion in potential borrowing, especially with interest rates of more than 4 (percent), to the \$2.66 billion in short-term borrowing already owed would have consequences on Illinois' financial outlook for years to come."

Among those consequences, she said, would be another sharp spike in the state's backlog of bills outside of the core payments for debt service, pensions, K-12 education, employee payroll, and social and human services.

# 'We are failing African-American students'

#### Data shows that Illinois moved backward in some equity metrics

The Illinois Board of Higher Education is preparing a strategic plan to make higher education in the state more equitable, which will be released for public scrutiny sometime between late December and early March of next year.

To inform the process —which starts in September — of crafting that plan, the board begins each meeting with presentations on equity. The first of these presentations was Aug. 4, with the topic being ethnic and racial equity in higher education.

"The story I will lay out today is not an uplifting one," IBHE Executive Director Ginger Ostro said. "On nearly every measure, we are failing our African-American

Based on data from the 2013 and 2018 American Community Survey, Black and Latino residents lag far behind their white peers in enrollment, retention, progression, developmental in education, access to early college, completion, attainment and earnings

While enrollment among all racial groups dropped between 2013 and 2018, the drop was steeper for Black and Latino residents.

"As we look again over time, the proportion of the student population that is African- American has declined every year," Ostro said.

In 2013, non-Hispanic Black residents made up 14.2 percent of the Illinois population and 14.9 percent of undergraduates. By 2018, while they remained a steady proportion of the population, Black students fell to 12.7 percent of undergraduates.

For the 2017-2018 school year, Illinois public universities retained 62 percent of first-year African-American students to the following school year, compared to 82 percent of white students. When looking at the percentage of students that actually progressed to sophomore status in the 2018-2019 school year, the gap grew even larger. Only 28.6 percent of African- American students gained enough credit hours to be considered sophomores, compared to 63 percent of white

According to Ostro, the disparity starts even earlier, before students

even set foot on a college campus.

"African-American students are missing out on opportunities to earn credits or get exposure to college level work. And research shows that early college experience leads to higher levels of college enrollment and completion," she said.

The most recent graduating class of Illinois high school seniors was 15.4 percent Black, 24.4 percent Latino and 51.6 percent white. Yet in high school programs that give students a chance to get college credit early, Black students were heavily underrepresented.

In Advanced Placement courses – high school classes that give college credits - white and Latino students were participants proportional to their graduating class, while Black students made up only 9 percent of AP students.

In dual enrollment college courses that high schoolers can take credit at community colleges or equivalent institutions -Black and Latino students were heavily underrepresented, making up 9.2 and 17.7 percent of participants, respectively. White students were nearly 65 percent.

A number of factors could cause these outcomes, such as schools that serve predominantly African-American and Latino students not having AP and dual enrollment courses available.

Equity gaps persist even when students finish school.

White college graduates on average made almost \$5,000 more annually one year after graduating with a bachelor's degree than their Black peers with a similar level of education. After three years, the disparity grew larger.

A gap also exists between white and Latino college graduates, but it's significantly smaller on average, never reaching more than \$2,000.

"These gaps are well above the national average," Kayla Elliott, a senior policy analyst for higher education at the Education Trust, said at the meeting. "We know that for people of color, for Black Americans in particular, attending college and earning a degree from a public institution might be the most promising pathway toward economic security and upward social mobility."

According to Elliott, conscious policies, or those that take race and ethnicity into account, can help alleviate equity gaps. Policies that substitute other demographics such as income and zip code for race

opportunity and outcome for Black and Latino students, she said.

In 2008, Advance Illinois, an independent public education policy organization, set the "60 by 25" goal: for 60 percent of adults in the state to have a post-secondary education

or equivalent credential by 2025. While the state is not on track to meet that goal, IBHE hopes with its upcoming strategic plan that Illinois will make great strides towards equity and higher-education attainment for all residents by 2025. According to Ostro, future

meetings will look at gender, income and geographic equity gaps.

# Asking, but not getting answers to questions

I am writing as a property owner at Apple Canyon Lake experiencing a problem with our Home Owners Association Board.

In 2002, the HOA board made the decision to allow more than 550 Apple Canyon Lake boat docks to be permanently attached to private homes.

That means only 193 boat docks are available for the rest of the more than 2,000 house/property owners.

Currently there are 300 names on that list, and those waiting patiently may want to add the names of their grandchildren on it as well, given the amount of dock availability compared to the number of people interested in leasing a dock.

As if that information isn't concerning enough, over 2,500 home/ lot owners at the lake are forced to pay dock maintenance on those 506 docks that we can never use. Nor do we receive the automatic \$20,000 to \$30,000 bump in our homesale price because we don't have a grandfathered dock to sell along with our house.

After a flood in the fall of 2017, many docks (along with a number of boats) were destroyed or washed away, forcing an enormous expenditure of HOA funds to repair/replace all those docks, even those controlled by private homeowners.

Currently, I am completing an

FOIA request to discover exactly how much of our HOA dues were used in that instant to repair what is, for all intents and purposes, private property.

This is an unethical use of HOA funds and I have requested a response to this situation from the Apple Canyon HOA board. I have also submitted a second request for a response after hearing nothing for over a month.

I am hoping that while the current board members refuse to contact me after my letters, perhaps seeing this editorial will encourage them to provide me with a response.
