State rep's petition asks governor to allow fall football

The lack of Friday night lights is being spotlighted by state Rep. Andrew Chesney, R-Freeport, who has organized a petition effort to reverse Gov. JB Pritzker's decision to delay fall sports.

In a news release, Chesney urged northwest Illinois residents to sign the petition at repchesney.com. Chesney's 89th District includes all of Jo Daviess and Stephenson counties.

"Let them play" is a sentiment I hear repeatedly from parents and student athletes in all sports in Illinois," Chesney said in the news release. "The governor has clearly made a political decision here. All of Illinois' surrounding states are safely allowing high school football and other sports, but Governor Pritzker is blocking local school and public health officials from making that decision here.

"The governor does not seem to understand how these decisions affect the average Illinoisan. Not to mention the academic opportunities lost by our youth not participating in sports."

A request for comment from the governor's office was not received by press time.

FROM LENA'S KITCHEN

We certainly have had our ups and downs temperature-wise. I guess that means fall is really here. As I write this column, they are predicting very cool temperatures. When you read it, you could be sweating. I guess it makes life exciting.

This week's recipes use a little of the vegetables from the garden that are being picked for the last time. There is a coleslaw that has a lot of color, cauliflower with a different taste, two main dishes and two desserts.

Cucumber Coleslaw

This slaw uses both green and red cabbage, shredded carrots and cucumbers, and a dressing with a little bit of a kick.

- ½ C. mayonnaise
 - ¼ C. apple cider vinegar
 - 2 T. sugar
 - ½ t. salt
 - ½ t. pepper
 - ¼ t. ground cumin
 - 1 small head cabbage (12 C. shredded)
 - 4 C. shredded red cabbage (½ small head)
 - 2 C. shredded carrot (4 medium)
 - 1 C. shredded English cucumber
- In a large bowl, whisk together mayo, vinegar and sugar. Stir in salt and pepper and cumin until smooth. Stir in cabbages, carrot and cucumber until well combined. Cover and refrigerate for one hour before serving.

Roasted Cauliflower with Buttery Pecans

Cauliflower is still one of the "in" foods. You can use it as a traditional side, mash it up for a potato dish, or rice it to use in Oriental dishes. This first recipe has great flavor and a little crunch. It is a great vegetable side or a substitute for potatoes.

- 2 heads cauliflower, sliced vertically 1 inch thick
- ¼ C. olive oil, divided
- ½ t. salt
- ½ t. pepper
- 4 T. unsalted butter

½ C. chopped pecans

Preheat oven to 350. Spray two large rimmed baking sheets with cooking spray. On prepared pans, arrange cauliflower in a single layer. Drizzle with oil and sprinkle with salt and pepper. Bake until tender and golden brown, 40 to 45 minutes, turning halfway through baking. In a small skillet, melt butter over medium heat.

Add pecans; cook, stirring frequently, until toasted, four to five minutes. Spoon mixture onto cauliflower. Serve immediately.

Creamy Spinach Chicken

This chicken dish has the vegetable right in it. Serve it over noodles, and it is good enough for company.

- 3 lb. boneless skinless chicken breast halves
- 1 can cream of chicken soup
- 2/3 C. chicken broth
- ½ C. gorgonzola cheese cut into pieces
- ¼ C. softened cream cheese, cubed
- ½ t. minced garlic
- ½ t. dried parsley
- ½ t. dried rosemary
- 4 C. fresh baby spinach
- Hot cooked noodles
- Grated Parmesan cheese

Place chicken in a 4-quart slow cooker. In a bowl, combine soup and broth; pour over chicken. Cover and cook on low for eight hours or on high for four hours.

Remove chicken from cooker. Shred chicken using two forks. Return chicken to slow cooker. In a small bowl, mix Gouda, cream cheese and herbs until blended. Gradually stir in cheeses to soup mixture in slow cooker. Add spinach and cook on low for 10 minutes, stirring after five minutes, and then after 10 until spinach is wilted. Serve chicken mixture over noodles and sprinkle with Parmesan cheese. If you don't want to put things back in the slow cooker, you can put soup mixture in a skillet, add shredded chicken and baby spinach and cook on low, stirring until spinach is wilted.

Crispy Orange Beef

This stir-fry recipe is made on the "lite" side. It does use top sirloin, but it uses cauliflower several ways. The soy sauce should be the reduced sodium to cut down on a lot of the salt. Freezing the sirloin makes it much easier to slice. I think you could substitute the cauliflower with broccoli. You can find the cauliflower rice in most grocery stores in the freezer section.

- 12 oz. beef top sirloin
- 2 oranges, zested and juiced
- 2 T. soy sauce
- 1 T. honey
- 1 T. cornstarch
- 2 T. olive oil
- 1 small head of cauliflower, cut into florets, about 2 C.
- 2 red bell peppers, cut into thin, bite-size strips, about 3 C
- 1 carrot, peeled and thinly bias-sliced (¼ C.)
- 3 T. grated fresh ginger
- 1½ T. minced garlic
- ½ t. salt
- 2 C. steamed cauliflower rice
- 4 green onions, bias sliced

Freeze beef until firm — about one hour — to make it easier to slice. Thinly slice beef and set aside. Whisk together ½ C. orange juice, soy sauce, honey and cornstarch in a small bowl. Heat 1 T. oil in a large skillet over medium-high heat. Add cauliflower and cook, stirring frequently, for five minutes. Add bell peppers and carrot, cook, stirring frequently until crisp tender, about three minutes more. Transfer to a bowl. Add remaining tablespoon of oil to skillet over medium-high heat. Add beef; cook, stirring frequently, until browned, two to three minutes. Transfer to bowl with vegetables, reserving the drippings in the skillet. Add ginger, garlic and 2 t. orange zest to skillet; cook, stirring until fragrant, about 30 seconds. Add orange juice mixture and salt. Bring to a boil, and cook until thickened, about two minutes. Stir in beef and vegetables to coat; cook until heated through. Serve over cauliflower rice. Garnish with green onions.

Caramel Apple Crisp

There are a lot of apple crisp recipes out there, and I have given you a lot of them. This one is unique because of the caramels. Enjoy the great taste of caramel apples in a crisp.

- 3 C. old-fashioned oats
- 2 C. flour
- 1½ C. packed brown sugar
- 1 t. cinnamon
- 1 C. cold butter, cubed
- 8 C. thinly sliced peeled tart apples
- 1 pkg. (14 oz.) caramels, halved
- 1 C. apple cider, divided

Preheat the oven to 350. In a large bowl, mix oats, flour, brown sugar and cinnamon; cut in butter until crumbly. Press half the mixture into greased 9-by-13 baking dish. Layer half of apples, half of caramels and half of remaining oat mixture. Repeat. Drizzle ½ C. apple cider on top. Bake, uncovered, 30 minutes. Drizzle with remaining cider; bake until apples are tender, 15 to 20 minutes.

Brown Sugar Bundt Cake

I think that Bundt cakes are great fall desserts. They look great on a cake stand. I like this cake because it uses powdered sugar dusted on top rather than frosting — it is a few less

calories.

- ¼ C. whole buttermilk
 - 1 C. oil
 - 3 eggs
 - 1 t. vanilla
 - 3 C. flour
 - 1½ C. packed brown sugar
 - 1½ t. baking powder
 - 1 t. salt
 - ¾ t. baking soda
 - ½ t. cinnamon
 - 3 T. powdered sugar
- Preheat oven to 300. In a large bowl, whisk together buttermilk, oil, eggs and vanilla. In a medium bowl, whisk together flour, brown sugar, baking powder, salt, baking soda and cinnamon. Gradually add flour mixture to buttermilk mixture, beating with a mixer at medium speed just until combined.

Spray a 10-cup Bundt pan with baking spray with flour. Pour batter into prepared pan. Bake until a wooden pick inserted near the center comes out clean, about one hour and five minutes. Let cool in pan for 10 minutes. Invert cake onto a wire rack, and let cool completely. Sift powdered sugar onto cooled cake just before serving. Store in an airtight container for up to three days.

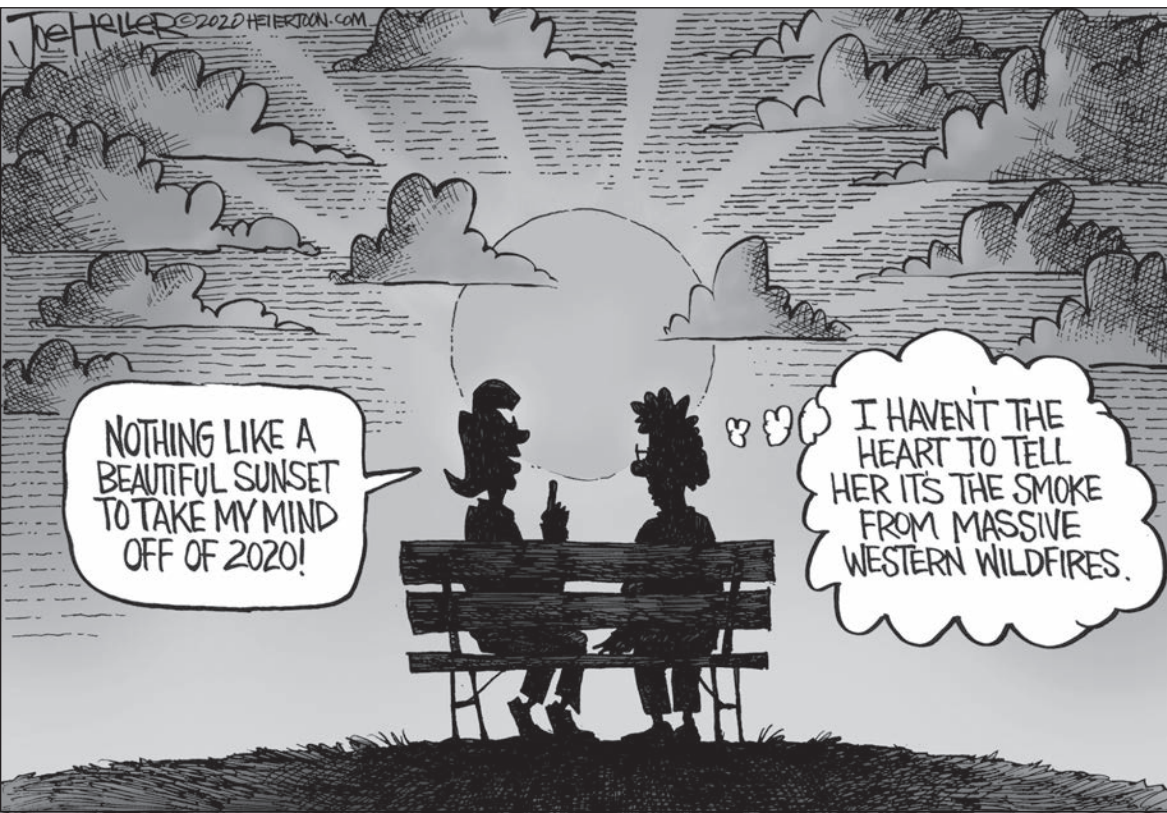

Slices of life

Don't let fear steal the life from your days

“The only thing we have to fear is fear itself.”

— Franklin D. Roosevelt

Fear is in the air. It is in every breath we take. It fills our lungs. It dictates our actions. We dodge an invisible enemy, knowing it is out there, but never sure quite where or when it might hit.

And this dictates fear among us. The unknown has a tendency to do that. And COVID-19 is the unknown. It is like nothing we've ever experienced before. So it's easy to be afraid. It's the default for most of us.

Something very serious and scary and real could hurt my family or me or our nation. It already has. And a lot of us are afraid.

I have an 80-something neighbor who is also a friend. She wears her mask when required. She wants to stay safe. She follows the rules, because that's what good people do.

One night last week I was chatting with her outside. We were socially distanced, but I lost track of that and took a step toward her. When I realized my action, I apologized and asked her if I should step backward.

Her response was not what I expected.

“Oh, no,” she said. “It's OK. We decided we aren't going to live in fear.” (In the “we” she was referring to her husband.)

I silently applauded her courage. Choosing not to live in fear is nothing short of that — when you are nearly 90 and living in the midst of a pandemic.

Another neighbor, probably in her 70s, learned of my dad's passing and offered a hug. A real, live, genuine warm-bodied hug! I remembered the words of my other neighbor about refusing to choose fear and I thankfully returned the embrace of this dear friend.

I've contemplated fear in the last few weeks.

I feared going to the grocery store. I feared my daughter going to the hospital to have her baby.

I feared (and avoided) going to a restaurant. It just wasn't worth the risk.

I feared the downfall of our economy.

I feared for those close to me who

have lost their jobs.

I feared visiting my dad for what the pandemic could do to him or what it could do to my family and me. And then I lost him to non-COVID-19 illness.

And more. There is much to fear if you let yourself go there. It's nearly impossible not to go there.

But, then there is my 80-something neighbor who has chosen a path that does not include fear (or at least not a path where fear is in control.)

I applaud her. I celebrate her. And, I've decided to emulate her. She is my role model.

Like her, I will follow the rules and the protocol. I want to keep everyone (everyone!) safe. I won't engage in behaviors that could potentially hurt others.

Still, I have made a conscious decision: I will not live in fear. Quite simply, I can't.

Living out fear long-term is a death sentence. Because death is, unfortunately, inevitable. We can't escape death — none of us. So whether is it COVID-19 during a pandemic or a heart attack during a pandemic, is there really a distinction?

No. But here is one distinction I believe we all should make: If we live in fear and die, we die in fear. If we continue to live, carefully, honestly and responsibly — but refuse the fear component — then we continue to live a quality life we all want, deserve and desire.

Stay safe, my friends. But deny fear as much as you can. It paralyzes. It harms. It hinders.

Fear is not the answer to this pandemic.

Take care out there.

Federal program offers payments to ag producers

An additional \$14 billion will be available to agricultural producers who continue to face market disruptions and associated costs because of COVID-19, federal officials announced last week.

Signup for the Coronavirus Food Assistance Program (CFAP 2) will run through Dec. 11.

“America's agriculture communities are resilient, but still face many challenges due to the COVID-19 pandemic. President Trump is once again demonstrating his commitment to ensure America's farmers and ranchers remain in business to produce the food, fuel and fiber America needs to thrive,” USDA Secretary Sonny Perdue said in a news release. “We listened to feedback received from farmers, ranchers and agricultural organizations about the impact of the pandemic on our nations’

"While full-contact sports certainly come with additional risks of transmission of communicable diseases, the Big 10 recently decided to move forward with their season, as well as no such mandate about high school sports from Illinois' surrounding states run by both Democrat and Republican governors," Chesney's release said.

Chesney said he will send residents' comments to the governor. "If the legislature could meet to

take direct action on the topic, I would vote to support letting our kids play, but the only two people in Illinois who can call the legislature back into session are Governor Pritzker and Speaker (Michael) Madigan.

"They have deemed action by the legislature on any topic unnecessary until two weeks after the November election."

The next scheduled date for the Illinois General Assembly to meet is Nov. 17.

Schools collect funds through exercise program

Several area schools will receive checks this fall for their students' participation in the FHN Miles and Minutes program.

Conservation district sets well water testing

The Stephenson County Soil and Water Conservation District is sponsoring a well water testing program from Oct. 5 through Oct. 14. "As with everything in 2020, our program has been pushed back due to COVID-19 and we will be handling the program differently," a news release said. "We will be selling kits from the entryway since customers are not currently allowed into the office."

Testing kits will be sold from 7 a.m. to 3:30 p.m. Monday, Oct. 5,

through Friday, Oct. 9, and Tuesday, Oct. 13, at the conservation district office, 1620 S. Galena Ave., Freeport. Participants are asked to take water samples either Tuesday, Oct. 13, or the morning of Wednesday, Oct. 14, and return the kits to the district office by 3 p.m., Wednesday, Oct. 14. Water samples for all tests will be immediately shipped to the laboratory.

Those who are picking up test kits should call the office at 815-235-2141, extension 3, when they arrive.

Personal checks are the preferred method of payment.

The program tests drinking and well water for nitrates, certain pesticides and 22 different heavy metals.

Prices will vary, depending on the type of test ordered.

A confidential report of the results will be mailed directly to the home or farm owner within six to eight weeks.

Former state senator pleads guilty to tax evasion

Link agrees to cooperate with federal investigators

Former state Sen. Terry Link pleaded guilty in federal court Sept. 16 to a felony charge of tax evasion.

Link, a Democrat from Indian Creek who recently resigned his seat, admitted in a plea agreement that he willfully underreported his income on his federal and state tax returns from 2012 through 2016.

Specifically, the plea agreement noted that in 2016, Link reported income of \$264,450 when, in fact, he

had total income of at least \$358,309. The difference included \$73,159 in money from his campaign account that he used for personal purposes.

As part of the plea agreement, Link agreed to pay restitution of \$71,133 to the Internal Revenue Service, and \$11,527 to the Illinois Department of Revenue.

Federal sentencing guidelines provide a maximum sentence for tax evasion of up to three years in prison and a \$100,000 fine. However, based on Link's lack of criminal history and other factors, his sentence would more likely be in the range of 10 to 16 months, according to the plea agreement.

Link will not face immediate sentencing, however, because he also

agreed to cooperate with continuing federal investigations, according to the agreement.

If Link continues to "provide full and truthful cooperation," according to the agreement, prosecutors could recommend a sentence of probation.

It has been widely reported that Link was the unnamed state senator mentioned in a federal indictment last year who wore a wire during a conversation with former Rep. Luis Arroyo, D-Chicago, who was later charged with attempting to bribe the senator to support gaming legislation that would have benefited one of Arroyo's lobbying clients. Link has denied being that confidential informant.

Corn, soybean production increases

Corn and soybean production is up nationwide from 2019, according to a recent crop production report from the USDA's National Agricultural Statistics Service.

Soybean production is up 21 percent from last year, forecast at 4.31 billion bushels; corn growers are expected to increase their production 9 percent from 2019, forecast at 14.9 billion bushels.

The average U.S. corn yield is forecast at a record high of 178.5 bushels per acre, up 11.1 bushels from last year.

Wisconsin is among a handful of states predicted to have record-high yields.

As of Aug. 30, 62 percent of this year's corn crop was reported in good or excellent condition, 4 percentage points above the same time last year.

Acres planted to corn, at 92 million, are up 3 percent from 2019. Area to be harvested for grain is forecast at 83.5 million acres, 3 percent more than was harvested last year.

Area for soybean harvest is fore-

cast at 83.0 million acres with planted area for the nation estimated at 83.8 million acres, up 10 percent from last year. Soybean yields are expected to average a record high 51.9 bushels per acre, up 4.5 bushels from 2019.

Officials from the National Agricultural Statistics Service interviewed more than 9,100 producers across the country and conducted yield surveys for the monthly crop production report. The report is available by going online to nass.usda.gov/Publications.

temporomandibular joint, which contributes to excessive grinding of the teeth and clenching of the jaw. While you can stop yourself from grinding your teeth during the day, it is important to routinely wear your night guard to avoid further damage to your teeth.

Dentists are also reporting irritation and inflammation of oral tissues from nail, lip and cheek biting. It is important to be aware of these issues and their consequences, so you do not allow them to develop into a chronic bad habit. Keep in mind that these compromised oral tissues allow pathogens to enter the body, contribute to the development of canker sores and can lead to the formation of fibromas or benign oral tumors.

As we lost our daily routines and stopped socializing, some daily self-care habits, such as routine oral care, took a hit. The negative effects on oral health were compounded by the addition of frequent snacking.

Unfortunately, plaque wasn't furloughed while the nation was. As patients are returning for their checkups and professional cleanings, dentists and hygienists are seeing higher levels of plaque, gingivitis and tooth decay.

As this pandemic is not going to be resolved for some time, we need to be proactive to take charge of our health. As stated in previous columns, give yourself and your children the lifelong gift of good health habits. Resume twice daily brushing and flossing. As with the 1918 pandemic, this too shall pass, and the whole team wants you to come out on the other side of this healthy and with a winning smile.
