'Fit to be Tied' quilt raffle

The new quilt for the 2020 raffle is a bow-tie pattern made from 1930s pastel prints. Some of the fabric prints have recognizable figures in them. They are called object or conversation prints. These were used as early as the mid-1880s.Often the early prints were of a patriotic or nautical subject, or a nature

The popularity of conversation prints spread as a new printing process made it economical to print small designs on fabrics. These prints remain popular and now include Disney characters and popular game or movie heroes.

The Heritage Quilters' Bow Tie quilt has a lightness and whimsy to it, with a center block of applique. The bow tie block alternates with a 1930s green to add interest and color. The Bow Tie was rarely used by Amish, but some rare examples of their use do exist.

The pattern dates to the 1880s and was first published by the Ladies Arts Company in 1895. Like so many quilt patterns, it had other names: Colonial Bow Tie, Peekhole, True Lovers' Knot, Dumbbell.

The persistent story of quilt blocks used as code for runaway slaves includes the Bow Tie. That story tells of signaling runaway slaves to dress up in fine clothes to pass in disguise if stopped. The ultimate authority of quilt history, Barbara Brackman, states there is no evidence of quilts being used as signals, codes or maps. This story persists, yet has no documentation in quilt history to back it up.

Tickets are \$1 each or six for \$5. Because of COVID-related programming interruptions the drawing date for this year's raffle quilt, "Fit to be Tied," was postponed until 3 p.m. Feb. 1, 2021, at the museum.

Scratching the surface of marriage

Everybody wants to live happily

Certainly, that's the expectation

But as a buddy observes, 'Marriage is like flies on a screen. 50 percent want in. 50 percent want

Truth is every marriage has challenges; as the bliss, mist, dogeyed stares, and couch-cuddling to the tune of Elton John's "Your Song" are often contradicted by days when wives think husbands come from Mars and husbands think wives come from Venus.

Think about the challenges – gender distinctives/obsessions, socioeconomics, in-laws, outlaws, and the many temptations threatening to tear apart marriages.

While this is a brief, incomplete, and indicative, not exhaustive, guide to happy, healthy, and holy marriages, I've discovered at least three essential ingredients in a recipe enabling romance after the honeymoon:

1. Take Jesus Seriously – You invited Him to the wedding. That's not enough. He must be invited/ welcomed/included/loved into the rest of your life together. Jesus was clear, concise, and conclusive about personal/marital survival: "Everyone who hears these words

of mine and does them will be like a wise man who built his house on the rock. And the rain fell, and the floods came, and the winds blew and beat on that house, but it did not fall, because it had been founded on the rock.'

2. Have Fun – Some favorite verses come to mind: "I meant to do my work today; but a brown bird sang in the apple tree and all the leaves were calling me. So what could I do but laugh and go?' Even those dusty old West-minster clergy got it/Him: "Our chief end is to glorify God, and to enjoy Him forever.'

3. Don't Take Yourself So Seriously - Here are 12 words that keep marriages together: "I was wrong. I am sorry. Please forgive me. I love you."

If you're really serious about taking Jesus seriously in your marriage, having fun in your marriage, and not taking yourself so seriously in your marriage, take a look at Mark Gungor's "Laugh Your Way to a Better Marriage."

Caution.

If you're not working on your marriage, someone else will be working on it for worse, not better, sooner or later.

Willard F. Harley, Jr.'s "His Needs, Her Needs: Building an Affair-Proof Marriage" is an excellent how-to on keeping

romance in marriage and preventing someone from stealing who God intended for you in marriage.

Dr. Harley's book identifies the emotional, intellectual, spiritual, and sexual needs that must be met in marriage; admitting unmet needs destroy marriages.

A man's basic needs in marriage are identified as sexual fulfillment, recreational companionship, an attractive spouse, domestic support, and admiration.

A woman's basic needs in marriage are identified as affection,

conversation, honesty and openness, financial support, and family commitment.

Dr. Harley: "In marriages that fail to meet those needs, I have seen, strikingly and alarmingly, how consistently married people choose the same pattern to satisfy their unmet needs: the extramarital affair. People wander into affairs with astonishing regularity, in spite of whatever strong moral or religious convictions they may hold. Why? Once a spouse lacks fulfillment of any of the five needs, it creates a thirst that must be quenched. If changes do not take place within the marriage to care for that need, the individual will face the powerful temptation to fill it outside of marriage.

Or as I've had to say to wives and husbands to emphasize this caution, "Your spouse's needs will be met with or without you. If your spouse ain't getting it at home, they're gonna get it from someone

Help the Winnebago-Boone Farm Bureau Foundation with year-end

 Gifts of appreciated securities a donor can give appreciated securities they have owned for one year or more and get a tax deduction for the full fair market value of the securities. They also pay no capital gains tax. This gift is especially attractive with the steady increase in the market over the past year.

• Charitable IRA rollover – a donor who is at least 70 1/2 can direct his IRA custodian to distribute from his IRA to a charitable organization. The distribution must go directly to the charity. Most charities qualify except for supporting organizations, donor advised funds, and private foundations. The donor can give up to \$100,000. The donor will not report any income, will get no deduction, but can count the distribution toward his or her required minimum distribution for the year, which is where the real benefit comes in.

• The distribution must come from an IRA. If the donor doesn't have an IRA, they will need to rollover a distribution from their existing plan, such a 401(k), to an IRA.

• This may not make sense for donors since minimum required distributions are not required for the balance of 2020. However, other charitable gifts may still be appropriate.

Donor advised funds

Gifts of life insurance: If you have an old paid up whole life insurance policy, you can donate it to the Winnebago-Boone Farm Bureau Foundation and get a tax deduction for the cash surrender value.

Fire chief helps department get new vehicle

There recently was disagreement among aldermen over allowing the fire department to purchase a new shift command vehicle, at a cost of

Discussion landed on both sides of the issue with Mayor Mike Chamberlain issuing a definitive comment: "My thought is he (Fire Chief Al Hyser) wouldn't ask for this if he didn't need

The mayor added: "I've worked with these department heads for almost eight years. They don't come to us (staff) frivolously; they come to us when they need something.

At the end of the lengthy discussion at the Nov. 23 Committee of the Whole meeting, aldermen voted 8-1 to recommend approval of the purchase. City council followed suit on Dec. 7, voting 9-1 for final approval. Dissenting in both votes was Alderman Marsha

There was back and forth Nov. 23, primarily over the timing of the purchase, whether it could be put off for a while, and the need.

Alderman Tom Porter wondered how urgent the need was for the new vehicle. "We're probably going to need to cut some costs because of the COVID-19," he said. "Could we hold off for a while?"

"We can certainly hold off for a while," Hyser replied. "However, I've had this (acquisition) for the last couple of years. I would like to get it (1995 Chevy Tahoe) replaced; these guys respond to mercy calls in the city. One of these days it (Tahoe) might just sit in the garage, because it won't start."

Alderman Ric Brereton wondered

"It's time for it (Tahoe) to go off to something less strenuous," the chief

Freeman asked about moving the purchase off to next year, calling that possibly a wiser decision. She pointed to this year's list of capital expenditures that included \$125,000 for the second and final payment on the mini-pumper. payment five of seven on a fire engine, the command vehicle, and some smaller expenditures.

Upgrade needed

"I'm here tonight asking the council to make this decision for me," Hyser said. "It's up to you guys. When we buy things at our fire department we make it last 15-16 years. Presently, we have a 1991 engine that should have been retired long ago. But we continue to operate with older equipment. I'm here tonight trying to upgrade our equipment."

Alderman Dan Snow said the city doesn't know what next year holds, with everything that's going on. "We need to have the equipment for these guys to function," he continued. "I believe we should vote 'yes' and get this moving.

Agreement came from Alderman Matt Fleury, who said, "I think it's time to get you a four-wheel (vehicle) that's going to be proper equipment for the fire department. While it is a struggle right now, I don't think we should be cutting corners. We should get this vehicle at this point."

Alderman Wendy Frank asked if there was something a little bit older out there, perhaps a 2018 vehicle that could be bought "to tide us over."

Hyser answered that he always had been skeptical about used equipment, "because you never know what you're

"This is something I feel is necessary for our fire department," he persisted. "When I started back in 2015, I didn't have the luxury of having great equipment and we've been playing catch-up ever since then. I'd like to keep up with our present way of doing business and keeping equipment up to date. So that's my contention."

Support came from city Budget and Finance Officer Becky Tobin, who said, "If I had my choice, I'd buy it now, in this (2020-21) fiscal year, when we have the funds. It's budgeted. Rather than trying to budget it for next year, when I think things will be tighter. This is one less thing we would have to try and squeeze in there. I think it (Tahoe) needs to be replaced.'

Alderman Clayton Stevens, a retired city firefighter, asked who would be driving the vehicle and for what pur-

"The officer of the day will be driving it, for his day-to-day operation," the chief responded.

Brereton concluded the discussion by saying, "I was a bit hesitant on this decision. But if the fire chief and finance director and the mayor all think this is a good idea, then I can support the fire department at this time.'

The recommended 8-1 vote then was taken, with city council following up two weeks later, 9-1.

At the Dec. 7 council meeting there was one question, from Alderman Snow, who asked, "When can we expect to get the vehicle in and on the

In the absence of Hyser, Tobin replied, "Usually it takes some time. He (fire chief) has to order it and receive the public safety package. Usually it's a three-to-four-month turnaround, I be-

University of Illinois Extension-Stephenson County hosted master gardener training with 11 participants this fall. This year was a flipped classroom style training where participants completed assignments and listened to recorded lectures before attending an on-line class to talk with Extension Educators regarding the specific topic for the week. The class met once a week for 12 weeks to complete the required amount of study hours. Topics included: botany, lawns, fruit, vegetables, trees and shrubs, soils, living with wildlife, integrated pest management, disease and diagnosis, annuals and perennials, and more.

"This hybrid flipped classroom style more than 3,500 Master Gardeners

training was a fun way to be able to offer master gardener training in this unique year," explained Nikki Keltner, Program Coordinator with the University of Illinois Extension. "I've worked with the master gardeners since shortly after joining the staff 13 years ago and we have talked for many years about changing the way we offer the training. This year was the perfect opportunity to try the flipped classroom style, it worked very well and we had a great group of participants complete the training.

While the master gardener program is nationwide, Illinois started its first training in 1975 and now boasts

statewide. Training is offered yearly throughout the state on a rotational basis so a county may host a training once every three to four years.

"Master gardener training is a fun, interactive educational program. Classes and volunteer work complement each other, building on materials learned, and sharing it with others in the community," stated Keltner.








sessions designed to build on leadership, Cox was able to help youth identify and understand who they are, where they want to go, and how to get there successfully.



Sen. Syverson: FOID renewal delays continue to be problem

State Sen. Dave Syverson (R-Rockford) is bringing attention to the ongoing delays within the Illinois Firearm Owners Identification (FOID) card processing system.

"My office has received hundreds of calls from frustrated citizens whose FOID cards have expired, and who have been waiting for months for their renewals," said Syverson. "While we were able to work with the administration to adopt emergency rules to help firearm owners with expired FOID cards amid the ongoing pandemic, gun owners are still encountering the

issue of stores not selling arms or ammunition without a valid FOID card and other states not accepting expired licenses.

According to the Illinois State Police (ISP), it takes an average of 121 days to process new FOID card applications and 145 days to process CCL applications. Renewals are taking significantly longer.

Syverson notes that Illinois is an outlier among many states, requiring gun owners to obtain a FOID card when most other states do not.

ISP has announced continued efforts being implemented to confront the growing workload, including hiring additional firearms eligibility analysts in February and employing additional temporary contractors to meet the continued demand.

"I applaud Director Kelly for working to address this ongoing backlog and am hopeful that these steps will finally get our program up-to-date in the coming year," said Syverson.

To roast or not to roast

If you are wondering if those spiny covered nuts in your yard are edible chestnuts, be sure to do your homework before hulling and roasting.

The difference between the edible American chestnut and the popular landscaping horse chestnut, yellow buckeye, or Ohio buckeye could turn out to be a toxic snack. Though they taste bad, and that should be enough to deter someone, if you eat enough of them it could be fatal. If you did not plant the tree, with the chestnut looking fruit you are considering consuming, chances are it is one of those other three.

The American chestnut was not historically an Illinois species but if planted it was able to grow in parts of the state. They were

very dominant in their woodland habitat and took many of the resources from surrounding trees growing massively in both diameter and height, reaching up to one hundred feet. The American chestnut dominance fell when different species of chestnuts, carrying a fungus, were brought to the Bronx Zoological Park in New York City in 1904 from China and Japan. Because our American chestnut had not evolved with this chestnut blight fungus, they were susceptible to

It's easy to see why. The cards are easy to purchase and (typically) easy to use. They can be the perfect gift for that difficult-to-buy-for-friend or a great stocking stuffer for a college

However, too many times I have heard stories about a gift card that was saved for a rainy day only to find out that there was no money on the card because too much time had elapsed.

One of the lesser-known roles of

involves gift cards. That is why I hear the stories. Here's what you can do to protect yourself:

Know that retail gift cards and bank gift cards are the two most common types of cards. Retail gift cards are redeemable at the specific retailer or restaurant that issued the card. Bank gift cards, which carry a payment network such as American Express or Visa, can be used at any location that accepts that specific brand.

Resist the urge to save the card for a rainy day. Doing so may increase the likelihood that some of the card's value if a replacement card is possible and at will be consumed by fees. Instead, use what cost.

of cash for a rainy day.

Remember that while money on a typical bank gift card cannot expire for at least five years, depending upon the circumstances, inactivity fees can begin in as little as 12 months. Therefore. it is possible that inactivity fees could consume the cash value of a card before the five-year window has expired.

Businesses that close likely will not honor an outstanding gift card.

Treat a gift card like cash. If lost or stolen, report it to law enforcement. Contact the card's issuer to determine
