Stockton eyes multiyear wastewater treatment project

The village of Stockton is moving ahead with a \$25 million upgrade and expansion of its wastewater treatment facility, according to a Dec. 10 village news release.

Construction is expected to start next year and take several years to complete.

The project includes the installation of a force main and lift station and a water main extension to the wastewater treatment plant. The plant has been upgraded several times since its 1956 construction, most recently in 2000.

“While the facility itself is in relatively good condition, it is currently operating at or beyond its design capacity,” the release said. “The proposed improvements are being completed to address an organically and hydraulically overloaded facility.”

Village officials have been working with the Environmental Protection Agency, Illinois EPA and other grant-funding agencies to finance the project, along with increased user fees, the release said.

Sewer rates will be adjusted starting Jan. 1. The basic user charge will decrease from \$16.50 for the first 1,000 gallons to \$10 for the first 1,000 gallons and decrease from \$8 per 1,000 gallons to \$5 per 1,000 gallons after the first 1,000 gallons.

A department service fee of \$15 per month will be added in January, with additional debt service charges added throughout the duration of the project.

Based on the current estimates and financing, a user of 4,000 gallons per month would see an increase of about \$26.26 per month by the end of the project.

Illinois on track to meet deadline for spending CARES Act funds

The head of Gov. JB Pritzker’s budget office said last week that the state of Illinois is on track to spend all of the money it received through the federal CARES Act by the Dec. 30 deadline.

That means it is unlikely the state will have to repay any of the funds to the federal government, but whether or not Congress approves any additional funding remains an open question.

Alexis Sturm, director of the Governor’s Office of Management and Budget, told a legislative oversight panel that of the \$3.5 billion the state received in April, a little less than \$1.5 billion remains unspent. But

she said state agencies have spent money out of their own budgets for COVID-19-related expenses that can be reimbursed with the federal funds.

“And that should be enough to ... expend the balance of those funds,” Sturm told the Restore Illinois Collaborative Commission, a legislative group that has been meeting monthly since July to monitor the state’s COVID-19 response.

Congress passed the \$2.2 trillion Coronavirus Aid, Relief and Economic Security Act in late March. It included financial aid to state and local governments to help cover their costs for responding to the pandemic.

In addition to the funds that went

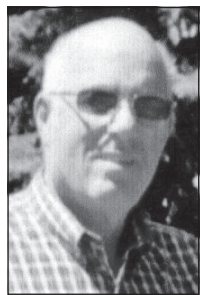

In lieu of flowers, a memorial has been established in his name.

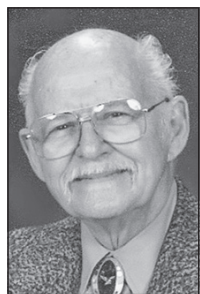

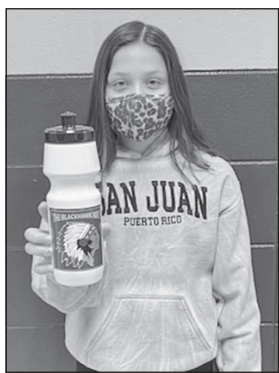
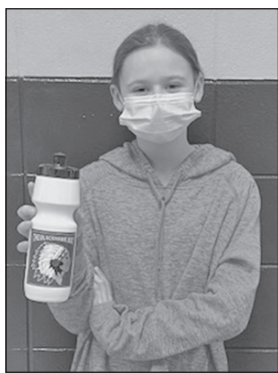

Farmers choose two for county committee

Dean Groezinger of Elizabeth was elected recently to represent local administrative area #3 on the Farm Service Agency County Committee.

Dennis Steffes of Stockton will be the first alternate with Benjamin Lehman of Hanover serving as the second alternate.

"County Committee members are a critical component of the day-to-day operations of FSA," Cory Cassens, FSA county executive director, said in a news release. "They help deliver programs at the county level and work to serve the needs of local producers."

The new committee members will take office in January, joining existing members Ann Heller of Galena and Rod Rogers of Stockton. Every FSA office is required to have a County Committee, and they are made up of local farmers who are elected by local farmers.

Nearly 7,800 FSA County Committee members serve FSA offices nationwide. Committee members impact the administration of FSA within a community by applying their knowledge and judgment to help FSA make decisions on its commodity support programs, conservation programs, indemnity and disaster programs, emergency programs and eligibility.

Northwestern Illinois Community Action Agency PY21 LIHEAP Emergency Furnace Program

Northwestern Illinois Community Action Agency has funding from the Department of Commerce & Economic Opportunity (DCEO) for the LIHEAP Emergency Furnace Assistance Program for income eligible households of Stephenson and Jo Daviess Counties who are homeowners and whose existing heating systems are not functioning or have been red-tagged by their utility.

The purpose of the LIHEAP Furnace program is to restore heat to the household and is available from July 27th, 2020 through April 30, 2021 or until funds are exhausted.

All income eligible homeowners may apply for emergency furnace assistance. The household must have active service with both primary and secondary heating utilities. Households with disconnected utilities are not eligible for this assistance.

To qualify for the LIHEAP Emergency Furnace Program, the household must first apply and be approved for LIHEAP or PIPP assistance. All applications will be taken by mail, email, phone or fax in response to COVID-19.

Assistance available for gas, propane, and electric bills

Northwestern Illinois Community Action Agency has funding from the Department of Commerce & Economic Opportunity (DCEO) to assist residents of Jo Daviess and Stephenson Counties with home heating utility costs (gas, propane, electric) through the Home Energy Assistance Program (LIHEAP), Percentage of Income Payment Plan (PIPP) and Weatherization Programs.

The LIHEAP and PIPP programs for Program year 2021 began on July 27, 2020 and will end on June 30, 2021. **All income eligible households are eligible to apply beginning July 27, 2020.** Households affected by loss of income due to COVID-19 are encouraged to apply.

Applicants may apply for a DVP payment or the PIPP program. The Direct Vendor Payment (DVP) is a one time payment to gas or propane and electric utilities. Applicants with ComEd and/or Nicor Gas as utility providers may have the option of choosing the Percentage of Income Payment Plan (PIPP) instead of the DVP. The PIPP program is a bill payment program that assists eligible customers by paying a monthly state benefit while the customer pays a percentage of their household income. PIPP applications will be taken on a first-come first served basis until March 31, 2021 or until funding is exhausted.

The not so skinny cook

I am writing this early and sending it in to my publisher. It is the last day of nice weather before some kind of precipitation and cold weather sets in. When you walk with a cane or walker, snow, ice and even rain is a challenge. I plan on having everything I need, so I can stay home, look at my Christmas decorations and listen to Christmas music. I plan on doing some baking this week. Later in the column there are several cookie recipes. I hope you enjoy the recipes this week. There is a nice winter salad, good sides, a main dish and some Christmas "goodies."

Perfect Winter Salad

You can serve this salad with your holiday meal or have it for lunch the next day with cubed turkey, ham or chicken on top. The recipe serves a lot of people, so use enough salad greens for one serving and along with half the apples, dried fruit, nuts and onions, use one-half of the dressing. With the saved greens for lunch the next day, add the apples, dried fruit, nuts and onions for the next salad. Hint: To keep apples from turning brown, put them in a bowl and cover them with lemon-lime soda. For diabetics, use diet lemon lime soda.

- 1/4 C. mayonnaise
- 1/4 C. maple syrup
- 3 T. white wine vinegar
- 2 T. minced onion
- 2 t. sugar

- 1/2 C. canola oil
 - 2 pkg. (5 oz. each) spring mix salad greens
 - 2 medium tart apples, thinly sliced
 - 1 C. dried cranberries or cherries
 - 1 C. pecan halves
 - 1/4 C. thinly sliced red onion
- In a small bowl, mix the first five ingredients; gradually whisk in oil until blended. Refrigerate, covered, until serving. To serve, place remaining ingredients in a large glass bowl; toss with dressing.

Creamy Mac 'N Cheese with Corn

If you are looking for a different side for Christmas dinner or New Year's Day, this macaroni and cheese will be a change from mashed potatoes. It also has corn in it, so you do have a vegetable most kids will love.

- 1 lb. elbow macaroni
- 3 C. frozen corn
- 4 T. unsalted butter
- 1/4 C. minced green onions
- 2 T. minced fresh garlic
- 1/4 C. flour
- 5 C. whole milk, warmed
- 8 oz. sharp yellow cheddar shredded
- 8 oz. American cheese, shredded
- 1 T. Dijon mustard
- Salt and pepper to taste

Cook macaroni and corn in a pot of boiling salted water according to macaroni's package directions; drain. In a saucepan over medium heat, melt butter. Add onions and garlic; cook until onions soften (about three minutes). Increase heat to medium high; whisk in flour and cook one minute. Whisk in milk until smooth; bring to a boil, then reduce heat to medium and simmer sauce until thickened, three to four minutes. Reduce heat to low. Add cheeses by the handful, whisking after each addition until melted. Stir in Dijon; season sauce with salt, pepper and cayenne. Stir in macaroni and corn.

Kale and Wild Rice Casserole

If you are up for a more traditional side for the holidays, this casserole will go great with turkey or ham. You can substitute button mushrooms if you can't find creminis. You can also substitute mozzarella for the Gruyere cheese. It will have a different flavor, but it is good if you don't have the Gruyere.

- 3 T. olive oil
- 1 pkg. (8 oz.) cremini mushrooms, sliced
- 1 C. chopped yellow onion
- 1 T. minced fresh garlic
- 2 t. salt
- 1/4 t. crushed red pepper
- 8 C. chopped and stemmed kale (about 1 large bunch)
- 1/4 C. flour
- 2 C. chicken broth
- 1/2 C. half-and-half
- 2 1/2 C. cooked wild rice
- 1 C. shredded Gruyere cheese

Preheat oven to 350. Spray a 2-quart baking dish with cooking spray. In a large nonstick skillet, heat oil over medium heat. Add mushrooms, garlic, onion, salt and red pepper. Cook, stirring occasionally, until onion is softened, about 10 minutes. Add kale in batches, stirring until wilted after each addition. Stir in flour, cook for one minute. Gradually add broth and half-and-half, and cook, about five minutes. Stir in rice and half of cheese. Spoon mixture in prepared pan. Sprinkle with remaining cheese. Bake until bubbly and cheese is melted, about 25 minutes. Let stand for 10 minutes before serving.

Roast Beef Pasta Skillet

Some people serve beef for holiday dinners. If you have leftover beef and don't want to make hot beef sandwiches, this dinner is perfect. You dress it up with Parmesan cheese and tomatoes. This recipe is for two people; you can easily double it for four.

- 1 C. uncooked spiral pasta
- 1/2 C. chopped onion
- 1 t. olive oil
- 1 t. butter
- 1 C. cubed cooked roast beef

- 1 t. pepper
 - 1/2 C. chopped tomato
 - 1/2 C. grated Parmesan cheese
- Cook pasta according to package directions. As pasta is cooking, in a skillet, sauté onion in oil and butter until tender. Add roast beef and pepper; heat through. Drain pasta; add to beef. Stir in tomato and cheese.

Orange-Date Bread

Many people this year are giving food as presents. If you are looking for a great bread that you can give as a gift, this tasty bread is one that you can make ahead and freeze. Be sure you wrap it up securely after it has cooled. I double wrap my breads.

- 1 egg
- 2 T. butter, softened
- 1 C. sugar
- 2 large oranges, zested and juiced
- 1/3 C. boiling water
- 1 t. vanilla
- 2 C. flour
- 1 t. baking powder
- 1 t. baking soda
- 3/4 t. salt
- 1 C. dates, pitted and chopped
- 1/2 C. chopped nuts

Preheat oven to 350. Grease and flour a 5-by-9-inch loaf pan. Beat egg lightly, then beat in butter and sugar until smooth. Stir in 1 T. orange zest, 2/3 C. orange juice, the boiling water and vanilla. Stir together the flour, baking powder, soda and salt in another bowl. Stir in dates and walnuts. Add flour mixture to egg mixture; stir to moisten. Spoon into prepared loaf pan.

Bake until a toothpick inserted near the center comes out clean, about one hour. Cool in pan 10 minutes. Transfer bread to a wire rack to cool completely.

Spicy Pretzels

My friend from Tulsa sent this recipe to me. You can use it as an appetizer or snack. Her family loves these, and her son, Carl, who lives in Winnetka, serves these at an open house in his high-end neighborhood. They love them.

- 1 lb. bag small pretzel knots
- 1 dry Hidden Valley Ranch mix (3 T.)
- 1/2 t. lemon pepper

- 1/2 t. cayenne pepper
 - 1/2 t. garlic powder
 - 3/4 C. Wesson oil
- Mix oil and all spices in a gallon Ziploc bag; add the pretzels and shake in the Ziploc until oil is gone and mix is used up. (My friend just keeps turning the bag over every time she walks through the kitchen.)

Toffee Chip Thins

If you take the best features from a lot of your favorite recipes, you will create this sweet, crisp cookie. It makes a great change from the traditional Christmas cookies.

- 1/2 C. butter, softened
 - 1 can (14 oz.) sweetened condensed milk
 - 2 C. graham cracker crumbs (about 12 squares)
 - 3/4 C. flour
 - 2 t. baking powder
 - 2 C. semisweet chocolate chips
 - 1 C. toffee or almond brickle chips
 - 1/2 C. flaked coconut
- Preheat oven to 375. In a mixing bowl, combine butter and condensed milk; mix well. In a separate bowl, combine cracker crumbs, flour and baking powder, gradually add to the butter mixture. Stir in chocolate chips, toffee bits and coconut. Drop by rounded tablespoonfuls 2 inches apart onto greased baking sheets. Bake at 375 for 10 to 12 minutes or until edges are lightly browned. Cool for two minutes before removing from wire racks.

Chocolate Thumbprints

For a change of pace, these chocolate thumbprints taste just as good as the regular thumbprints. You can use chopped walnuts instead of pecans if you wish.

- 1/2 C. butter, softened
 - 2/3 C. sugar
 - 1 egg, separated
 - 2 T. milk
 - 1 t. vanilla
 - 1 C. flour
 - 1/3 C. baking cocoa
 - 1/4 t. salt
 - 1 C. finely chopped pecans
- Filling:
1/2 C. powdered sugar

Dental care is safe and essential during COVID-19

The patients calling into our dental offices are understandably nervous. They ask important questions: What will my visit be like during COVID-19? Will I be safe? Fortunately, we have been ready for these challenging times for many years.

All across Illinois, dental offices are welcoming patients back for care they put off this spring when coronavirus forced them to shutter to all but emergency treatment. As cases surge again this fall and government officials put in necessary restrictions, our message is clear: Dental care is safe, essential and must continue because it is a valuable part of our individual and collective public health.

In the early 1980s, the emergence of HIV and AIDS forced all health care providers to take extra precautions — especially in dental offices, where potential exposure from the nature of the oral care we provide is highest. Detailed infection prevention strategies were developed, our staffs and dentists went through comprehensive training and education and we embraced safety

standards by the federal Occupational Safety and Health Administration. Today, the protective masks, gloves and gowns we have been wearing all this time and the strict attention to cleaning and disinfecting has become commonplace in health care facilities as we all fight this insidious disease.

While our dental offices closed for a few weeks initially, both our industry experts and government officials agree it's not only misguided to consider seeing the dentist a safety or health care risk as the pandemic continues, it does more harm to skip such care.

Put simply, our mouths are a window to our entire body's health. When our mouths and gums are healthy, we see the benefits. But when we let our oral health suffer, even if we do not notice any obvious signs of problems, they are sure to

develop. Chipped or cracked teeth, cavities and sore or bleeding gums can lead to many larger issues. If oral infection spreads throughout the body, research has shown it can contribute to dementia, heart disease and other life-threatening health challenges.

Not only can minor dental issues become major ones over time, they also are sure to be more costly to fix.

In implementing infection prevention and control guidance from the Centers for Disease Control and Prevention, we have stepped up during the pandemic to show patients we are serious about their safety and health. When you call to set up an appointment, you're asked detailed health questions and again when you arrive. We have you call before you come in the office for your appointment, wear your mask and take your temperature. Patients wait in their vehicles or in our socially distanced waiting rooms that no longer have toys or magazines but plenty of hand sanitizer — all to put safety first.

Even in the dental chair you notice the difference. Our dentists and assistants have even more masks, gloves and other coverings to reduce

exposure. We thoroughly scrub down chairs, utensils and other equipment before and after each visit. We have developed a purchasing program through the Illinois State Dental Society to ensure our members have adequate supplies of personal protective equipment to keep everyone safe and healthy.

A summer survey of dentists nationally by the American Dental Association found our efforts are working, as fewer than 1 percent of

dentists had contracted the virus. A recent ADA article noted the CDC reports there have been no documented cases of COVID-19 transmission in a clinical dental setting.

Dental care is safe. Dental care is essential. And dental care should be here to stay throughout the pandemic. Our public health depends on it.

can no longer go to restaurants, but food delivery has become easier and more accessible.

Curbside pick-up for groceries is the new catchall, end-all. We stay at home and do more than ever before. Shopping? Online. Seeing a doctor or therapist? Telemedicine is the new black. Worship? That's online, too. We've become a culture that doesn't need human contact to survive; yet I believe we are a culture that requires human contact to

survive.

I'm rooting for a future that includes hugs, handshakes, high-fives and the human race. Game on, COVID Zone. I'm searching the horizon for an exit ramp and plan to take the first one I see.

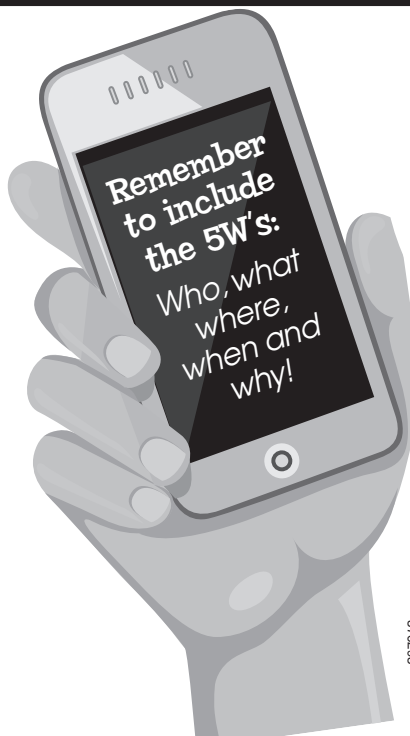

Brush correctly to avoid tooth sensitivity

Many people experience sharp, temporary pain in their teeth when they eat or drink cold or hot foods and beverages. This may also occur when consuming acidic beverages, very spicy or sweet foods and when they brush their teeth.

There are many reasons why teeth become sensitive. As with any health issue, healing requires diagnosis and treatment of the cause rather than the symptoms. Some of the many causes of tooth hypersensitivity include worn or damaged enamel, decay, fractured or chipped teeth, damaged fillings, loose crowns, exposed roots and gum disease. If you have sensitive teeth, the first step to recovery is to visit your dentist.

Underneath the outer protective layer of the crown of your tooth, called the enamel, and the outer protective layer of the tooth root, called the cementum, is a porous layer called the dentin. When the enamel and/or cementum is worn away or damaged, the tiny pores in the now exposed dentin transport heat, cold, changes in air pressure and other negative stimuli to the nerves, causing sudden and acute pain.

Some of the ways enamel can be worn away is by regular consumption of sugary and/or acidic beverages and foods, grinding and clenching your teeth, not brushing and flossing regularly, exposed roots, decay, gum disease and bleaching your teeth. While brushing your teeth is a prerequisite for healthy teeth, it may surprise you to know that overly aggressive brushing is a common cause of tooth hypersensitivity. Many people mistakenly believe that you have to brush extremely hard to remove plaque and only a hard-bristled brush will do it effectively. Plaque is soft. It only becomes hard when it is not removed regularly and mixes with minerals to form calculus. Brushing too hard can actually wear away your enamel.

The formula for thorough plaque removal is proper technique plus time (two minutes, twice a day). Use a soft bristled brush, place it at a 45-degree angle to the gumline and use soft, short strokes, applying just enough pressure to feel the bristles against the gums. If you are using enough pressure to squish the bristles or aggressively sawing them back and forth, you are going to hurt your enamel and/or gums. Your

dentist and hygienist can assist you by evaluating your brushing and flossing technique. Do not use a toothbrush with worn bristles as these can damage your enamel. Do not brush immediately after eating as some foods and beverages, especially carbonated/acidic beverages, can weaken your enamel. Rinse well with fluoridated tap water and wait at least 20 minutes before you brush. Always brush twice a day with a fluoride toothpaste. The second time should be right before you go to bed. This is crucial, as you make less saliva at night. If brushing with cold water hurts use warm water, but do not stop brushing your teeth because they are sensitive. Without that protective layer of enamel, decay will spread aggressively.

Depending on the cause, location and extent of damage, you may require desensitizing toothpaste, fluoride treatments, a mouthguard, sealants, bonding or other restorations, periodontal therapy, root canal therapy or even extractions. In short, prevention and early intervention can help you to avoid a lot of pain.

Clinic, hospital adjust visitor policy

Officials at Monroe Clinic and Hospital put new visiting policies in effect Dec. 9.

"We will continue to adjust our policies and make decisions rooted in safeguarding and caring for our patients, visitors, caregivers and the community at large," a news release said.

Hospital visitor policy

Hospital visits are suspended at Monroe Clinic. Visitors over 18 years of age may still be allowed in some circumstances:

- Compassionate care exceptions may be made in end-of-life situations or when a visitor is essential for the patient's emotional well-being and care.
 - Family Birth/Women's Center patients will be allowed one support person for the duration of their stay, with permission of the administrative supervisor.
 - Pediatric patients will be allowed one visitor per stay, with permission of the administrative supervisor.
- If a visitor is allowed, then the following must be followed:
- Visitors must bring their own food, beverages and comfort items, as move-

ment throughout the building is not allowed.

- Visitors may only enter the building one time per day. Once a visitor leaves, they will not be permitted to return until the following day.
- Visitors will be asked to complete a health screening, including a temperature check, before entering Monroe Clinic facilities.
- Visitors are always required to maintain social distancing and cover their nose and mouth with a face covering while on-site. This is without exception.
- Anyone with a positive exposure to COVID-19 or elevated temperature will not be allowed entry without approval by the administrative supervisor.

Clinic visitor policy

The clinic visitor policy remains the same as it has been since Nov. 4: Patients are not allowed to have a visitor accompany them for in-clinic appointments.

One accompanying visitor may still be allowed for pediatric patients and for patients whose cognitive, physical

or emotional abilities make a visitor an essential part of caring for the patient. If either criteria are met, then the visitor will be screened before being allowed to proceed to the visit with the patient.

into state coffers, the city of Chicago along with Cook, Kane, Lake and Will counties, which all have populations over 500,000, received direct aid of their own, for a total of roughly \$4.9 billion that came to Illinois.

Congress stipulated, however, that the money could only be used for expenses directly related to COVID-19 response efforts and not to make up for revenue shortfalls due to the pandemic. The law also requires that all of the money be spent on costs that are incurred on or before Dec. 30.

During the first several weeks, Sturm said, the Illinois Emergency Management Agency spent about \$375 million for things like personal protective equipment, setting up alternate care sites and testing sites, contact tracing and reimbursing state agencies for their increased operational costs.

When lawmakers came back for their abbreviated session in May, they established a framework for spending the remaining funds in the fiscal year that began July 1. By that time, about \$3.1 billion of the CARES Act money remained.

Since then, the Pritzker administration has set up a number of grant programs that have been funded with CARES Act money. Those have included the Business Interruption Grant, or BIG, program for businesses that were forced to close or reduce operations during the initial stay-at-home order, a separate BIG program for child care facilities, financial aid for homeowners and renters, and a reimbursement program for local governments to cover their COVID-19 expenses.

The BIG program received \$270 million, of which \$168 million has been paid out to more than 6,300 small businesses across the state, according to the governor. The grant application process closed Dec. 15.

The program for local governments, known as the Local Coronavirus Urgent Remediation Emergency, or Local CURE program, is one area where the state has had difficulty finding applicants. During his daily COVID-19 briefing Thursday, Pritzker noted that only \$147 million of the \$250 million available had been paid out so far. He said that money went to 688 cities, towns, counties and local health departments.

"However, hundreds of local governments have yet to take steps they

need to register for this program and we encourage them to do so soon so that together we can ensure that no federal dollars are left on the table and every community has access to economic support," he said.

In addition, Sturm said, agencies throughout state government have incurred costs for additional cleaning and sanitizing of facilities, overtime costs, workspace hazard mitigations such as setting up plastic shields, purchasing PPE for employees and buying equipment so employees could work remotely.

Sturm said the federal government is not requiring that all of the funds be "out the door" by Dec. 30, but all of the goods purchased with the money and all of the services the state contracts for have to be delivered by that time. She said the federal government has said it expects that state and local governments will continue to receive invoices for several months after the deadline.

Meanwhile, however, the COVID-19 pandemic has not abated, and in fact the entire country is going through another surge of the disease that has been more severe than the initial wave in the spring, but Congress so far has been unable to agree on another relief package.

One bipartisan group in Congress

recently unveiled a compromise plan that included some financial aid for state and local governments, a top priority for Democrats, as well as a limited liability shield to protect businesses from lawsuits by employees who contract the disease, a top priority for Republicans.

Continuing talks over that proposal, however, so far have not produced a deal, opening the possibility that no additional federal aid will be forthcoming at least until President-elect Joe Biden's administration takes office in January.

Asked during one of his recent daily briefings whether such a delay would

hamper the state's response efforts, Pritzker said Illinois probably has enough PPE stockpiled to last about 60 days while local health departments have enough for about 30 days.

"At least at the PPE level we, I think, have a pretty good situation. We think that that will hold us for now," he said. "But we do think the federal government is going to have to step up. Look, there's also going to be money needed going forward for vaccine distribution. There's some available now but this is going to go on for some time now."

Coffey moved up from being a Second Team All-Conference selection in 2019 to being selected First Team All-Conference this fall and qualifying to play at the sectional competition.

"Each year, he (Coffey) improved by spending more time at the course," said Kenna, who also teaches English at the high school. "The key was he wanted to be better."

Kenna said golf can test the mind and Coffey exemplifies the characteristics it takes to be successful at the game.

"Golf is at first a skills game, but it quickly becomes mental," Kenna said. "If you can get on top of the mental challenges, the game gets easier, but never easy."

"Mitchel has improved significantly in the past two years, but the most exciting part of his game is his potential to keep improving."

He explained that Coffey can reach his full potential if he stays on track, saying, "With the right coaching from here and the commitment to improvement, he could become quite skilled."

Coffey knows that improvement is ongoing.

"I think that my short game is decent but there can always be improvements," he said. "Personally, I think I can hit a ball pretty far, but the key is to hit it straight."

Although, basketball is a much different game, Coffey exemplifies the same characteristics on the court as he does on the course. John Hamman, Stockton's athletic director and varsity boys' head coach, shared many of the same compliments as Kenna when discussing Coffey's desire to improve.

"Mitchel's work ethic has definitely helped him improve his game over the years," Hamman said. "He is constantly in the gym working on his shot and his overall game."

"Mitchel has also really bought into the weight room to help him gain strength to compete in the post."

It was important for Coffey to develop that strength, as his growth spurt took him from being a 5-foot-9-inch guard to being a 6-foot-4-inch player down in the post.

"I think the area he has improved the most on is his versatility," Hamman said. "When he came to our program, he was strictly a shooter. Over the years, he has worked on his ball handling, and most importantly, his

post skills.

"For a guard to be able to go into the post is a big advantage, and Mitchel has worked hard to be a diverse player."

"Freshman year I was a better three-point shooter than I am now, only because I had that consistency for so long," Coffey said. "I got moved into some posts last year and being able to work on the inside, I would think, is a lot harder to do than it is to shoot threes. It really helps make some diversity in my game."

Hamman explained that it is Coffey's diversity that makes him so tough to guard.

"Mitchel's best attribute on the basketball court is his ability to shoot. He is a terrific shooter, especially from outside," Hamman said. "Mitchel's length is also a good benefit to his game. He is a tough matchup for whoever is guarding him."

"If a guard is on Mitch, he can take him to the post. If a big man is guarding him, Mitch can step outside."

Coffey's ability to be cohesive and create mismatches on the court allowed Hamman to be creative with his system and to attack opponents' weaknesses.

Ready for challenge

Coffey visited Clarke University several times, in addition to visiting other schools, before deciding to commit to the university, Nick Coffey said.

"I really liked talking to the golf coach, Adam. He is a really nice guy, and he is really straight forward," the younger Coffey said. "The bigger thing is that not having a senior year for the basketball side of things, I'm getting an opportunity for that too."

"They were able to see me for golf and give me a shot for that, but the

fact that I can get a shot for basketball without having my senior year, it's a thriller."

Coffey knows there are some who might doubt his abilities, but he's ready to take on challenges at the college level, both as a computer science major and as an athlete.

"Even going back to middle school, there was always adults, and even kids, that were like, 'You can't do that.' There are just people in front of you telling you that you can't do it, and playing two sports, it's more people saying you can't."

"It's all motivation and drive at that point."

Illinois, D.C., others file anti-trust lawsuit against Facebook

Illinois Attorney General Kwame Raoul filed a lawsuit against Facebook Inc. on Dec. 9 as part of a coalition of 48 state attorneys general and top lawyers from U.S. territories.

In the 123-page complaint filed in the U.S. District Court for the District of Columbia, the 48 states listed as plaintiffs allege that Facebook used illegal tactics to undercut competition "in the personal social networking market in the United States."

The states are asking the federal court to ban Facebook from continuing certain financial practices, restrain their ability to purchase other companies valued at \$10 million or more without notifying the plaintiff states and potentially restructure Facebook by removing assets the court determines were illegally obtained.

The Federal Trade Commission also has filed its own lawsuit against Facebook to "undo and prevent its anticompetitive conduct and unfair methods of competition in or affecting commerce."

"For nearly a decade, Facebook has profited tremendously by monetizing the personal information and online habits of users. Key to

its strategy has been impeding and eliminating any perceived competition, ensuring that users have no alternative to Facebook's platform," Raoul said in a news release.

"Facebook's ruthless anticompetitive practices have stifled innovation, harmed small businesses, and most importantly, reduced privacy protections and alternatives so that it could continue to earn billions of dollars at users' expense. I am joining my colleagues around the country to ask the court to end Facebook's monopoly and give consumers the choice and protections they deserve."

Key to both lawsuits filed against Facebook is its 2012 acquisition of the photo-sharing platform Instagram and its 2014 acquisition of the mobile messaging application WhatsApp. The FTC and states that are suing Facebook allege that the company tracked the metrics of start-ups in industries Facebook was interested in and offered to buy out the companies with offers far above their actual value, inflating the worth of those companies during acquisition and eliminating future competition that could hinder Facebook's growth.

Mentioned in the FTC lawsuit is Facebook's failed attempts to purchase Snapchat and Twitter, two

other now-large competitors, early in their development cycle in 2013 and 2008 respectively.

By purchasing competitors, collecting vast amounts of private information on their customers and freezing out third parties from accessing that data after they became reliant on Facebook, the company was able to establish an advertising monopoly in the social media-sphere, according to the two lawsuits.

While separate from the states' lawsuit against Facebook, the FTC's filing also calls for assets, such as Instagram and WhatsApp, to be removed from Facebook's holdings under existing anti-trust laws.

"Personal social networking is central to the lives of millions of Americans," FTC Bureau of Competition Director Ian Conner said in a release.

"Facebook's actions to entrench and maintain its monopoly denies consumers the benefits of competition. Our aim is to roll back Facebook's anticompetitive conduct and restore competition so that innovation and free competition can thrive."

Madigan floats income tax increase

As the state government attempts to close a multi-billion-dollar budget hole, Democratic House Speaker Michael Madigan has said he is prepared to vote for an increase to the state's flat income tax rate should the governor request it — a proposal met with pushback from his Republican counterpart, House Minority Leader Jim Durkin.

The \$3.9 billion budget shortfall, projected by the state budget office, that lawmakers will confront this spring has gained an increasing sense of urgency with the defeat of the graduated income tax constitutional amendment at the ballot on Nov. 3.

Voters rejected the initiative that would have replaced the state's flat income tax with a graduated income tax, which was projected to raise revenues by more than \$3 billion annually.

The state's flat income tax rate is currently 4.95 percent. The rate has been 3.75 percent from 2015 to 2017, and it was 5 percent from 2011 to 2014.

The state budget office has projected budget deficits ranging from \$4.8 billion in 2022 and \$4.2 billion by fiscal year 2026, according to a report last month from the Governor's Office of Management and Budget.

That report attributed the sizable budget deficit largely to the economic impact of the coronavirus pandemic that has forced many businesses to shut down and led to skyrocketing levels of unemployment.

Madigan's comments, reported by the Chicago Sun-Times, came during a speaker candidate forum of the Illinois Legislative Black Caucus on Dec. 5.

Madigan, 78, has served as speaker of the Illinois House of Representatives every year since 1983, with the exception of 1995 to 1997, making his tenure the longest of any state House speaker in U.S. history.

But Madigan's support from his House Democratic caucus has splintered in recent months, following charges from federal prosecutors that allege high-ranking Commonwealth Edison officials bribed close members of Madigan's inner circle

for years with lucrative no-work jobs and contracts, in exchange for favorable energy legislation.

In making his pitch to House Black caucus members, Madigan said he will provide strong leadership that might be necessary if Gov. JB Pritzker asks the Illinois General Assembly to address the budget shortfall by raising the state income tax rate — a scenario Madigan described as "very possible," according to the Sun-Times' report, which was based on a recording of the closed candidate forum.

"I'm prepared to vote for that, presuming it's the governor's request," said Madigan, D-Chicago, according to the Sun-Times.

Pritzker dodged a question at his daily briefing Dec. 7 about Madigan's statement that he would support a tax hike endorsed by Pritzker.

"I'm focused on the cuts that need to be made in state government, making sure that we're paring back as best we can, making efficiencies in state government, looking to Republican and Democratic leaders as I already have and asking them for their best ideas about what it is that

we need to cut in state government," Pritzker said. "And I will say that I have not yet heard back from the leaders about what their best proposals are for what cuts need to be made. And so I'm awaiting their responses."

On Dec. 8, Durkin, of Western Springs, called on Pritzker to release the spending cuts his administration requested from each agency leader last September. Pritzker made that request in an effort to reduce the state's bill backlog, which was roughly \$7.3 billion, as of June 30, 2019. The bill backlog had reached about \$7.6 billion as of Dec. 8.

The September 2019 request by Pritzker's administration asked each Cabinet director to submit budget proposals that would reflect a 6.5 percent spending cut.

This September, Pritzker warned state agency directors to prepare for a 5 percent budget reduction this year,

and a possible 10 percent cut in fiscal year 2022, which begins July 1.

When asked about whether Durkin has drafted his own proposed list of agency spending cuts, a spokesperson for Durkin said he has asked "repeatedly to begin by looking at this list of agency cuts."

In his letter to Pritzker, Durkin said he asked the governor to release the agencies' budgets reflecting a 6.5 percent cut when they spoke by phone last month.

"As of today, I have not received that document, and I am now asking again for the list of spending reductions by agency," Durkin wrote. "Speaker Madigan has stated he will work with you on another tax increase, but I hope you will respect the will of the voters and instead look to live within our means."

- 1 T. butter, softened
- 2 T. milk
- ¼ t. vanilla
- 26 chocolate kisses, unwrapped

Preheat oven to 350. In a mixing bowl, beat butter, sugar, egg yolk, milk and vanilla until light and fluffy. Combine flour, cocoa and salt in a separate bowl; gradually add to creamed mixture. Cover and chill one hour or until firm enough to roll into balls. Meanwhile, in a small bowl, lightly beat egg white and pour chopped pecans in another bowl. Shape dough into 1-inch balls; dip in egg white, then roll in nuts. Place on greased baking sheets. Make an indentation with your thumb in center of each cookie. Bake at 350 for 10 to 12 minutes or until center is set. Combine the first four filling ingredients in a small bowl and mix until smooth. Spoon ¼ t. into each warm cookie; gently press a chocolate kiss in the center. Carefully remove from

baking sheet to wire racks to cool.
