Health department looks to increase available vaccines

of Health (MCDH) anticipates that COVID-19 vaccine availability will begin to increase as more vaccine comes into the county and state and federal supplies are distributed through local partnerships.

McHenry County is in the process of transitioning its vaccination efforts to administering first doses for Phase 1b recipients, including educators and school personnel, who will begin to be inoculated by the end of next week ahead of schedule.

"With federal and state vaccine supplies going to retail pharmacies, in addition to a growing number of community partners, residents and those who work in McHenry County within the priority groups will have many more options of where they can receive the vaccine," Public Health Administrator Melissa Adamson said.

First responders and those 65 and older are the first two groups prioritized in Phase 1b in McHenry County. More than 25,000 of the approximately 90,000 people who have enrolled through the MCDH website to receive the vaccine have identified themselves as being at least 65 years old.

The county has been working with local school districts to set up two points of dispensing, one at Huntley High School and the other at Woodstock North High School, in order to

The McHenry County Department vaccinate educators and school support personnel across the county. A total of 6,560 doses have been allocated for these appointment-only clinics scheduled for Feb. 11 and Feb. 12.

As of Jan. 29, the MCDH has received 20,275 doses of vaccine - the county received its first allotment of the Moderna vaccine on Dec. 28. while other counties received their initial shipments earlier in the month. Of those, 6,000 doses are allotted specifically for second doses. The MDCH began administering second doses to Phase 1a recipients - frontline healthcare workers and residents of longterm care facilities - beginning the last week of January, when it also began transitioning to expand its vaccine efforts to first doses for Phase 1b.

Since January, MCDH has distributed 9,400 doses to local hospital systems, local pharmacies and community partners, expanding options for vaccine administration for Phase 1a and 1b priority populations.

As of Feb. 1, the Illinois Department of Public Health is reporting 16,239 McHenry County residents have received vaccine, and 1.32% of the population (4,067) has been fully

MCDH is currently vaccinating Phase 1a and Phase 1b seniors at its clinics. Links to MCDH clinics are shared weekly and emails that receive the links are selected at random. If you have enrolled online and received a confirmation email, you are in our system. Due to limited vaccine supply, clinics are only scheduled one week in advance and based upon vaccine allotments re-

The State of Illinois is also part-nering with retail pharmacies such Vaccine.

Residents can call the COVID-19 as Walgreens and Jewel-Osco to provide COVID-19 vaccinations. Information about where and how to schedule an appointment with these pharmacies is available at coronavirus.Illinois.gov.

Regional hospitals are inviting patients who are 65 and older to receive the vaccine. MCDH is encouraging residents to look for these direct communications from their healthcare provider's health system about the option to receive the vaccine at their clinics.

"As local, state, and federal partnerships and vaccine supply încrease we anticipate more opportunities for residents to obtain a vaccination and encourage everyone 65 and older to take the first available appointment they can schedule," Adamson said.

New law on odometer disclosure

White is alerting the automobile industry, along with private party vehicle sellers, of a new federal odometer disclosure rule that increases the amount of time odometer readings must be declared at the time of a vehicle sale. The new fed-

eral rule took effect Jan. 1, 2021. The new federal rule, which was issued by the National Highway Traffic Safety Administration, is intended to help combat odometer fraud as the nation's fleet of vehicles ages. The average age of a vehicle in the United States is now almost 12 years, up from 7.6 years when the odometer rules were last changed in 1988.

Under this new federal rule, vehicles made in 2011 and newer will

Illinois Secretary of State Jesse be subject to odometer disclosure compliance include: for 20 years rather than the current

Under the old rule, a 2011 vehicle would have become exempt from disclosure in 2021. Now, the odometer reading must be disclosed at the sale of a 2011 vehicle until 2031. For example, 2012 vehicles will become exempt in 2032, and so on.

The immediate impact is that 2011 vehicles will not become odometer exempt on Jan. 1, 2021, as they would have under the old rule. The new rule applies even if the existing title says "Exempt -Model year over 9 years old." This applies to automobile dealers and private party vehicle sellers.

Simple guidelines to help ensure

- If the vehicle is a 2011 model or newer, the seller must enter the current mileage in the Odometer Reading section of the title upon sale of the vehicle.
- If the vehicle is a 2010 model or older, the seller may check the "Exempt" box on the title.

Due to the new federal rule, the Secretary of State Vehicle Services Department must reject paperwork for sales of vehicles 2011 or newer unless the odometer disclosure is

For used vehicle dealers and other businesses in the automobile industry, the new federal rule means they will be required to disclose the odometer reading on a greater number of vehicles.

IHSA Board announces sports schedule for remainder of 2020-21

for a special board meeting on Jan. 27, 2021, where the board provided an updated sports schedule and other guidance for the remainder of the 2020-21 school year.

"We understood the high level of anticipation surrounding today's announcement, along with the scrutiny that will accompany it," said IHSA Executive Director Craig Anderson. "Ultimately, the board adhered to its stated goals throughout the pandemic: providing an opportunity for every IHSA student-athlete to comnete safely this year and maximizing opportunities for traditional IHSA spring sports after they lost their entire season a vear ago. I recognize that many schools and coaches could likely offer a tweak here or there that would have, in their opinion, made it 'better' for their school or sport. Our Board faced an impossible task with a litany of factors. They were conscientious in considering every

sions today are a positive step for the mental, emotional, and physical well-being of our students. We are excited to channel our energy into creating as many positive experiences for Illinois high school students as we can between now and the end of this extraordinary school year.'

The board is considering State Series competition for traditional IHSA spring sports only. Dance and cheerleading will be allowed to conduct virtual sectional and state final meets, as they will record their performances and submit them to be judged.

"The board wants to do everything in their power to prevent spring sports from going two consecutive years with no postseason IHSA play," said Anderson. "There are obviously no guarantees, as risk levels by sport and local region mitigation statuses will factor significantly. Postseason could mean being limited to a regional or sectional level of competition,

of playing a full state tournament in these traditional spring sports if possible. The overwhelming feedback we have heard from athletic directors and coaches was that returning to play in all sports should be the main goal.'

With the exception of football, which requires individuals to participate in practice on 12 different days, all sports will be required to hold practice on seven different days prior to holding a contest. Holding multiple practices on a date does not impact that timeline. If student-athletes transition from basketball or boys swimming & diving into football, they will need to participate in practice on 10 different days prior to their first contest. Winter sport contests could begin as early as today, dependent on when a school's Region reached the appropriate mitigation status and when they began

The IHSA Sports Medicine Advisory Committee (SMAC) issued a statement reminding all student-athletes, coaches, and schools on the importance of acclimatization:

'The IHSA SMAC reminds mem-

need additional conditioning in order to participate in a full schedule this season. In addition to season/practice requirements, care needs to be given to each student's individual acclimation as they return to play. When building schedules, attention needs to be given to academic pressure, changes from in-person to remote learning, changes between tiers of mitigation, time spent traveling to events, appropriate time to practice/ learn the sport between games, etc. to ensure the student experience truly enhances the academic day.'

IHSA guidelines require all student-athletes to participate in masks (with the exception of swimming & diving, gymnasts on an apparatus and outdoor events where social distancing can occur) and for all game personnel not participating in the contest to also wear masks and adhere to social distancing.

"We still have regions of the state that need to make strides in order be able to play basketball this winter," said Anderson. "That underscores the importance of our schools following all the mitigations and precautions. We need to maintain a possports going, but to make sure we do not have any regions regress before spring and summer sports have their opportunity. We can all do our part by wearing a mask and socially dis-

tancing." The board also agreed to consider other participation opportunities for a given sport, like basketball, if the sport is unable to be played in a spe-

"We have said from day one that if and when we were allowed to play again this year, the situation would be fluid," said Anderson, "We don't feel great about the notion of some schools falling behind based on their region's status, but also recognize that we are running out of time and can't afford to hold back the Regions that can play."

In October, the board ruled that students who play sports (football, boys soccer, girls volleyball) that were displaced from their traditional season could participate on high school and non-school teams simultaneously. The board affirmed this position in Wednesday's meeting

Rep. Sosnowski on governor's reversal to give legislators priority

State Rep. Joe Sosnowski, R-Rockford, responded Friday, Feb. 5, to Gov. JB Pritzker's decision to give members of the Illinois General Assembly priority access to the COVID-19 vaccine, reversing his previous position that Phase 1B of the state's vaccination plan be limited to seniors age 65+ and frontline essential

"I am disgusted with the governor's decision to put legislators at the front of the line for the COVID-19 vaccine. As with many of his other decisions, there is definitely no science behind this decision. Legislators over age 65 should wait in line with other senior citizens to receive the vaccine during Phase 1B. That would be appropriate.

'No member of the legislature under the age of 65 should have priority access over the elderly, patients waiting for an organ transplant, or those with pre-existing conditions. The governor has buckled under pressure from politicians in his party who want to put themselves ahead of our seniors and the most vulnerable. It's a

"I would expect my colleagues to do the right thing and save the vaccines for those who are most in need."

Rep. Sosnowski serves the 69th District, which includes portions of Boone and Winnebago Counties.

COVID-19 variant found in Region 1

variant B.1.1.7 has been identified in the Northern Illinois Rockford Region, Region 1. The case is a resident of Lee County with unknown travel history as the disease investigation is ongoing. The B.1.1.7 variant was first identified in the United Kingdom and has already been reported in other regions in Illinois including Chicago, Cook County and Lake County.

According to Cathy Ferguson-Allen, administrator of the Lee County Health Department, "The identification of this variant in the region was anticipated as the variant is known to spread more easily and had already been identified in Illinois in nearby regions. This case is a reminder that the community must be vigilant in practicing prevention measures to protect themselves and each other from COVID19. It also highlights the importance of following quarantine recommendations and to get tested if you've been in close contact with someone who has tested positive for COVID-19."

Protect Yourself, Your Family, and Your Community:

- WASH-UP: Wash your hands with soap and water for 20 seconds frequently.
- MASK-UP: Cover your mouth and nose with a cloth face cover
- BACK-UP: Keep at least 6 feet apart from others.
- VAX-UP: When it is your turn, get vaccinated for COVID-19. Early indications are that the vaccine offers protection against the B.1.1.7 variant, however, information is preliminary and evolving. Local health departments (LHDs) in the Northern Illinois Rockford Region (NIR-HDs) are working hard to get the community vaccinated with the resources that are available. The vaccine supply continues to be limited.

While those in Phase 1b, which includes frontline essential workers and those 65 and older, are eligible for the COVID-19 vaccine, there is not enough vaccine available to vaccinate everyone

Those in Phase 1b should know the following about vaccinations:

- Check your local health department's website or social media page for instructions on how vaccines are being distributed in your
- While you may be eligible to get the vaccine, Phase 1b includes a large group of individuals, so it may take a while for your turn, but
- Your patience allows the NIR-HDs to focus limited resources on administering vaccinations.

County to have public hearing Feb. 17

The Boone County Board will have a public hearing before the start of its 6:30 p.m. Wednesday, Feb. 17, monthly meeting on a proposed two-year moratorium on impact fees. After that, the board will vote on whether to approve such a moratorium.

A motion was on the floor and the board was all set to vote on the matter Jan. 20 when board Chairman Karl Johnson said there had been "a little bit of a change on this." He said he had talked with State's Attorney Tricia Smith, who told him the way the county's subdivision code was written there had to be a public hearing prior to

changing the code.

"And the impact fee is listed in that

subdivision code," he said.

Given that, he added, "So I'm to ask that we change this motion to read: 'moving to approve a public hearing for discussion purposes of a two-year moratorium of impact fees.' If we get that approved, then we can have the public hearing at the next (board) meeting."

Smith, who is legal counsel for the board, said she had a little bit different motion, but that it stated the same thing. Her proposal was a motion "to set a public hearing to amend the subdivision code to adopt a two-year moratorium on impact fees.

Johnson asked board member Rvan Curry, who chairs the Committee of the Whole administration if that was the motion he intended to make?

"That is spot on," Curry replied. "I appreciate that." Board member Bill Robertson provided the needed second.

Johnson said having the public hearing prior to the Feb. 17 board meeting would provide plenty of time to let the public know about the hearing. Then the board would be able to vote on the matter the same night.

There was no further discussion and the new motion passed, 12-0.

Earlier that night Neeley Erickson, governmental affairs director for the Illinois Realtors organization, appeared during the public comments portion of the meeting. She said she also was representing the Belvidere Board of Realtors and Rockford Area Realtors, which recently had merged. Her purpose was to express the support of those organizations for a two-year moratorium on

She said a moratorium would encourage new residential growth for platted lots within the county, which does not burden the infrastructure designed to support its residents. "We are in a housing recession," she continued.

"Boone County growth is stagnant," she said. "We have provided information and examples of how other communities have eliminated or placed a moratorium on impact fees to encourage housing development. Those communities are experiencing success. Our infrastructure is sound; we have room for smart growth."

Impact fees were created many years ago by municipalities to help defray the cost of providing additional services, such as police, fire, and public works, brought about by residential growth.

Two newcomers seek Ward 3 seat in Belvidere City Council primary

Daniel Hulina and Sheryl Prather have declared for the upcoming vacancy in the Ward 3 seat on city council, created when two-term incumbent Tom Ratcliffe chose not to seek re-election.

The winner of the Feb. 23 Republican primary election will claim the four-year term as no Democrat or Independent signed up to run in the April 6 consolidated election.

Each candidate was asked two questions: What prompted you to run for this seat? And, why should voters select you?

Here are their answers:

This Republic is the most rare, prosperous and free form of government in the history of the world. Their design was to prevent any other form of government from destroying it. For a governmental

officer to betray their oath to preserve the same for posterity was worthy of

Bill aims to reshape health care delivery

'Hospital transformation' plan targets service gaps, disparities

During the early hours of the morning on one of the last days of the lame duck session, Illinois lawmakers passed a sweeping piece of legislation that seeks to revamp the way hospital services and health care generally are delivered in communities throughout the state.

The so-called "Hospital Transformation" bill. Senate Bill 1510. House Floor Amendment 3, was not part of the Legislative Black Caucus' agenda, which was the focus of much of the activity during that session. But it did pass unanimously out of both chambers and will soon head to Gov. JB Pritzker for his signature.

In short, the bill makes about \$150 million a year available to local communities to form partnerships that will develop and implement plans that improve medical access, with a focus on the uninsured and Medicaid users. The funds are meant for "integrated" health care, such as community-based services, preventive care, obstetric care, chronic disease management and specialists.

The program specifically targets what are known as "safety net hospitals," which serve large numbers of Medicaid and uninsured patients, as well as "critical access" hospitals," which are small hospitals in sparsely-populated rural areas that offer acute care and emergency medical

Funding for the grants will come from a statewide hospital assessment to earn federal dollars, which lawmakers renewed during the abbreviated regular session in May, combined with federal matching funds

The bill was the result of a yearslong effort by a group called the Medicaid Working Group, made up of lawmakers from both parties and both chambers as well as officials from the governor's office and the Department of Healthcare and Family Services. The group consults with hospitals, clinics and other stake-

Welch seeks to set a new tone in Illinois House

New speaker talks changes to House rules, path forward for General Assembly


The election of Rep. Emanuel "Chris" Welch as Speaker of the Illinois House of Representatives marked the beginning of a new era in state politics. Not only is he the first Black speaker in state history, he is also the first speaker in 24 years whose name is not Michael Madigan.

But Welch assumes the gavel at a precarious time in state history, a time marked by a deadly pandemic that has resulted in an economic crisis and a steep drop in state revenues, as well as a time of social unrest over racial inequities, many of which have been exacerbated by the pandemic.

"Well, I definitely agree that I'm taking over at a challenging time," Welch said during a podcast interview. "Any one of the things that you just mentioned makes for an interesting session by itself. And I'm inheriting a situation where we're going to have to deal with all of that all at once. And so, I think that where you start is where have already started. And that's by putting a diverse leadership team in place, a team that reflects the diversity of our state, which is our strength."

Welch unveiled his new leadership team on Jan. 21. It includes a mix of old and new faces. Rep. Greg Harris, of Chicago, remains House Majority Leader and Rep. Jehan Gordon-Booth, of Peoria, remains deputy majority leader. But the team also includes some newer faces such as Chicago-area Reps. Mary Flowers, Jaime Andrade Jr., Robyn Gabel, Elizabeth Hernandez, Marcus Evans and Delia Ramirez, as well as Urbana Rep.

It will be some time, though, before the House is able to fully get back to work. Welch had announced that the House will come back into session on Feb. 10 for the sole purpose of adopting new rules, which are expected to allow for remote committee meetings that will then occur regularly over the next couple of months. But other substantial action at the Statehouse in Springfield is unlikely to occur until at least sometime in April.

General Assembly to move into high gear.

'As we approach April and May, as we're getting to crunch time, I anticipate being in Springfield a lot more than we have over the past year," he said.

Welch, 49, of Hillside, said he was born and raised in the 7th District that he now represents. He is a graduate of Northwestern University and the John Marshall Law

At that point, Welch said, he expects the his speed, he wouldn't disclose his batting average, saying only that it was below .300, but he described the experience as "one of the best times of my life." But he did not play his senior year, saying he chose to focus on his grades that year "because I knew I wanted to go to law school."

As speaker, Welch faces a challenge distinguishing himself from his predecessor. That's because many members of the House were not even born yet the first time Madigan was elected speaker in 1983.

"I really speak very highly of Speaker meet regularly for coffee."

Madigan," Welch said. "We wouldn't have 73 Democrats and a super majority in our chamber without Speaker Madigan. But I will say that I still have to be Chris Welch."

Madigan, through much of his tenure as speaker, was known for keeping a tight grip on the House. It was often said that no bill ever reached the floor of the House for a vote unless it had his blessing, including such issues as legislative ethics reform.

Welch, by contrast, has indicated he may try to govern with a softer hand by relaxing some of the House rules.

"We're being sincere in taking a quick, hard examination on these rules," he said. "But you know, we can't do much until rules are approved. And so, our intent is to let this go on for the next couple of weeks. And Feb. 10, we will have a vote on the rules. I anticipate that there will be some changes to the rules from the past."

Welch also said he hopes to repair the Democratic majority's relationship with House Republicans, including Minority Leader Jim Durkin, of Western Springs, who led an effort last year to have Madigan removed from office over his role in a yearslong bribery scheme involving utility giant Commonwealth Edison.

Welch, who chaired the special investigating committee that was formed to investigate Madigan's role in that scheme, played a key role in preventing the filing of formal disciplinary charges. But now, as speaker, Welch said he hopes to rebuild a working relationship with Republicans.

"And I actually called him this past Saturday (Jan. 23) to talk to him about the intent about going back to session to improve the rules on February 10, find out who his point person is on the rules," Welch said. "And he was pleasantly surprised to receive a call from me on a Saturday morning.'

"That's my style," he added. "And that's what I intend to do going forward is to keep an open line of communication. We actually live less than five miles from each other. When things open back up, we'll probably







Many boons found among changes forced by pandemic

Apple orchard and pumpkin patch operators can pick out a number of surprise benefits from doing business during the COVID-19 pandemic.

During a recent afternoon session at the virtual Illinois Specialty Crop Conference, operators of two of the state's biggest such companies went over unforeseen boons-from a more productive relationship with government officials to more fruitful use of social

The biggest surprise, perhaps? Sales went up year-over-year, according to Chris Eckert, president of Eckert's Country Store and Farms in Belleville.

"With everything we've learned, I expect [profits] to be even better this year, or at least to stay at those numbers," he said. "I certainly don't expect them to go back to where they were in

'Suddenly, we're on the front line'

Eckert and Randy Graham, chairman of the Illinois Specialty Growers Association and co-owner of Curtis Orchard & Pumpkin Patch in Champaign, helped form and lead a working group that wrote COVID-19 operating guidelines and protocols, as they pertain to agritourism, then presented them to legislators and the Illinois Department of Public Health.

Eckert said it was refreshing to have not just a seat at the table, but officials' undivided attention.

"They'd never really listened to us like this," Eckert said. "I think it's very easy for the governor, the administration or the public health department to make rules without thinking about us. Suddenly, we're on the front line of what seems like a war. Twelve months ago, we didn't necessarily think of ourselves as essential workers.'

Graham said working with the group to write the guidelines opened his eyes to the wide range of ideas, opinions and

"There was a lot of give and take, and you'd think it would be a little easier to come to an agreement on some topics, but we discovered a lot of diversity in opinion," he said. "That really helps us view the situation through different

After the state health department issued its guidelines, businesses were at the mercy of their local health depart-

Things were more strict in Champaign than, say, St. Clair County.

"Very strict, I would say," in Champaign, Graham said.

For instance, those inflatable play areas that keep patrons on-site all day, after they've bought their children an all-day wristband? The Champaign-Urbana Public Health District took the air out of those structures

But whereas some other health departments around the state required rigorous ticketing and appointment systems for orchards and pumpkin patches, the Champaign department didn't.

"Having the strength of numbers document maybe helped sway them to work a little more with us in some areas." Graham said.

No one likes to stand in line

Eckert braced for blowback when his business instituted a picking appointment system in Belleville.

"It was a challenge," Eckert said. We had been charging some field admission for years, but we'd never pushed for advance ticketing. We didn't know how much resistance we were going to get."

Eckert's started with 100 patrons per 30-minute timeframe, \$2 to \$5 apiece per slot, to gauge how many people they could safely put on a wagon, and determine how many wagons they could run without issues. They slowly increased the number until they reached 300 per half-hour.

"While there was a lot of fear of it, acceptance was very high," Eckert said. "Don't get me wrong. There's always complaints."

On the flip side, he said he and his staff got more compliments than in

He and Graham said there were fewer cars in the parking lots during typical peak times. But there were cars in the lots all day, and sales went up. With no long lines to stand in, pumpkin sales 'skyrocketed," Graham said.

Same with Christmas trees."

Going against traditional grain

Graham admitted it was tough to make decisions that flew in the face of conventional, perceivably successful

He winced when the decision was made to eliminate that play-all-day wristband.

"Usually, the longer they stay on the farm, the more money they'll spend,"

This year, the Champaign farm couldn't use its store as a sort of funnel, and a gateway into the pumpkin patch. But patrons spent more money in the store when they had elbow room, when the store wasn't packed to the gills. The plan going forward is to sell pumpkins at an outdoor structure, as well.

Some forced decisions were not only easier to carry out than expected, but saved a lot of time and resources. For instance, replacing the clunky, foot-pedal hand-washing stations with dozens of hand sanitizer stations cut down on maintenance, while making patrons feel more safe.

Eckert said industrywide, apple sales have been declining in recent years. Whereas a grain farmer can change up his planting patterns, apple trees are So, in an effort to buoy sales and cut

down on food waste, Eckert's partnered with grocery chain Schnucks to sell apples wholesale.

"It's the first time we've done wholesale in 30 years, in any meaningful way," he said.

Video is going to be the real winner

Graham said he and his staff saw a lot of new faces this past season. The trick now is bringing them back, especially when, as Eckert pointed out, other entertainment options, such as minor-league professional sports, are bound to return this fall.

"Video is going to be the real winner," Eckert said, before laughing a

"We'd eroded the public trust, and we needed to get it back," Eckert said. "Being good stewards of the industry is an important part. We have an important role in connecting people with food, and them feeling good about that."

He and Graham agreed that in 2020, families were willing and eager to come to the farm and see how food is grown, and how the products they buy in the store are produced. "Our guests really felt safe coming

to us and seeing where food was produced," Eckert said. "There was some security that came with that." Organic, locally grown food has been trendy in past years, but 2020 felt

"Before, it was more of a luxury, and Graham said the kids were a joy to now I think people see us as critical.'



The Illinois Pesticide Act requires individual farmers to become certified as a Private Pesticide Applicator in order to purchase and use restricted use pesticides (RUPs). These products will clearly state the words "Restricted Use Pesticide" on the label. Common examples include insecticides Counter and Force and herbicides such as Atrazine and Harness.

To become certified, you must pass a closed-book, 50-question examination administered by representatives of the Illinois Department of Agriculture. Once passed, a three-year certification license will be issued by the IDA upon re-

holders to design Medicaid policy.

House Majority Leader Greg Harris, D-Chicago, who is part of that working group, said during an interview that for the last several years, it has been focused on trying to design a modern Medicaid system that reflects a very different health care environment than the one that existed decades ago.

"When our system was designed, most healthcare was delivered in

hospital settings, in medical surgery settings," he said. "Now, you know, huge amounts of that kind of work is being done in outpatient settings. whether it's diagnostic imaging or specialty care, or same day surgery. Hospitals are not the central hub for a lot of services like they used to be.'

The problem being faced in many parts of the state, he said, is that not all communities have access to the full array of medical services, result-

reduce health care disparities, including specific metrics that can be used to track whether or not the project is meeting its goals.

Beyond that, the bill puts few limitations on the types of proposals that will be considered. Evan Fazio, a spokesman for the Department of Healthcare and Family Services, which will administer the grant program, said that was intentional.

'We want to cast a really wide net and we want this to be about what the community needs and what the community wants," he said. "And since it is a community-first initiative, we want people to kind of come up with the partnerships and collaborations that they think could come together to meet the needs of their communi-

Rep. Tom Demmer, R-Dixon, who also serves on the Medicaid Working Group, said one of the biggest challenges in crafting the bill was getting all the various players to come to a shared understanding of what a health care "transformation" should look like and what kinds of local programs the state was looking for.

"It's been years in the making. These discussions have literally been proposals specifically designed to going on for years, trying to craft

some definitions and parameters for just what do we mean by this transformation idea," he said.

The bill is what's known in legislative jargon as an "agreed bill," meaning lawmakers from both parties and both chambers, as well as all of the various interest groups affected by it, came to a general agreement on its provisions.

That's a relatively rare occurrence in the Illinois General Assembly, but both Harris and Demmer said it has become common with Medicaid legislation, primarily because of the bipartisan nature of the Medicaid Working Group.

"Over the years, people have really learned to work together, and people put aside political differences and partisan differences in order to get really good policy outcomes," Harris said. "And I think that has really helped us do good work, and it's really nice to see.

"I think this hospital transformation fund is a unique and innovative way to put additional money in communities that are struggling with health care today," Demmer said. 'The need has always been there, but it's been highlighted by the impact we've seen with COVID in a lot of
