Panthers claw past Chicago Hope enroute to fourth consecutive state title game

Lena-Winslow's round four matchup of the Illinois 1A high school football playoffs was an absolute thriller. The Panthers met up with the Chicago Hope Eagles in a matchup that will go down in Le-Win history.

Chicago Hope came into the matchup with an overall record of 11-1, while the Panthers were a perfect 13-0. Despite the Panthers being on the road, you wouldn't have known by the size and sounds from the crowd. The Panther community showed up and showed out for their team and they were loud, especially when it mattered most.

This game was far from the usual for the Panthers. In the first two minutes of the game, Chicago Hope put their passing attack on display as they connected on a 61-yard touchdown pass. Le-Win found themselves trailing 7-0.

The Panthers quickly responded, however, as they gave their crowd something to cheer for. With just over five minutes left in the first, Cobryn Lynch took a run seven yards to paydirt. Gage Dunker gave the Panthers an early advantage as his two-point conversion put them up 8-7.

After a defensive stop, the Panthers extended their lead when quarterback, Jake Schumacher found Lynch on a 26-yard passing score. Dunker once again tacked on the two-point conversion as the Panthers took a 16-7 lead that held until the end of the

first.

Hope wasn't ready to go away easy, however. Early in the second quarter, the Eagles continued to let it fly as a 29-yard passing score brought them within two. That's where things got a little different for the Panthers. Le-Win is often so dominant that it was hard to know what to expect when they faced a little adversity. Chicago Hope brought more than that when they took a 21-16 lead that held through the halftime break.

In the third quarter, the Panthers found themselves in uncharted territory. With just over five minutes left in the third, Chicago Hope took a seven-yard run into the end-zone. With that touchdown, the Panthers trailed by 12 points with a score of 16-28. It was the only time the Panthers trailed by multiple scores this season.

With the season on the line, Le-Win's biggest playmakers stepped up. All season long, the main focal point of the Panther offense has been Dunker. While Dunker still got his, it was Le-Win's next ball carrier, Lynch, who stood out. After a pair of scores in the first quarter, Lynch tallied the hat trick late in the third. It was his second receiving touchdown of the game as Schumacher connected with him on a 22-yard passing score. Lynch's third score of the day could not have come at a better time as he helped the Panthers make it a one-score game with them trailing

24-28.

In the fourth quarter, Lena-Winslow's defenders stepped up. Chicago Hope had their way with the passing game through the first three quarters. Deep ball after deep ball, Le-Win seemingly had no answer for the air raid. Throughout the season, Jaylen Rakowska left his fingerprints all over a number of games with his defensive play. Round four was no different, as Rakowska forced a late pass breakup on fourth down. It came at a key time as it allowed the Panther offense to run more time off the clock.

Lynch's offense was the story of the day at that point, but oddly enough, the touchdown receptions weren't even his best catch of the day. In the closing moments, with all the marbles on the table, Chicago Hope tested the Le-Win defense with another deep ball. This time, Lynch was up for the answer as he leapt in front of the front-left pylon for a game winning interception, sending his team to state.

Dunker carried the load for Le-Win with 208 rushing yards on 35 carries. Lynch rushed for 60 yards and a score on 19 carries, to go along with three receptions for 46 yards and a pair of scores.

The Panthers are set to meetup with Camp Point Central on Friday, Nov. 24 at 10 a.m. It's a rematch of last year's 1A Championship game where the Panthers won by a score of 30-8.

Aging farmers have less incentive to invest in cattle expansion

The average age of a farmer and the future of the cattle industry go hand-in-hand.

As contraction of the U.S. cattle herd continues, farmers nearing retirement age are faced with deciding whether to expand again, invest more into infrastructure and whether someone is in line for succession who is willing to take on the responsibility.

Prices might be good now, but what happens if demand decreases?

"If I have infrastructure that's aging, and I have to take on additional debt at these high interest rate levels, does it really make sense as a business decision to expand again?" asked American Farm Bureau Federation Economist Bernt Nelson. "There aren't a ton of incentives right now to overcome these obstacles, and there are a lot of individuals considering liquidating or getting out."

The average age of a farmer is 57, which puts many farmers in a difficult position of deciding whether to take on more debt.

The rebuilding timeline for the cattle inventory will largely depend on incentives to farmers and sustained consumer demand through the macro economy as a whole, Nelson said during the Agricultural Bankers Conference in Oklahoma City, adding that likely won't be until the end of 2024 into 2025.

"We're still putting a lot of

heifers through our marketing supply chain," he said. "And as that continues to occur at around the 40 percent level, we're going to see contraction continue."

The Ag Department pegged the inventory of cattle and calves on feed for the slaughter market as of Oct. 1 at 11.6 million head, up nearly 1 percent from last year. Placements in feedlots during September totaled 2.21 million head, 6 percent above a year ago, according to the bearish cattle on feed report released Oct. 20.

Cattle prices are up in 2023, but high market volatility and drought continue to push cattle farmers toward herd liquidation.

"If we have a situation that arises where we have to make an investment to expand again, does this make sense as a business decision?" Nelson asked. "Do we have somebody in the next generation that wants to come back to take over the farm?"

Nelson's presentation focused on the U.S. protein outlook, noting demand and the state of the economy are two giant question marks that play a huge role in the beef, pork and poultry markets.

Production issues persist, and disease issues are floating around, including concerns of African Swine Fever and avian influenza, which made a resurgence in the last month. Nearly 1 million chickens have been culled at a Minnesota egg operation during the

current bird flu outbreak.

"And this has all led to a lot of market volatility," Nelson said.

If consumer spending begins to shift away from beef and toward less expensive substitutes such as chicken or pork, demand for beef will fall, putting downward pressure on cattle prices and making profitability challenging for farmers, Nelson wrote in a recent Market Intel.

Feed

Feed is one of the largest livestock expenses, and with corn prices under \$5 for the first time in about three years, the margin for profitability has improved.

But drought conditions persist, and hay stocks have been beaten up with huge pockets of pastureland dried up.

The top five beef-producing states have experienced severe drought in 2022 and 2023, pushing many cattle farmers to liquidate cattle, which continues to hold the cattle industry in the contraction phase of the cattle cycle.

Pork/hog supply

ASF remains a worry, with many believing it's inevitable the disease will reach the U.S.

"The projection is if that would hit U.S. soil, we would see a 50 percent drop in price of pork overnight," Nelson said. "So that concern is still very real on some producers' minds. And while I don't think the likelihood of that is very strong, it's still there. It's

popping back up in China."

According to Iowa State University, estimated returns from farrow to finish demonstrate the difficulty of profitability in the pork industry throughout the year. The average loss per head for eight consecutive months was \$18-\$25.

"That's a big deal. That can eat into a lot of working capital quickly," Nelson said.

"Looking at futures, we saw things come down quite a bit. There's been a lot of volatility and a lot of confusion in hog futures," Nelson said. "They haven't really chosen a direction. And as we get closer to Jan. 1, I think we'll start to see some of that come alive."

The overall hog population is looking to decline in the next year. The hogs and pigs inventory sits a tad higher than last year, and up 2 percent from June at 74.3 million, according to the USDA's latest quarterly hogs and pigs report. Most of that came from record pigs per litter.

"The nice thing about the hog market is they can expand a little bit faster than the cattle sector," Nelson said. "But we're still going to be looking at a lot of profitability issues going into next year."

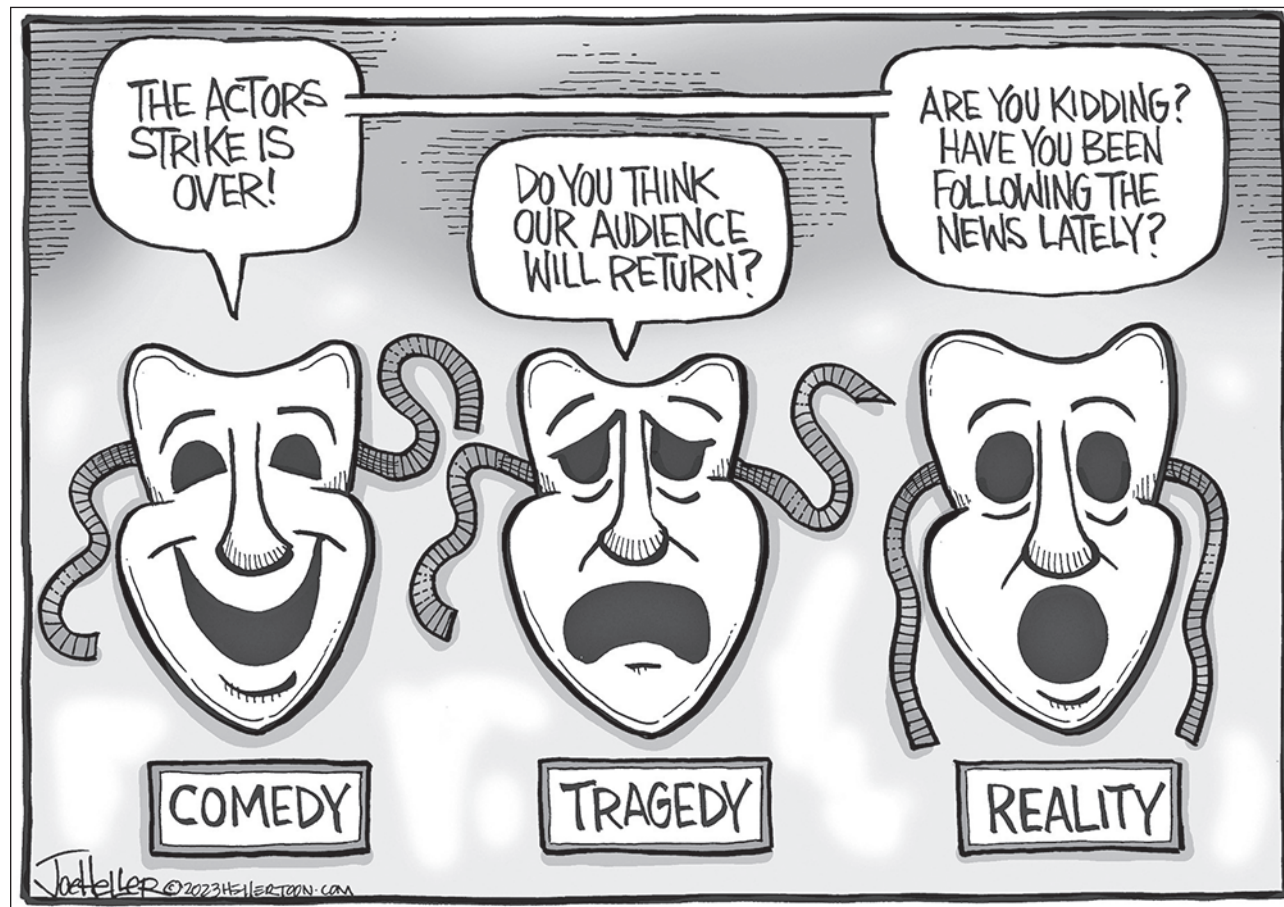

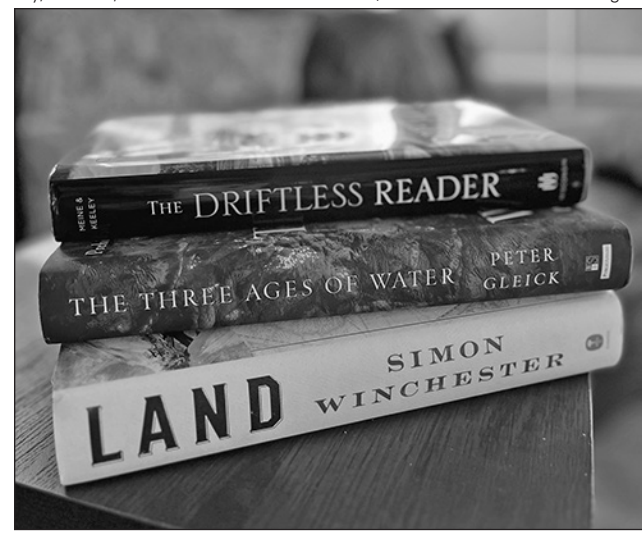

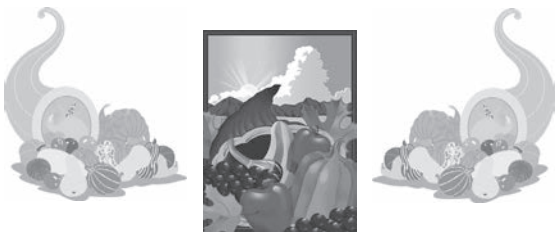

Lawmakers approve plan to allow small-scale nuclear development

Governor, who vetoed previous bill, supports new effort

Lawmakers have approved a proposal that would allow companies to develop new nuclear power generation in Illinois for the first time since 1987.

House Bill 2473 does not entirely lift the 36-year-old moratorium on nuclear construction. Instead, it creates a regulatory structure for the construction of small modular nuclear reactors, or SMRs.

The bill limits the nameplate capacity of such reactors to 300 megawatts, about one-third the size of the smallest of the six existing nuclear power plants in Illinois. It also requires the state to perform a study that will inform rules for regulating SMRs, which will be adopted by regulators at the Illinois Emergency Management Agency by January 2026.

Proponents of the measure say it is a step to make the ongoing transition away from fossil fuels more reliable for customers throughout the state, while opponents warn the unproven technology comes with safety risks and the potential for cost overruns.

The bill passed with bipartisan support in the Senate, 44-7, and the House, 98-8. The opposition came exclusively from Democrats.

Gov. JB Pritzker said in a statement that he would sign the bill. He worked with lawmakers on the new language of the new bill after vetoing a broader measure this summer.

Leadership of the Illinois AFL-CIO umbrella labor organization released a statement, calling the policy an "important for our state's economy and our clean

energy future."

It echoed a release from the Illinois Manufacturers Association, an industry advocacy group that testified in support of the proposal several times, saying that it would allow the state to "continue leading in energy and manufacturing innovation."

The legislation's sponsors, Sen. Sue Rezin, R-Morris, and Rep. Lance Yednock, D-Ottawa, said the bill has the potential to bolster Illinois' electric reliability as intermittent sources like wind and solar begin to make up a larger portion of the state's energy output.

"In order to reach our clean energy goals, we may have to invest in more nuclear generated carbon-free energy," Yednock said. "The policy does not subtract from the growth of wind and solar energy; it could be an enhancement, as a potential use of small modular reactors could be to energize large manufacturers, therefore keeping more traditional new sources of energy for residential, small commercial customers and our future [electric vehicle] needs."

Rezin noted that she is particularly interested in the potential for SMRs to be developed at the sites of former coal plants in Illinois, avoiding the need to build new transmission lines, although that process could take many years.

Because permitting nuclear energy takes many years at the federal level, the earliest a nuclear project could be brought online in Illinois would be in the 2030s.

Environmental, safety issues

Critics of the bill and of nuclear power remain worried about its implications.

David Kraft, an outspoken critic of nuclear energy and head of the Chicago-based advocacy group Nuclear Energy

Only one in five victims will survive a tractor rollover accident. The leading cause of farm related deaths in Illinois is tractor rollover accidents. They account for more than 30% of farm related deaths. ROPS help protect farmers and family members from being crushed in the event of a tractor turnover or rollover.

Safety Chairman, Dan Robbe, states, "Safety is a priority of the farm bureau, and we would like to encourage our members to install ROPS on their tractors".

Jo Daviess County Farm Bureau members who purchase a ROPS could receive a reimbursement of \$250 towards the purchase of a ROPS (there are six rebates

are available). To receive the \$250, members need to bring in their paid invoice to the Farm Bureau office in Elizabeth. Customers are responsible for the cost, freight, and installation which are available through the dealer. If you have been thinking about putting a ROPS on one of your tractors, now is the time! Injuries present new opportunities for 2023-2024 Wildcats

The River Ridge Wildcats found themselves down a player before the 2023-2024 boys basketball season even started. With only one other returning starter from last year, there are plenty of opportunities to go around for some new Wildcats.

"Unfortunately, we are not healthy to start this season," River Ridge head coach Jeremy Knauer said late in the offseason. "Our only All-Conference player from last year, senior George Winter, is most likely going to miss the entire season after shoulder surgery. That's a huge loss for us and we can't replace that with just one per-

son," Knauer explained.

The Wildcats do have a plan of attack, however, and there are plenty of reasons to be excited about this year's squad. First and foremost, the Wildcats return Seth Nicholas, a senior who started last season. Nicholas is one of the players the Wildcats count on to do the dirty work. Last year, Nicholas averaged just over five points and five rebounds per game. This season, River Ridge should expect him to lean further into his leadership role.

Outside of that, the Wildcats will be counting on an exciting group of newcomers. Tyson Heidenreich is the only other senior on the active roster. River Ridge

has a strong class of juniors coming in. Mason Smith, Camden Flack, Nate Haas, and Logan Keleher all expect to see minutes during their junior season. Knauer also expects sophomore Sam Rife and freshman, Kaden Bauer to get opportunities this year.

Knauer recognizes the challenges that lie ahead for the Wildcats. "We have some younger kids that are going to have to collectively step up for us," Knauer said. Often with youth comes growing pains, learning lessons, and all the typical struggles of fighting through a varsity season. It also means potential.

This year, Knauer is hoping the team's potential can

lead to a step in the right direction for the program. "We probably have more upside than the last few years," Knauer shared. Just last season, the Wildcats finished with an overall record of 14-15. That was Knauer's first year as the head coach of the varsity team. Knauer is plenty familiar with his newcomers from previous years, however, and he has faith in their basketball talent. "Our guards have potential to score, and we have some size in our frontline. Last season, we didn't have a player score 20 points in any game. We have several that have that ability on any given night," Knauer added. The Wildcats are going to need that. Win-

ter was the leading scorer from last season and without him, River Ridge lost almost all their offensive production.

Knauer explained that the young Wildcats still have some work to do, but they have the potential to compete with some of the better teams. The River Ridge coach explained that the Wildcats will have to do the little things, like playing defense and taking care of the ball. "The key for us will be on defense and taking care of the ball. We have to cut down on the turnovers. If people can do that and guard the paint and three-point line, we have a chance this year to surprise some people," Knauer said.

Knauer and the Wildcats still recognize the challenge of playing basketball in this area. "This year is very balanced, especially our conference. Scales Mound is still the team to beat," Knauer said. The River Ridge head coach also mentioned, "East Dubuque looked terrific over the summer and Galena and Warren are going to be tough. I also see Eastland and Lena-Winslow being very strong as well."

On Nov. 25 the Wildcats begin regular season play when they travel to face off with the Dakota Indians. A few days later, the Wildcats play their first home game as the Polo Marcos come to town on Nov. 28.

Hornets appear for another impressive basketball season

Last year, the Scales Mound Hornets had to replace nearly all of the team that took them to the state tournament in 2022. Scales Mound responded by taking a new group all the way back to the state tournament for a second-place finish in 2023.

This season, the Hornets get the best of both worlds as they return a full group of experienced winners.

Nine players are back from last year's state tournament team as they lost just two starters to graduation. This season the Hornets are led by a deep class of upperclassmen in Thomas Hereau, Jonah Driscoll, Max Wiene, Evan Cogan, Seth Birkett, and Travis Wallin.

Hereau was a First Team All-State player last year, and he's coming off a state championship in his fall golf season. Scales Mound Head Coach Erik Kudronowicz calls Hereau a "strong player with a variety of skills and is an excellent jump shooter." We saw that last year when Hereau averaged nearly 17 points per game. This year, Kudronowicz is expecting Hereau to take an increased role as one of the team's primary guards. Kudronowicz went further in depth on Hereau stating, "He is an instant offense player for the Hornets. Thomas is a great shooter that knocks

down open shots, runs the court, and takes players off of the dribble. Thomas can and will impact a game in a variety of ways." Hereau also set the Scales Mound record for points in a season with 655 last year, and you can bet he has got his eyes on that record again in 2023-2024.

Driscoll also returns off an impressive year. Driscoll is a team captain this year as he enters his fourth season on the varsity squad. Much like Hereau, Driscoll is expected to see an increased roll this year as Kudronowicz said, "Jonah is a very skilled post and perimeter player. He can score in a variety of ways." The Scales Mound coach added that Driscoll is a "tremendous passer with a great feel for the game."

Wiene is the third returning starter for the Hornets. Wiene is a defensive asset for the Hornets and Kudronowicz is hoping to see his offensive game continue to develop this year. "We look for Max to do more this season due to graduation," Kudronowicz shared.

Scales Mound also returns a handful of key players from last year's bench. Evan Cogan was one of their first guys off the bench, and he's expected to join the starting lineup this year. Kudronowicz called Cogan "a tremendous defender

with toughness." There is no doubting that, as Cogan has fought back from two ACL tears in each knee and the Hornets are hoping he can stay healthy this year. "Evan is a tremendous shooter from deep and mid-range. Evan has developed into a tenacious defender that plays with leverage," Kudronowicz shared.

Birkett was another first player off the bench last year. Much like Cogan, Birkett is expected to join the starting lineup in his senior year. Birkett can score from all three areas and the Scales Mound coach said, "Seth does a little bit of everything for us and can play multiple positions. He is a Swiss army knife when it comes to using him on the court."

Scales Mound also return a couple key juniors in Derrick Distler and Connor Ellis. Distler was the leading scorer on last year's JV team and Ellis "will give depth to the back court" according to Kudronowicz. The Hornets also return Kaden Deurr who earned a spot as one of the

varsity reserve players as a freshman. In Deurr's sophomore year, Kudronowicz says he is "a tremendous shooter" who can assume the point guard position and is a high IQ player.

The Hornets are one of the deeper teams around in terms of not only experience, but winning experience. Kudronowicz believes the Hornets may have the best backcourt in the area with Hereau, Cogan, and Distler. On the team as a whole, Kudronowicz said, "This group of Hornets are tireless workers and are very involved with playing basketball outside of the season. The team has been in numerous tournaments and leagues to sharpen their skills."

It is no wonder Kudronowicz mentioned the team's experience when talking about their strengths. Over the last two seasons, this group helped the program earn an overall record of 69-9. They also sport veteran players in key positions, while having a ton of exciting players ready to earn

new roles on the bench. This year, the Hornets will have two sophomores and a freshman who are expected to round out the varsity team. Sophomore Aidan Soppe stands six feet, three inches tall and is well rounded with ball handling, passing, and shooting skills. Kudronowicz has high praise for Soppe, as he compared him to Nikola Jokic of the Denver Nuggets. Freshman Payton Van Lent is also joining the varsity squad and Kudronowicz called him a "very

skilled guard."

After opening their 2023 season in the Scales Mound Turkey Tournament, the Hornets will play against Shullsburg on Tuesday, Nov. 28 at Scales Mound high school. On Saturday, Dec. 2 the Hornets start the new month by facing off with Belleville in the Stateline Shootout, also in Scales Mound. Finally, on Wednesday, Dec. 6 things pick up as the Hornets travel to Pecatonica to face off with the Indians at 7:15 p.m.

Information Service, urged lawmakers at a Thursday committee meeting to reject the bill.

Kraft said he was concerned about the lack of existing SMR installations and the unproven nature of the technology. While some nuclear reactors of this scale do exist in other countries, no commercial SMRs have ever been built in the United States.

"This isn't an energy policy, it's a Las Vegas craps shoot," he said during the committee hearing.

In a follow-up interview, Kraft said that SMRs bring with them security concerns, as the smaller installations have different staffing requirements than traditional reactors and use a more highly enriched type of uranium. This relative abundance of this uranium, according to Kraft, could incentivize the further proliferation of nuclear weapons.

Some environmentalists also lined up against the bill, worrying that investment in nuclear could take away from investments into renewable energy technology. Sierra Club Illinois chapter director Jack Darin called nuclear energy "at best, a distraction." Sierra Club was one of the main advocacy organizations that sought Pritzker's veto of the previous bill.

While the Sierra Club remained opposed to the updated version of the bill, the Illinois Environmental Council - which co-signed a letter requesting the August veto with the Sierra Club—adopted a neutral position on the new bill before it was approved on Thursday.

Rep. Lilian Jimenez, D-Chicago, was one of the eight House Democrats who voted against the bill. She said that there had not been enough study of the potential drawbacks of SMR development in the state.

"Illinois has plenty of time to assess the risks and costs

before opening the door to these projects," Jimenez said during floor debate. "I believe we should be focusing on this piece before taking this huge leap and this huge step."

Industry issues

Since 2016, five other state legislatures have either repealed or weakened their bans on nuclear construction. Counting Illinois, bans on nuclear construction remain on the books in 11 states.

Several of the states that have lifted their bans in recent years have done so to pave the way for SMR technology. But the biggest player in that industry has seen several upsets in recent weeks.

As lawmakers debated the bill, NuScale Power—the only company with a federally approved SMR design—announced that it was canceling its highly watched "Carbon Free Power Project" in Utah, which would have been the first commercial project with a NuScale reactor.

The project's cancellation comes after months of falling stock prices and criticism from trading firms. Still, its leaders say the company will continue with its other projects, which are at various steps of regulation and planning.

"NuScale will continue with our other domestic and international customers to bring our American SMR technology to market and grow the U.S. nuclear manufacturing base," NuScale CEO John Hopkins said in a Wednesday news release.

Rezin noted that "there's a lot to learn" from NuScale's canceled project, but hopes Illinois' and other states' moves to reverse their construction bans will encourage nuclear energy development in the U.S.

"If we do not build out this technology with companies that are in the United States, there's other companies and countries such as Russia that are looking to sell that technology," she said. "We don't want that."

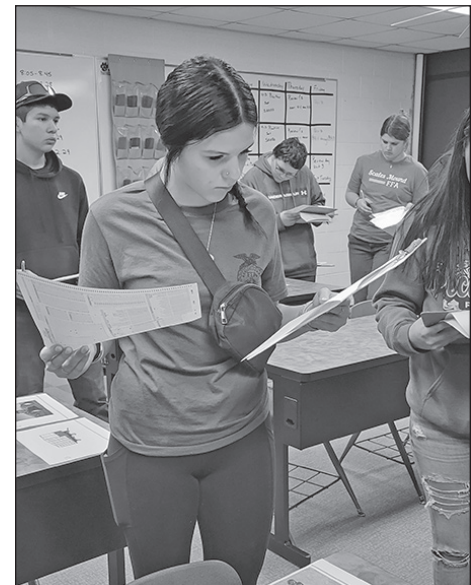

IDNR awards \$392,150 in snowmobile trail grants

Seven snowmobile trail projects in Illinois have been awarded \$392,150 for the development, rehabilitation, and maintenance the trails.



The grants come from the Illinois Snowmobile Grant program (SNOW) and the Snowmobile Trail Establishment Fund Grant program (STEF).

Snowmobile Clubs – \$57,500 for consistent trail markings and signage, maintenance and operational expenses.

SNOW grant recipients are:

- Freeport Park District – \$39,150 for rehabilitation and maintenance of the trail for snowmobile use.
- Freeport Park District – \$120,000 for purchase of a tractor to groom snowmobile trails.
- Lake County Forest Preserve District – \$29,000 for replacement of snowmobiles and trailer for park rangers so they can perform routine patrols.
- McHenry County Conservation District – \$30,000 for rental of a tractor for maintenance, operation expenses, and trail signage.
- Rockford Park District – \$40,000 for operational and maintenance expenses, rental tractors, and snowmobile trail equipment

SNOW provides financial assistance to eligible local units of government (Section 3010.10 of the Illinois Administrative Code) to assist them in the purchase, construction, maintenance and rehabilitation of public snowmobile areas, trails and facilities in Illinois. The program is funded entirely by snowmobilers through their registration fees (625 ILCS 40/8-1 and 9-1).

STEF grant recipients are:

- Illinois Association of Snowmobile Clubs – \$76,500 for trail maintenance and operational expenses.
- Illinois Association of

STEF provides financial aid to eligible private snowmobile clubs and organizations in Illinois (as noted in Section 3020.10 of the Illinois Administrative Code) for the purpose of assisting them in the construction, maintenance, and rehabilitation of snowmobile trails and facilities on public lands, designated roadways, or private land opened to such use. Funds for the program are derived from revenue generated in the state treasurer's Snowmobile Trail Establishment Fund.

Illinois hunters harvest 262 turkeys during 2023 fall firearm season

Hunters in Illinois harvested a preliminary statewide total of 262 wild turkeys during the 2023 fall firearm turkey season. The season dates were Oct. 21-29.

The 2023 total compares with the statewide turkey harvest of 267 in 2022. The record harvest was set in 2005 when 1,218 birds were harvested.

This year, 1,711 regular fall firearm season permits were sold compared to 1,727 last year. The highest permit sales total on record was in 2007 with 4,968 permits sold.

Fall turkey firearm was open in 56 of Illinois' 102 counties. The top counties for harvest this year were Jo Daviess, 23; Marion, 14; Williamson, 14; Franklin, 13; and Pope, 12. Preliminary data show 55% of the harvest were female birds and 48% were male.

The information below includes the preliminary 2023 county-by-county fall firearm turkey harvest results with comparable totals for 2022.

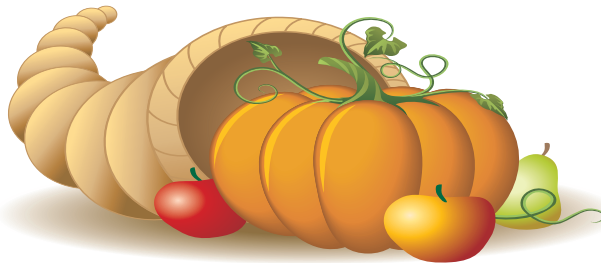

Orangeville-Aquin boys looking to get back on track in 2023-2024 season

Things looked promising for the Orangeville-Aquin Broncos during the first two seasons of Josh Fahs' tenure as head coach. After two seasons, Fahs and the Broncos held an overall record of 20-16 as the program appeared to be heading in the

right direction. After a 3-27 2022-2023 season, Fahs and the program took a step back. This year, the Broncos are hoping to restore their status as a competitive team.

Fahs is entering his fourth season at the helm of the program and, after the three-win season last year, his overall record at Orangeville

dropped to 23-43. The personal record doesn't necessarily matter to Fahs, but it is an indication of the direction of the program. Fahs has hopes of bouncing back after the down year, as he said he plans to "get [the] program back to the hard-working, defensive-minded team we were in [his] first two years

at Orangeville."

Despite Fahs and the program building together over the last few years, it's almost like everyone gets another fresh start. Fahs wants to hit the ground running as the Orangeville-Aquin coach hopes to "create a successful co-op with Aquin for [their] first year together."

Orangeville-Aquin is already seeing the benefits of their co-op in practice. "The first two weeks of practice have been competitive so far, with the team realizing a co-op and more players means much more competition for varsity roster spots, starting spots, and playing time,"

Fahs shared.

Last year, Aquin finished with an overall record of just 4-26. Although neither team posted a flashy record, the hope is that Aquin and Orangeville can combine their returning experience and turn the page in the 2023-2024 season.

Cody Wirth (guard), Brock Tyrrell (forward), Ben Briggs, (center), Boden Gustafson (center), Jaxon Grillot (guard), Paxton Bastian (forward), Miklo Webb (forward), and Blake Folgate (forward) all return with varsity experience under their belts. With so many returning athletes, the Broncos should see improvement this season. Fahs acknowledged the program has "much more experience than last year, good depth inside and outside, and a lot of offensive potential."

Scoring is flashy, but the Orangeville-Aquin head coach believes they will have to improve defensively if they want things to turn around. When asked about the team's needs for improvement, Fahs mentioned their defense and rebounding.

For now, the Broncos are keeping things simple in the

first year of their co-op. They are alleviating the pressure focusing on the little things with hopes of being competitive. At the end of the day, Fahs and the Broncos want to compete. When asked about the team's goal for this year, Fahs said, "Be competitive and give ourselves a chance to win every game."

The Broncos will also need a handful of newcomers to step things up if they want to see improvement. Brant Carlson (forward), Anthony Garcia (guard), Joe Isenberg (guard), and Film Pimsen (guard), are all expected to get opportunities at the varsity level this season. With so much competition for playing time, these newcomers have a great opportunity to work their way into the mix.

The Broncos opened their 2023-2024 by competing in the Scales Mound Turkey Tournament. On Nov. 21, they faced off with the River Ridge Wildcats. On Saturday, Nov. 25 the Broncos get another tough matchup as they battle the Scales Mound Hornets at 3:15 p.m. Then, on Wednesday, Nov. 29 at 7:30 p.m., the Broncos play host to the Stockton Blackhawks for their first home game of the season.

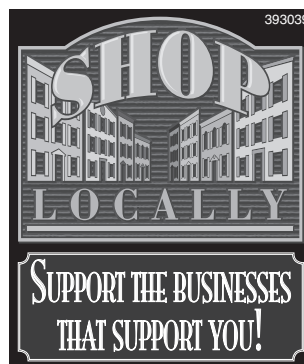

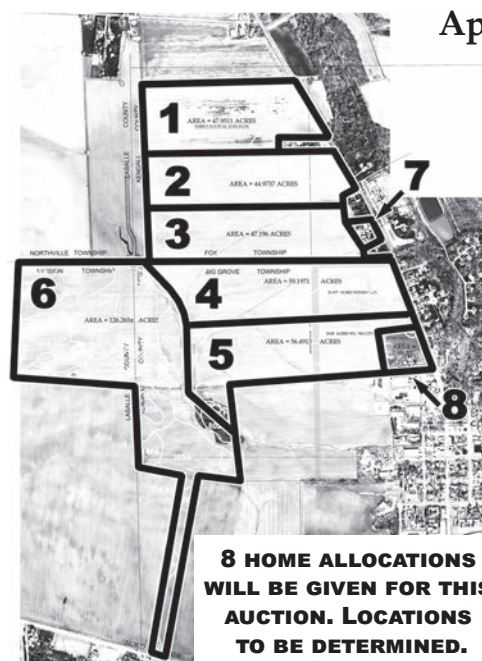

Lawmakers pass bill aimed at modernizing professional licensing in Illinois

CAPITOL NEWS ILLINOIS

As Illinois faces shortages of health care practitioners and mental health professionals, the state agency in charge of licensing for those and more than 100 other industries has struggled to keep up. The Illinois Department of

Financial and Professional Regulation has failed to meet its goals to speed up both initial licensing and renewals in key industries as applications to the agency grew by 15 percent between 2019 and 2022.

IDFPR's director called the situation a "crisis" earlier this fall when testifying before

lawmakers at a committee hearing on the issues facing the agency.

The General Assembly recently approved a measure to help IDFPR move beyond its antiquated systems and—at least temporarily—assist

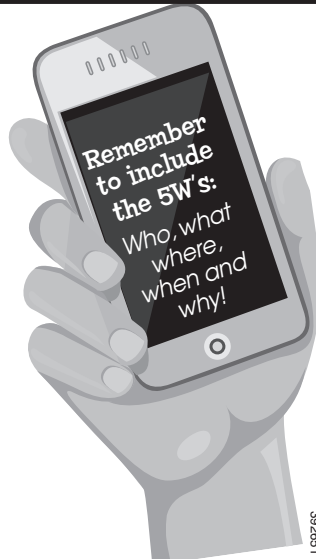

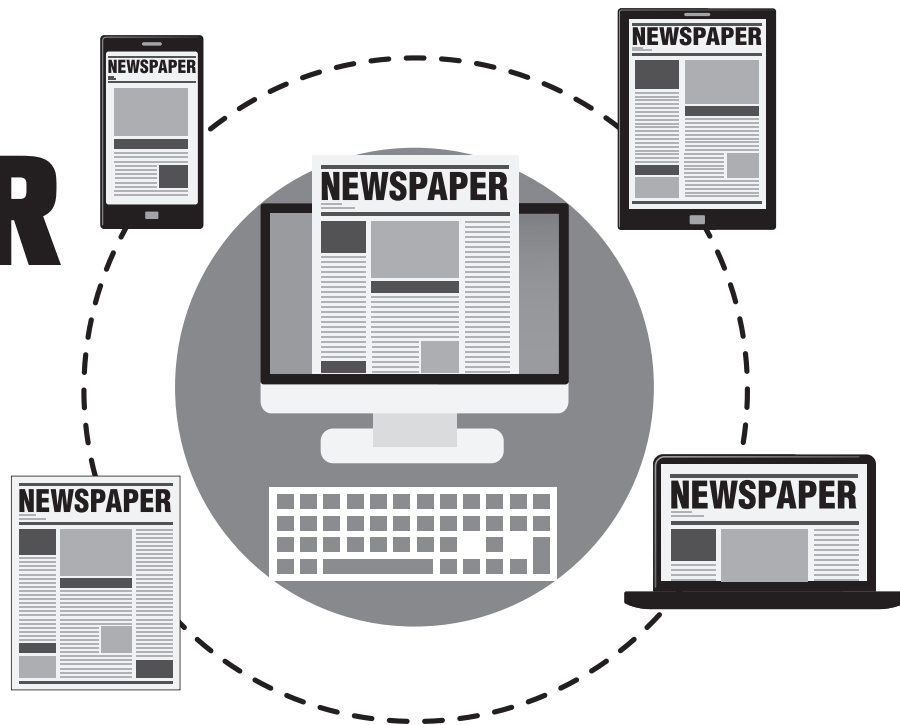

FROM LENA'S KITCHEN



The not so skinny cook

November has finally caught up with us. The beautiful sixty-degree days are probably behind us, and we will be wearing more clothes. Thanksgiving weekend will usher in all of the Christmas sales and trees will be going up. The recipes this week will work for the entire holiday season. Have a great week cooking!

Party Cheese Ball

This recipe makes two cheese balls. It is great to feed a crowd. You can make them

several days ahead also if you need to start early to get everything done.

1 pkg. (8 oz.) cream cheese, softened
2 C. shredded cheddar cheese

1 jar (5 oz.) sharp American cheese spread
3 T. finely chopped onion
1 t. lemon juice
1 t. Worcestershire sauce
Dash garlic salt
½ C. minced fresh parsley
½ C. chopped pecans, toasted

Crackers for serving

In a large bowl, beat the first 8 ingredients until blended. Cover and refrigerate until easily handled, about 45 minutes. Shape into 2 balls; roll in parsley and pecans. Cover and refrigerate for at least 2 hours. Remove from the refrigerator 15 minutes before serving.

Cranberry Delight

Enjoy a cranberry salad for the holidays. You can use this for both Thanksgiving and Christmas. It is easy because it isn't molded and is beautiful in a glass bowl for serving.

4 C. cranberries
1½ C. sugar
¾ C. water
1 envelope unflavored gelatin
¼ C. lemon juice
2 T. orange juice
1½ C. heavy whipping cream
3 T. powdered sugar
1 t. vanilla

In a saucepan, bring the cranberries, sugar, and water to a boil. Reduce heat and cook until cranberries burst. Strain through a sieve into a large glass serving bowl. Stir in the gelatin, lemon juice and orange juice. Cool until mixture coats the back of a spoon. In a small cold bowl, whip

cream until soft peaks form. Add powdered sugar and vanilla. Gently fold in cranberry mixture. Chill until set.

Chubby Sweet Potatoes

If you want an easy way to make sweet potatoes, this recipe is for you. You can make the sweet potatoes the day before and assemble them quickly before serving the meal.

8 sweet potatoes (about 4 cups)
½ C. packed brown sugar
½ t. cinnamon
½ t. ground nutmeg
¼ t. ginger
8 T. unsalted butter at room temperature
½ C. boiling water
Pecans for garnish

Heat oven to 325. Grease a 9 x 13 baking dish. In a pot of salted water, cover po-

tatoes completely and cook until tender about 25 minutes. Drain and rinse in cold water. Peel and slice potatoes into ¾ inch slices. Combine the sugars, chopped, pecans, and spices. Layer 1/3 of potatoes in baking dish; sprinkle with 1/3 of the sugar mixture over the potatoes. Repeat layering twice. Pour boiling water around potatoes. Bake until potatoes are tender, basting several times (about 45 minutes.) Sprinkle more pecans for garnish.

Scrumptious Green Beans

If you want a lighter alternative to the traditional green bean casserole, this vegetable is easy to make and tasty too. If your crowd is not a pepper fan, leave them out.

2 T. olive oil
1 medium onion, finely chopped
1 garlic clove, minced
1 lb. green beans, trimmed and cut into 2-inch pieces
¼ t. Lawry's seasoned salt
¼ t. pepper

Finely chopped red pepper
In a nonstick skillet, heat olive oil over medium heat. Add onion and garlic; cook, stirring until softened, about 3 minutes. Add beans, salt and pepper; cover. Cook stirring occasionally until beans are crisp tender, about 6 minutes. Transfer to a platter and top with red pepper.

Turkey Tetrazzini

If you have some leftover turkey, this dish is a good one because it is simple and easy. It has a creamy and cheesy sauce with meat and vegetables. You can also freeze turkey to use later.

1 pkg dry spaghetti
3 T. olive oil, divided
1 C. onion, finely chopped
1 lb. mushrooms, thinly sliced
2 T. garlic, minced
2 t. salt
½ t. pepper
¼ C. flour

2 ½ C. chicken broth
1 T. lemon juice
2 C. heavy cream
2 C. baby spinach
3 C/ chopped turkey
½ C. shredded mozzarella
1 t. fresh parsley, finely chopped

Preheat the oven to 350. Bring a large pot of salted water to a boil over medium high heat. Add spaghetti and 1 T. olive oil. Cook until al dente, about 10 minutes. Drain the spaghetti in a colander and rinse under cold water. Set aside in pot.

Heat remaining 2 T. olive oil in a large saucepan for 2 minutes over medium high heat until the oil sizzles. Add mushrooms and sauté until

golden brown, about 4 minutes. Stir in onion and garlic and sauté until fragrant, about 2 minutes. Add salt, pepper, and flour. Stir well to combine, about 1 minute. Pour in chicken broth and lemon juice and whisk until the sauce is smooth. Whisk in heavy cream and bring the sauce to a simmer over medium heat; let simmer and stir until thickened, about 5 to 8 minutes. The sauce should be the consistency of gravy. Remove from heat and stir in spinach until wilted, about 1 minute. Add cooked spaghetti and turkey. Toss well until fully combined and coated.

Transfer to a greased 9 x 13 pan and evenly top with mozzarella cheese. Lightly grease a piece of aluminum foil with cooking spray and place over casserole to prevent the mozzarella from burning. Bake covered for 25 minutes. Remove the foil and bake uncovered another 15 minutes or until the melted cheese turns golden and bubbly. Let the casserole rest for 10 minutes before serving. Garnish with chopped parsley.

Pumpkin Spice Cake

This cake is known as a "Thanksgiving Cake" because it is a tasty alternative to pie, but it can be eaten any time in the winter. It is easy because it uses a cake mix and pudding. Place it on a cake stand, and it is a beautiful dessert.

1 pkg. spice cake mix
3 large eggs, room temperature

1 C. canned pumpkin
½ C. water
½ C. canola oil
1 pkg. (3.4 oz.) instant vanilla pudding mix
1 t. cinnamon
½ C. chopped pecans
Cream Cheese Frosting
4 oz. of cream cheese softened

½ stick unsalted butter
2 ½ C. powdered sugar
1 t. vanilla
Milk to make a pour able consistency

Preheat the oven to 350. Grease and flour a 10-inch fluted tube pan. In a large bowl, combine the dry cake mix, eggs, pumpkin, water, oil, pudding mix and cinnamon. Beat at medium speed for 5 minutes. Stir in pecans. Pour into prepared pan. Bake until a toothpick inserted in the center comes out clean, 45 to 50 minutes. Cool 10 minutes before removing from pan to a wire rack to cool completely.

Frosting: In a mixer, combine the cream cheese and butter until fluffy. Add powdered sugar and vanilla and

those awaiting license renewal. The measure cleared the General Assembly unanimously and needs only a signature from the governor to become law.

State Rep. Bob Morgan, D-Deerfield, who sponsored the bill in the House, said with legislative approval, IDFPR would be able to batch-renew licenses for those who've been waiting "not days, not weeks, but months—up to six to eight months."

House Bill 2394 also calls for IDFPR to contract with a technology vendor to build a new computer software system within three months of Gov. JB Pritzker's signature on the bill, and to have that system up and running three months after that.

In a September hearing, IDFPR Secretary Mario Tretto Jr. told lawmakers his agency is hamstrung by 1990s-era technology that doesn't allow the agency to add new types of licenses to its online system, even as more types of profes-

sional licensure have come under the agency's purview.

As a result, IDFPR has seen "an onslaught of paper applications," Tretto said, contributing to "historic wait times." A sizeable number of the 104,000 total applications the agency received last year were submitted on paper via snail mail.

Earlier this year, the agency had been in talks with an existing state vendor that's already under a "master contract," which would have sped up the often-slow process of contracting with a new company. But in the September hearing, Tretto revealed the agency had walked away from those talks once IDFPR leaders realized the vendor wouldn't have been able to meet the agency's specific needs.

"And candidly we were quite disappointed with the news," Tretto said.

In that same hearing, leaders of industry groups aired their frustrations with IDFPR's licensing delays.

Daniel Stasi, a consultant with the Illinois Mental Health Counselors Association, noted he's been the point person for licensing-related issues for 24 years.

"Very little has changed," Stasi said in September. "The wait is actually longer."

Illinois State Medical Society executive senior vice president David Porter told lawmakers that the most concerning aspect of IDFPR's current licensing system is the "lack of transparency" from the agency.

"Applicants tell us that there's no real way for them to obtain status updates on their applications or renewals, and there's virtually no chance to be able to connect with someone at the department by phone or email who can provide such updates," Porter said. "Most frustrating to new applicants is that they are rarely notified when their applications are deemed to be insufficient or incomplete, which adds days or weeks to when they can expect to obtain a license."

Tretto assured lawmakers he's been speaking with his counterparts in other states to get ideas about how to improve IDFPR's systems—and said Illinois isn't alone in facing licensure issues. But, he said, some states seem to have figured it out. Oklahoma, for example, has reduced its call volume by 95 percent.

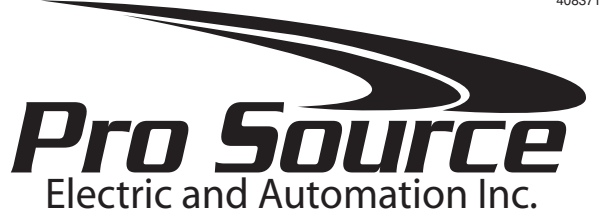

mix well. Add milk to make it thin enough to cover the cake and run down the sides.

Cover and refrigerate overnight. Cut into 15 squares. Top with whipped cream sprinkled with cinnamon.

Pumpkin Shortbread Dessert

This dessert feeds a crowd of people and again is easier than making pies. Enjoy this nontraditional dessert for the turkey day.

- 1 3/4 C. sugar, divided
- 1 1/2 C. flour
- 1/2 C. butter
- 4 large eggs, lightly beaten
- 1 can (29 oz.) solid pack pumpkin
- 1 t. salt
- 1 t. cinnamon
- 1 t. ground ginger
- 1/2 t. ground cloves
- 2 cans (12 oz. each) evaporated milk
- Whipped cream with cinnamon for garnish

Preheat the oven to 425. In a bowl, combine 1/4 C. sugar and flour; cut in butter until the mixture resembles coarse crumbs. Press into an ungreased 9 x 13 baking pan. In a separate bowl, combine the eggs, pumpkin, salt, spices, and remaining sugar. Stir in milk. Pour over crust. Bake for 15 minutes. Reduce heat to 350; bake for 50 to 55 minutes longer until filling is set. Cool on a wire rack.
