# Illinois ranks as No. 1 soy, No. 2 corn producing state for 2023

Illinois once again produced some of the largest crops of any state in the nation despite drought and other weather challenges last year, according to USDA's crop production report released Jan. 12.

Prairie State farmers produced 648 million bushels of soybeans in 2023 (down from 2022 but the most of any state nationwide) and 2.27 billion bushels of corn (up slightly from the previous year and the second-most nationwide behind Iowa).

Statewide, yields averaged 206 bushels per acre for corn in 2023 (up 3 bushels from the November estimate but down 8 bushels from the 2022 record) and 63 bushels for beans (up 2 bushels from November and even with last year).

The trend of higher-than-expected yields was also evident nationwide in USDA's annual crop summary.

U.S. corn production was pegged at 15.3 billion bushels last year with an average yield of 177.3 bushels per acre, both records. Soybean production totaled 4.16 billion bushels last year (down 2 percent from 2022) with an average yield of 50.6 bushels (up 1 percent from the previous year).

"It's a bearish one this year, at least from the reaction so far," Joe Camp, of CommStock Investments, told the RFD Radio Network after the release of the report. "I think it was triggered first off by these higher yield estimates."

USDA raised corn yield estimates from its previous report by 9 bushels in Nebraska, 4 bushels in Minnesota and 1 bushel in Iowa, along with the boost in Illinois. Iowa finished with a final corn yield estimate of 203 bushels per

acre while Indiana was right behind at 201 bushels.

"Those are big states that really add extra production," Camp said. "It's hard to reconcile after the year we had."

"No doubt this crop ended up better than we feared it was going to be," he continued. "Still, to see states like Iowa be ahead of where they were a year ago is hard to put together."

Futures prices for corn, soybeans and wheat all closed the week on a down note following the release of the report.

"It can be a relief this report is out of the way, with an outlook toward higher seasonal prices normally leading us into spring," Camp said. "But there's nothing really friendly to talk about on this crop report."

As for crop inventory, USDA pegged stocks in all positions as of Dec. 1 at 12.2 billion bushels of corn (up 13 percent from the previous year), 3 billion bushels of beans (down 1 percent) and 1.41 billion bushels of wheat (up 8 percent).

USDA also released its winter wheat seedlings report on Jan. 12. It pegged all winter wheat plantings for the 2024 crop at 34.4 million acres, down 6 percent from the previous year.

Seedings of soft red winter wheat totaled 6.86 million acres, down 13 percent from 2023. But Illinois farmers bucked that trend and planted 860,000 acres of winter wheat last fall, up 2 percent from the previous year and up significantly from 650,000 acres in 2022, USDA reported.

# Illinois proposal calls for expanding vote-by-mail

State representative proposes measure that would allow all-mail elections in some areas

As the 2024 election season draws near, voters in Illinois will once again choose whether they want to cast their ballots in person or by mail.

But one lawmaker is proposing a bill in the Illinois House that could make that decision a lot easier, making voting by mail the default option for people in counties and cities that choose to go that route.

State Rep. Carol Ammons, D-Urbana, said voting by mail has been shown to be a more convenient and efficient way of running elections.

"Vote-by-mail has been proven by way of court order, as well as people's utilization of vote-by-mail—I vote by mail—that it has been safe," she said during an interview.

"There have been no problems. I have not missed a single election. And people who use it increase their voter participation."

Voting by mail, often referred to as absentee voting, was originally intended for people who planned to be away from home on Election Day, particularly military personnel, as well as college students and people whose jobs required them to travel. That often required voters to ask their state or local election official for an absentee ballot and, in some cases, explain why they wanted to vote by mail.

In more recent years, Illinois and other states have made voting by mail an option for anyone by adopting "no-excuse" absentee voting laws, meaning anyone could request a mail ballot without

giving a reason.

Illinois also gives voters the option of asking to be placed on a permanent vote-by-mail list so they can automatically receive a mail-in ballot without having to fill out a new request for one each election cycle.

And in 2020, amid the COVID-19 pandemic, the General Assembly passed a law requiring local election officials automatically send vote-by-mail applications to every voter in their jurisdiction, instead of requiring voters to ask for one.

During a special meeting of the House Ethics and Elections Committee held recently in her hometown of Urbana, Ammons said voting by mail has become increasingly popular. But she said the multi-step process of voting by mail is still inefficient

because it requires voters to fill out and send in a vote-by-mail application to receive a ballot.

"But when we went back to look at the utilization of the ballots, the number that came back, and the cost associated with mailing a ballot, we realized as we talked to other jurisdictions that you would actually save the money if you simply mailed them the ballot," she said.

Ammons is the sponsor of House Bill 4198, which would allow county clerks and other local election authorities to make voting by mail the default option in their jurisdiction. It would give them the option of mailing ballots to all registered voters in their jurisdiction, without requiring voters to ask for one. But it would still require local election authori-

ties to offer in-person voting as well for those who prefer to cast their ballot in person.

Currently, eight states and Washington, D.C., operate elections almost entirely by mail. William Cavecche, an election administrator in King County, Washington, which includes the city of Seattle, said that state passed a similar law in 2005 and immediately, two-thirds of the counties in the state shifted to vote-by-mail systems.

"Speaking to someone who has run both polling-place elections and vote-by-mail elections, I can tell you from experience that vote by mail elections are significantly easier to administer," he said.

Among other benefits, Cavecche said, in a vote-by-mail election, there is no need to worry about problems that commonly occur at in-person

polling places such as running out of ballots, voting machines breaking down or poll workers failing to show up.

He also said vote-by-mail elections are more secure because all ballots can be counted in a centralized location. He said ballot counting can also be livestreamed on the internet to provide more public transparency.

The meeting was a subject matter hearing, meaning the committee only heard testimony and did not take action on the bill. But Rep. Maurice West, D-Rockford, who chairs the panel, said he intends to hold additional hearings during the legislative session, which began Jan. 16, and it's possible lawmakers could vote on the measure in time to take effect for the 2024 general election in November.

# As recreational cannabis sales again hit record, Illinois AG calls for federal rescheduling

As Illinois' recreational cannabis industry once again reported record sales for 2023, the state's attorney general is calling on the federal government to reclassify the substance.

The U.S. Drug Enforcement Agency classifies cannabis as a Schedule 1 drug, meaning the federal government believes it has "no currently accepted medical

use and a high potential for abuse."

But Attorney General Kwame Raoul and his counterparts in 11 other states are calling on a reclassification to Schedule 3, meaning it has "a moderate to low potential for physical and psychological dependence."

Raoul and the other attorneys general said the reclassification would allow states to continue to "set the standard"

for legal products, would allow businesses to take ordinary tax deductions, and would increase the ability to research the substance to fully determine its effects.

"Illinois is one of several states that have established robust regulatory frameworks for legal cannabis sales," Raoul said in a news release. "State-regulated cannabis industries protect consumers from the dangers of unregulated products and the illicit market. Rescheduling cannabis will remove obstacles for legitimate businesses and allow them to better collaborate with law enforcement and regulators."

Last year, Illinois recreational cannabis dispensaries sold a record \$1.6 billion of product, accompanied by a record number of sales to Illinois residents.

Sales to out-of-state residents, however, fell by \$71 million from 2022's total, marking the first drop in that category since cannabis was legalized on a recreational basis in January 2020.

The growth in 2023 marked a 5 percent increase from the year prior, meaning the pace of the industry's growth is slowing. From its first year of legalization to its second, sales grew by 106 percent, while in 2022, growth was

marked at 12 percent from the year prior.

## Lawmakers introduce bill to create state prescription drug price oversight board

A new bill in the Illinois General Assembly would create a board of health care experts that would have the authority to set price limits on prescription medications.

House Bill 4472 was introduced Jan. 17 by Rep. Nabeela Syed, D-Palatine, and Sen. David Koehler, D-Peoria.

Using a variety of information related to the medication's market, including the number of people taking the medication and its out-of-pocket cost, the board would assess its price. If the board finds it to be unreasonable, it could limit the amount wholesalers, pharmacies and hospitals can bill insurers and consumers for the drug.

The bill's sponsors said it was an effort to limit health care costs across the board.

During the hearing, I took the opportunity to question Timi Harda, a Client Partner and Senior Executive for West Virginia IBM, and Dr. Richard Levin, the former President of Yale University and a Senior Advisor to Coursera, on the importance of workers who are Skilled Through Alternative Routes (STARs).

This category of workers does not have a bachelor's degree but have acquired valuable professional skills

# Lawmakers clear path for assault weapon registration rules

*Some members record symbolic objection, saying rules are too vague and complicated*

New permanent rules will soon go into effect spelling out how people who own assault weapons and related items that are now heavily regulated in Illinois can register them with the Illinois State Police.

The legislature's Joint Committee on Administrative Rules voted along party lines Jan. 16 to let the rules go into effect, ending months of negotiations and debate between supporters of the law and gun rights advocates.

"Obviously, this is an issue where there is a difference of opinion on a partisan basis, and I think you saw that play out today," Sen. Bill Cunningham, D-Chicago, a co-

chair of the committee, told reporters after the meeting.

The rules are the result of an assault weapons ban that state lawmakers passed last year in the wake of a deadly mass shooting at an Independence Day parade in Highland Park in 2022.

That law, known as the Protect Illinois Communities Act, bans the sale, purchase, manufacture, or possession of a long list of firearms that are defined as "assault weapons," as well as several types of attachments, large-capacity magazines and certain kinds of high-power ammunition.

Under that law, people who already owned such items before the ban took effect are allowed to keep them. But to do so legally, they were sup-

posed to register those items with the Illinois State Police before Jan. 1.

Last fall, ISP published temporary "emergency" rules that went into effect Oct. 1, enabling people to begin filing online registrations ahead of the Jan. 1 deadline. But many gun owners, gun rights advocates, and state lawmakers pushed back against the rules, complaining that they were too vague in some areas, too complicated in others, and generally impossible to comply with.

In response, ISP held additional public hearings in October and November as it worked to craft permanent rules.

One of the concerns raised during the discussions focused on how ISP planned to collect and store information about the items people registered, and what the agency

would do with that information if the law is eventually overturned as unconstitutional.

So far, the law has survived legal challenges in both state and federal courts, but the National Association for Gun Rights, which is the major plaintiff in one of the federal lawsuits, has said it plans to file an appeal with the U.S. Supreme Court within the next several weeks.

Rep. Ryan Spain, R-Peoria, who also co-chairs the committee, said he was frustrated by the short timeframe used to adopt the new rules and by the way some issues were handled. He then offered a motion to prohibit ISP from adopting the rules, arguing that the rules do not meet a requirement in state statute that they be "simple and clear" so that people and groups affected by them can understand

them. That motion failed because it needed eight votes on the 12-member committee but only received six.

Spain then made a motion to "object" to the rules on the same grounds that they were not "simple and clear." An objection has little practical effect on the rule, except that it requires the agency to respond to the objection in writing within 90 days before the rule can take effect.

That motion, which only requires a simple majority of members taking part, passed on a 6-5 vote.

That vote allows ISP to move forward by adopting the permanent rules and enforcing them into the future. But it remains unclear how many assault weapon owners will comply with the law by registering those firearms.

According to data main-

tained by ISP, just under 30,000 individuals had filed registration forms ahead of the Jan. 1 deadline. Those registrations covered roughly 69,000 firearms that fall under the ban as well as nearly 43,000 accessories.

It is not known what percentage that represents of the total number of assault weapons and banned accessories in circulation in Illinois, but many people have suggested that a large number of gun owners will refuse to comply with the registration requirement.

Cunningham, however, said he was not concerned about speculation of widespread noncompliance with the law.

"I would just repeat what I said earlier, which is the law is in place, and I would encourage people to follow the law," he said.

Dr. Anthony Douglas, general surgery resident at University of Chicago, said he sees patients every day who struggle to afford their medication—some of whom cut their pills or skip doses to make their prescriptions last longer.

"I cannot effectively care for patients if they cannot afford the therapies necessary to keep them well," Douglas said at a Statehouse news conference to introduce the bill.

The five-person board would be appointed by the governor and work with a bipartisan 15-member coun-

cil of legislators and relevant experts to address the price of medications.

The board would be tasked with assessing high-cost drugs, like ones used to treat cancer, auto-immune disease, and diabetes, as well as other drugs that might impact the state health care system. The board members may receive compensation from a special fund created through an annual tax on prescription drug manufacturers.

The bill had not yet been assigned to committee as of Jan. 17, although House Speaker Emanuel "Chris" Welch signed on as a cosponsor.

through other means such as apprenticeships, internships, and previous work experience. However, due to automated hiring systems, which many companies use to help screen job applicants, applications by qualified workers who do not have a four-year degree are being filtered out, even when a bachelor's degree is irrelevant to the role.

This type of degree-based discrimination in hiring not only hurts skilled workers, but also businesses and our

entire economy by preventing us from making the most of our workforce. I introduced my bipartisan Opportunity to Compete Act to end this and help ensure that Americans who have developed the skills necessary to succeed in a job don't hit a 'paper ceiling' of being rejected simply because they lack a piece of paper in the form of a four-year degree. As we work to strengthen our middle class and our economy, it is critical that we expand apprenticeships and skills-based

education while also ensuring that the workers benefiting from them can reach their full potential so our economy can do the same.

## Supporting Taiwan's democracy and others against Chinese Communist Party interference

On Jan. 13, Taiwan successfully held free and democratic elections despite attempted interference, coercion, and threats from the Chinese Communist Party (CCP).

Beyond its significance as a single election, the stability of Taiwan's democracy in the face of the machinations of the CCP is an important example for the world's democracies as the CCP and similar totalitarian regimes continue their efforts to destabilize and weaken the free nations of the world, especially the United States.

To address these issues and discuss my work on them

as the Ranking Member of the Select Committee on the Strategic Competition Between the United States and the CCP, I joined a Politico discussion panel with my colleague Congressman Andy Barr, Yun Fan, a legislator and member of the Taiwanese Democratic Progressive Party, and Jason Hsu, Harvard Kennedy School Fellow and a former Taiwanese legislator.

As our discussion emphasized, while the threats posed by the CCP to Taiwan are unique as a matter of its close physical proximity to the People's Republic of China and their shared history, the CCP's political and economic coercion against Taiwan are indicative of the threats posed by the regime to other U.S. partners and allies in the region, as well as to our own country.

# Wildcats bounce back from loss to Pearl City

The River Ridge Wildcats have dropped back-to-back games just one time this season. The team's biggest strength is arguably the way they respond to their losses. That sentiment remained true when the Wildcats split games with Pearl City and Ashton Franklin-Center last week.

River Ridge entered the week with an overall record of 11-6. They were coming off victories over Belmont and Stockton. With another important game coming up against the Pearl City Wolves, it looked like the Wildcats had a chance to win their third in a row.

Pearl City entered their Jan. 18 matchup against the Wild-

Just two days later, the Wildcats were back in action with an opportunity to bounce back as they faced off with AFC. Once again, the Wildcats were the favorites on paper ahead of this matchup. AFC came into the game with a record of just 3-16. They were also riding an eleven-game losing streak at the time. The Wildcats hoped to avoid the trap game and keep AFC's losing streak alive when they met up on Jan. 20.

Walters came out bound and determined for a win as a pair of first quarter three-pointers helped him put up ten points in the opener. Defensively, the Wildcats held AFC to just five points in the quarter, allowing them to expand their lead even further. By the end of three, the Wildcats appeared well in control of the game with a 47-29 lead.

AFC wouldn't go away so easily, however. With a trio of

fourth quarter three-pointers, AFC managed to combine for 21 points in the fourth. It was almost enough to complete a miraculous comeback, but the Wildcats hit the shots they needed to.

River Ridge didn't shoot a great percentage at the free throw line, but they hit enough to win. In the fourth quarter alone, the Wildcats hit just six of their 13 attempts. On the game, River Ridge hit fifty-eight percent of their free throws, going 17 for 29 at the line.

In the end, River Ridge held on to win by a score of 60-50. Walters led the team in scoring with 20, while Dittmar and Winter each added 12. The victory improved the Wildcats' record to 12-7 on the season.

# Stockton boys fall to Scales Mound in NUIC matchup

Late last week, the Scales Mound Hornets and the Stockton Blackhawks faced off in an NUIC boys basketball matchup in the Hornets' nest.

The 2023-2024 boys basketball season has been very different for the Hornets and Blackhawks. Scales Mound has consistently been ranked among the top 1A teams in

Northern Illinois. Scales Mound recently took second place at this year's Martin Luther King Tournament, and they brought a record of 14-5 into their matchup with Stockton.

Wienen added three points of his own.

The Stockton offense didn't quite have enough to keep pace with the Hornets, but most teams wouldn't. The Scales Mound offense is already efficient enough, let alone when shots are falling like that. Westaby did his best to keep them in the game by attacking the defense and getting to the line.

In the second quarter alone, Westaby went four for four at the line. Westaby put up six points in the quarter, but the Blackhawks didn't find much production outside of him. By the break, Scales Mound held a 33-22 lead.

Scales Mound continued to expand their lead in the third quarter. Derrick Distler, who went scoreless in the first half, put up a trio of baskets to help the Hornets in the third. four different Blackhawks scoring in the quarter, Stockton still went into the fourth trailing Scales Mound 47-34.

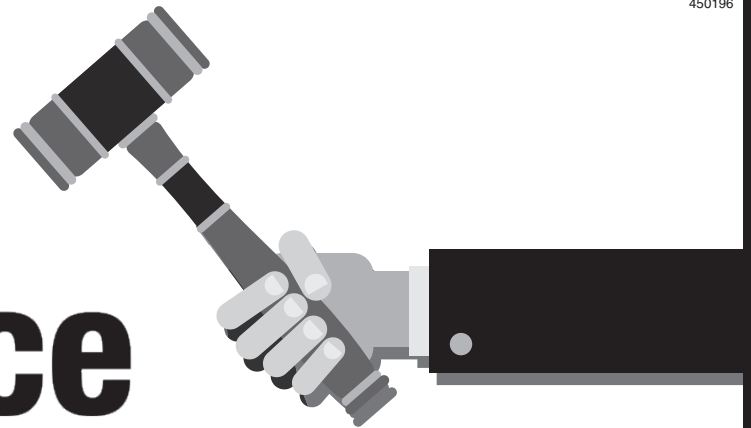

With the double-digit lead, the Wolves didn't take their foot off the pedal. The Wildcats were forced to foul early in the fourth quarter, in hopes of extending the game. Downs had four trips to the line in the fourth, hitting six of his eight attempts. Petta provided another six points as the duo helped to ensure the victory.

The free throw line is, perhaps, where the Wolves made their biggest difference. On the night, Pearl City shot nearly eighty percent at the line, hitting 15 of their 19 attempts.

For Petta, it was a night to remember. Not only did he surpass 1000 career points at the varsity level, but he dropped 31 points to help his team upset the Wildcats. Birchen was next up with 17 points, and Downs as the third Wolf in double figures with 16. The trio provided most of the offense as Pearl City beat the Wildcats 73-55.

The Wolves are scheduled to travel to face off with the Pecatonica Indians on Friday, Jan. 26.

Time and time again, the Orangeville Broncos have proven they have what it takes to compete with the top Illinois 1A girls basketball teams. After getting off to a 22-1 start to the 2023-2024 girls basketball season, the Broncos faced another imposing challenge. The Aquin Bulldogs got off to an impressive 15-4 start of their own. Aquin has especially found success in this year's NUIC play, getting off to a 4-1 start. By all means, the Bulldogs are one of the NUIC's top challenges for Orangeville.

Eastland is the only school who didn't, and their enrollment is 199. The decision left many in the Orangeville-Aquin communities puzzled, as Aquin struggles with numbers to form their own teams.

Despite the drama prior to the matchup, the Broncos and the Bulldogs put on a show when they faced off on Friday, Jan. 19. Coming into the game, Orangeville sat atop the NUIC, while Aquin sat just behind them in second place. These teams met up earlier this season, with Orangeville winning by a score of 53-34. This time around, Aquin came better prepared to prove themselves.

This game had a ton of hype leading up to the matchup and the teams played up to that hype right away. Orangeville's Whitney Sullivan was approaching another career milestone with 1000 rebounds. On the other end, Aquin's Payton London is leading the way for a special Bulldogs' season. Those two players rose to the occasion on Jan. 19.

In the first quarter alone, London and Sullivan combined for 18 points. London

put up 10 quick points. On Orangeville's end, Sullivan hit a three-pointer and a free throw on her way to eight first quarter points. Both athletes provided a majority of their team's offense on the night. By the end of the first, Orangeville held a slim 14-13 advantage.

Sullivan continued to attack in quarter two. Her second three-pointer of the night helped to expand their lead. Laney Cahoon and Nadalee Doyle complimented their big's play with some threes of their own. Cahoon hit her first three, while Doyle hit her second three of the night. They helped to slightly expand the lead as Orangeville took a 27-23 lead into the half.

Sullivan took things up a notch in the third quarter. She came out firing, hitting her third three-pointer of the evening to start the second half. Sullivan wound up putting up another 10 points in the third. Kaylynn O'Haver added a three of her own as the Broncos outscored the Bulldogs 12-8 in the quarter.

The Broncos came out looking to put things away in the fourth. Sullivan remained consistent, hitting her fourth three-pointer, giving her one in each quarter of the game. Although the focus was on Sullivan for most of the night, it was Doyle who took over the fourth quarter. Doyle hit a trio of three-pointers in the fourth, giving her five on the night. Doyle's 11 fourth

quarter points played a crucial role in the final outcome.

Aquin made things close in the closing minutes. London refused to let her team go down easily as she hit a pair of late three-pointers, keeping her team in the game. In the end, the Bulldogs didn't have enough to produce around London. Orangeville held on for a 58-54 victory, improving their record to 23-1 on the year.

Sullivan put up jaw-dropping numbers with 30 points and 16 rebounds. Not only did she have a double-double and four threes, but she eclipsed the 1000 rebound mark, stamping herself in Orangeville history once again. Doyle added 17 points in the victory as well. Aquin was led by London, who put up 29 points on the night.

The average American adult now spends over two hours a day on social media and the average teenager spends four plus hours a day. Keep in mind that these are averages I am talking about. Some teenagers report up to nine hours a day spent on social media platforms.

Social media is often the first place Americans go for health information. Unfortunately, information on social media can range from accurate, to misleading, to dangerous. Whether to increase company profits or to contradict scientific evidence-based health care for political or ideological reasons, the explosion of health misinformation on social media has become a major issue of concern for public health.

Researchers looking into how to best address this public health concern define misinformation as false or inaccurate information deliberately intended to deceive. This may include manipulating facts, propaganda and misleading or biased information based solely on anecdotal evidence and lacking precise scientific data. Their research has revealed the increasing use of social media bots, (automated programs that engage in either a partially or fully autonomous fashion with social media platforms,) to promote certain products for

material gain.

For example, one study showed that registered dietitian influencers had been paid by the American Beverage Company as part of a campaign to promote their products and undermine the World Health Organization's warnings about aspartame, an artificial sweetener. Social bots can also tailor your content, limiting your exposure to other, reliable information and your ability to make an informed decision.

In order to fully understand what is needed to address this issue, numerous research projects are being conducted to try to understand which platforms are best at spreading health misinformation, what tools and/or methods are they using to propagate this misinformation, what is their impact on the development

of unhealthy or dangerous behaviors and what are the costs in terms of damage to mental, oral and systemic health.

To protect your family's health, do not accept any health information you find on social media without checking the source. Rely on known, trusted sources such as the World Health Organization, the Centers for Disease Control and Prevention, the National Institutes of Health, and established medical institutions such as the Mayo Clinic. Make sure that the information is current and accurate. Be alert for sponsored content or potential conflicts of interest. Misleading health information often utilizes marketing techniques that prey on your emotions. When you see phrases such as "miraculous results," "awe-

inspiring," or "exclusive", or emphasis on the "trendiness" or "FOMO" (fear of missing out) or that rely on personal anecdotes or stories but lack any specific details or knowledge gained from scientific research and reliable data, these are red flags of warning for you to heed. Be aware that researchers have found that some of the "bad players" on social media are now incorporating scientific language into their content to appear more legitimate.

Talk with your health care provider before making any decision about your healthcare. They can answer any questions and verify or health information that you find on social media. Rely on their knowledge and experience, as well as their understanding of your unique health care needs before making any decisions that could negatively impact your health. Be part of the solution. Never share any unverified health information.

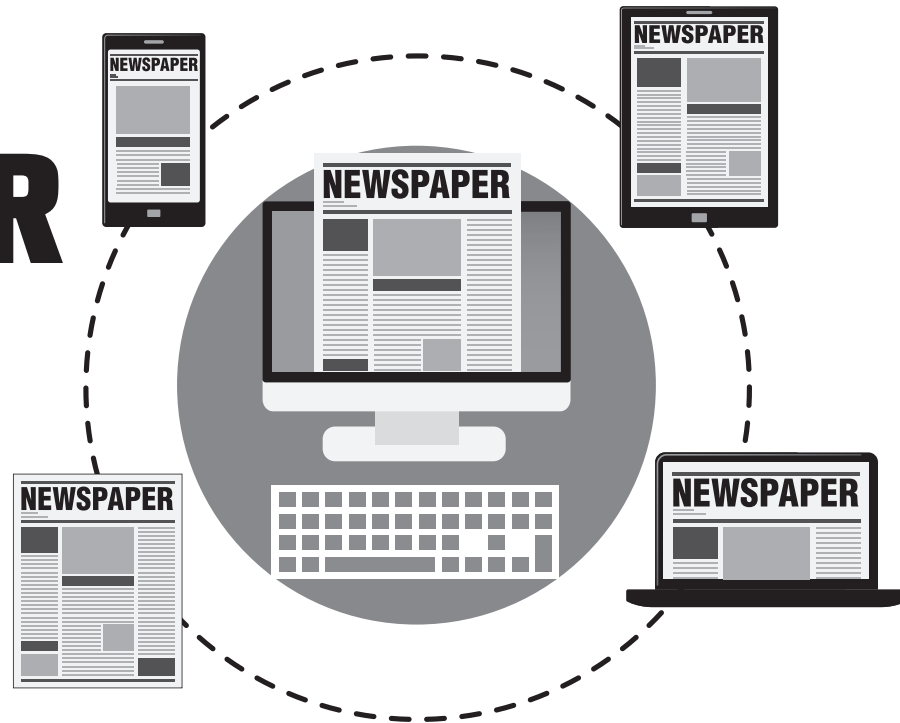
