# Certified Livestock Training sessions start Feb. 1

Depending on an operation's size, livestock manager training certification is required for many Illinois production livestock facilities. Having certified individuals on staff strengthens an operation through shared knowledge and building conversations with individuals responsible for livestock care.

University of Illinois Extension and the Illinois Department of Agriculture kicked off the 2024 Certified Livestock Manager Training Workshop schedule on Jan. 30. Several locations around the state, including Freeport, will host training workshops that meet the Illinois Livestock Management Facilities Act training requirements for Illinois livestock managers.

Pre-registration is required to attend an in-person workshop. For complete program details and to register, visit [go.illinois.edu/CLMT](http://go.illinois.edu/CLMT). Class size is limited in some locations due to space constraints.

The remaining 2024 workshop dates and locations include:

- Thursday, Feb. 1, Morris: University of Illinois Extension Grundy County Office, Kendall-Grundy County Farm Bureau Bldg., 4000 N. Division St., Morris

- Friday, Feb. 2, Freeport: Stephenson County Farm Bureau Bldg., 210 W. Spring St., Freeport

- Tuesday, Feb. 6, Effingham: University of Illinois Extension Effingham County Office, 1209 North Wenthe Dr., Effingham

- Wednesday, Feb. 7, Breese: University of Illinois Extension Clinton County Office, 1163 North 4th St., Breese

- Thursday, Feb. 8, Pitts-

field: University of Illinois Extension Pike County Office, Pike County Farm Bureau Bldg., 1301 E. Washington, Pittsfield

Each workshop location will open at 8:30 a.m., and training will begin at 9 a.m. The training lasts 3.5 hours, and IDOA staff will administer the exam after the training. The Illinois Extension training fee is \$40, and IDOA's certification fee is \$30.

A range of topics related to the operation, management, and utilization of livestock waste and waste facilities will be covered. Additionally, the latest regulations, best management practices, and research for manure-related issues will be discussed. The training manual used will be the "Livestock and Poultry Environmental Stewardship Curriculum." It is available at [go.illinois.edu/manual](http://go.illinois.edu/manual).

The LMFA requires facilities designed for 300 or more animal units to have at least one employee certified in environmentally aware manure management techniques. Facilities designed for 301 to 999 animal units must have at least one employee attend a workshop OR complete the online training. Facilities with more than 1,000 animal units must have a certified livestock manager attend a workshop and pass the IDOA exam OR complete the online training and pass the online test.

For the 2024 season, there will be 50 questions on both paper-based and online tests. The pass rate is 70% or 35 of 50 questions. A Spanish version of the test is now available upon request. Young family members under 18 are welcome to take the training, but they cannot be the only certified managers at the facilities.

Cannot attend a workshop? Online training and testing are available year-round and follow the same format as the in-person workshops. Online training involves nine modules of 10- to 20-minute videos that can be viewed at an individual's own pace. Those who have more than 1,000

animal units may take the test online.

# Conference offers landowners opportunity to learn about forestry, conservation practices

The Tri-State Forest Stewardship Conference has an over 25 year tradition of providing great information and resources to forest landowners in the Illinois/Iowa/Wisconsin tri-state area. It has been one of the largest conferences for forest landowners in the Midwest.

The University of Illinois Extension is happy to announce that Tri-State will return to its historic format on Saturday,

March 2, in Freeport at the Highland Community College from 9 a.m. to 4:30 p.m. This conference is sponsored by Illinois, Iowa, and Wisconsin Extension Services.

This year's keynote speaker is Jason Meyer, executive director of the White Oak Initiative. Meyer will discuss the importance of white oak ecologically and economically along with efforts underway to sustain

white oaks on the landscape. Other topics on the agenda include bottomland forest management, timber harvesting, forest taxes, invasive species control, prescribed fire, tree diseases and pathogens, wildlife management, tree physiology, streambank erosion, forest soils, tree identification, and silvopasture.

The day will end with a discussion with experts from each

of the state's Extension professionals on the state of forestry in the tri-state area.

The Tri-State Forest Stewardship Conference is designed specifically for forest landowners in the Midwest, but forestry professionals, consultants, volunteers, Master Naturalists, and students are all encouraged to attend. The conference is scheduled to be held at the Highland Community College

Student Conference Center, Building H, Parking Lot A, located at 2998 W. Pearl City Rd. in Freeport. Check-in will be from 8 to 9 a.m. that morning. The conference begins promptly at 9 a.m.

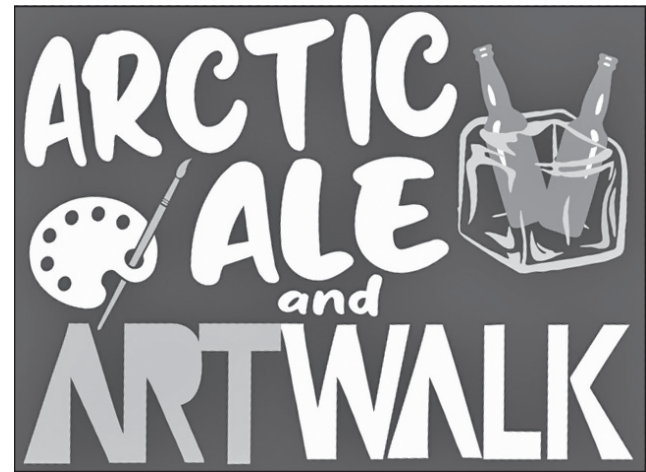
"We are excited for another exciting Arctic Ale and Art Walk in Downtown Free-

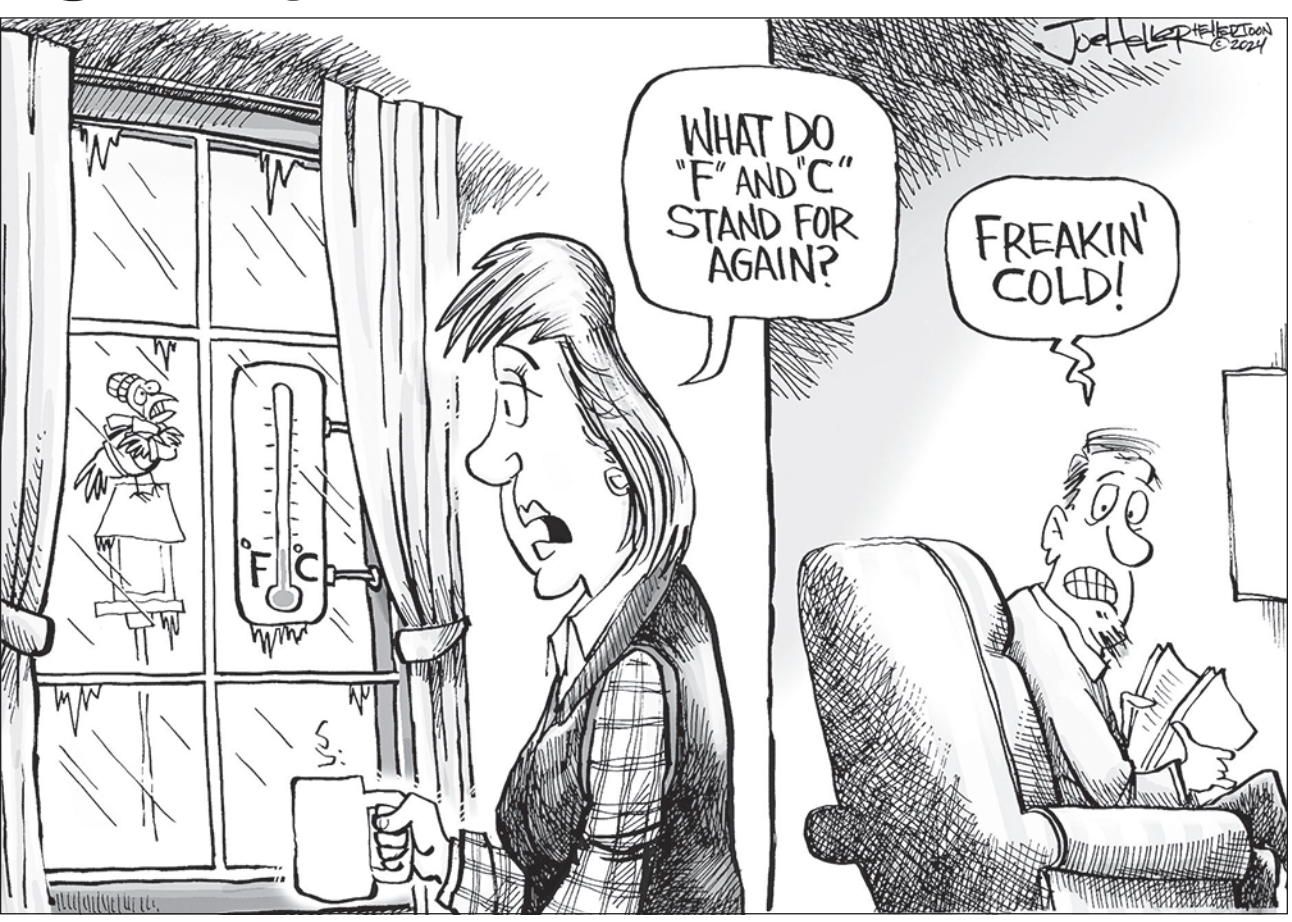

# Warren basketball wrap

Both Warren's boys and girls basketball teams found success when they picked up victories in their recent play.

The Warren Warriors boys' basketball team has experienced its fair share of ups and downs throughout the 2023-2024 season. After going through a coaching change and picking up an upset victory over Scales Mound, the Warriors fell back to earth with five consecutive losses.

Warren finally bounced back into the win column on Jan. 20, when they faced off with Easton Valley in this year's Manny's Shootout.

It was a day that saw the Warriors get off to a hot start, which is something they direly needed. More specifically, it was a game that Treyton Pafford simply refused to lose. Pafford practically willed his team to victory as he dominated the game from start to finish.

An early three-pointer got Pafford going in the first quarter, but he began to attack the interior of Easton's defense after that. Pafford put up thirteen points in the first, including a successful and-one opportunity. The Warren

junior handled a majority of the Warriors' production early on as he helped the team take a 17-10 lead into the second quarter.

Pafford's teammates continued to feed him the ball in the second quarter. Pafford went two for two at the line before adding another pair of baskets. Bryce VanRaalte, a sophomore, joined the party with a trio of his own baskets. They provided all of Warren's offense in the second quarter as the Warriors took a 29-14 lead into the break.

Easton didn't have the offense to complete a comeback, but Pafford was going to be sure to put them away. Pafford hit another three-pointer on his way to ten third quarter points. Jordan Kohl added a three of his own as the Warriors combined for seventeen points in the quarter.

Two hot starts defined the day for the Warriors. Seventeen points to begin the first and second halves allowed the Warriors to safely put this one away. Pafford led the way in scoring with a monstrous thirty-four-point performance. VanRaalte was next up with ten, and Kohl added six in the victory.

It was the seventh win of

the season for the Warrior boys, who went on to drop their next game against Oregon. The Warrior boys will be back on the court on Feb. 1, as they play host to West Carroll at 7p.m.

For the Lady Warriors, they have maintained a middle of the road approach to the season. After losing five games to open the season, the Warriors revitalized their year with a four-game win streak. Since then, they've kept things pretty balanced, helping them get off to a 10-12 start.

Their tenth win of the year came on Jan. 22, when they played host to the Potosi Chieftans. Much like the boys, the Warren girls got off to a quick start of their own.

Mayci Mullen got things going by going two for two at the free throw line. Later in the first, Mullen sunk a three-pointer. Meridyth Neff had a hot start of her own as an early three-pointer helped her put up five points in the first. Addy Bohnsack matched them with five points of her own as the trio combined for all of Warren's first quarter points.

At the start of the second, the Warriors held a 15-10 advantage. That lead would only continue to grow as Lauren

Williams had an exceptional performance in the second. Williams went two for two at the line and hit a three-point-er on her way to nine second quarter points. Bohnsack added another four points. Averi Sabinson added a three-point-er of her own as the Warriors put up eighteen in the quarter.

Warren outscored Potosi in each of the first three quarters. In the third, Mullen hit her second three-point-er of the night, as did Sabinson. Katie Schneider got on the board with a pair of free throws and a two-point field goal as the Warriors outscored Potosi 15-14 in the third.

Heading into the fourth, Warren held a commanding 48-36 advantage. Potosi couldn't erase the deficit in the fourth as Bohnsack put up eight insurance points in the final quarter.

Bohnsack led the team in scoring with eighteen points, while Mullen finished with fourteen. Williams added nine, all of which came in the second quarter. Neff had seven as Warren won by a score of 59-49.

The Lady Warriors are scheduled to play host to West Carroll on Feb. 2, beginning at 5:30 p.m.

### Jo Daviess County Farm Bureau offering \$250 towards ROPS purchase

The Jo Daviess County Farm Bureau would like to offer funds to reimburse farmers for purchasing Rollover

Protection Structure (ROPS). Fifty-five percent of farm tractors in Illinois do not have a cab or ROPS. Only one in five victims will survive a tractor rollover accident. The leading cause of farm related deaths in Illinois is tractor rollover accidents. They account for more than 30% of farm related deaths. ROPS help protect farmers and family members from being crushed in the event of a tractor turnover or rollover.

Safety Chairman Dan Robbe states, "Safety is a priority of the farm bureau, and we would like to encourage our members to install ROPS on their tractors".

Jo Daviess County Farm Bureau members who purchase a ROPS could receive a reimbursement of \$250 towards the purchase of a ROPS (there are six rebates available). To receive the \$250, members need to bring in their paid invoice to the Farm Bureau office in Elizabeth. Customers are responsible for the cost, freight, and installation which are available through the dealer. If you have been thinking about putting a ROPS on one of your tractors, now is the time! 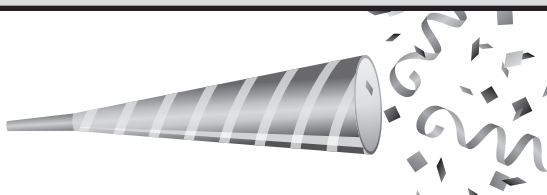

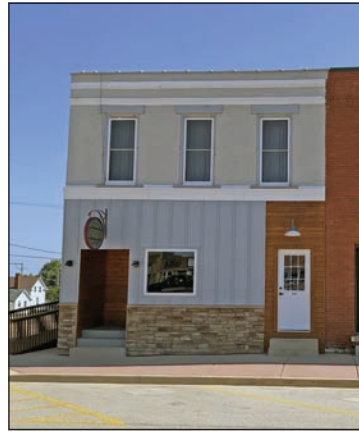

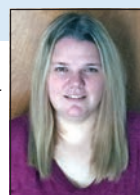

# Broncos defeat Pearl City in NUIC matchup

The first year of the Orangeville-Aquin boys basketball co-op hasn't exactly been a walk in the park. The Broncos recently struggled through an eight-game losing streak, which dropped their overall record to 3-13 on the year. That stretch included a pair of losses by four points or less, and two more losses within 10 points.

When the Broncos can learn how to win those close games, they will sit in a much better position. Fortunately for them, they recently picked up a pair of tough wins over LaMoille and Pearl City.

On Jan. 20, the Broncos hit the road as they took on the LaMoille Lions. Prior to

their matchup, the Lions held an overall record of 7-13. Albeit below five hundred, the Lions still looked like the early favorite over Orangeville-Aquin.

The Broncos had a massive first quarter that set the tone for the rest of the game. After Orangeville-Aquin's Junior Varsity team picked up a commanding 30-16 victory, the Varsity squad picked up right where they left off to start their game.

The Broncos' big three of Brant Carlson, Miklo Webb, and Cody Wirth led the way offensively. The trio found success from the field, but also at the free throw line, where they made a major difference. Wirth was four for four, Webb was three for four, and Carl-

son was five for six at the line on the day. Ben Briggs was also solid, hitting three of his four free throw attempts.

By the halftime break, the Broncos held a commanding 31-23 advantage over LaMoille. The Broncos maintained their lead up until the final buzzer, when they went home with a 72-62 victory. Wirth led the team with 20 points, but Webb was right behind him with 19. Carlson finished the day with 15 points. Briggs was nearly the fourth Bronco in double figures as he finished with nine points.

Webb and Carlson led the team in scoring with 11 points each, while Wirth was next up with six. It certainly wasn't the offensive performance the

Broncos saw against LaMoille, and they eventually fell by a score of 47-36.

Orangeville didn't have to wait long to bounce back with the Pearl City Wolves on the schedule for the very next day. Not only were the Broncos in need of a win, but they had the advantage of being on their home court to host the Wolves.

Pearl City has seen their fair share of struggle this season, but they have been known to surprise a few teams. The Wolves gave the Broncos a tough fight in a game that came down to the wire.

The Wolves held a slight advantage in the first half. After outscoring the Broncos 15-13 in the first, the Wolves

maintained their two-point lead all the way up to the half-time buzzer. Orangeville had an impressive third quarter that would swing the momentum.

Once again, Carlson and Webb had excellent days, but it was Briggs who stepped things up for the Broncos. Briggs helped the Broncos outscore the Wolves 20-14 in the third which gave the Broncos the final lead change of the day.

Briggs wound up leading the team in scoring with 16 points. Both Webb and Carlson finished with 12 points. Webb did his damage from deep with a pair of three-pointers. Wirth added nine as the Broncos beat the Wolves 59-55.

After their battle with Durand, the Panthers faced another obstacle as they hit the road to play against the Eastland Cougars on Jan. 24.

Early on, the Panthers had the offense to match the Cougars. Rakowska had a solid first half with eight points. Lynch hit a big three-pointer. Mowery had a couple of nice baskets and Mahon found success at the line with a trio of free throws. By the break, Le-Win sat tied with Eastland at 24-24.

The Cougars took over the second half. Eastland's defense held the Panthers to just six points in the third quarter and nine in the fourth. Rakowska provided most of that offense with a three-pointer in each quarter.

The local board is seeking applications from qualified service organizations (please see list of qualifications below) serving Stephenson County. Those interested in applying can visit United Way of Northwest Illinois' website or contact our office to receive an application.

Stephenson County has distributed Emergency Food and Shelter funds previously to Freeport Area Church Cooperative, Northwestern Illinois Community Action Agency Senior Citizen Services, Hearts That Care, VOICES of Stephenson County, Lena Ministerial Food Services and many others. Areas that are eligible to receive funds include organizations with existing programs: served meals, other

food, mass shelter (on-site), other shelter, supplies/equipment, and utilities assistance.

## Eligibility to receive funds

Under the terms of the grant from the National Board, local organizations chosen to receive funds must:

- 1) Be private voluntary non-profits or units of government (If private voluntary organization, must have a volunteer board) with a UEI, Unique Entity Identifier Number & FEIN Number
- 2) Have an accounting system
- 3) Practice nondiscrimination
- 4) Have demonstrated the capability to deliver emergency food and/or shelter programs

### IFB launches Urban Growers Cohort

Illinois Farm Bureau (IFB)

is hoping to connect urban producers with the agricultural community across the state by creating an Urban Growers Cohort and investing \$1.2 million in community gardens. IFB will be entering into a three-year partnership with USDA and Natural Resources Conservation Service to build connections and prevent growers from being "siloeed." "There's programs everywhere, there's nonprofits that are doing all sorts of things, but people didn't feel like everyone knew how to connect, not just within Chicago but across the entire state," said Raghela Scavuzzo, IFB associate director of food systems development. Over the next three years, six community gardens will be identified throughout the state, and those gardens will receive between \$50,000 and \$75,000 for infrastructure based on a needs assessment.

The funding is not a grant and Scavuzzo said it is to create a long-term partnership meant to be a "true resource" for growers. "At the end of the day this is going to be what you as growers need," she said. Ben Skipor, ag science teacher and student garden coordinator at Freeport High School, said he sees this partnership as a way to excite young people who have not been a part of agriculture. "When I talk to my students about agriculture, a lot of them don't see opportunities because they don't come from a family that has a farm or they aren't the traditional farmer, so I think opening up those opportunities to them is really important so they can see themselves in the industry," Skipor said.

Scavuzzo said NRCS defines community gardens as anything that has either education to the community or food access components, which many urban farms provide. She also noted the definition of an urban community is broad and the goal of the program is to reach multiple geographically diverse communities. Joseph Bridges, urban conservationist for USDA, said this program is important to make sure that urban and smaller scale size operations are "in touch" with available technical and

financial assistance. "Every particular area is unique to its own demographic, what kind of produce they have, what is going on at the sites," Bridges told FarmWeek. "Bridging the gap and addressing things like the food deserts and addressing things like the general educational informational side of, how do we feed ourselves five to 10 years from now." Bridges said he believes everyone has a role in agriculture and that the Urban Growers Cohort will allow a systematic approach to "put all the pieces together" between traditional growers and specialty growers.

The program will do one site in the first year, two sites in the second year and three sites in the third, with additional funds, supplies and materials each year. "This is going to be a true grassroots opportunity where we're working with local government, local leadership, we aren't coming in to control anything. We are here help others build those relationships in the community," Scavuzzo said. She said they also want to ensure grant programs and other funding is used to its full potential. Preventative dental care includes not only early and regular dental visits, toothbrushing and flossing, but preventative education. Throughout the entire month of February, healthcare professionals across the nation will be

promoting the benefits of oral health education and its role in establishing healthy habits throughout each developmental stage of a child's life. Oral education plays a key

role in helping to establish and maintain habits that optimize your child's health from before conception, throughout pregnancy and throughout their lives. Parents, caregivers, teachers, and children all benefit from understanding what causes dental disease, the positive or negative ways our diet can affect our oral and overall health, the benefits of fluoridation, recognition and early intervention in craniofacial developmental

issues, disease, injury and trauma prevention, and the impact of oral health on overall health.

Establishing habits requires consistency. If you do not make oral care a priority, your child will not. The more parents learn about the benefits of oral health and the habits that promote it, the more likely they will be to develop and retain these healthy habits throughout their lifetime. When children see their parents model these

habits and are taught the important roles that their teeth serve, how and when to floss and brush their teeth, why they should visit the dentist, and the role that good nutrition plays in both oral and overall health, the more likely they are to value and carry those habits into adulthood.

Manual dexterity varies between children, so when it comes to teaching your child how to brush and floss, some children may need more assistance and for a more prolonged time. Do not

assume if one child could brush and floss well by a certain age, that all children should be able to. As always, ask your dentist and hygienist if your child is brushing well and what you can do to support their efforts.
